**Items Examined**

**Item #MC4:** One box labeled "Stained wood inside edge of sill..." containing apparent wood flakes.  
**Item #MC5:** One box labeled "Inside window ledge..." containing brown dust/powder.  
**Item #MC6:** One box labeled "Outside window ledge scrapings..." containing grey dust/powder.  
**Item #MC7:** One box labeled "Upright edge between inside and outside window ledge..." containing apparent wood flakes/debris.  
**Item #MC20:** One box labeled "Scrapings from head of bed..." containing red/brown flakes.

**Examination Procedures and Results**

A stereomicroscope was used to aid visual examination of all items examined for this report. With the exception of item MC4, all boxes contained minimal evidentiary material.

**Item #MC4:** Red/brown staining observed on apparent wood flakes was tested with phenolphthalein (PHT), a presumptive test for indications of blood. Negative PHT results were obtained.

**Item #MC5:** A portion of the brown powder was sampled and tested with PHT, with negative results.

**Item #MC6:** A portion of the grey powder was sampled and tested with PHT, with negative results.

**Item #MC7:** One flake with red/brown staining was removed and tested with PHT, with negative results.

**Item #MC20:** Red/brown flakes/crusts were tested with PHT, with negative results.

**Conclusions/Interpretations**

No indications of blood were detected in any of the items examined for this report.

**Disposition**

The remaining evidence was returned to the evidence vault pending return to the submitting agency.

**Results and Conclusions:**

A onetime search of the DNA typing profile obtained from the reference sample of Theodore Bundy (MC31) was performed against the Washington State Patrol Combined DNA Index System (CODIS) databank and no matches were found.

**Evidence:**

**MC31:** Two blood tubes reported to be reference samples from Theodore Bundy.

**Methods and Observations:**

A portion of the blood from each tube was removed and extracted for DNA content.

The extracted samples were quantified for human DNA levels. One sample was amplified by the PCR process using the Applied Biosystems AmpF<sub>l</sub>STR® Identifiler® Plus amplification kit. The resulting amplified STR DNA products were analyzed using an Applied Biosystems 3500 Genetic Analyzer.

**Remarks:**

The evidence was returned to the evidence vault pending return to the submitting agency. A portion of the blood from each tube was dried onto a filter card and returned as new item MMC-1.

**Glossary:**

**PCR (polymerase chain reaction):** A process used to make many copies of short target segments of DNA, which subsequently can be typed.

**STR (short tandem repeat):** Short segments of DNA, of a particular sequence, which are repeated a variable number of times. STR's are differentiated and categorized based on size.
