Milo,

I interviewed Joan Elkins at the LaCrosse Police Dept. LaCrosse, Wisc. Jan. 11, 1975. Joan said she left LaCrosse on June 8 or 9, 1974 along with Sandra Weaver and Jeffrey L. Skarboszewski. Subjects hitchhiked to Salt Lake City then to Tooele, Utah and stayed in a canyon for several days eventually meeting Ken Jones who invited them to stay in his home located near Tooele. Jeffrey worked part time for Jones father and the girls found employment in Salt Lake City and worked through Manpower Inc. 370 So. 7th East SIC. The girls worked for a week taking inventory of motion picture products the next week they went to work for Wycoff warehouse SIC. The girls continued staying at Ken Jones home and hitchhiked to and from work. Ken Jones is believed to be having an affair with Sandra Weaver at this time.

On Friday evening June 28, 1974 Sandra and Joan bought some groceries in SIC then hitchhiked to Tooele, arriving home about 7:00pm about 11:00pm Phillip Quintana aka Phillip Martinez and a friend showed up at the Jones home. Phillip Quintana worked with the girls at the Wycoff warehouse and hitchhiked to Tooele and to spend the weekend with the girls. Friday evening was spent at home. Joan Elkins slept with Phillip Quintana and believes Sandra slept with Ken Jones, Quintana's friend slept in a chair. Ken Jones also had a friend living with him at this time, described as WM 18 to 20 years and an athletic freak.

Joan says Sandra Weaver left Jones Saturday afternoon and went to Jeanines trailer in Tooele (Jeanines is trailer where Party was held June 29, 1974). Sandra met Glade Gamble at Jeanines and went for a ride through canyons with him, they were using Jeanines Blue VW beetle. Approximately 7:00pm June 29, Glade and Sandra returned to Ken Jones home and picked up Joan, Phillip, and Phillips friend. All five persons went to a drive inn on the edge of Tooele and had supper. The group ate corn dogs, onion rings, french fries. Sandra may have had a chiledog, coke or shake. After eating the group went directly to Jeanines trailer home and attended a party. Sandra introduced Joan to Bruce Bolinder. Sandra told Joan she had met Bruce in the afternoon while riding with Glade Gamble. According to Sandra Bruce was supplying Glade with the drug THC. Sandra is believed to have snorted some THC also used Pheno Barb and possibly Nebutal. Joan claims there were about 25 persons at the party and most of them were doing drugs. Among the participants were Joan Elkins, Sandra Weaver, Glade Gamble, Bruce Bolinder, Jeanine (owner of trailer) Glades sister and her boy friend, Phillip Quintana and his friend, Steve Symonds, Ken Jones.

Sometime during the evening of June 29, 1974 Phillip Quintana slept on the floor of Jeanines trailer. After a short time Joan woke Phillip and he went outside and slept in Glade Gambles VW van. Phillips friend was also sleeping in the van at this time. Around Midnight Joan woke Phillip and told him they could get a ride to Ken Jones home with Bruce Bolinder. Bruce was driving a Gold Cadillac. After dropping Joan and Phillip off Bruce drove away and Joan does not know if he returned to the party at Jeanines. Glade Gamble his sister, her boy were the only people at the trailer when Joan, Phillip and Bruce left. Jeanine was sleeping. Sometime during the day Sandra bought a \$15.00 bag of Pheno Barb from Bruce Bolinder and used some of this at the party, Joan claims she took some of this Pheno Barb Sunday June 30, and again July 1, 1974. Sandra stayed at Jeanines with Glade Gamble.

Sometime Sunday June 30, 1974 Joan called Jeanines and talked with Glade and asked to speak with Sandra, Glade said she was sleeping. Joan did not have any contact with Sandra on Sunday and did not see any of the people who had been at the party. During the conversation with Glade he told Joan that Jeanine would give the girls a ride into Salt Lake City Monday Morning.

Monday July 1, 1974 between 7:00 and 9:00 am Sandra came to Ken Jones and woke Joan and asked to borrow some money, Joan pulled her billfold from her purse took out a \$5.00 bill and gave it to Sandra. Phillip Quintana was in bed with Joan and she woke him and told him to get up because his ride was their. Sandra and Phillip left and that is the last time Joan saw Sandra. Joan is not sure who had the car and did not hear a car leave. Sandra was wearing Blue Cordury shorts and halter.

Tuesday July 2, 1974 Joan recieved a call from the secretary at Manpower inquiring why the girls hadn't came to work, Joan said she was sick and the secretay replied "yes I know Sandy told me" she also said Sandra had worked until 11:30 am Monday July 1, 1974. During the day Joan noticed her billfod was missing. (The last sentence should be in the preceeding paragraph) Tuesday evening Bruce Bolinder came to Ken Jones home and visited with Joan he also visted several times in the next few days and finally invited Joan to move in with him which she did sometime in the second week of July. Glade Gamble also moved in with them at Stockton, Utah.

Around the 5th or 6th of July Joan contacted the Salt Lake Police and wanted to report Sandras disappearane and was advised to call the Tooele County Sheriff, which she did. Sandra next called Sandras mother in Wisconsin and told her Sandra had went to work July 1, and never returned. Joan claims she asked Bruce Bolinder to assist in locating Sandra and he always put it off.

Joan stayed with Bruce Bolinder and Glade Gamble for about 3 weeks and the moved in with Danny Quinn who also lived at Stockton, Utah.

Joan left Utah August 13, 1974 and arrived home in LaCrosse, Wisc. on the 15th. Joan came home by bus and also brought Sandras belongings, which were given to her parents.

Dirk Pehrson Approx. 17 years old former employee of Wycoff warehouse told Joan he had talked with Phillip Quintana and was told Phillip got dropped off and Sandra went to work the morning of July 1, 1974. He did not say who was driving. Phillip also told a secretary at Manpower Sandra had been talking to a truck driver the morning she disappeared. The Manpower secretary also told Mrs. Weaver Phillip Quintana told her Sandra had been seen on a bus heading for Idaho.

Sandras father Bruno Weaver went to Salt Lake City and Tooele, Utah in Nov. 1974

and contacted a number of persons her daughter associated with. Mr. Weaver had a phone conversation with Phillip Quintana in Nov. 1974, Quintana denied he had attended the party the night of June 29, 1974 but said his friend Martinez did. Mr. Weaver also talked with Bruce Bolinder who said Steve Symonds and Phillip Quintana gave Sandra a ride into Salt Lake City the morning of July 1, 1974. Symons address 9th East 8th So. Phone #364-3125 Phillip Quintana address 226 East 4050 st. SLC. Bruce Bolinder Address P.O. Box 68 Stockton, Utah. All subjects seemed uncooperative and hesitant to talk to Mr. Weaver.

Sandra had two pair of shoes and both pair have been returned to Weavers, these were in Ken Jones trailer. Jones told Bruno Weaver that another pair of Sandras shoes were at his home this was in Nov. 1974. Joan and Jeff Skarboszewski both claim Sandra only had two pair with her. Joan also said she used some of the Pheno Barb that Sandra bought from Bruce Bolinder, she used this Sunday June 30 and again on July 1, Joan can't explain how this bag of drugs got to Ken Jones trailer because Sandra had not returned until Monday AM. Joan also says she gave Sandra her last \$5.00 and was broke. Why would anyone steal her billfold? Joan claimed Sandra was wearing Blue Cordury shorts and a blue halter the morning of July 1, the Blue Cordury shorts are in Sandras belongings at the Weaver home. Joan told myself she had not been corresponding with anyone from Utah since her return home, She has been receiving letters from Phillip Quintana. During the conversation with Joan on 1-11-75 she claimed she did not recall how Sandra first met Glade Gamble but thought it must have been the afternoon of June 29 the day of the party. During the interview with Jeffrey Skarboszewski he says Glade came to Ken Jones home around the 20th of June and stayed all night sleeping with Joan Elkins. Joan also seemed to be shielding Steve Symons. She never mentioned his name until asked and then seemed hesitant to admit she knew him. According to Mrs Weaver Joan told her about Phillip Quintana staying with the girls the last weekend of June 1974 but never mentioned Phillips friend being along. Approximately the 10th of July Joan called Mrs Weaver and explained about Sandras disappearance, at this time she seemed very upset and emotional, the following day Mrs Weaver called Joan and she didn't seem upset or concerned. I also am skeptical about the reported phone call from the secretary of Manpower asking Joan why the girls didn't come to work. Mrs Weaver sent Joan a picture of Sandra and asked to have it put in the newspaper, Joan claims she gave this to Bruce Gamble to take to the paper, he told Joan he tried to put it in the SLC paper but they wanted \$40.00. Joan says she asked Bruce Bolinder to assist in locating Sandra but he always had an excuse.

Glade Gamble told Joan that Sandra was hard to move when she was sleeping. It seems strange if Joan had been sleeping with Glade on the 20th of June and Sandra also was there, why would Joan say she was not sure how Sandra met Glade and thought it was the afternoon of the 29th.

Jeffrey Skarboszewski claims the girls never went any place without shoes and was sure Sandra would not go to work barefooted.

I had a phone conversation with Joan Elkins on Saturday Jan. 11, 1975 at this time she was positive the party at Jeanines had been held June 29, 1974. She also said Glade Gamble told her that Sandra was doped up Monday AM when she left Jeanines and went to Jones home to get Phillip Quintana, he said this may be the reason she didn't wear shoes to work. She also said that Glade had told her Phillips friend " had hitch hiked into SLC Sunday June 30, 1974.

INTERVIEW WITH: Glade Gamble 1-22-75

Q. I told you we would probably be back when they got in here. The story is a little different from the last time I talked to you. Does that look like her?

A. Yeah

Q. Is that a good picture?

A. Yeah that is a good picture.

Q. Did she look that good?

A. No

Q. How about her hair, shorter, longer or what?

A. I think it was that long, I remember it being more frizzy, I don't remember it being straight.

Q. But for somebody that didn't know her, that is a good likeness, they would have recognized her from that picture do you think?

A. Probaby.

Q. In that picture she appears to be a nice looking girl. Would you describe her as that?

A. Yeah, she was a good looking girl.

Q. You are the one that arranged the ride that morning, is that right?

A. Yeah me and

Q. Do you know Scott Williams? Was he out there at the party that night? Do you know?

A. Yeah

Q. OK, there is a few things I wanted to ask you Glade. If I am wrong when I point out will you tell me so we can get things straightened out. You heard this on the news, is that correct?

A. Yeah

Q. Now I will give you a little bit more, where it puts you guys in a position where I am at. Sandy left that morning from Jeanine trailer. Steve took her and Scott headed for Salt Lake, is that right?

A. Yeah

Q. Was you there when they left?

A. I was leaving at the same time.

Q. You was leaving at the same time. Within hours of that time Glade she was murdered. Within hours of your seeing her.

A. I didn't know that.

Q. I know you didn't, if you did know you would be in alot of trouble. Within hours of leaving you, she was murdered brutally, and I am not kidding you when I say brutally. I probably shouldn't do this but there is a little difference isn't there? As you can see, I dont think many human lifes deserve that kind of treatment. So if you can help me for God's sake give me some information. I don't care if any drugs were involved cause were not here or have no interest at all in petty crimes or drugs at this time. I am interested in that.

A. I will tell you what ~~XXXXXX~~ everything I know, but I told you everything last time except for dates.

Q. Did she ever contact you after that morning you left her at Jeanine trailer?

A. No sir

Q. Did she call you?

A. No I was to work that day. She didn't have the number there.

Q. OK now you left that morning and I understand you kissed her goodbye out there at the car or before, and she went with your 2 friends, is that correct? Is that the last time you seen her or heard from her? What did Joan tell you about Sandy? Did she say that Joan came back from work that morning or was sich or called her or something?

A. No, as far as I knew Joan was as up in the air as the rest of us.

Q. Was Joan really upset over the thing in your opinion or did she or didn't she care/

A. No, she just, well being on the road the way they were she just thought - - -.

Q. Did Joan report her to Tooele, missing?

A. I don't think so.

Q. You never heard her do it.

A. No

Q. Did she call her parents?

A. I think after awhile, she waited quite a while .

Q. Days, weeks, months.

A. At least weeks

Q. Did Mr. Weaver get ahold of you when he came out here?

A. Yeah

Q. Where did he meet you?

A. Down at my house.

Q. Did one of the Tooele guys bring him down or how did he come down here?

A. Yeah, I can't remember his name, the real heavy set guy from the sub-division.

Q. When was this?

A. It was in November sometime.

Q. Going back quite a ways Glade, I understand, clothing wise that neither one of the girls had much clothing with them so they approximately wore the same thing all the time, right or wrong?

A. Right

Q. Can you tell me, dresses, long pants, shorts or what?

A. Mainly cut off shorts.

Q. Mainly cut off shorts, levis or regular shorts?

A. Levis shorts.

Q. Were they the kind they had cut off any frayed them or were they straight? Do you remember anything about them.

A. They were the frayed kind, just take the scissors and cut them off.

Q. did any of them have any corduroy shorts, blue or brown corduroy?

A. I don't know.

Q. Do you recall that morning she left was she wearing shorts, long pants or can you recall what she was wearing that morning when she left?

A. I can't recall for sure, but I ~~XXXXXX~~ would say probably long pants since she was going to work.

Q. Did she usually wear long pants? When she went to work?

A. Well yeah she usually wore them to work. That is the first time I have seen her leaving for work.

Q. What did she wear to the party, shorts?

A. No she had pants on so she probably had pants on.

Q. What are we talking about pants, levis?

A. Yeah levis.

Q. Now she wore halters quite a bit. Was she wearing a halter top?

A. I don't know.

Q. Ever remember seeing her in a blue halter, or one of them that has no back, you know?

A. I can't recall for sure. I can't give you a yes or no.

Q. How about sandels? Do you recall if she had shoes on that day, or if she had sandels carrying them with her or what do you remember about that?

A. She usually wore a pair of clogs. Just the slip on type clog, and I think she had those on.

Q. That morning she left? The last time you seen her you mean.

A. She didn't have shoes on, thats one thing I found out.

Q. She didn't have shoes on that morning, did she have clogs?

A. She left the shoes at Jeanine's

Q. She left the shoes at Jeanine's.

A. Thats what I understand.

Q. And where did they go from there?

A. I don't know, Joan might of picked them up. Joan made a habit of picking up all her stuff after she had been gone.

Q. If I got some colored pictures of her, would you be able to recognize some of the items you had seen her in, do you think. Shoes, etc.

A. I might be able to.

Q. Who did you hear from that she didn't wear shoes, who told you that?

A. Steve told me.

Q. Simon

A. I think, because they went up to the trailer in Pine Canyon to get some shoes or something to see if Joan was going to work.

Q. Oh so she picked up here shoes at the trailer?

A. This is a different trailer I am talking about.

Q. He is talking about Ken Jones trailer. She didn't have shoes, she was barefooted the last time you seen her, right?

A. This is what I heard from other people.

Q. then she got a ride up to Kenny's trailer and was supposed to pick up shoes there. But you really don't know if she had shoes on that day or not.

A. No

Q. Do you recall if she had her purse with her?

A. No

Q. You don't know or you can't recall?

A. I can't recall.

Q. Did Joan ever mention to you that somebody stole her wallet?

A. Somebody stole Joan's wallet.

Q. Right

A. I think I remember something like that.

Q. Did she tell you if it was taken out of the trailer or it was taken at the party.
Do you recall any of this.

A. I think it was stolen at the party, because I remember, most of the people at the party were my friends and I remember having to protect them against her because I didn't think any on of my friends would steal her wallet. There were a few people there that weren't my friends.

Q. Do you remember what Sandy had in her purse?

A. I can't remember.

Q. You can't recall ever seeing her purse.

A. I probalby did

Q. You don't recall her little necklace with a wooden cross. Ever see her wear that?

A. I can't remember.

Q. How about rings or other jewelry, watch?

A. Nothing verbal

Q. did she wear contacts? did she take them out at night.

A. Yeah

Q. Do you recall seeing them around?

A. I couldn't tell you for sure.

Q. How about this?

A. I couldn't tell you for sure.

Q. That week you went to work on Monday, did you work that whole week?

A. No I think I took Tuesday off.

Q. What did you do Tuesday Glade?

A. I can't remember why I took it off.

Q. Did you stay in town

A.

Q. Are you sure of that? Did you go see Joan, out to Ken's trailer, the day you took off?

A. I can't recall.

Q. Have you ever been in Grand Junction ?

A. Once when I was going to College on a tennis trip.

Q. You haven't been there in the last few years? Do you know anyone ? Have you been to Grand Junction and attend Mesa College there.

A. I know one person down at Grand Junction, he was a tennis player but that is the only person I know.

Q. Is he still there?

A. I don't know.

Q. How long ago was this?

A. 1968

Q. Did Joan like Bruce?

A. Yeah

Q. Was she afraid of him?

A. In a sence I guess, well she was afraid when he ~~XXXXXX~~ would kick her out or something like that, send her home.

Q. Wahy

A. Cause she was

Q. Why did she think he would kick her out?

A. Well Bruce is a ladies man, and I think Joan knew that Bruce would eventually get tired of her.

Q. Why did she leave Kenny's trailer and go to live with, who did she go to live with you or Bruce?

A. Bruce

Q. Why

A. I guess Bruce just silver tongued her. She wasn't really anything to anybody out at Kenny's trailer.

But prior to that was she afraid of Bruce?

A. Prior to the time she lived with him?

Q. Yeah

A. I don't think so.

Q. There were no quarrels or problems between her and Bruce prior to Sandy disappearing?

A. No

Q. How about Sandy, did they get along.

A. I think Bruce asked out Sandy once or twice, I was working both times/

Q. Was this before or after the party?

A. Before

Q. Did he like Sandy do you know?

A. I don't know.

Q. Has Joan corresponded with you since

A. No

Q. She hasn't called you or anything this month or anything?

A. She hasn't called me since she left. She hasn't written or called.

Q. Do you know who she has contacted?

A. I haven't heard of anybody.

Q. Glade, when is the first time that Joan and Sandra met Bruce Boltinder?

A. Probably the night of the party. The 29th of June.

Q. No time prior

A. Not that I can remember.

Q. I understand from when Jerry talked to you first that you and Sandra drove up and down the Canyon, is that correct.

A. Yeah

Q. This was prior to the party?

A. Just 2 days, it might have been a day, I don't recall.

Q. As far as you know Joan and Sandra met Boltinder the night of the party?

A. It seems as if Sandy and I went out to Bruce's before the party. I know we went out there, I don't think it was a Sunday after the party, I think it was before.

Q. Joan wasn't with you?

A. No

Q. Did Joan ever say anything, do you know if they ever had any outs over boys or over anything?

A. Not when I knew them, not as far as I know.

Q. Was any of them left handed.

A. I can't recall.

Q. Are you left handed?

A. No

Q. Is Bruce left handed?

A. No

Q. I know Sandy was involved in this drug deal, was there anyone she was getting stuff on or there was any conflict of interest she knew something that someone didn't want her to know.

A. Not that I know of.

Q. She didn't threaten to go to the Police on somebody using drugs or anything like that?

A. Not that I know of.

Q. Can you think of a reason for anyone wanting to kill her?

A. Nobody I knew, nobody really knew her that well to kill her.

Q. Well you don't have to know somebody in order to kill them.

A. Well nobody really argued with her that I knew about.

Q. Can you think of a reason why somebody would want to brutally murder a girl like this?

A. No

Q. Have you ever gave it a thought?

A. No.

Q. What do you think? You know I have my opinions.,

A.

Q. Why do you think somebody would brutally murder a girl like this? You certainly couldn't say it was a sexual act because she certainly would have give in.

A. I couldn't give you a reason.

Q. Would she be the kind of girl, you know some people have violent tempers. Is she the type that would frustrate a man over something like this, anything in that line.

A. The only way she upset me at all is that she was kinda slow mentally, slow to react to things. That would be the only reason to do something like that. That was the only thing that ever upset me about her. I don't know why anybody would do that.

Q. Were you aware that she was killed shortly after she left here at any one time.

A. I had suspicions, that is what I always thought seeing as nobody heard from her here.

Q. You thought something had happened to her.

A. Well Joan and I, both of us thought she was probably dead somewhere.

Q. What was the comment, how, why or why would somebody kill her. You know you thought she was dead.

A. I didn't know why anybody would kill her, or how or anything else but I figured she would have gotten ahold of somebody sooner or later.

Q. Do you think Joan knows something about the situation that shes not saying to somebody?

A. Joan

Q. Yes

A. No I thought she was just as much ----as the rest of them.

Q. Do you know if Joan has ever been on the law, or has she ever mentioned anything about it?

A. I think she had hassels about drugs and thing s like that. Thats the only ones I ever heard her talk about.

Q. Do you know of any of the guys at the party, that left Tooele after that party for awhile?

A. None of the people I know did.

Q. When did you move in with *Bruce*

A. July, the latter part of July sometime

Q. After she left you went and lived with Danny Quinn?

A. Joan Did

Q. Do you know Ed Martinez?

A. Not by name.

Q. He ran with Danny Quinn?

A. There was a Mexican kid over there, I don't know if that was his name.

Q. Have you had any encounters with the law?

A. Yeah

Q. What

A. Drugs

Q. Anything else?

A. Drunken Driving

Q. Has Bruce got a violent temper?

A. Iv'e heard of him fighting, Iv'e never been there.

Q. What is the opinion of girls, you say he is a ladies man. Did they like him or did he force his way with girls?

A. I think girls liked him, buth they didn't get close to him, that is the impression I got.

Q. Were Sandy and Joan well aware of his drug contacts? Did they know who his contacts were or that he got them for you?

A. No.

Q. They wouldn't have enough informatiion or him to harm him or anybody else?

A. No, I don't think so.

Q. I understand there has been some other parties out here since that time with other individuals? Have you noticed any other girls out of this area that has hitch hiked their way in that you can recall?

A. I don't know.

Q. Have you heard the name Laura or Lauri, big girl maybe 5'9"?

A. No

Q. Did Bruce go out of state quite a bit?

UNABLE TO READ FOR SOME TIME

Q. As far as you're concerned, Glade, you never did see Joan make a call to the Tooele Law Enforcement reporting Sandy missing?

A. No.

Q. Were you present when she made that call to Wisconsin telling Sandy's parents?

A. I was present when she made calls to Wisconsin, but I don't know if I was there then.

Q. Glade, I'm going to have to put you on the spot and be truthful on this point or you are going to be in worse trouble. When was the last time you had sexual intercourse with Sandy? Was it Sunday night, before she left?

A. No verbal answer

Q. It was Sunday night, what time was that?

A. I don't know.

Q. I am going to ask you another question. In sexual intercourse was there any anal intercourse that night?

A. No verbal answer.

Q. The night prior?

A. No verbal answer

Q. You left her that morning, what 7:00, 6:00, 8:00, when?

A. 6:00

Q. Give me the time before that when you had intercourse with her? Was it midnight or after?

A. It was probably after midnight.

Q. I am glad you didn't tell me No.

A. I would have been a fool.

Q. I guess you would have.

Q. You took that Tuesday off, but you can't recall why you took it off? You worked that Monday and then took the following Tuesday off.

A. I think it was Tuesday, I can look again, but I know I took one day off.

Q. To your knowledge do you know if anyone else had intercourse with her that Friday, Saturday or Sunday other than you?

A. No

Q. Would it have been impossible for anyone to have intercourse with her other than you?

A. Well I wasn't with her all the time but I spent two night with her.

Q. But she could have left during the day is that right?

A. Yeah

Q. Did anybody call you on Sunday prior to Sandy going to work on that Monday?

A. I don't know, I can't say for sure.

Q. Do you recall getting a call from Joan?

A. I don't know, she might have called I just don't know.

Q. You don't know if any of her clothes have been left behind that we don't know of?

A. The only places I can think of would be at Kens trailer of Jeannies trailer.

Q. Has Jeanie gotten ahold of you since we talked to her?

A. No verbal answer

Q. Why did Joan leave you guys to go to Kenny's trailer?

A. I guess she just got tired of Bruce. He didn't come home at night, he wnet out and partied all night and I guess she just got ded up.

UNABLE TO READ FOR SOME TIME

Q. Did anyone get ahold of you about her ~~XXXX~~ death, other than that one night prior to that when you talked to me?

A. The first that I knew she was dead was when I saw it on televison.

Q. You saw it on T.V. Did you know when she had been killed?

A. No

Q. Can you think of anyone out there that I haven't talked to or any names, any individuals that knew her that I don't know?

A. No verbal answer

Q. WhoX would she got ahold of is she went to work and got sick or something? Would she call somebody out here and ask them to come and get her?

A. Yeah. if she was going to call anybody she would have called somebody out here.

Q. Who would she have called the other day?

A. Probably Joan at Ken's trailer. I think that was the only number she had. I don't think she had to many numbers.

Q. Could Joan have gone and got her? Did she have any wheels?

A. Joan would have had to call somebody else.

Q. Did Joan know Bruces phone number?

A. Bruse didn;t have a phone.

Q. At that time Bruce was living there in Stockton.

A. Yeah

Q. Do you know anything about those kids from Salt Lake that were out here that night?

A. That was the first time I seen them.

Q. Did Sandy like them, did she dance with them or did you notice any problems?

A. I don't know, she didn't say. W got mad that night because one of them had taken a bunch of downers .

Q. The Mexican

A. Joan was trying to get him to go out to Pine Canyon so she hassled with him for 45 minutes or an hour and everybody was just kinda mad at them.

Q=, She finally ended going out with him though didn't she? Didn;t Bruce take them to Pine Canyon?

A. No verbal answer

Q. Did Sandy have a bunch of downers when she left that Monday morning do you know?

A. I don't think so, I had given her 2 Friday night.

UNABLE TO READ FOR SOME TIME

Q. Did she make any comment to you that she was coming back if she didn't feel well, or how she felt?

A. No, she didn't say anything.

Q. What did she like to eat when she went out to eat?

A. Jus usually we would stop at a hamburger stand.

UNABLE TO READ

- Q. So she didn't have nothing to eat that morning she left to work?
- A. I usually drink coffee so she might have had some coffee. Then again she might have just made it up in time to go to work, I can't remember.
- Q. The last time you seen her she was with Steve and Scott Williams?
- A. The last time I seen her she was getting in the car.
- Q. Have you seen Steve Simons or Scott Williams since Sandy disappeared?
- A. I seen Steve quite a bit.
- Q. Are you the one that called Steve before I talked to him?
- A. No
- Q. Have you seen Scott since?
- A. Yeah I've seen him since but its been 3 or 4 months.

UNABLE TO READ

- Q. Are you staying here by yourself now?
- A. I'm living with my folks.
- Q. What kind of car do you drive?
- A. A 72 Grand Prix.
- Q. Did you use to own a Volkswagen bus? Do you still have that?
- A. No
- Q. What color was that ?
- A. Red
- Q. Was it all red or red & white?
- A. Red & White
- Q. When did you sell it?
- A. October
- Q. Did you sell it out here to somebody?
- A. No I traded it in to a dealer in Salt Lake.

Q. Right now we think she might have got back to Tooele. Is Joan the kinda girl that would hold something back from the Police.

A. Well I don't think you would say she was fond of the Police.

Q. Well I don't think your fond or anyone else, lets put facts shere they lie. I realize that nobody is fond.

A. I guess everybody would hold something back if they were put in the position.

Q. Would you hold back from us on the murder if you thought you could help?

A. No because I'm not involved.

Q. OK, I said if you thought you could help would you hold back, not saying you had anything to do with it, but if you had some information would you hold back?

A. I'm trying to tell you I didn't have anything to do with it.

Q. Well you just said everybody would. Would you hold something back?

A. No

Q. Would some of these out here?

A. I don't think so cause I don't think anybody out here has anything to ~~hide~~ hide.

Q. Do you think Joan would hold anything back just because she dosen't like policeman?

A. I don't know if she would hold something back, I don't know her that well.

UNABLE TO READ

Q. Well she left Tooele that morning?

A. Yeah, Steve was on his way to the University that morning so I know he went to Salt Lake and he took her with him.

Q. Was Steve going to school at that time?

A. No Scott was.

Q. Steve, he was just taking Scott in?

A. I think Steve was job hunting.

Q. He was looking for a job? He wasn't work at that time was he?

A. No

Q. Did he go out of town looking for work?

A. Just in Salt Lake.

Q. Has he had any problems with the Law, do you know?

A. No verbal answer

Q. Did I ask you if you would take the Polygraph?

A. Yeah I will take one.

INTERVIEW WITH: Ken Jones 1-22-75

This is probably a little different from the last time I talked to you Ken.

Q. Is that Kenneth?

A. Yes

Q. And what is your middle name?

A. Initial H.

Q. Only an initial H. And your date of birth?

A. 3-25-54

Q. And what is your address?

A. RFD Box 124, Tooele.

Q. Is that a trailer court?

A. No, it is just outside of town.

Q. Remember her, does that look like her, Sandy,?

A. I don't know.

Q. Ken, the reason I am talking to you again is cause Milo is from Grand Junction investigation in the murder of Sandy, she was murdered. In fact she was murdered that day she left your trailer, within hours. And, we need to get some answers if we can. I realize this was 6 months ago and it is hard to remember, and I don't expect you to remember everything. We have had a chance to over this and some other things have come up that need to be answered, and I was hoping that you could help me or guide me to the right person. Now correct me if I am wrong. I understand that Sandy left the trailer on this Monday morning, July 1st to go to work with a mexican kid by the name of Phil Quintana, who had stayed at the trailer that night with Joan. Is that correct?

A. Ah huh

Q. Was you there at the trailer when they left that morning?

A. I don't remember, I was either still in bed or I had already gone to work, cause I didn't see them leave.

Q. So you don't recall

A. No

Q. But, do you recall them staying that night at your trailer?

A. Yes

Q. Who was there that night?

A. Lets see, I was in my room, and 1 or 2 out there on the couch.

Q. That was Joan and this Phil, wasn't that his name?

A. Yes, I think.

Q. And was you back up to that party back up to Jeannies that Saturday night, I can't remember IF YOU SAID you were there or not?

A. No I wasn't there.

Q. You wasn't there?

A. No

Q. Do you recall when Joan came back that Saturday night, was you home when she came back with this Mexican kid.

A. No, I don't think I was home.

Q. You don't think you was? Who else lived at your trailer with you?

A. There was this other kid, Allen Pitts that was living there.

Q. At this time?

A. Yes

Q. Is he around Tooele nor ow is he still living with you?

A. No, he is living right up the road from me.

Q. Did he know these 2 girls?

A. Not really very well, he knew them.

Q. He was living with you and both these girls?

A. Yes

Q. Did you go to work that Monday morning?

A. Yeah

Q. What time do you go to work?

A. It is from 7:30 to 4:00.

Q. When you came home that night do you no if Joan was still at your trailer.

A. Not readable

Q. Did she say anything about Sandy at that time?

A. Yes

Q. What did she say?

- A. Well, you know, it wasn't right away but she couldn't figure out why she didn't come back. You know she figured maybe she would come back later, and she never did, she was worried about her.
- Q. In your opinion was Joan upset about Sandy, not being able to find her?
- A. Yeah
- Q. She was really upset?
- A. Well right at first, you know she thought she might have had a pretty good excuse, and then after she didn't show up for a day or so, well then she was getting worried.
- Q. Ken, Having lived, here and I don't know how much attention you paid, but this is a really critical point. In the line of clothing, I understand both these girls had very little clothing when they lived here, is that correct?
- A. yeah as far as I seen.
- Q. As far as you seen, give me a idea, 5 or 6 changes, 1 or 2, can you give me an idea? Did they wear shorts much of the time, alot?
- A. Yes they wore shorts.
- Q. They had shorts, any other type clothing? Did they have any dresses? Did you ever see them in a dress?
- A. Joan had one she made out of levis, a real long one. But I never seen any more.
- Q. What did they wear, long pants?
- A. Yeah they had long pants.
- Q. Slacks, levis or what?
- A. Yeah, I think they were levis.
- Q. Mainly levis
- A. Yeah, ah huh
- Q. Do you have any idea if they had more than 1 or 2 changes, or what?
- A. I know they didn't have very much, but I didn't pay any attention.
- Q. Now Sandy wore halters and so forth quite a bit, do you recall any of the colors of these halters?
- A. No, I can't say what colors they were.
- Q. When she went to work, do you know if she went in shorts or long pants?
- A. I don't have any idea.
- Q. How about shoes, did she have alot of shoes?

Q. Do you remember sandels, did she use to wear sandels?

A. I think she had some sandels.

Q. How about clogs?

A. Between the two of them they had some clogs and sandels, I think, or something like that.

Q. When she didn't come back home, the rest of her belongings were left at your trailer, is that correct?

A. Joan took them with her when she left.

Q. Do you recall what was left when Joan took them?

A. Nope, I have no idea.

Q. How long after did Joan move out of your trailer after Sandy didn't come back?

A. eh

Q. Days - Weeks

A. Well it was over a week and she went and moved with this other kid, Danny Quinn.

Q. Did she say why she was leaving, did you ask her to leave or anything like that, or did she just want to go on.

A. No, she just left.

Q. Do you know her relationship with Bruce Boltinder? Did she like him do you know?

A. I think she liked him, but nothing really him alot, he was over alot. you know, she just talked about

Q. He was there alot? He came over after that night?

A. Over, maybe 2 or 3 night after.

Q. Was he over there before Sandy turned up missing?

A. No, I don't know, I can't say for sure.

Q. Do you know how they got to work, back and forth to Salt Lake? Is there any one out there that?

A. As far as I know they hitch hiked.

Q. They hitch hiked every day?

A. Yeah

Q. Have you ever corresponded with Joan, has she called, wrote letters or anything since she went back to Wisconsin?

A. No

Q. Did you see her when she left, just before she left?

- Q. Do you know if she tried to get a bunch of you guys, and you, to go with her and try to help her find Sandra, or go to the Newspaper or some means to come up with Sandra?
- A. She didn't ask for me to help, is that what you mean?
- Q. Right, ask you to do anything particular or anything that you heard of?
- A. No, she contacted Sandra's parents and they decided to put in in the paper, her picture, and I think she turned it in, she said she turned it in.
- Q. Did she ever make any long distance phone calls from your trailer?
- A. I don't remember any.
- Q. You don't remember paying for any long distance phone calls? Did Sandra ever make any long distance phone calls from your trailer?
- A. I don't remember that either, I don't think they did.
- Q. When you came home from work that Monday night, Joan was there at the trailer, is that right.
- A. As near as I can remember she, I am sure she was there that night, I don't remember if she came in after me or I came in after her, I don't remember.
- Q. You don't know, but Sandy wasn't around?
- A. No Sandra was over at Jeanine that night.
- Q. We are talking of that Monday when she got up to go to work.
- A. That Monday morning she got up from there and then they came over to get Joan.
- Q. And when was the last time you actually seen Sandy?
- A. It was Friday, Friday night. She left over to Jean's and she stayed there that Saturday night, the night of the party, and she stayed there Sunday and then left Monday morning.
- Q. When is the last time you actually seen her?
- A. It must have been Friday night.
- Q. Over at Jean?
- A. No, I seen her at my ~~XXXXXX~~ place.
- Q. At your place?
- A. When she left.
- Q. But you didn't see her Saturday or Sunday during the day, and you didn't see her Monday when she left? Have you heard of anyone that has heard if Sandy came back into town that Monday morning after she left and went to work that morning.
- A. No

Q. Did anybody come out to the trailer or did Joan say anything? Was anybody there when you come home from work Monday besides Joan?

A. I don't think so.

Q. How about if I ask you, Did Sandy Sandy's father come in there and talk to you?

A. Ah huh

Q. When was this?

It might have been a month, I don't no, see my brother brough him out but I can't remember.

Q. About a month after Sandra disappeared?

A. No about a month ago

Q. Oh, about a month ago?

A. A month, a month and a half.

Q. When is the first time that you learned Sandy was dead?

A. Lets see, what was the day you questioned us last time?

Q. I don't remember, I can find the day, Was it that day?

A. Yeah, it was that night. Glade heard it on the news and he called me right after he hear it, and then the next day you called Gamble.

Right

Q. But Glade heard it on the news and he called you and told you. I mean you guys were all out here together and they lived with you, and what is any of the comments? What is your opinion of the situation, what could have happened or how? She died that morning.

A. That morning

Q. Thats right, she died that morning. What I am talking about morning is noon, before noon, right around noon.

A. Did you ever find out if she made it to work?

Q. Yes she did make it to work.

A. It must have been somebody from work that she decided to go with or something.

Q. Any one out there that would?

A. No one out here.

Q. Any reason

A. No

Q. Well, like I say, we realize the drug traffic . We are not here to bother anyone, that we are not trying to make a case. Did she know anything about any big drug deals and somebody thought she knew to much that you know of?

A. No

Q. You wouldn't have to kill her to rape her, correct.

A. Uh huh

Q. And that certainly wouldn't be a motive?

A. Unless it was somebody that picked her up, you know, that what it had to be or somebody she decided to come home with or hitch hike back to or something.

Q. Did Joan ever give an opinion of what she thought might have happened?

A. No, she didn't know either, just the same thing, you know, she left with somebody from work or something like that.

Q. Did she really think that something had happened to her or did she just go on her merry way?

A. It was a few days later, you know, she thought maybe she had found somebody in there and stayed over night in there or something.

Q. Was her and Joan pretty close?

A. Yes, they were real close.

Q. Did Joan ever mention that her wallet was missing or that somebody had stolen it from your trailer when she left for work that morning?

A. I don't remember.

Q. Sandy's purse wasn't left in your trailer when she left for work the morning?

A. I don't know that either.

Q. I understand you told Mr. Weaver that you have a pair of her tennis shoes, or shoes, or something.

A. After she had left and , it was either that night or the next day she didn't show up Joan said something about "that is the only pair of shoes or something, and she left them and she aint got no shoes on or something. She couldn't figure out why she would leave without shoes.

Q. Joan said " That is the only pair of shoes, I can't figure Sandy leaving that is the only pair of shoes, right?

A. Yeah

Q. Do you still have them shoes, Ken?

A. No Joan took them. She took everything.

Q. Them shoes that you told Mr. Weaver that he could stop by and pick up?

A. No, I didn't tell him that.

Q. You told Mr. Weaver that you still had a pair of her shoes at your trailer?

A. I told him that Joan must have took them, I didn't tell him that I had them.

Q. That is why I asked you that because the comment I got was you had them?

A. No, you must have misundertood me or something. I am sure she took everything.

Q. Did she ever make any comments about any of the guys at work, somebody she liked, or any problems at work? Did she ever say anything about it?

A. None

Q. How about this Jeff, how long before he left prior to her disappearing?

A. About a week.

Q. About a week?

A. Somewhere right close to a week.

Q. Do you remember if he said where he was going or what he was going to do?

A. I think he said he was going to Arizona, Phoenix, Arizona.

Q. Did they seem to know him pretty good?

A. Yeah, they traveled with him.

Q. What kind of a kid was he in your opinion?

A. Oh he seemed to treat them real good and always wanted to do what was best for them.

Q. Was he involved in the drug traffic do you know?

A. Well he talked about it but I don't know.

Q. Who was the worst on drugs, Sandy or Joan?

A. I don't know.

Q. You don't know?

A. They both talked about it that they would like to get some.

Q. You mean they didn't use any speed or any stuff in your trailer?

A. Not that I know of.

Q. Joan said they used speed. Like I said, I'm not here on the drug problem, I am just trying to get an example of who had the most, and when.

A. They talked about speed alot.

Q. Phenobarbital did they mention that?

A. No, I wasn't around. I was always working and then I come home from work and we would eat.

Q. When did you first know Joan and Sandy?

A. Lets see, I found them 3 up in the Canyon, Settlement Canyon, so I went back there I don't know the exact day, it was around the 10th or 11th. It was in that week but I don't know for sure.

Q. Were they hitch hiking through the Canyon?

Yeah, some guy picked them up and brought them up and they didn't know what they were going to do. He was supposed to come back and give them a ride to Salt Lake or some place and he never did so they went with me to my trailer.

Q. What month was this?

A. June

Q. June, the 1st part, last part, when?

A. You mean when I picked them up.

Q. Yeah, when you first met them?

A. It was the second week of June. I don't remember the day but about the second week in June.

Q. Do you know Bruce pretty well?

A. No, the first time I met him was just before they come or ~~wix~~ while they came, I still don't remember.

Q. Do you know Glade quite well?

A. Yeah, we worked together.

Q. Is that where Glade met them, up at your trailer?

A. Ah huh

Q. And that was before the party?

I don't exactly know, it might have been about a week before the party.

Q. Joan and Sandy both met him about a week before? Ken, do you know of anyone else that possibly knew these girls that might have some information about where they went or something?

A. They might have had some other friends in Salt Lake but I don't know anything about them.

Q. Do you know anyone out here?

A. They were closest to me and Gamble.

Q. Did they ever mention anything about their home life, any problems back there?

A. No, only talked about they had arguments and wanted to leave, I don't know exactly.

Q. It didn't appear to bother them about their parents? They just wanted to get away from them?

A. Oh they were planning on going back for sure, they just wanted to get away.

Q. Did one or either of them ever mention about what their parents did, what their father did for a living, if they had money or they didn't?

A. No, I don't remember.

Q. But you never seen Sandy after, what it was Friday or Saturday night, is that correct?

A. Ah huh

Q. Have you heard of anybody that has seen or heard of Sandy after she left for work that morning?

A. No

Q. You don't know anybody that was giving them a ride? From what I understand is there might have gotten a ride with somebody here from Tooele.

A. That Monday morning Glade arranged a ride for her because he knew his friend was going into Salt Lake.

Q. This was prior to that. Somebody that knew them here in Tooele that had given them a ride maybe once or twice, do you know who that person might have been.

A. Huh huh as far as I know they hitch hiked every day and they sometime stayed there.

Q. Did Sandy ever talk about having to get back to Wisconsin by a certain date?

A. Yeah, for a wedding or something.

Q. Would that have been her sisters wedding?

A. Yeah, that was her sisters wedding.

Q. Did she say when she was planning on leaving?

A. No, but they was trying to get some money so they could go back. Thats why they were working.

Q. Ken, did you work the whole week of July 1st?

A. Lets see, we had the 4th of July off, but I worked all the resto of the week .

Q. Let me ask another opinion Ken, I'm not saying were going to do this, but we are asking everybody that knew or had anything to do with her we are asking the same question. If it comes down to the thing that we feel we would like to run a Polygraph examination on a strictly voluntary thing would you be willing to submit to one or would you rather not?

A. A Polygrahp

Q. Yeah that is known as a lie detector, it is strictly a voluntay thing.

A. OK

Q. There would be no problem there? If we run one after 6 weeks out there where you work would they let you off so we could take you to Salt Lake and run it and bring you back or what would be the conflict there?

A. You would have to talk tothem because I'm not sure.

Q. OK in other words if we got down to that it would be alright with you?

A. Yeah

Q. Ken, now you don't have any stuff of the girls that Joan might have left behind, and you are not living in the same trailer now?

A. Yeah I'm living in the same trailer.

Q. Did Bruce Boltlinder ever come to your trailer prior to the party?

A. Prior to the party?

Q. Yeah

A. The party out at - - - - Well I don't know, he was over there just a few nights. He was around in that area.

Q. But he was never over there or around? Were you good friends? Did Joan ever mention she was scared of him or didn't like him?

A. No

Q. Did Sandy?

A. No I don't know, Sandy didn't have much to do with Bruce at all, it was Joan.

Q. I understand that Joan liked Glade quite a bit. Did one like Glade?

A. Well they both liked him, I guess about the same.

Q. Did Joan ever mention anything about her wallet being missing?

A. She might have mentioned it. I remember something about that but I can't remember exact.

Q. Do you know if Joan notified Tooele down here that Sandy was missing?

A. Yeah I think she did, and then they told her to contact Salt Lake.

Q. Do you know if she ever did?

A. She said she did but I am not sure.

Q. Did you actually hear her talking on the phone?

A. She said she did,

Q. But no one ever came up to the trailer and talked to her or you don't know?

A. I don't know.

Q. What is your space number out there Ken? Is there a trailer space?

A. No, its not a trailer court, it is just a little town, you go down her to the viaduct and make a right, there is a little road just before that. You make a right and it is the 2nd ~~XX~~ trailer on the right.

Q. What color is the trailer?

A. It is green.

Q. Since talking to individuals, and you guys found out she was murdered what is the feeling or why, there must have been something.

A. Well it must have been somebody she didn't know or she just met that day, or somebody she just went with. Maybe they told her they would give her a ride home or take her out somewhere else over night or something.

Q. Why would somebody kill her? Doyou know?

A. No, she was nice.

Q. Do you know of anybody here that knows anybody in Grand Junction.

A. No

Q. Ever made a trip to Grand Junction . Let me ask you another thing Kenny. I could care less but it is very important to me of her sexual habits. Would she, and I am sure you can answer this, Would she fight or resist an individual to have anal intercourse with her? Did she like it, would you know, or was she definitely against it?

A. Well if she didn't like the guy or she was forced or he was forcing it on her or something she wouldn't.

Q. Well what I am trying to get at is that sex act, from your experience would she go along with that?

A. Yeah, she would go along with that.

Q. She would go along with that. OK, and another thing I need to know very badly is has she had anal intercourse? I don't care if you have or somebody else has, but has she.

A. Yeah

Q. OK I need to ask another question. Her carrying on oral sex with a man, would she resist this?

A. She wouldn't resist unless, depending on the circumstances.

Q. Do you know if she ever wore a bra?

A. I don't think so, neither one of them did.

Q. Do you know if they had one.

A. I'm not sure, I think Joan did but I don't know cause I never seen them with one on.

Q. Do you recall a necklace she wore with a little cross on it?

A. Not that I remember.

Q. How about ear rings? How about rings?

A. No, not that I remember.

Q. In relation to this picture. Is her hair about the same length, is it longer, shorter did she comb it different, did she take care of her hair?

A. She always kept it clean and everything but

Q. You can see the length is way down. Was it that long?

A. I don't think it was that long. It might have been a little shorter.

Q. Did she comb it like that, parted on the side.

A. Yeah, it was just hanging down.

Q. Was she a girl that kept herself clean or so called clean, or was she one of those that didn't care if she ever bathed.

A. Well she was on the road and they didn't care, while they were there they took care of themselves.

Q. That is what I mean, while they were with you they took care of themselves. Did she wear finger nail polish in this line.

A. Yeah I think she did, and toe polish.

Q. Did she have a wrist watch?

A. I don't think so.

Q. Do you recall seeing her purse, it probably had a shoulder strap, maybe tan in color, embroidery on the top? Do you recall seeing her brown wallet with flowere dsign?

A. I probably did, but I cant remember.

Q. Did Joan mention or did Sandys check ever get mailed out to the trailer? Did she mention what happened to the last check?

A. Let's see, I think it did come come out and I think Joan had it. ~~XXXXXXXXXXXX~~

Q. Joan had the check?

A. Yeah, I know she did, I don't know what she done with it.

Q. But she got the check?

A. I am pretty sure she got it.

Q. Do you know if she cashed it?

A. I don't know, she might have. I remember sher talking about it but I don't remember what happened, she might have cashed it.

Q. Has Joan called you or do you know of anyone out here in Tooele she got ahold of this month, January? Since she has been in Wesconsin?

A. Uh huh

Q. Has she written to anybody or ca fied anybody prior, since she went back to Wisconsin?

A. When she went back she wrote somebody, Glade knows who, he told me, I don't know. He might have written her. That was before we found out about Sandra. I don't know what she said but he told me she wrote. Maybe it was Glade, maybe Quinn, I don't know which one.

Q. Did Joan and Sandy ever get into little arguements that you know of?

A. No I don't think so.

Q. Was any of them left handed?

A. I don't know.

Q. Are you left or right handed?

A. I am right handed.

Q. Do you know of any of your friends at the party that night that might have been left handed?

A. I wasn't at the party.

Q. Do you know any of your friends that are left handed?

A. Huh huh

Q. That Monday when Sandy left for work , was Joan the only one at the trailer of did Joan leave, go up town or something?

A. I don't know that, I guess she was sick, that is why she didn't go.

Q. Was she home when you got there?

A. As far as I know.

I can't think of anything else Milo. Ken we may be talking to you later and we may not. Lets say right now we have a murder. We don't have a normal murder but one hell of a brutal murder. I don't know what you thought of the girl, I don't know what anyone else thought of her but she didn't deserve to die the way she did. And it was like I say she was killed shortly after she left your trailer. So some where along the way some enemy or she met somebody.

A. Well if she did make it to work this guy she got a ride with dropped her off and went on his way I guess.

Q. That is right, but I understand she might have come back to Tooele. Did she know any truck drivers that might have given her a ride?

A. If she came back to Tooele she might have gotten ahold of Joan.

Q. But Joan didn't say she ever got ahold of her.

A. Yeah I know she said she didn't, so I guess she didn't.

Q. Well that is what I mean, did Joan ever tell you she called her that morning and told her she was sick or that she was coming back.

A. Huh huh

Q. Did the girls call from Tooele maybe and reverse the charge to your trailer on your phone?

A. They might have, I don't know.

Q. Do you have your phone bill for July?

A. No, I threw them all away.

Q. Would it be alright with you if I checked with the Telephone company to see if there was a call from there, with your permission?

A. Sure, through June & July to see what calls were made.

Q. I am mainly interested if she called that day.

A. Yeah that's alright.

Q. Well we may or we may not, but if the phone company does, they will ask your permission you would know what it was all about, and that would be alright?

A. Yeah

Q. this way maybe we could see when Joan called Weaver's. Do you recall a long distance phone call you had to pay later on your phone bill; to Wisconsin.

A. They might have made some long distance calls but I don't remember.

Q. Is the phone listed under your name Ken?

A. Yeah

Q. Was he ~~XXXX~~ by himself or was another guy with him?

A. Mr. Weaver

Q. Yeah

A. He was alone when he talked to me, but then Glade told me he had another guy with him when he talked to him.

Q. Did he come out to the trailer by himself?

A. No my brother brought him.

Q. No other guy from back in Wisconsin was with him, just your brother.

Thanks Ken, like I say we might be getting ahold of you. Is Danny and Glade out there?

A. Yeah

Q. Ask Glade to come in. Another thing Kenny, if you do come up with something get ahold of Mr. Thompson. You might think of something.

A. You think she come back to Tooele?

Q. I think she did, or somebody from Tooele went and met her. Do you have any idea who it would be.

A. No I don't.

Q. Who would she get ahold of if she was hurting or sick or something. Would they call you at work or could they get you at work.

A. No they wouldn't call me, she would call Joan.

Q. Was Joan really upset over his missing. How truthful was she.

A. Yeah, she would have been truthful over it, I am sure she was.

INTERVIEW WITH: Philip Quintana 1-21-75

Q. I think it was Dirk, somebody said that you said Sandra had gone to Idaho or something to live or something. Do you recall that?

A. Yeah, I said that.

Q. Did you tell me that?

A. I might have, I think I did.

Q. Tell me where you got this from or where it came about?

A. This guy that picked me up hitch hiking, but I can't remember his name. He said he seen her and she was supposed to be living with this guy that she was living with in Memory Grove, she was supposed to leave with him to Idaho.

Q. He said that she was supposedly living with a guy in Memory Grove?

A. Not in Memory Grove, but those houses along the ----

Q. OK, can you tell me when was this that this guy picked you up, give me some times? Now this guy wasn't Dirk that picked you up?

A. No, Possibly August-September.

Q. How did the conversation start about Sandy?

A. Well he asked me if I had ever been out to Tooele, and because he asked me if I wanted to go to a party out there, and I said yeah, I had been out there before, and he asked me if I wanted to go to a party, and I told him "No", I had just come from one, and so then he asked me if I knew these people that lived out there by the name of Glade, Sandy and all of those. I said "Yeah" but I hadn't seen them since about July, and I asked him if they were supposed to be there and he said yeah, and he dropped me off at 13th, and I haven't seen him since.

Q. Where did this conversation of Sandy come up, Did you mention Sandy, mention Joan, or what was the deal?

A. Mentioned both of them, and Glade.

Q. What did he say about them?

A. He, I asked him if, eh eh, well he asked me if I knew them, and I said "Yeah", and then he said they were going to be there at the party too, but I told him that I was to, that I was coming back from a party, well he could tell, so he dropped me off at 13th.

Q. Well he said that both these girls would be at this party, and this was in August?

A. Ah - August, September somewhere in there.

Q. At this time did you know that Sandy was missing?

A. No

Q. When did you find out she was missing?

A. Well, I had a pretty good idea last month, because they called me from Manpower and asked me if I had seen her, and I said No not since July.

Q. But you didn't go after that party that Sandy was missing?

A. Well I - - - I, what party?

Q. The one out in Tooele that you were all out at. The Big Drug Party that Saturday night.

A. Well after that she wasn't missing until - Tuesday, after the Monday that her and I came back to Salt Lake.

Q. OK, you knew she was missing then?

A. No, I thought she was going to work, she said she was going to work, and anyway they didn't want me back over there and so I just went down to my mom's.

Q. You never went back to work?

A. No

Q. Did you quit then or had you working working a week before?

A. I had been working a week before but they, they only need you sometime temporarily.

Q. What was the last day you worked though, was that the Friday before the party.

A. Yeah the Friday before the party.

Q. And you never went back to work over there?

A. No.

Q. You don't know who this guy was that picked you up?

A. No, I just noticed he had blonde hair, short, kinda heavy set,

Q. Do you recall the car he was driving?

A. It was a truck.

Q. It was a truck.

A. It was a older GMC, it was night.

Q. And about where was you at?

A. I was down to Sandy's.

Q. How old was he, what was his age?

A. 23 or 24, It was a light red or dark orange P/U, somewhere in the 50's, It was a flat bed.

- Q. This was, was this after Joan went back to Wisconsin, do you know?
- A. I don't know because after I left on the Monday I never seen her again either.
- Q. You never saw either one of them? Did Joan ever call you after that or try to find out about Sandy?
- A. Well I thin she tried to get ahold of me cause Dirk went down where I was staying, down here on 13th one day and said Joan was trying to get ahold of me, but I never found her cause she never went over.
- Q. But this was sometime after that that this guy picked you up?
- A. It was about 2 or 3 weeks after I guess Sandy was missing.
- Q. 2 or 3 weeks, this was sometime in July?
- A. Yeah
- Q. And he said that both these girls were going to be at this party in Tooele, and did you want to come? Did he say where it was going to be?
- A. He didn't say, he just said I could go with him if I wanted to and get some of my buddies, I told him I was too tired.
- Q. Did he say how you could get ahold of him if you wanted to go to the party?
- A. No.
- Q. Do you think he was living in town?
- A. Well, I asked him where he lived and he said Kerns, I asked him how he knew Pete ----- in Tooele and he said he was always going out there.
- Q. Did he say if he knew Ken Jones, Glade Gambill and all them?
- A. I don't think so.
- Q. But he sure knew Sandy and Joan?
- A. Well, he just said their first names so I guess he must have.
- Q. Tell me as you can remember Phil, what did he come up and say "Do you know Joan, Do you know Sandy", I mean this really got me, I don't understand.
- A. Well, I was hitch hiking he picked me up then asked if I wanted to go to a party, he said do you smoke dope, I said yeah, and he said do you want to go to a party, and I said no, and he lit up a joint, and he asked me if I wanted to go to a party out in Tooele and I said no, and he said, and then I said who is going to be out there, do you know a lot of people out there and he said, "I know a chick named Joan and one named Sandy and this Dude named Glade, that Glade was supposed to be having it," and I told him no I was, and he just dropped me off.
- Q. OK, where did the conversation about Pleasant Grove or Idaho or what.
- A. No this was a different guy that picked me up that told me who was living in Idaho.
- Q. Well that's the one I'm interested in.

A. What, thats the one you were talking about. He was, I was just asking him if he knew Joan and Sandy from Tooele and he said yeah, that Sandy was supposed to be living in Memory Grove with some guy.

Q. OK, when was this that he picked you up? Where did he pick you up?

A. He picked me up at 37th and State.

Q. You were hitch hiking?

A. No verbal answer

Q. Give me a moth?

A. a little after Haloween.

Q. What was he driving?

A. A little white Ford about a a later model Ford.

Q. Did you know him?

A. Huhuh

Q. No name, no nothing?

A. Huhuh

Q. You said she was supposed to be living in Memory Grove?

A. He didn't say, he said she was supposed to be living up in Idaho, eh Memory Grove with some guy that sold dope or something.

Q. What did he look like, ~~XXXXXXXXXXXXXXXXXXXX~~

A. The guy that picked me up?

Yeah

A. He had brown hair about as long as me but he was 6'2" maybe 6'3".

Q. How old, 20 - 30- 40

A. Probably 21, 22, kinda husky .

Q. But you knew Sandy was missing at that time right?

A. I satarted to think about it and then they called me from Manpower and aksed me if I had seen her I started to have thoughts about it.

Q. Well you knew she was missing before November?

A. Uh huh

Q. Dirk told you

A. I hadn't seen him before.

Q. How about Joan? Wasen't Joan trying to get ahold of you?

A. She was trying to get ahold of me but she never did.

Q. She never did talk to you ? She never did get ahold of you?

A. Uh huh

Q. You haven't alked to Joan since that party, Phil?

A. Well since that party, well after that pary when me and Sanday went back to the trailer.

Q. Yeah, OK, that week end, you mean when you went to work with Sandy you never talked to Joan since then? When did Dirk get ahold of you?

A. I just seen him eh -----

Q. I mean when he was trying , I mean when he was trying to get ahold, when he said Joan was trying to get ahold of you, when did Dirk get ahold of you and tell you this.

A. 2 or 3 weeks maybe after I cam back to Salt Lake.

Q. OK that puts it in July, Did he tell you then Sandy was missing.

A. Huh huh, he just, he didn't even mention anything about Sandy, he just aked me if I knew where to get a lid and that Joan was trying to get ahold of me.

Q. Ok, and then Manpower or Wyckoff called you say and asked about Sandy?

A. Manpower

Q. Manpower did

A. Uh huh

Q. When was that?

A. About the 1st or 2nd week of December.

Q. Was her dad ever hear from, did you talk to him.

A. He didn't talk to me.

Q. How about on the telephone

A. Nope

Q. Are you sure Philip?

A. Nope

Q. He claims he did, how about him calling you on the phone Phulip/ I am going to try to refresh your memory" and you told him --- he asked you if you were at a pary with his daughter in Tooele, and you said no Not me but my friend Martinez" Do you recall that?

A. Martinez, that that is what I wanted to ask you.

Q. Yeah, who is Martinez? We're getting the name that you are using Phil Martinez or Quintana, are you using both names?

A. No, I am just using my legal name.

Q. Quintana

A. Ah huh, that is what I wanted to ask you, well see that week end you, I guess you came out to my moms, she said that you were looking for me, she said that you asked for Philip Martinez or a Philip Quintana, and she asked me if I was using another name and I told her no. Because I found, well -- when my dad got married, when he first married my mother I was on Probation and I started using his last name and it took them 6 months to find me, and when they did they told me if I used it again they would stick me in State School because I was using an illegal name.

Q. What illegal name were you using?

A. Gurule, that was, I have just been using my real name since, Now i have a clean record so.

Q. But you never talked to her father on the phone ; Mr. Weaver,

A. Nope

Q. Asking about Sandy? Ok I will tell you here, talking to Joan at the party, you stated that at the party it was a friend of yours. That friend got up and left Sunday morning hitch hiking back to Salt Lake City. You said he had shoulder length dark hair, a young kid. Was there another kid with you out there?

A. Yeah, my friend, but I dont think he had anything to do with it.

Q. Well I didn't say he had anything to do with it but who is your friend?

A. Danny Brumfield

Q. Danny Brumfield, I know Danny. OK now did he go to the party with you.

A. He went with me when I left, I think it was Saturday I left. We went out and hitch hiked together, and Sunday he was supposed to go with his Dad to Elko, cause his dad is a Truck Driver, and he was going along to help unload the truck, and I told him we would make it back by Sunday night, and Sunday morning he woke up, he was still at Glades. He had crashed in the van and me and Joan had left, and we had gone in the Cadillac. He couldn't find me, he thought I already came back so he just came without me.

Q. So he took off and hitch hiked back to Salt Lake Sunday? Is that the first that he ever met Sandy and Joan? Did you introduce him to them?

A. No

Q. Danny is how old, 17?

A. 17

Q. Is he 18 yet?

A. I don't think so pretty close, he might be.

Q. Anybody at the party by the name of Martinez?

A. Most people I know of only first name.

Q. Did you ever meet any one by the name of Ed?

A. Might have been the guy that Glade said was his girl friend's cousin's boy friend.

Q. OK, so I think I got things straight, " Thursday night you and Dirk took the 2 girls out to the movie?

A. Friday

Q. Are you sure Friday or Thursday, because they claim they stayed out there all 3 nights so does others.

A. It might have been Thursday, one night we stayed at this buddies on 4th South, but he wasn't there and another night me and Dirk went ~~320~~xxxx and we took them back to Tooele, it might have been Friday, I think it was Friday.

Q. OK now if it had been Friday it went this way; you went to the movie and then the next night was the party or was it the night after that? Was it the very next night, the party?

A. I think it was the next night.

Q. OK, now Dirk didn't go with you?

A. No, just Danny.

Q. Just Danny, how did you get out there?

A. We hitch hiked out there.

Q. Oh you hitch hiked out, where did you first go when you got out there?

A. To the trailer, Kens, and went from there to the party.

Q. Who took you out to the party?

A. Glade

Q. Glade did?

A. Yeah

Q. And Sandy & Joan were there?

A. Well Sandy was with Glade all day, and then they came back later and came and got us to go get something to eat and then we went back and had a couple beers, and then, I I don't know.

Q. Sandy was with Glade Saturday?

A. Uh huh, almost the whole week end.

- Q. The week end of the party?
- A. The next day to.
- Q. OK, its my understanding you were at the Trailer with Joan Sunday night. Monday morning Sandy came in, is that right? Do you recall Sandy borrowing or asking Joan for some money?
- A. I think she asked her for \$5.00 or \$10.00, because they were keeping their money together, and Joan was saving it. I think Sandy asked for some so she could eat lunch at work.
- Q. OK, so that is when you left with Sandy and you went out and got into the car with Steve and them, and they took you up here to Salt Lake. AND what did Joan say, that she was sick, or what was the conversation, do you remember?
- A. That she wasn't going to work because she was getting cramps.
- Q. OK, did you remember what Sandy was wearing? Was she wearing shorts, levis, a halter top or what? Shoes?
- A. I think she was wearing sandels and I think it was navy pants.
- Q. What was she wearing at the party? Shorts or pants? This is what I am trying to get at, Does she wear shorts alot?
- A. Yes
- Q. Was she wearing shorts at the party?
- A. Yes I think so, maybe just a old pair of jeans she had cut off.
- Q. She had cut off or something. Did she go to work in these or was it long pants?
- A. Long pants.
- Q. It was long pants when she left the trailer in the morning. Was she wearing just a halter, blouse, sweater, do you know?
- A. I don't know, she was wearing and had her coat zipped up.
- Q. She had a coat on in July?
- A. It was just a thin one.
- Q. Like a wind breaker or something? What color, do you know.
- A. - - - - - eh black.
- Q. Did she have her purse with her? What kind of purse do you recall?
- A. Kind of suede, kind of.
- Q. Was that the one with the shoulder strap she had that Monday morning?

Q. Can you give me a time Quintana when they got over to the trailer Monday morning 6, 7, 8:00 oclock, about?

A. Well she had to be to work at 8:00, it was about 7:00.

Q. OK, Joan stayed, and when you left was Kenny Jones in the trailer when you left, do you know?

A. Well he might have been in bed but they weren't awake.

Q. They weren't awake so you dont know if they were in the trailer or not.

A. No .

Q. And there were 2 other guys in the car, Steve, Scott.

A. I think, they were the ones that were driving us over.

Q. They dumped her off over here at

A. Wyckoffs

Q. Wyckoffs, by that little store, and then they dropped you off where?

A. At 8 South and State

Q. At 8 South and State, and have you ever seen them since then? How many blocks difference is it that they dropped Sancy off and they dropped you off?

A. They dropped her off at 3rd West, maybe 7 blocks.

Q. Did Steve Simons or Scott Williams say they might come back and get you later or something?

A. They didn't say nothing.

Q. Or meet you for lunch or something?

A. They didn't say nothing, they were just talking to each other. They weren't talking to Sandy.

Q. Did Sandy give you any indication when she got off that she was going to come back at noon, or that she didn't feel well, or that she was going to go back and see Joan or anything like that?

A. She said that cause she didn't feel well that morning " she was kind of burned" she said that if she still felt that way at lunch she was just going to go back to Tooele.

Q. To Tooele. Did she say how she was going to go back, call and have one of those guy come and get her or what did she say?

A. She didn't say.

Q. Now I understand she took some speed that morning before she left, and I understand she gave you some? or was it speed or what was it?

A. I think she took some downers.

- Q. Well I am going to have to get you more observant I can see that, you ain't shitting me any. Joan didn't go to work that morning because she had cramps. Did she start her period that day or the day before?
- A. Well I think she started that day because that night she was starting to get them them bad. She might have started sunday night.
- Q. Well you spent the night with her?
- A. Yeah but I didn't check tho.
- Q. Oh Jesus, you know you got me almost to think I am going to send you out to the nut farm and have you checked out here. Was she pretty well smashed out, Joan, that monday morning or was it mainly from her cramps.
- A. Mainly from her cramps.
- Q. I heard she had a crush on Glade Gamble, Joan did to. I understand she was kinda chasing Glade around.
- A. She didn't say anything to me, she might have, she acted kinda funny toward him.
- Q. What did she have to say about this Bruce Boltinder? Do you recall him at the party, the one with the gold Cadillac? Do you recall any of their conversation about him? Either one of the girls, Did they appear to play up to him, have nothing to do with him, mediocre or what?
- A. Well Joan didn't seem to have anything to do with him. When she got in the car she made me set by him, and I told her no way was I going to set in the middle so I made her set in the middle and she scooted over toward me.
- Q. Now hes the one that gave you and Joan a ride back to Ken's trailer, is that right? After that party? Is that correct? So she more or less wanted you to set by him, she didn't want to? Did Sandy mention anything about him? Did you notice any indication of Bruce playing up to either one of the girls that night or trying to?
- A. Well when he was in the house I went outside in the van and crashed. When I woke up Joan asked me If I wanted to .
- Q. How about Kenny Jones, what was their comment toward him, either one of the girls.
- A. They said they liked him, he was a pretty nice guy, but they were just staying becuase of their relationship, just a place to stay I guess. I guess they were giving him something to stay there, some money or something to stay with him but they never did say.
- Q. Did you know a guy by the name of Allen Pitts , lives in the trailer with Ken.
- A. Yeah
- Q. Was he at the party?
- A. I think that both were but they came a little later. ~~XXXXXXXXXXXXXXXXXXXXXXXXXXXX~~
- Q. Did he stay at the party very long do you know? Was he still there when you crashed out.

A. When I crashed, yeah they were still there.

Q. How about this Steve Simons, when did he arrive, in the morning? Did he spend much time there at the party?

A. Couldn't understand what was being said (not quoted from tape)

Q. Was he there when you crashed out?

A/ Yes, everybody was there except, when I woke up they were pretty well gone.

Q. Do you know a girl by the name of Terry that was out at the party? A Friend of Jeannie's maybe?

A. Yes I think so, there were 3 of them sitting in the front room where she does her business.

Q. How about Margie, does that name ring a bell?

A. Not really.

Q. Did they mention anything about a Terry or a girl that lived right across the street or close to Jeannie?

A. Not while I was there.

Q. How about Marge, describe me one of these girls, One of them, I know Jeannie.

A. Brown hair, shoulder length, kinda heavy.

Q. Did she ever say she worked for a Bank.

A. I never remember talking to her, Glade just told me their names.

Q. How long did you work over at Wyckoffs, Philip?

A. 4 or 5 days.

Q. About the week the girls worked and everything?

A. It was the same week, I started Monday or Tuesday.

Q. Did you know a kid by the name of Lynn Dumas?

A. No I just knew Dirk.

Q. You didn't run across a guy by the name of Roy L. Melanson, maybe in his 30's.

A. Ah no

Q. What about a Roy King, does ~~XXXXXXXXXX~~ any of those names ring a bell?

A. Roy King does, but not from the party.

Q. Where does this name ring a bell to?

A. I think he was at some other party I went to about a year ago.

Q. But not this party out in Tooele.

A. No.

Q. Any of those guys that sound famaliar, did any of them work at Wyckoffs.

A. That I know, the only one I knew was Dirk.

Q. Dirk

A. That is because he worked in the same spot with me.

Q. Was Joan scared of any one there.

A. No not that I know of, she didn't tell me.

Q. What about Sandra?

A. Well they got along real good with everybody out there as far as I knew.

Q. But Sandra told you when she left to go to work that morning that if she didn't fell well she was going to go back home.

A. Ah huh

Q. Do you know how they got to work every morning?

A. Well when Manpower had a job for them they gave them a call out in Tooele and they hitch hiked to the job. The very first day they started Manpower called them about 8:00, i guess, they got there around 10:00, 10:30.

Q. And then from then on do you know how they got in there every moring and got home?

A. Well after that first day we all went together.

Q. You all went together?

A. Ah hah

Q. And where did you meet them?

A. At Wyckoffs.

Q. They lived in Tooele, how did they get to work every morning?

A. Well that first day from Wyckoffs they hitch hiked, and after that they were with me all the time.

Q. Well you took them back to Tooele?

A. No they just slept her with us.

Q. Ohhh in town here, they didnt go back to the trailer that whole week they stayed with you.

A. Ah hah, until they went back to Tooele that Saturday, that Friday night me and Dirk took them to the show they stayed with us one night at 1st South, and another night well with this one guy, but he don't work for Manpower any more.

Q. This guy, whats his name.

Q. What was it?

A. GG , I think his name is how Martines fits in. I think that was his name.

Q. GG Martinez

A. Ah hah

Q. Did they stay there one night at his place?

A. We all did.

Q. How far is that from Wyckoffs?

A. Well it is up here in town between 2nd & 3rd Avenue right up State Street.

Q. It is quite a ways for Sandy to walk there?

A. Ah huh.

Q. OK Sandra and Joan worked 1 week at Wyckoffs, Monday through Friday?

A. No I did

Q. Monday through Friday?

A. Ah hah

Q. That last week, did they spend that entire week with you here in Salt Lake.

A. Lets see, Monday night they did, Tuesfay night they did, I think after that Wednesday they went home, said they wanted to get some clean clothes and then they came back the next day.

Q. And you met them at Wyckoffs

A. Ah huh

Q. Monday

A. Like I was there at 8:00 when they wanted me and GG, there was about 3 or 4 of us around.

Q. How old in GG?

A. Maybe late 20's.

Q. Does he have a car?

A. Uh huh

Q. He don't have a car, how did he get to work?

A. He walked.

Q. He walked. Well he walked quite a ways in the morning then didn't he?

A. Well he didn't work out there either, he worked for Manpower, he did.

Q. This guy you were telling Jerry gave you a ride in the older pickup, this was 2 different guys, the one they said she was staying ?

A. Yes two different guys.

Q. Did Danny Brumfield ever contact these girls since then do you know?

A. I don't know, I don't think so.

Q. Does he have a car?

A. No

Q. He doesn't have a car? Does anybody know anybody in Grand Junction.? Has anybody ever been to the party or ever mentioned anybody from Grand Junction? Do you know anybody Phil that knows somebody in Grand Junction or used to live in Grand Junction? Did any one of them mention anything about any friends or relation or anything in Colorado?

A. Not that I can remember.

Q. Was you out there Saturday during the day or Saturday evening or afternoon?

A. Well I was out there, Yes it was Thursday night we took them to the movie because me and Danny hitch hiked out there /Friday night.

Q. OK, so Thursday night you went to the movie and on Friday you hitch hiked out there. And you spent Friday in Ken's trailer, you and Danny. And then Saturday you both went to the party and you left the party and came back to the trailer and ?

A. We split Sunday morning.

Q. Now what did you guys do Sunday?

A. Well me and Joan went back to the trailer about 3 or 4:00 in the morning and we crashed and we woke up about 4:00 well about 6:00 in the evening.

Q. Did you go anywhere that night? Down town to get something to eat or did you stay at the trailer, do you remember what you did?

A. Well Joan, eh Sandy called and asked if we were going to work, and I told her Joan wasn't but I was going to Salt Lake and she asked me if I wanted to drive to Salt Lake, so she told me to be ready about 6:30 or 7:00 o'clock.

Q. And that was Sunday night when Sandy, Sandy was the one that called you? It wasn't Glade, it wasn't Jeannie?

A. No, uh huh it was Sandy

Q. It was Sandy? Do you think any one of them guys would kill that girl?

A. I can't really say it.

Q. For what reason?

A. I don't know them, but I know what kind of people they are.

Q. No, but you were around them.

A. Yeah, the only one I can think of is the guy in the Cadillac cause he looked like he could do it.

Q. Did Boltlinder, did you, eh what kind of Cadillac, what year? Did it have fins in the back?

A. 73 eh 72

Q. What is that late of model? Did it have a temporary permit or license plate?

A. No it had a license plate.

Q. Did he seem like an onery guy?

A. No, he just didn't say much.

Q. Well you said he seemed like the guy that could do it. You know everybody has their opinion. Why?

A. He was kinda mean.

Q. He was a big guy?

A. Ah huh, maybe 6 ft 6ft 2.

Q. A Tall guy? Kind of muscular?

A. Weighed about maybe 225.

Q. How was he wearing his hair, long, short or what?

A. Short

Q. Was there any comments about him? Do you know if any of these guys have ever been arrested out there? Was there any comments about there arrest records or their problems with the law?

A. No, but I think he was the one that Glade was getting his dope from.

Q. And Joan was scared of him or didn't like him because when she went to get in the car she told you to set by him, that she didn't want to set by him?

A. Ah huh

Q. Is that right?

Ben, on the story I know who the friend was that Hitch hiked out there Friday night, it was Danny Brumfield, and Danny hitch hiked back to Salt Lake Sunday morning because he crashed in the truck and he couldn't find him and he came back to Joans and apparently he left.

Q. Were you living with them down on 45th & South at that time?

A. No thats where my mom lives, and I lived about 2 houses away

Q. He claims the story about hearing about Sandy living in Idaho in the Memory Grove area that some guy picked him up hitch hiking back in November.

A. A little after Haloween.

Q. And asked him if he wanted to go to a party out in Tooele, and he mentioned that there was going to be certain , Glade, a few names and the 2 girls names. Is that correct? Go ahead and tell him the story about this girl living in Idaho.

A. He just told me that she was supposed to be living with this guy in Memory Grove and that - - - - -garble.

Q. What was the date on this, when did you hear this?

A. About the first week after Haloween.

Q. Driving a little white Ford did you say, a little white car?

A. Well there was two different guys, one was driving a pickup.

Q. And one in a white truck, which is which?

A. The guy that asked if I wanted to go to a party, he was driving the Ford.

Q. Now did they specifically say that was Sandy?

A. Well they said Sandy & Joan, I don't know if they were the same chicks but he said Sandy and Joan. Might be two different chicks, I don't know.

Q. But he mentioned something about Glade or something.

A. He said Glade, the name.

Q. Have you ever seen this Bruce Boltinder since that time?

A. No that was the first time I have ever seen him, I don't even know his name, I just know he drives a Cadillac.

Q. Why didn't you go to work that day?

A. They didn't want me back.

Q. They didn't want you back?

A. Ah huh, they didn't need me.

Q. When did they tell you that?

A. Friday.

Q. Who told you that?

A. The guy out there where I worked. He is the foreman.

Q. What's his name ---- Joe

A. Yeah Joe

Q. Now do you remember when Sandys' dad was here in November?
Well he said he never talked to him.

A. I never talked to him.

Q. See, I talked to Mr Weaver, Sandras' dad and he said he called you on the phone, I have the date written down and I will be getting it; him and his attorney was out here and he called you on the phone and he asked you -- he talked to Philip Quintana, he asked about the party, you said, or this Quintana said that he knew Sandra, that he didn't attend the party in Tooele but a friend Martinez did. You don't recall him saying that to you?

A. I don't even remember talking to him, I am pretty sure I didn't.

Q. This would have been in November.
He claims he don't know Martinez, he asked me about what was said when I was over to his moms house cause he don't know anything about him anyhow.

A. It might be that GG, I think that was his last name.

Q. GG

A. But I don't think he was at the party. He was with us the last night we was there, and then Tuesday we stayed over at his place.

Q. Is there another another Philip Quintana that works over at Wyckoffs?

A. I don't think so.

Q. Mr. Weaver stated he had a phone conversation with you and you denied being at the party, but said your friend Martinez was there. It was not you?

A. I would have told him yes.

Q. Did you mention anything to Joan about using an alien name Martinez?

A. No

Q. Ever mention at the party of anything that you ever went by Martinez, never told anybody?

A. No

Q. Did you know Danny Quinn, or ever know or meet anybody by the name of Ed Martinez that was at the party or could have been at the party?

A. He could have been there.

Q. Did you ever make a statement to anybody saying that you saw Sandy talking to a Wyckoff truck driver about 11:30 about the 1st of July.

A. No verbal answer

Q. Where did you go after they dropped you off that morning?

A. Down to my moms.

Q. Down to your moms, did you spend what, most of the day there, or what?

A. She made me something to eat, I think I went to sleep, and then I went back to 54th South.

Q. You didn't go back over to Wyckoffs?

A. Uh huh

Q. And you didn't see her talk to a truck driver or anything like that?

A. The last thime I say her was when we dropped her off.

Q. By the store or over at Wyckoffs?

A. No, by the store.

Q. Did she say why she wanted to go in the store?

A. She wanted to get some cigarettes.

Q. Well if she hitch hiked back to Tooele what route, where would she , what would she take to get a ride?

A. North Temple.

Q. Does taht leave on the Interstate?

A. That was only about 4 blocks from where she was working.

Q. She would normally walk to North Temple and then take the North Temple street out?

A. She would probably hitch hike to North Temple and then go out.

Q. He also states, Ben, the week they worked out here at Wyckoffs, they spent a couple of nights here in Salt Lake with friends rather than go into Tooele. You believe you went back out there when did you say? Wednesday?

A. Thrusday

Q. And then you went out there Friday?

A. Ah huh

Q. Did anybody - - maybe Sandy wanted some speed or something? Did anybody know somebody back in Grand Junction?

A. Well I don't know, but if she wanted speed she could have come to me, she knew where it was.

Q. Is this Ken Jones or or any of those guys make a phone call to you or get ahold of you since I talked to you or before and tell you that the police was

going to talk to you or anything to say? Any conversation with any of these guys?

A. I haven't seen any of them since out in Tooele. I seen Dirk, it was maybe Thursday, Friday night last week.

Q. What did Dirk have to say last week?

A. He just said have you talked to the cops yet, and I told him "No".

Q. Did he say anything else?

A. That he had seen her at work, he said he seen her there, and then he left.

Q. Have you heard anything from Joan, anything lately? Have you had any correspondence with her?

A. No

Q. Never have.

A. No

Q. She never wrote you a letter and you never wrote to her?

A. I knew she was in Wisconsin but I don't know what part.

Q. But you never wrote her any letters and she never wrote you any? How about, has she called you?

A. No

Q. Did Dirk say if he talked to her since, or if she wrote to him or anything?

Q. How about it Philip, if I come up with some letters?

A. Sure

Q. You see no problems with it?
