 17:20 E-2 left the Fina station amd was over at the Shamrock station checking out two white male american, on Alcohol violation.  
 17:30-17:35 E-2 noticed a green van at the Fina station. E-2 went over to check it out.  
 17:37 Bonnie Peck, (manager) asked E-2 if he had seen Nancy. E-2 stated that he had seen her about 20 min. ago. Manager stated that Nancy was to be working, from 13:00 to 24:00 that date.  
 17:45 E-2 proceeded to seach the building and the grounds within proxcmity. Negative contact.  
 18:00 E-2 proceeded to call E-1, unable to get contact. E-2 then called Layton P.D. and talked to Sgt. Palmer. Layton dispatch contacted the Hospitals to see if the victum had a emergency. Also try to contact ex-husband, Dee Baird. Negative contact.  
 18:00-18:30 E-2 research building and grounds. Negative contact.  
 19:00 Norma Pitt (sister of victum) came into the Fina station and asked where Nancy was. E-2 told her of the situation.  
 19:10 Norma Pitt, led E-2 up to parents house. E-2 talked to Mr. & Mrs. Kenneth Perry. The parents stated that Nancy had had lunch with them earlier that afternoon and that she was in good spirits.

21:00 E-1 went to victum's house, (with sister) and obtained picture and list of boyfriends from phone book and excetra.

21:15 E-1 & E-4 patrolled Fernwood Park and City. Negative contact.

22:30 E-1 contacted a Denzle G. Williams by phone. obtained information on possible suspect. referred to D.C.S.O.

23:50 to 7-5-75 02:30 E-1 and E-2 kept surveillance on Fina station.

7-5-75, 07:00 E-1 & E-2 checked victum's house. Negative contact.

07:25 E-1 called possible suspects from City office, contacted a Lavarr Reynolds. E-1 set up an appointment for 16:00 that date.

11:30 E-1 & E-2 searched Fernwood Park. Negative contact.

12:15 run 10-28 on a Mr. Convery's vehicle.

16:00 E-1 ~~was~~ questioned Lavarr Reynolds back. He stated that he used to date her, but nothing steady. He also stated that he had a affair with her girl friend ~~EXX~~ Deloris Drake, but hasent seen ~~XXXXXXXXXX~~ Nancy since Dec. 74. at Fortlane shopping center in Layton.

 12:00 E-1 & E-2 talked to Deloris Drake, she was unable to give any information concerning Nancy's boyfriend's. But told us about a red compact car, possibly MG.  
 14:00 E-2 arrived at Fina station where employee should E-2 a brush in the back of the building.  
 14:15 E-2 turned over brush to D-13.  
 14:45 E-2 and D-13 searched the house of Nancy Baird. D-13 took one white black bristle brush also one pink white bristle brush. We also found the victim's birth control pills. Last pill taken 4-7-75. We also found an assortment of pain pills.

10:25 E-1 & E-2 meeting at D.C.S.O. E-2 received 10-21 from Dave Cable. Receiving information from Richard Marinoka, at the Security Employment office in Ogden. He stated that Nancy had come into the office at 11:00 A. M. on 3-7-75. He stated that she was very unhappy with her job and wanted a better one.

11;25 E-2 talked with Monty Torres's mother. She told E-2 that her son was in Idaho and that he hasn't seen her in about 3 months.

11:30 E-2 gave Sgt. Terry, Sheriff Dept. Pocatello, Idaho. Asked him if he would look into Torres' aliby.

13:15 E-2 & E-3 talked to an Ann Stephens. She was very upset, the information given was irrelavant to the case.
