I was sound asleep, probably about Tam when I was awakened (I believe by him opening the window and shutting it). I had forgo to put the wooden slot in the window to lock it and although it would be difficult to see the it was not there in the dark, he must have seen it as he took off the outer screen to reach I opened my eyes and he was standing in the doorway and I saw only the profile the window. There was a light shining from the living room where he had left his flashlight on the table and left it lighted as later I asked him where the light was coming from and he He came right over and sat on my bed and told me to re! told me it was none of my business. that he was not going to hurt me. I asked him how he got in and he said it was none of my business. He sat there for maybe 10 minutes and mostly I asked questions and his answeres were confined to just relax and that he would not hurt me. He was wearing a/white T undershi levis and no shirt or jacket although it was cold outside. He had a dark havy watch cap pulled down over his head to below his chin. It was not a ski mask as there were no holes for nose and I think he must have made slits in it for his eyes although I could not see them. So I never saw his face or his hair and I have no idea of the color of his hair, if he had mustache or beard or anything like that. I know it was not a ski mask as it did not go down on his neck. His voice sounded like a Northwesterner and he was well educated and could be a student at U. of W. I do not recall any jewelry or watch and although I saw his bare arms, did not see any hair on his arms. He told me he would not use his knife if I did not scream and he showed me a hunging knife and it looked like a carved bone handle, dark with streets i He had been drinking but was not drunk.
