1 Concerning William Corden Jr.  
23 His sister Susan has sent Bill a 6 page letter to tell him  
4 how she felt, & in part said;5 - That she told their east coast relatives about why he  
6 is really in prison.7 - That she knew of Bill's also sexually abusing  
8 brother Tim.9 - That both sisters have now made statements against him  
10 - That she intends to fight her efforts at a parole11 in "Nov. 1994".  
1213 Bill called his mother's house with Susan was there, &  
14 she spoke with Bill for the first time in a long time. He  
15 spoke of how he has to come clean in the program &  
16 that 150 are in it. He had not yet seen her letters.  
1718 update 2/3/94:19 Bill Jr. called sister Susan last night. He was not upset.  
20 However, he had earlier called his brother Tim, yelling and upset,  
21 demanding to know what the girls are really up to? Bill also  
22 claimed that Susan's letter told of detail of Bill's sex abuse of  
23 Tim at an earlier age, (which the letter did not do.) Now Bill  
24 makes nervous claims;25 - That he now recalls that he too was sexually abused

1 as a child by an unknown baby sitter.  
2 that he now realizes he was guilty of Rape & claims  
3 his father had convinced him he was innocent  
4 earlier. He admits to Susan that he did a lot worse  
5 things. Bill was told by Susan, that she believes  
6 as does the family, that Bill also killed Kathy  
7 Devine. He denied it.  
8 That Bill wants Tim, Susan, & Karen to go to the  
9 prison for a family counseling session, as part  
10 of his program. He was told that Susan  
11 would come, but only if their mother could come  
12 also. Bill was clear that no, he did not want  
13 her.  
14  
15 Susan explains a few of these things. Her mother  
16 said that Bill never once had any baby sitter. The mother  
17 always was there, but for some brief periods of grandparents  
18 watching him. Bill is said to be untruthful & this is why  
19 he doesn't want his mother at a family counseling session.  
20 The worry is that she will expose untruthfulness that  
21 will cause Bill to be expelled from the sexual therapy  
22 program. Brother Tim & his wife Margaret now tell  
23 Susan that Bill used to try and Rape Margaret on (5)  
24 five occasions before his prison incarceration. Bill  
25 broke in her home, as Tim was working. One one particular

occurrence, Bill allegedly picked Margaret up and threw her on the bed of her own home. He then jumped up on the bed & broke it. Further, Bill claimed to Susan that Margaret planned it all to happen. Tim is & has been aware of these allegations, yet still tried to get Bill out of prison, which Susan is amazed about, & reminded Tim of the risk to Tim's 5 daughters.

Bill claimed he would maybe take a polygraph from a private polygrapher, but is still hesitant to permit a police polygrapher to examine him on Devine.

Tim has told Bill of Susan building a new home at Puyallup, which makes Susan concerned of him finding her.
