SUBJECT Missing College-Age Women

Some random deductions occurred to me this evening regarding the search and arrest of the mysterious "Ted" or other person or persons abducting or presumably killing young Seattle college-age women. As I have three daughters, and we live one mile from Lake Sammamish, maybe my imagination was working overtime, but here goes.

Common characteristics of "Ted":

- Apparently engages in <u>surreptitious observation</u> of his victims and prospective victims—such as at Lake Sammamish Park. Otherwise, how would he have known that girl abducted from rooming house at University of Washington was in a <u>girls'</u> rooming house. This is also suggested by his movement at Lake Sammamish, also in circumstances of the other disappearances.
- 2. Based on above he also apparently "hangs around" over where young college-age girls congregate, such as around Central Washington State campus, Evergreen college campus, University of Washington campus, Lake Sammamish Park, etc., maybe dances, taverns, social events, etc. Could extra plain clothes patrols, especially in the afternoon or evening, in everywhere college-age kids congregate, help arrest this killer? Does he follow prospective victims around? Strike up conversations, or what?
- 3. How can he <u>spend all this time</u> plotting these attacks and murder?
 Does he have:
 - a. A job with unusual hours?
 - b. An independent source of wealth from a trust fund, wealthy parents, a robbery, or what?
 - c. Is he also a student? If he is not, how does he blend into the college-age environment he frequents?
- 4. He must have a past history of treatment or observation for sex crimes or sex deviations or mental disturbances. How to run some kind of check on younger men in this category in Washington, Oregon, Idaho, and B. C. (as inference that "Ted" at Sammamish had slight English accent).

- 5. Per (4) above, would it be possible to run a check of English, Australian, or other "commonwealth" men here on visas, work permits, student permits, etc., in the Northwest? Where do such records exist? Maybe segregate into ages 16 to 35?
- All of the crimes indicate these characteristics. Let's think about and discuss these over coffee tomorrow:
 - a. Killer must be very powerful—all victims have vanished without any screams or disturbance. It is not material that Lake Sammamish disappearances were in broad daylight—the other kidnappings were at night, and these intelligent young women, who might let some smooth talking killer try to date them or whatever in daylight with crowds around would not do so at night.

All the victims were intelligent. How does the killer fool them?

How does the killer maintain his physical strength, if the above is true. If the killer of all 6 to 7 girls in Western Washington is "Ted", he is of small stature. He must be very strong to kill his victims swiftly and silently and pack them off quickly to a place of hiding.

Does the killer stay powerful by :

- I. Working out in gyms with weights? Running? Calisthenics?
- II. "Work out" at home?
- III. Run laps on tracks, etc.?
- b. Is the killer in league with other, if he is not powerful per above? A bikini-clad girl was seen with one of the girls at Sammamish. Is this some wierdo lesbian Bonnie and Clyde setup, as has occurred before in American criminal history?

In this context, has everyone at Sammamish Park been interviewed? Could a better public appeal go out, maybe let people-witnesses call a toll-free number?

7. How does the killer transport and hide his victims? As no bodies have been found, he must transport them in the trunk or back seat of a large car. He must have a house or farm, etc. to hide them on. (Was this "Ted" supposed to have had a V. W. "Bug" or "bus"? Seems improbable he would customarily use a V. W. Bug, at any rate. Also presuming that the killer must be burying his victims, he must

> live somewhere where he can come and go as he pleases and not be observed as he goes in and out.

Does he perhaps have a garage in basement or wing of his house that he can drive into, if he lives in town, or does he live in a rural setting?

As most of the attacks are in the <u>Puget Sound Area</u> and also some 6 to 7 young women were also <u>killed in British Columbia</u>, couldn't border crossing records be studied of students or other coming <u>from B. C. to Washington?</u> Where are such records kept?

Incidentally, if he is a student, could he be on some kind of fellowship or scholarship?

The odds are that the killer has a house in greater Seattle area, or at least has had one though the last scenes of murder, probably a rented house or farm, as odds are against fact he owns such a property. How could Seattle P. D. and other interested agencies "profile" the killer, beyond the rudimentary profiles already published in the Seattle Times and the P. I.? What do the Vancouver papers say on the murders up there?

- 8. The killer must be feeling the "heat" now. Where will he go next? Probably an urban center where he can "blend in" with a large population. I suggest Portland, San Francisco, or Los Angeles as likely possibilities. If this is a viable suggestion, police authorities should be alerted in those areas.
- He is a loner, with no real friends or acquaintances, otherwise, someone would have informed (a) As a public duty or (b) for the reward.

Where does this character hang out when he's not out tracking his next victim? What does he do? What are the rational assumptions?

10. When he is tracking his victims at night, how did he stay unabstrusive? How does he park and stay in his car for extended periods? Does he just walk around?

How about more patrols checking out cars, especially vans, etc. parked around our college campuses, especially larger campuses the next few months.

11. The killer is getting bolder, witness daylight abductions.

How does he do it? Chloroform or strangle his victims? How
does he get to a place where he won't be surprised, to transfer them to back seat under blankets or to trunk of his vehicle
or whatever.

Incidentally, does he possibly have access to several vehicles?

12. 1 week later, 8/14 . . .

Suspect apparently also has a cast--where did he get all his experience in making casts--military, Viet Nam paramedical? This would tie into the violence angle. Where did the pity angle come from? Has he stayed in a hospital somewhere? Viet Nam?? Where does he buy the stuff to make these arm and leg casts? Where did he buy the white tennis outfit mentioned in the Seattle Times articles?


