





A FORD. MOORE ADVISED THAT AS HE APPROACHED THE VEHICLE FROM THE WEST HE SAW THIS INDIVIDUAL DUCK DOWN BEHIND THE TRUNK OF THE CAR AND AS HE PASSED THE SUBJECT MOVED AROUND THE CAR TRYING NOT TO BE SEEN. COMPL. THEN WATCHED IN HIS REAR VIEW MIRROR AND THE SUBJECT WENT DOWN INTO THE DITCH AND TRIED SEVERAL TIMES TO CLIMB A BARBEE WIRE FENCE. AT THET TIME THE CO,PL WAS EDUT OF VIEWING RANGE.

MOORE ADVISED THAT THE SUSP. VEH WAS PARFED VESTBOUND ON THE SHOULDER OF THE ROAD ON THE OLD CLE ELUM HIGHWAY APPROX. 2 MILES EAST OF THE HAYWARD HILL INTERSECTION. IT WAS JUST AT THE BOTTOM OF THE HILL WHERE THE SAND BANKS RUN ALONG TE HIGHWAY. MOORE BELIEVED THAT THE SUBJECT IN QUESTION WAS ATTEMPT TO HIDE SONTHING ON THE NORTH SIDE OF THE ROADWAY. To Whom It may Concern:

Today, while hunting for wild blackberries south of Arlington, an incident occurred that seemed well worth reporting to the Arlington police department. Immediately following the incident I did phone a report to that agency. After more thought on the occurrence I wanted your department to have the information for whatever it may be worth.


The car I was driving was a 1970 green cadillac sedan. The occupants, other than myself were my 23 year old daughter, my 32 year old daughter, and my husbands 82 year old uncle.

Uncle Rex is very short and at the time of the incident I did not realize that he is so short, and always lays back in the corner of the back seat and is not visible from the rear of the car. I noticed this later and I think this had a lot to do with what happened.

At 8:30 A.M. we had driven north on highway 9 and turned East on 172 N.E. and followed that curving road in for a couple of miles to a berrying spot we were familiar with. We picked berries there for two hours and as we were driving back out to highway 9 Uncle Rex spotted McElroy road, going north, and suggested we drive up that looking for a berrying spot. I drove about one mile and slowed to look on my right at an area. As I slowed I had not noticed a car in either direction and was almost stopped when I spotted a blue van right on my bumper.

I explain ed to the family I was holding up a car and speeded on down the road, picking up to 45 and 50 miles an hour and the van did likewise. There was nothing unusual in this other than at the time I was slowed to almost a stop nothing was coming southbound on the road, there was plenty of clearance but the van hadn't passed me. At that point this hadn't registered in my mind as a menace of any kind.

The van continued to tailgate me down the road (going North) for a mile or more. I spotted a road coming up on my right and entered it to turn out of his way so he could pass. I did not nose stright east on the road but East and then curved around to re-enter McElroy to keep going North. I swore because the van turned up the road right on my tail and said to the family. "A car just turned right in here



on my tail, wouldn't you know because I pulled off to let him pass he would be going in this road." At this point the girls looked out the window and said "what a creep". The man, about 27 with brown hair, worn longer than below his ears, a round face and with dark rimmed glasses sat there peering at us. Thinking the back of my car might still be blocking his driving East I pulled back into McElroy, going north, and he drove up that side road. I shot out of there and the girls kept saying"is he following us, mother." I said "no, you saw him go up that road."

I drove at about 50 or 55 for about four miles and we spoted a turn in that might be a likely place for berries. Being a little uneasy and knowing the road I was on was a dead end (there was an orange metal wide barred gate) I turned the car around so my nose pointed down to the main road. We were about 150 feet straight in from the MAIN road.

Uncle Rex and Patricia had gone in around the bend toward the gate. and were out of sight, looking for berries. I was just turning my back and heading the opposite direction and Joan was just stepping out of the car when we heard a car tearing down the road. passed in a flash and it was the blue van. Joan yelled, "Mother that's him". "I said, you must be mistaken, that van that was behind me went East." "She said again - it's him". I yelled and she yelled for Rex and Patricia. Just then we heard squealing tires and could tell the van was turning around up the road. He had spotted us as he roared up the road.

Patricia came running and all three of us had our hands on a car door to get in and lock the doors and were all yelling at Uncle Rex"get here fast." At this precise moment the van crossed the road and came into the entry to our road blocking off the road and our exit. As he pulled in he could here us screaming "Rex" and Rex popped into view heading for the car. As Rex came into the drivers vision he tore out of there heading south.

The van at all times was so that we couldn't see the license plates, other than at first when we had no reason to suspect we should look at the plates.

The young man appeared to be wearing tinted or sun glasses and though he never stepped from the van he appeared to be short.

The van was bright blue, in good condition and had the prefessional lettering across the side "High Meadow Ranch." It was clearly visible to me when he parked crosswise blocking our road.

I'll leave it to you what his intentions were. I have never allowed a gun in my home and don't believe in them but this experience made me wonder how in the world women alone can protect themselves when trapped in a manner like this.

We originally were going without uncle but he called at the last minute and joined us. Thank the lord for Uncle.

The terrible things that have been happening to young girls in this

area prompted me to report this incident. Even the I dont have much for you to go on. Should I have just shunted this aside, I might be neglecting to give you some helpful information.

There isn't any doubt in my mind he thought we were three women alone and when he heard us yell for a man and Rex appeared he figured he had more than he could handle.

As per the letter of Hal Bradley, dated August 27, 1974, we have completed a check on the records of those persons forwarded by Corrections as generally resembling the description of "Ted."

of these only three were out of the hospital at all, and of those, it is unlikely that one was outside of custody although there does appear to be a records screw up between hospital records and Corrections records. The one where the records don't seem to jibe is an inmate of the Monroe Reformatory named.

Hospital records reflect that he was returned to court on March 5, 1974; Corrections records indicate his discharge from Western State Hospital on May 14, 1974. I'll personally check out that two month gap if you wish, but it does not appear to be particularly significant in connection with the dates in question.

The other two have both been out of the hospital for some period of time. They are ________, Corrections Number 528319, who appears to have been discharged from Western State Hospital on August 31, 1972. The other is _______ who has been on escape status from Western State since March 26, 1967. We were informed about a year or so ago that he had been arrested in Wendell, Idaho. I do not know what the outcome of that arrest was. He has not been returned to this state.

To this officer's understanding, they were looking for a vehicle with out-of-state license plates to this homicide that occurred at the D&R Market approximately five years ago. To this officer's understanding there is also an Indian or Mexican-type ornament that was found at the scene of a homicide at the Eastmont old Mobil station that could possibly fit into this.

MRS. ROBINSON stated that this individual hates women, refuses to have anything to do with them, and she stated that he hardly even talked to her.

In this officer's opinion, this would be worth checking out, and there the o should be copies of this report duplicated and sent to the Seattle Police Department and the other agencies investigating these homicides and missing girls.






