While making a routine investigation of the rape that occurred in Multnomah County, 3/29/75, Multnomah County Sheriff's Office file #75-7036. The victim was a DOB: 1/1/63, WF, 12.

Subject and have been married approximately three years, dating back to the tenth month of 1972.

Writer was interested in the suspect in this case due to the fact that the way it was done. The victim, was on Kelly Butte playing with her two younger brothers, ages 10 and 9, and a younger sister age 6. The children had gone up there for a picnic in the afternoon and then observed the suspect loitering in the area. The suspect approached the children and asked them for a drink of water. When the victim complied the subject sent the other children away, retaining the victim at the scene. He sent the two boys to his automobile with the pretext of getring a knife out of the glove compartment. During the time that the boys were gone the subject picked up the victim and attempted to carry her off into the brush, located near the top of Kelly Butte. The victim struggled, causing the suspect to take and put the victim down.

The suspect then proceeded to pull the victim off into the brush, pulling her pants down when he got there. He shoved her down on the ground and proceeded to rape her. The suspect was subsequently arrested at approximately 2:00 PM on the 29th of March 1975 by writer and Sergeant Judy Taylor at the suspects residence at 3 SE Division Street.

Writer at the time observed the suspect, remembered the description of a case earlier involving several girls in the Seattle area that had disappeared and that they had found parts of their bodies in and around Taylor Mountain. Writer, making a comparison with the physical description of the suspect in that case out of Seattle, and comparing it to the suspect involved in the rape, found that they were similar.

Writer proceeded then after transporting the suspect to Rocky Butte Jail to contact Frank Konekoa, Deputy Sheriff, assigned to Detectives in Clark County, in Vancouver, Washington, where he issued a composite drawing out of Seattle that was drawn 10/30/74 by a Dean Quizlene. This composite when compared to the color photograph of the suspect in the rape case was almost identical except for the mustache and a few varying lines in the eyes and the hair line.

Writer proceeded, then accompanied by Sgt. Taylor, to follow the background a little deeper into the suspect. It was learned from the suspects wife and the suspects mother to another woman approximately 1968 to 1971, by the name of Sharon. Last name at this time unknown. It was also learned that the suspect, had worked for the Cohn Brothers Furniture as a carpet layer and had been so since sometime around 8/12/74. It was also learned that the suspect had been on work release since that period of time up until some time in February 1975.

at this time the name of the logging firm. When writer asked the subject, Sharon Cadwell, as to the relationship she had with her ex-husband, she stated that it was a poor relationship. That the suspect was addicted to glue sniffing and had been on glue sniffing since they had gone together and she was 15. She is now 25. A period of approximately ten years that she had known the suspect. She also stated that the suspect was an auto thief. That whenever he wanted to go anyplace he would think nothing of stealing a car to go. She recalled one time when he had gotten mad at her and joined the Marine Corp, that he wanted to come home, so he just stole a car and drove to where she was.

Writer questioned her along the lines of the type of automobiles that the suspect takes and he stated that they were small cars mostly. He talked about Chevy Novas wanting to steal Chevy Novas and also sports cars. The last vehicle that was known to have been stolen by the subject was the one that was involved in the city case file #73-80880, Re was a Sprite.

Every place that writer and Sgt. Taylor have gone in this investigation would indicate that the subject could possibly be one in the same as thought to be "Ted" or went by the name of "Ted" in the Seattle area. All indications are that the suspect fits the description physically, also by sight, and has the mild manner, the soft spoken words and also has a slight accent that would indicate possibly be mistaken of the accent mentioned in the brochures.

Writer has contacted Clark County Sheriff's Office, Officer Konekoa again, and stated that the subject could possibly be involved in the three murders thereinvolving women in their locality. Writer also received information from Sharon Cadwell that the suspect most generally carried a knife of some type on him and when writer said by knife do you mean a pocket knife. She stated no, she said it would be either a switch blade or a larger type knife, such as a hunting knife or a dagger or this type.

While writer was talking to the subject, Sharon Cadwell, I reached into the foloder container the picture of the suspect called "Ted" and casually laid it on the table. At that time the subject, Sharon Cadwell, said that is him. That is there. She said although the hair is a little different, that is him. And writer never indicated as to who the suspect was in the composite that was sent down by Seattle.

Writer is in the process now of contacting the Seattle Detective in King County, Robert Kepple and Detective Dunn, and also Sgt. Miller of Corvallis P.D. It is felt by writer that the suspect involved in the rape, \_\_\_\_\_\_, could very, very well be the suspect "Ted" involved in the various murders in the Seattle area.

In summing up, due to the fact that the location, the subject was familiar with the location, also the suspect being in a central location between Seattle and Corvallis where Roberta Kathleen Parks was taken and discovered 3/3/75 on Taylor Mountain. Also the suspect is unable to, or through investigation, unable to account for the times of 1/31/74, 3/12/74, 4/17/74, 5/6/74, 6/1/74, 6/11/74, 7/14/74, and 7/14/74 and 11/27/74 which are the dates of the disappearances of the girls that are listed in the Lashington area. Out of the nine girls there have been six recovered and all of them in the Taylor Mountain area.

Writer and Sgt. Taylor proceeded with the backgrounding of the suspect and contacted an ex-employer by the name of Rick F. Russell, who owns and Operates a Mobil Service Station on Hall Street in Tigard. This is right across the street from the Safeway store. It was learned from Mr. Russell that the suspect began work for him 6/15/74 on a Saturday and he worked during that time, Saturday, Sunday, Monday and Tuesday, having Wednesday off. Came back to work Thursday, Friday and Saturday and took off Monday, which he didn't show up for work. Then he went back to work Tuesday and then had Wednesday off. Then he worked Thursday, Friday and Saturday of the following week and was let go by Mr. Russell because he couldn't depend on him being there. Also that the suspect's attitude was bad with the other people that worked around him.

Unon further investigation, it was learned that the suspect also worked for a Burt Thompson of Route 1, Box 219, Newberg, Oregon. At the time that the suspect worked for Mr. Thompson, Mr. Thompson was a private contractor operating as B. & A. Maintenance and worked for Broadway Cap Company as a car washer. The suspect, worked nights for Mr. Thompson starting at midnight and working until eight in the morning. He started on the 15th of March 1974 and he terminated on the 31st of May 1974. During that time the first week he worked the full week and then the second pay period he worked two weeks. Out of the third pay period he worked ten days and then nine days and eleven days, which indicated that the suspect was very undependable. Upon questioning Mr. Thompson he also indicated that that was the reason why the suspect had been discharged because of his undependability. But stating that when the subject was there at work he was a good worker.

It was also learned that the suspect, was arrested on a warrant Portland Police Number 73-80880 on the 17th of July 1974. The subject was arrested for using a motor-vehicle without the owners permission or auto theft. The subject was transported to 767 7/21/74 to MCCI where he was released on work release to obtain a job, and he went to work 8/12/74 for Cohn Brothers. Upon checking with Cohn Brothers the suspect was there everyday, was very dependable, they were very happy with his work. At one occasion they cited a time that he had gone into a house to do some work, some repair work, and the people were not there. Although the people had left the house unlocked for him he would not go in. The subject continued to work for Cohn Brothers up until the day of his errest.

During this time writer had attempted to contact the ex-wife, Sharon. Writer finally located her in the Grove Mobile Estates, #176. She is living as Sharon Cadwell and this is located at 3839 Pacific Highway Avenue, Forest Grove. After making three attempts to contact Mrs. Cadwell in regards to her ex-husband, writer was able to do so 4/9/75 at approximately 11:00 at Tectronics where she is employed. Writer spent approximately 15 minutes talking to Mrs. Cadwell, not explaining why I was there other than backgrounding the suspect, and that he had been involved in a serious crime. It was learned that she and the suspect had lived in the Washington area in Bremerton in 1969. Also had lived in Shelton, Washington. During this time the suspect had worked for Simpson Logging Company, that was during the summer of 1969. From there they moved to Longview and he went to work for Weyerhauser as a logger. So the suspect was fairly familiar with the area in and around Seattle and also in and around the area of bremerton and Longview and the mountainous region in that location.

It was also determined that sometime in 1972 that the suspect had spent at least two weeks in Alaska, thought to be in and around the Anchorage area looking for work or going up there on the prospect of going to work for a logging firm there. Unknown
