While he was in the Navy he was connected with the medical corp, but I'm not sure what the title or job was. He has knowledge of casts & slings and wants to work as a medic.

He has visited colleges to see where he wanted to go and mentioned Central, U of W. and Evergreen by name. He said he had decided to attend Evergreen and had been accepted, but now he couldn't go because he wife had taken all his money. (Varification of this was attempted but this information is confidential from the admissions office until a person is a registered student) He has talked to a local doctor to get him to sponsor him in training for a doctors helper.

He had choices of places to work this summer in parks; Lake Samminish was one of them but he didn't like it as well as Deep Lake. He would have knowledge of boats or kayak type; but it isn't known if he owns one, but he would access to one from the park.

This summer he scared some girls one night while sitting around a camp fire, he was working on a knife as usual, and he jumped out of the bushes and told the girls he had something to tell them, he was Ted. They all fled.

He traded his car the end of August and now drives a blue Mazada. He did drive a ~~blue~~ VW.

Did I see 'Ted' at Valu-Mart on August 14th?

Where? Valu-Mart now located in previous White Front across from Sears Overlake Park, 2200 148th N.E., Bellevue-Redmond.

When? Approximately 12:30 P.M., August 14th.

Was it Ted? I wish I knew but the face I saw haunts me because of the marked resemblance to composite drawings published in recent issues of THE SEATTLE TIMES.

The face was like an expressionless mask; displayed no emotion whatever as this young man ate his lunch at a table in the cafeteria of Valu-Mart. He was alone and had no mannerism that in any way would attract anyone's attention. However, there was quite a difference in hair-style as that shown in composites. I'm almost positive he was wearing a medium-blond wig, very carefully coiffed in a most conservative style, parted on the right side and rather short in length by current standards. See the enclosed suggestion of the style. He was clean-shaven and had no side-burns. I wondered at the time if he might not be a hair-stylist.

In my judgment, he was a man probably in his late 20's or early 30's. Possibly 5'9" tall and would weigh between 165 and 175 lb. Neither his build nor coloring would suggest he is an outdoor man.

He was dressed in beige, almost the same shade as his wig(?). He wore an expensive-looking suede jacket and same color slacks. His shoes were brown.

His manner was unobtrusive; he appeared to see no one. Upon finishing his lunch, he went over on the mall briefly, then back through the cafeteria and over into the grocery-store section. I lost sight of him for a few minutes, then saw him circle the perimeter of the checkstands twice and then go out the door and to his car.

I observed him as I ate lunch. When I saw him go out the door of the grocery store, I hurried out also to see if he was driving a Volkswagen and if so, to get his license number. I don't believe it was a Volkswagen but instead a dark-colored sports' car with very similar lines. It was a two-door with light interior, high-backed bucket seats. This may sound a little stupid but I'm not that knowledgeable about cars of recent vintage. My main concern was to appear nonchalant and get his license number which was DKV- [REDACTED]. The last I saw of him he drove out of the parking lot and headed north toward the freeway.

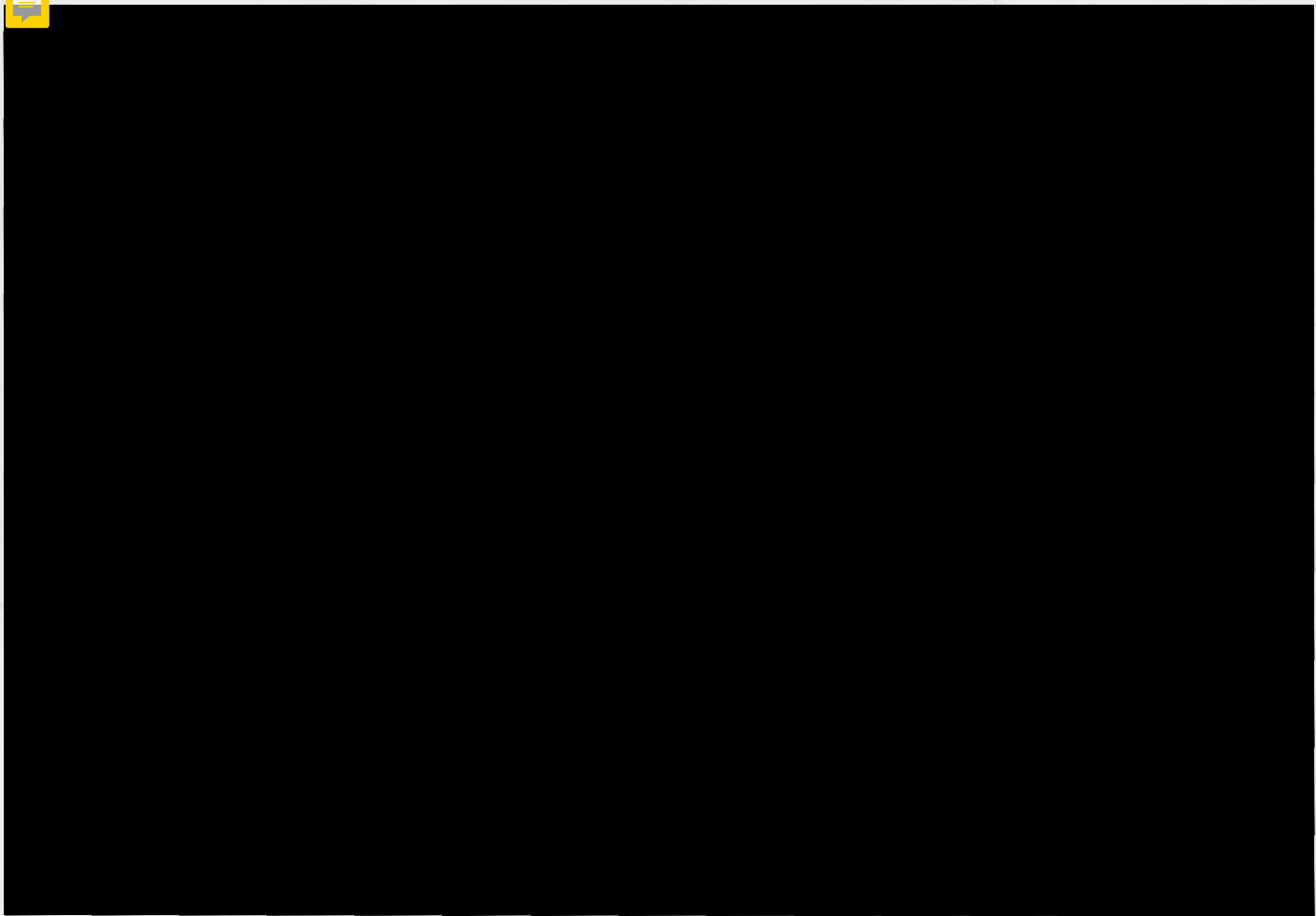
I went back into the grocery store to try to guess what may have interested him at the checkstands. If this was indeed Ted, a young, girl checker who resembles other missing girls may have been his interest. She is a nice-looking girl with long, brunette hair parted in the middle - an intelligent looking girl.

My reasons for this note are three-fold. One, like so many others, if I am of any help, it is the least I can do and the face really "hit" me. Two, my concern for this little checker if this was Ted. Three, I can supply a license number even though its owner may be entirely innocent and unconnected. I would be very sad to cast suspicion upon an innocent person.

I couldn't tell you any more if I were to contact you in person. Therefore, I wish to remain anonymous and hope I may have given you a valid lead.
