In 1969, after 10 years of teaching dance and performing with top companies throughout Europe and in New York, William Earl met a woman who changed his life.

It isn't the typical man-meets-woman, woman's-love-inspires-man story.

"I HAD BEEN dancing with the Jazzbaletten in Stockholm," said Earl, now head of the Madrona Dance Studio here, "when I was invited by the Karolinska Institute to teach movement classes in their out-patient program for the mentally or emotionally disturbed.

"In the class was a woman who hadn't spoken or made a sound in eight years.

"After about the fourth or fifth class, she began to hum to herself as she danced across the room.

"It had a profound effect on me, and I realized then that I had to go into dance as rehabilitation therapy."

IN 1970 Earl enrolled at the University of Washington in physical therapy, and in 1972 was awarded a bachelor's degree with honors. Since April of this year he has acted as dance specialist and co-ordinator at the Madrona Studio, while working for his master's degree in therapy.

"What really interests me," said Earl, "is to have a dance and movement notation system universally adopted by hospitals. The medical profession will look at a patient and write on the chart, 'he walks funny.'

"That's no way to evaluate the problem and chart progress.

"At the Madrona Studio I'm doing some work with rehabilitation. In my dynamic relaxation class, for example, we have a heart patients who do very well. I also teach private classes for handicapped children."

Beyond dance as entertainment

are making Madrona Studio one of Seattle's top dance centers.

Under Earl's guidance, the studio has played host to such outstanding dancers as Merce Cunningham and the Theater Flamenco of San Francisco, and has brought together many local dancers and companies for major performances, as in last month's Bumbershoot: Festival '73 at Seattle Center.

A new series of classes at the studio, sponsored by the Seattle Department of Parks and Recreation, begins tomorrow.

"WHEN I CAME to the studio in April," said Earl, "I started shaking the cages of the arts and dance establishment. And the cages don't like being shaken.

"The city has a notion there should be one major dance company here, probably ballet. But monopolies are really dangerous. The different and unusual points of view aren't there.

"I want to see more support for the different local dance groups, and that's why I'm encouraging a variety of performances at our studio. And the Bumbershoot performances demonstrated the various factions can co-operate, instead of compete.

"It's got to be a community thing. There's plenty of interesting dance going on here. You don't have to go to New York. Because many groups here are amateurs or beginners is no reason not to see them, give them a chance.

"At the studio I want to give everyone a chance to

perform. I told the city officials, 'You can't teach classes to individuals without giving them a performing experience.'

"I'm interested in making

programs that touch the individual, that capture something of his potential and fulfill some of his need."

Not a bad aim for any city department.

Subject: Information on "Ted"

This morning at about 1045 hrs, an anonymous caller phoned the Homicide-Robb. office with the following information:

About ten years ago, the caller and his mother rented a house in Kirkland, Wn. from a Mr. and Mrs. Elvin Hearn, who lived next-door to the rental. They had a daughter, who had a boyfriend named [REDACTED]

[REDACTED] was about 18 at the time, which would make him about 28 now. He was a moody sort, and a loner, having no friends at all, other than the Hearn's daughter. The caller said that [REDACTED] had some sort of bad criminal record, but he couldn't remember exactly what for. [REDACTED] carried a gun often, explaining that he often visited gambling clubs in Seattle, and needed it for protection.

The caller said that [REDACTED] acted sort of strange, and he can recall a couple of times when he wore his arm in a sling when he wasn't suffering any physical problem. The caller said that as best he can recall, [REDACTED] did this to "put people on" or gain attention and sympathy.

The relationship between [REDACTED] and the Hearn's daughter broke up over the fact that he began to abuse her, and did assault her enough on one occasion to cause visible bruising. She is now married, and lives in the area with her husband and children.

The last the caller heard of [REDACTED], he was living in Preston, Washington, East of the Lake, but beyond that, he doesn't know anything more about him. He thinks that [REDACTED] would have gone to Lake Washington High School when he attended, which wasn't often.

SUBJECT "TED"

I received a phone call from a Mrs. Doris Wright, 9208-45th N. E. (LA 4-9059). Mrs. Wright is a neighbor of a personal friend. My name was given to her for someone to contact.

Mrs. Wright indicated in her phone call to my home that she had some information regarding the missing girls and wished to speak to me personally. I agreed to meet with her at her home at 0800 hours this date. I determined later that Mrs. Wright works at the Veteran's Hospital in the Psychology Department. She personally claims she is a Psychologist.

The following events are what was repeated to me for what value you may gain:

Mrs. Wright's daughter has been going with a 21-year old white male, shoulder length hair. His name is [REDACTED]. She does not know his whereabouts at this time. His phone number was 365-[REDACTED]

Mrs. Wright states, putting together some strange events that have occurred, and determining that [REDACTED] resembles the suspect "Ted", decided to relate the information very reluctantly to me. She states [REDACTED] is a very disturbed young man, has some very different sexual hangups, and is obsessed with mutilation.

One one occasion her daughter observed all of the pictures of nude females in a girly magazine having the pelvic area cut out. [REDACTED] relates his experiences and dreams to Mrs. Wright, for what reason I do not know.

He does own a Volkswagon, blue in color, that he is selling to Mrs. Wright's neighbor. I observed a blue Volkswagon upon leaving, license number OTU-765, which could or could not be the Volkswagon she mentioned. She states that when her friend and daughter were going through the car they found a plastic coin purse, clear on one side and some color on the other side, zipper type, containing Canadian coins. (She relates this to the missing girls in Canada) a miniature bouquet of straw flowers and a Martian figure of some type.

Also found inside the vehicle was a silk scarf (given to Ted Fonis) that he seemed to be very concerned with finding and being returned to him. (She feels this may belong to one of the missing girls).

Mrs. Wright further states that [REDACTED], along with other unusual type persons, is a member of SON MYUNG MOON Sect located in the University District at 4700 - 18th N. E. She had some literature referring to Sect worship and mentioned blood in different phrases.

Sometime in July [REDACTED] went to eastern Washington with a work-study group from the University of Washington (list attached). Upon his return, he asked Mrs. Wright if he could place some fish that he had wrapped, and supposedly caught in eastern Washington, in her downstairs freezer. Later that week he invited Mrs. Wright and several other people to a special gourmet dinner that he wished to give.

This is an unusual pattern as he has never cooked before or shown any interest. It was apparently quite a ceremony in the preparation of this meal, one in which he wore the scarf about his head, showing an unusual attachment to same.

Mrs. Wright observed the meat, that was supposedly fish. It was pinkish in color, had the texture of flesh, and was marbled with a layer of fat. Upon eating the meat she discovered several pieces of cartilage. [REDACTED] at this time was questioned quite extensively as to what type of food they were eating, and he insisted it was fish he had caught in eastern Washington, and would discuss it no further. These were 4-inch squares, 1/2-inch thick, approximately 5 pounds worth. She no longer has any meat, nor the wrappers that contained the meat, for examination. She is somewhat disturbed that this may have been human flesh.

I do know that this [REDACTED] attended Nathan Hale High School and a picture should be available in their annual.

On 3-30-75 at 0100 hrs., we were dispatched to Duffy's Tavern at 4300 NW Leary Way to check up on a suspicious person who looked like "TED". Upon arriving, I was informed by a man who insisted upon remaining anonymous, that he, his wife, and his wife's girl friend, (a 24 year old attractive blond), had been being followed around all night by the following person. He stated that none of his group knew this person and that they had first noticed him in the Lockspot Tavern. After leaving there and arriving at the Soundtrack Tavern, they noticed the same man showed up within minutes. After leaving the Soundtrack Tavern, they went to Duffy's Tavern and again the same person showed up within minutes. Because he appeared very interested in the 24 yr. old blond, and because he bore a good physical resemblance to "TED", they called the police to have the man checked out. The person appeared cocky and very sure of himself. My partner and I tried to be as vague as possible with him and feel he does not know why we talked to him. We asked him for I. D. and he I. D'd. himself as follows.






