ITEM:

1. 10/06/75 - 1500 hrs. - I was reassigned to the Task Force to assist Det. KEPPEL.
2. 1550 hrs. - I called S/A JERRY SNYDER's office, 442-5443, and was told he was temporarily in San Francisco, but will call back when he returns.
3. 1600 hrs. - I called SYLVIA VALINT and made an appointment to meet her at her residence.
4. 1605 hrs. - I called JANICE GRAHAM at home. She had resigned her job at the Boeing Co. She said she had been contacted at home last week by ROBIN GROTH of KING - TV. GROTH showed her BUNDY's photograph alone and asked if he was "TED." JANICE said that she recognized him from other photos that she had been shown and that she had seen his photo in the newspapers and on television. It was her impression that he looks similar to the guy who approached her and who she saw walking away with JANICE OTT, but she could not be positive that he was the guy. She feels that the photo shows him as being too old.
5. 1635 hrs. - I contacted SYLVIA VALINT at her residence, 5718 S. August St., 723-3109, and showed her the new photo montage including BUNDY and seven others. She was unable to recognize him and went on to say that she hadn't been following the recent developments of the Salt Lake case and the local publicity on him and his picture.
6. 10/07/75 - 0830 hrs. - Capt. MACKIE assigned me to check out a friend of BUNDY's named JOHN MULLER.
7. MULLER's parents are GLENN E. MULLER, 10632 Des Moines Way So., 242-0924, but are gone fishing and aren't expected back till 10/09/75.
8. MULLER lived at the same address with BUNDY, 4143 - 12 N.E., and they were good friends. MULLER was reportedly ineffective at picking up girls so BUNDY would set him up with girls. Some of the places they went to were The Rainbow Tavern and Dante's Tavern. LYNDIA HEALY was at Dante's earlier in the evening that she disappeared.
9. MULLER was partners in a diving venture with "STAN." They sought out specimens for aquariums. STAN reportedly drowned a month ago and a lot of his belongings are in the garage used by BUNDY at 4143 - 12th N.E. After STAN's death, a guy named DOOR (phonetic) took over business and MULLER has reportedly gone to Australia.

10. 10/07/75 - 0850 hrs. - I recieved a phone call from:

MARLEIGH LANGE, 17125 - 40th W., Lynnwood, Wa., 743-6277

While she was a student at the U.W. in the 66-67 school year, she roomed with:

DIANE EDWARDS

who is now married to WILLIAM ZUENDT and living at 1200 Gaugh St., San Francisco, California, home phone unknown, but was last working at Wells Fargo Bank, 415-347-0651. They lived at McMahon Hall and so did BUNDY.

11. BUNDY and DIANE became friends, started dating, and fell in love. MARLEIGH did not like BUNDY and was not impressed by him. She got the impression that BUNDY was effeminate and spoke with some sort of accent not identifiable as Washingtonian. When he and DIANE got in a beef, BUNDY would counter with stories about all of the women that he had contact with and who did him favors, and trying to put DIANE down. BUNDY didn't have a car and DIANE had to drive him around everywhere. MARLEIGH thought that DIANE was out of BUNDY's league and that he was only interested in her money. BUNDY did not have a major when she knew him, but he was interested in Chinese culture and language.
12. In July, 1967, BUNDY got some sort of a grant or scholarship to attend Stanford to study Chinese so she and DIANE went down to visit him on the campus.
13. During the next shcool year, 67-68, she and DIANE lived in an apartment near N.E. 62 and 2nd N.E. BUNDY didn't come around as much although he and DIANE were still dating. MARLEIGH got the impression that he was not in school that year.
14. While staying at McMahon Hall, another tenant who had contact with DIANE and BUNDY was:
- JOHN DUFFY
- who now lives in San Francisco also.
15. DIANE moved to San Francisco in March, 1969, and has lived there ever since.
16. DIANE reported that BUNDY would pop into town occasionally during 1969 and say that he was traveling around the country.

ITEM:

17. 10/07/75 - MARLEIGH and DIANE corresponded for a time and arranged to meet right after Christmas 1973. On 12/27-28/73, DIANE came to Seattle. MARLEIGH invited her and Bundy over for dinner, but BUNDY couldn't make it because he was tired from working on the campaign. DIANE came over in BUNDY's light brown Volkswagen (about the color of a cardboard box). DIANE said that they were engaged and would eventually be married, but he was going to go to Law school and she was returning to California.
18. At this time BUNDY had a full beard and DIANE still seemed unsure of him and their relationship.
19. As soon as the news of Lake Sammamish broke, MARLEIGH thought that the suspect could be BUNDY even before the composite was published.
20. In late August or early September, 1974, DIANE wrote and said that she had broken off her relationship with BUNDY and wrote that "she shuddered when she thinks how close she came."
21. DIANE is described as a white girl, possibly of Jewish descent, 5'10" to 6' tall, with long black hair and olive complexion and strikingly beautiful.
22. MARLEIGH described herself as 5'4", long dark brown hair parted in the middle with grey eyes. BUNDY always acted uneasy around her and he may have viewed her as a threat to him or his relationship with DIANE.
23. MARLEIGH said that DIANE didn't discuss her sexual activity with BUNDY and was unaware of any hangups.
24. MARLEIGH said that the only hobbies that BUNDY was into were snow skiing and sailing when he was with DIANE because she liked to sail.
25. 0945 hrs. - Sea-King check on MULLER shows:

26. 10/07/75 - 0950 hrs. - D.M.V. any and all shows:

27. 1020 hrs. - MULLER checks clear with King County Records.

28. 1025 hrs. - S.P.D. Records show that MULLER was the victim of a burglary on 02/05/71 at 1115 - 35th and the victim of a larceny/bunco at the Leschi Park Shell Station on 06/05/71.

29. 1030 hrs. - Called the Medical Examiner's Office who said that the friend "STAN" who drowned was STAN OTTERSON, M.E. Case #12803, but their records were not yet transcribed.

30. 1430 hrs. - Capt. MACKIE, Det. KEPPEL and I met with P.A. PHIL KILLIEN to review the case.

31. 1550 hrs. - Picked up copy of S.P.D. Case 71-6232 wherein MULLER reported a burglary to his and RICHARD HARRISON PALMER's residence on 02/05/71 at 1115 - 35th Ave. MULLER reported a larceny/bunco at his place of employment, Leschi Park Shell, 121 Lakeside So., under case 71-27790. At the time he was living at 6013½ - 17th N.W.

32. 1555 hrs. - A driver's record check on MULLER shows him as 6', 205#, with blue eyes. His license is endorsed for motorcycles and he has received no moving citations and shows an address of 10632 Des Moines Way So.

33. 1605 hrs. - King County incident reports show that MULLER's wallet was turned in as found property at 14820 Ambaum Blvd. So. (Taco Bell) under Case 73-25076 on 04/04/73. In his wallet was a "private guard license" and it was released to him the same day.

34. 1720 hrs. - I went to the Medical Examiner's Office and got a copy of their report #12803 and S.P.D. Case 75-56822, wherein STANLEY GEORGE OTTERSON, WM, DOB 08/22/17, was a drowning victim at Pier 51 on 09/06/75. He apparently dove into the water on purpose and tried to swim from pier to pier but tired and went under. The next of kin is DAVID OTTERSON, 31820 - 162 S.E., Auburn, Wa., 833-4654. STANLEY lived at 4420 So. Brandon St., #2.

ITEM:

35. 10/08/75 - 0815 hrs. - Called Det. GEORGE MARBERG at S.P.D. Homicide, 583-2342, who was at the scene of OTTERSON's drowning. He said that OTTERSON was a wino/horn and it is highly unlikely that he could be MULLER's business partner.
36. 1015 hrs. - I contacted DUANE MATTHEWS and GLORIA HAMILTON at the University Branch of Rainier Bank where BUNDY had his checking account. I received photostatic copies of his checks, deposit slips and statements from early 1974. More checks will be coming on 10/09/75. BUNDY didn't have a safe deposit box at any time.
37. 1120 hrs. - JERRY SNYDER came to the office to view the eight photo montage of BUNDY. He tentatively identified BUNDY. This is the same photo that has been in the papers and on T.V., but he was in San Francisco and had never seen the picture before. I showed him a color photo of BUNDY which was in file, and he positively identified BUNDY as the guy who approached OTT and left the beach with her. A taped interview was made of the events at the park and of his identification. He initialed the photos.
38. 10/09/75 - 0910 hrs. - Det. KEPPEL and I contacted FREDA ROGERS at her home, 4143 - 12th N.E., and got her permission to search the garage where BUNDY kept his belongings and his vehicle. There were no evidentiary items there whatsoever. I searched the flower beds and garden area with a metal detector but found nothing.
39. While at the residence, I interviewed:
- JAMES A. DOROS, WM, DOB 09/09/51, 6'4", 190#
4143 - 12th N.E., Basement Apt., 634-3452
Driving Red Chev. pickup, Washington license U 49744
40. He said that the first time he met BUNDY was in June of 1974 when he was a resident. He admired BUNDY for his life style, the fact that he was going to law school and able to live on a nominal budget. He didn't socialize with BUNDY and knew his friend JOHN MULLER better than BUNDY. MULLER has been previously commented on in Items 6 - 9 and 25 - 28. BUNDY was a "nice" guy and reserved. He didn't have any trouble with girls. He drank with BUNDY on occasion at the house and BUNDY got "pretty high" on beer and wine.
41. BUNDY got a little rowdy when drunk, but DOROS didn't describe him as a problem drunk.
42. BUNDY had a small yellow two man rubber raft, but DOROS didn't think it could be rigged up with a sail. BUNDY kept the boat clean as he did all of his belongings.

ITEM:

43. The last time DOROS saw BUNDY was in May - June, 1975, when he drove back to Seattle for three or four days to put in a garden for the ROGERS.
44. He described BUNDY's speech as having clipped, concise diction similar to an Englishman who had been Americanized.
45. DOROS said that he and STAN NIELSEN took over the business of Northwest Marine Collectors in May, 1975, from JIM STYRES and JOHN MULLER. STYRES and MULLER formed the business about three years ago.
46. DOROS interview (Cont'd.) - BUNDY was never involved in the business.
47. NIELSEN and he were diving for octopus on 08/25/75 off Blakely Rock. It was an area they had dove in about 20 times previously and they operated at 80'. NIELSEN was down alone when he failed to surface from 150' of water. The Coast Guard was able to find NIELSEN's bag but no body was ever found. The Kitsap County Coroner is handling the death investigation.
48. DOROS said that MULLER has gone to Australia and is working for the State Department in some kind of security capacity but DOROS did not know if it was the C.I.A. or not.
49. 1400 hrs. - A master list of leads that should be worked, their relative importance and detective assigned was compiled. Leads assigned to me are:
- Contact SCOTT FLEGAL, 5712 - 16th N.E., 525-1949, for information on a ski injury to BUNDY at Crystal Mountain.
 - Contact the witnesses who saw a Volkswagen at High Point 07/14/74.
 - Search the High Point area for a possible sight.
 - Continue the MULLER investigation.
 - Obtain all other bank records.
 - Check out storage places where evidence items may be.
 - Check K.O.A. campgrounds 6/29 and 7/5.
 - Check for sailboat rentals.
 - Check on Geracol A brand handcuffs, made in Taiwan.

53. 1620 hrs. - Called SCHACK's office and left a message to call.
54. 1715 hrs. - Contacted SCOTT FLEGAL
 5712 - 16th N.E. - 525-1949
- and received a group of ski lift tickets that he had saved. He had gone skiing with CHRIS and BUNDY at Crystal Mountain during the Fall of 1973 or Winter of early 1974. He couldn't recall the exact date, but it is represented by one of the lift tickets. He said that on that occasion, BUNDY fell on his ski and got a bloody nose. He doesn't recall him going to the aid station but he got pretty tired and slept in the back seat all the way home. His impression was that it was about Christmas, 1973.
55. (OUT OF ORDER) 1200 hrs. - A.P.B.s were sent to Oregon and Washington, requesting any available data from F.I.R.s, citations, arrests or victim files in connection with BUNDY or his vehicle or the vehicle owned by his girlfriend, LIZ KLOEPFER, OPM 001.
56. 10/10/75 - 0800 hrs. - Received TWX from Oregon State Police with negative record.
57. 0805 hrs. - Received TWX from Corvallis P.D. with negative record.

58. 10/10/75 - 1200 hrs. - Received a phone call from LARRY SCHACK. He had no information to offer other than that he had classes with HEALY and did not know BUNDY. SCHACK also graduated in '72. He has a friend who was associated with Camelot House in the U. District and will have her call the office.

59. 1220 hrs. - Received a phone call from:

WANDA GARFIELD, H/P 546-6750, B/P 365-6050

who said that she was the student director of the Camelot Program for severely retarded children. The program was in the residence of BOB DAY, located on 7th N.E. in the 5200 block. The supervisor of the program was Dr. SCOTT FRASER who is now at U.S.C. and the assistant was Dr. SANDY MARTIN who is now in Texas.

60. The students who volunteered to work with the kids were all "A" students in psychology at the U. of W. From among those volunteers, Dr. FRASER would select those who got to work. She remembers HEALY very well, but did not HEALY knew BUNDY. LYNDIA worked with the kids and WANDA said that she felt sure that BUNDY and HEALY must have had classes or known each other through work seminars sponsored by the Psych. Dept.

61. The program started in '71 and ended in about June, '72. The volunteer students were not paid but received course credits. She said approximately 30 students worked at the program and she will attempt to get the names and call back.

62. 1320 hrs. - Reviewed the case with Lt. MURPHY and received a biographical sketch done by Det. EBLIN.

63. 1400 hrs. - KILLIEN will contact the sales manager at R.E.I. for information on BUNDY's purchases and/or application.

64. 1520 hrs. - re-ran film footage of the Rainier party picnic at Lake Sammamish from 07/14/74 shot by KSTW in an attempt to spot BUNDY, but we could not see him.

65. 1540 hrs. - Called Aero-Marc Communications
5518 Empire Way So.
725-1400

who also had film footage of the park, but they will have to check their film library to see if they retained the film and will call back.

66. 1630 hrs. - Received a call back from Aero-Marc and they said they had erased the video tape taken at Lake Sammamish.

67. The A.P.B. sent out on BUNDY was released via the AP wire service and the Tacoma News Tribune printed the phrase about BUNDY being a "prime" suspect. The paper was placed in file.
68. 10/14/75 - 1030 hrs. - Received a call from WANDA GARFIELD, who said that she had called Dr. SCOTT FRASER in California, and he had the impression that BUNDY and HEALY were in an individual research class at "Camelot" with behavior modification in the classroom. He will have to research all of his personal records for that data. FRASER remembered BUNDY as definitely being a blond. WANDA will call back as soon as she gets the data.
69. 1330 hrs. - Called S/A KUSAK at the F.B.I., MA 2-0460, and requested assistance interviewing MULLER. He advised to contact Air Force Intelligence at Mc Chord A.F.B.
70. 1410 hrs. - Called VAL O'DONALD who is the investigative Unit Chief at Mc Chord A.F.B., 984-2567, and requested assistance in interviewing MULLER.
71. 1500 hrs. - Met with S.P.D. Capt. LEITCH, Lt. MURPHY, Detectives STRUNK and EBLIN to discuss case and request assistance with leads. They will follow-up background, both personal and employment, associations with Republican Committee, HVH, Crisis Clinic, sailboats and storage places in Issaquah, U. District, Tacoma and Olympia.
72. 1600 hrs. - Received a phone call from VAL O'DONALD who said that MULLER is stationed at Alice Springs, Australia, and that base is a support facility for OPERATION DEEP FREEZE in the Antarctica. He may even be on Antarctica. They have no agents at Alice Springs, and suggested going through the F.B.I.'s legal attache with the U.S. Embassy in Australia.
73. 1630 hrs. - Called S/A KUSAK at F.B.I. who will research the possibility of interviewing MULLER.
74. 1640 hrs. - Attempted to call JOHN COWELL who is BUNDY's cousin in Tacoma at the phone listing of 572-6386, located at 308 N. Yakima St., Tacoma. He was not home.
75. 1800 hrs. - Attempted phone call to COWELL - N/A.
76. 1930 hrs. - Attempted phone call to COWELL - N/A.
77. 10/15/75 - 0830 hrs. - Met with Det. STRUNK to exchange information.

79. 1000 hrs. - Called K. M. Snider and confirmed that COWELL is still employed there.

80. 1025 hrs. - Information slip received from S.P.D., dated 10/03/75, from CLIFF MUNSON noted that he received a call from:

LARRY TRIVETT, H/P 659-8176, B/P 659-8282

who said that during the summer of '74, he lived at the ROGERS' residence with BUNDY and a friend named:

DANNY LAZARES, H/P 473-1719, B/P 572-6677

81. 1030 hrs. - Called DANNY LAZARES at work. He and TRIVETT were going to law school during summer quarter '74. They moved in around 06/20/75 and moved out in late August, 1974, at the end of the term. LAZARES didn't know BUNDY well and did not socialize with him. The only time they spoke was about law school because BUNDY was also enrolled. LAZARES said that BUNDY was known as the "Phantom" because he was around for a time, then would disappear for days at a time and then show up suddenly. LAZARES didn't know of any male associates and thinks he saw him with a girl only once. He associated with MULLER who lived in the next room, but even they didn't appear to be that close. LAZARES noticed his car, but never saw him with any strange paraphernalia such as a yellow bike, jewelry, packs, slings, casts, crutches et al.

82. 1050 hrs. - Attempted phone contact to LARRY TRIVETT at home and work - N/A.

83. 1315 hrs. - Contacted Det. HARRY HANSEN and Lt. MARVICK at Tacoma P.D. and gave them copies of the line-up photos from Utah. Their rape case is still up in the air at this time and one of the important facets of the case would be if BUNDY did or didn't have a beard on 11/20/73, since their suspect didn't.

84. 1340 hrs. - Attempted to contact JOHN COWELL at his apartment. He was not home so a message was left for him to call the office.

156. WILLIAM KDENIG was BUNDY's French teacher for two years and is very, very effeminate. KOENIG remembered BUNDY quite well and thought he was such a 'wonderful, intelligent and warm person.' BUNDY told him that the reason he wanted to take French was because his grandfather spoke French. BUNDY got a chance to talk to some French students while skiing at Crystal. BUNDY was pleasant and responsive and even though BUNDY didn't have much of a father figure at home, KOENIG didn't feel that he was BUNDY's father figure. BUNDY was not a group conformist but rather an 'original thinker.' I did not pry into any sexual discussions they may have had.
157. DICK HANNULA was a Physical Education teacher, but he didn't remember BUNDY at all. I asked him about the masturbation incident in the showers and he wasn't aware of any, but said that if incidents like that did occur, the teachers wouldn't have heard about it anyway.

167. After the campaign, he ran into BUNDY a few times after that and had him to their house where he got along great with their youngest daughter and "threw her up in the air." His best working relationship with BUNDY was on the Seattle Crime Commission.

168. STOTLAND didn't think highly of TOM SAMPSON and it was his impression that BUNDY took SAMPSON's place. BUNDY developed an interest in white collar crime so STOTLAND advised him to contact REG BRUCE of the State Attorney General's Office for research data. However, BUNDY was not received well by BRUCE and got thrown out of his office.

I told DAVIS what the burglar tools consisted of and he said that he often saw a ski mask in BUNDY's car, since he was a skier; he had to carry tools to work on his Volkswagen (ice pick and crowbar) and he had rebuilt his Volkswagen from other cars' parts; the rope was there to tow his car and DAVIS had to give him a tow off the freeway one time because his distributor had conked out; and DAVIS had seen HANDCUFFS in BUNDY's car in the past but he didn't know why he carried them around.
239. DAVIS didn't think that BUNDY had been involved in the LUD KRAMER campaign, and said the guy to talk to would be GARY MC INTOSH who ran the campaign.
240. DAVIS will compile a list of all statewide events or elections during 1973 and 1974 and call the office. He will also have his wife SARA call the office since she is better about remembering specific dates that he is.

- TIM CLANCY and GARY MC INTOSH were both on the payroll and have been mentioned previously.
289. However, BUNDY's name appeared nowhere in the KRAMER Disclosure files, either as a paid worker, cash contributor or in-kind contributor.
290. Several contributors were noted from the Southwest Washington area during early May and early August, 1974, but it is unknown if they were mail-in donations or door to door solicitations. Several contributors had consecutive addresses in the Olympia area and were undoubtedly from doorbellers.

ITEM:

485. 01/07/76 - 1500 hrs. - Det. EBLIN called to say that Sgt. JACK ADAMS' son had reported seeing BUNDY in the U. District on 01/06/76, but it has not been confirmed at this time.
486. 01/12/76 - 1600 hrs. - KEPPEL learned that BUNDY was indeed back in town and had been for some time. Capt. MACKIE made the decision to follow BUNDY and that Sgt. LETTICH would be the surveillance coordinator. Narcotics detectives would take the first shift and attempt to locate him at his known haunts. KEPPEL and I were scheduled to relieve them in the morning.
487. 01/13/76 - 0620 hrs. - Sgt. LETTICH called to advise that BUNDY had been located at LIZ's house at about 2000 01/12/76 and was still there.
488. 0750 hrs. - KEPPEL and I relieved TRIPP and HAMBLY on surveillance at LIZ's apartment, 5208 - 18th N.E. TRIPP advised that the lights had been on in her apartment since 0630 hrs. I took up a position in my vehicle on the N.E. corner of intersection of N.E. 52 and 18 N.E. KEPPEL was in his vehicle in the alley behind the house.
489. 0820 hrs. - LIZ came out of the house, walked around the north side and got into her car. She drove south in the alley and lost KEPPEL as he tried to follow her.
490. 0825 hrs. - BUNDY came out the front door and began walking south on 18 N.E. He had on dark rimmed glasses, blue down ski parka, tan flared trousers, dark shoes and was carrying a green satchel under his left arm. He had about a month's growth of beard and moustache. I got out of my car and followed him on foot after advising KEPPEL.
491. BUNDY walked at a normal pace up to 17 N.E. and south into the Campus and was aware that I was behind him. He walked in near the Burke Museum and then back out onto 45th. He turned south on University Way N.E. very aware that I was behind him.
492. With hope gone of a covert tail, I decided to make an overt tail to gauge BUNDY's reaction, so I closed the interval to 20'.
493. 0840 hrs. - He went into the Coffee Corral at N.E. 42 and U. Way and came out a moment later smoking a cigarette.
494. 0844 hrs. - He went into the office of Student Affairs at N.E. 41 and U. Way and walked into Room 170A and inquired about a \$1,000. loan. I positioned myself in the corridor so he would walk by me but as he exited, he only looked at me and didn't make any effort to speak or acknowledge that I was there staring at him.

495. 01/13/76 - 0846 hrs. - He came out of the building and walked back onto campus. As we waited at the light at N.E. 41 and 15 N.E., I positioned myself directly behind him at an interval of 2' but he still did not acknowledge me.
496. 0850 hrs. - He walked up through Red Square and into the undergraduate library. As we got into a crowd, he went downstairs and through the cafeteria in an effort to lose me.
497. 01/13/76 - 0855 hrs. - BUNDY went into a phone booth in Suzallo library. The portion of the conversation that I could hear was, "There's a detective following me - where's the car?"
498. 0858 hrs. - BUNDY came out of the phone booth and went into men's room P 63A in Suzallo library. I paused a moment to catch up on my notes thinking that the restroom only had one entrance.
499. 0901 hrs. - I went into the restroom and discovered that there was a back door that opened into an employees' locker room and an adjoining stairway to the scientific stacks. I checked for BUNDY in the immediate area but he was gone.
500. 0915 hrs. - I checked the Psych. Dept. in Guthrie Hall to see if he may have been en route to talk with Dr. ELIZABETH LOFTUS but he was not around.
501. 0920 hrs. - Called KEPPEL and advised that BUNDY was lost and that he may be headed for LIZ's car which KEPPEL had located near N.E. Boat and 15 N.E.
502. 0940 hrs. - I walked back to my vehicle where Det. STRUNK and EBLIN were driving past. I advised them what BUNDY was wearing in case they spotted him.
503. 0950 hrs. - I drove to the U.W. Law Library at N.E. 41 and 12 N.E. and checked in top to bottom without luck.
504. 1015 hrs. - Guthrie Hall again - nothing.
505. 1030 hrs. - Student Union Building and lounges - nothing.
506. 1050 hrs. - Suzallo Library - nothing.
507. 1130 hrs. - Administration Building - nothing.
508. 1200 hrs. - Called Sgt. LETTICH and advised of the status.

509. 01/13/76 - 1230 hrs. - I drove to MARLIN VORTMAN's apartment in an effort to relocate BUNDY. As I approached the apartment, I spotted BUNDY walking along the sidewalk dressed in a grey hooded sweatshirt, faded green sweatpants, blue turtleneck and white tennis shoes. When he saw me he smiled, I waved and continued past him to the corner of 36 W. and W. Gov't. Way. As I turned south I looked in my rear view mirror and saw BUNDY sprinting into the woods in Discovery Park. It was raining moderately at the time.
510. 1233 hrs. - The district S.P.D. patrol car came by and I advised the officer (badge #284) that BUNDY was in the area. He said he would advise military police and the horse patrol that was in the park.
511. 1245 hrs. - I contacted the cleaners on the corner near VORTMAN's apartment, but BUNDY had not been in. VORTMAN was a frequent customer, but he had not been in recently.
512. 1255 hrs. - I parked in the parking lot south of the apartment house and BUNDY came walking back and entered the door on the west end.
513. 1257 hrs. - BUNDY came out of the east door still dressed in the sweats and smoking a cigarette. He walked between the apartment and out of sight toward the front of the apartment.
514. I waited a moment and then decided to drive around the area to see if BUNDY had another car stashed that he could have driven to the area in since KEPPEL was still sitting on LIZ's car.
515. 1308 hrs. - I spotted BUNDY walking up to VORTMAN's Tan VW, AQB 894, parked on W. Thurman near 34 W. When he saw me, he continued walking past the vehicle and walked down through the ravine on the east side of VORTMAN's apartment so I couldn't follow him in my vehicle.
516. I felt that BUNDY would return to the VW so I returned to it and waited.
517. 1328 hrs. - BUNDY walked up the street to the vehicle. It apparently didn't start so he had to push it and then went to W. Gov't. Way, down through Fisherman's Terminal and north on 15th N.W. toward Ballard.
518. I followed BUNDY down into Ballard's business district and it soon became evident that the only reason he was driving at all was to play tag with the cops. He would drive legally but try his best.

518. (Cont'd.) to lose me. Some typical maneuvers would be: park the car in hopes that I would have to drive by in traffic and/or get out of the car (in sweats) and walk down the block, get one car between us at a stop light and then make a free right turn and then a few more turns in an effort to get free of a tail. It became very easy to predict what BUNDY would try to do but my car was not conducive to quick albeit legal maneuvers. BUNDY was taking great delight in the 'game' and smiled when he would execute a clever evasive tactic.
519. 01/13/76 - 1407 hrs. - BUNDY drove to the Ballard Locks, parked the car and jogged (in heavy rain) back along the railroad tracks and out of sight around the end of the government property.
520. Since BUNDY's behavior had become predictable, I parked my car next to his and waited.
521. 1416 hrs. - BUNDY came walking back to the car from the same direction.
522. I got two impressions as to why BUNDY uses a tactic of parking the car and walking away:
- He hoped that I would immobilize the operation of the car so he could scream 'harassment.'
 - Hoped that I would get out and follow him on foot so he could double back to the car and drive off without a tail.
523. 1419 hrs. - BUNDY made a free right turn at the light at 15 N.W. and Market, and I was boxed in and couldn't follow.
524. 1423 hrs. - I believe BUNDY continued south on 15 N.W. and made it across the bridge before it opened. I didn't however, and BUNDY was lost.
525. 1435 hrs. - I checked around VORTMAN's apartment for the vehicle, but couldn't find it.
526. 1437 hrs. - I got a message from Radio via Sgt. NDLAN to discontinue to attempt to locate BUNDY and return to the office.
527. My impressions of BUNDY during the day while I was following him is that he does not act like a normal, mature 29 year old law student. He seems to thrive on attention just like a spoiled child and that is the only reason that he altered his behavior, which is to say the more 'attention' he gets, the more he eats it up. It would

528. Det. KEPPEL and I reviewed the day's activity with Capt. MACKIE and he made a decision to conduct a periodic spot check on BUNDY with whoever may be in the area with some spare time. S.P.D. will take the same policy.
529. 01/16/76 - 0940 hrs. - Called LARRY VOSHALL's office, 753-7993, and left a message for him to call.
530. 0945 hrs. - Called GLORIA HAMILTON and left a message for her to call, 587-2282.
531. 01/19/76 - 1100 hrs. - LARRY VOSHALL called to say he could not remember a rip or tear in BUNDY's vehicle seat at the time of the raft trip in June, '74.
532. 01/21/76 - 1520 hrs. - Called GLORIA HAMILTON who is still trying (sic) to retrieve copies of checks that BUNDY deposited to his checking account.
533. 01/23/76 - 1415 hrs. - Contacted MARY MC KINNON at Pacific Northwest Bell and received a copy of long distance calls billed to LIZ's phone to the end of the year. All calls were to the Utah area and will be forwarded to Det. JERRY THOMPSON with S.L.C. S.O.
534. 01/30/76 - 1200 hrs. - I received a call from Capt. LEITCH. He had just received a call from ANN RULE. RULE told him about a call she got from BINDY on 01/28/76 at about 1930 hrs. He said that he had a cold and was not coming back to Seattle. BUNDY said that he is confident that he can get acquitted on the Kidnapping charge. He said that he had an alibi partially supported by receipts.
535. 1210 hrs. - I tried to call ANN RULE, 824-0213, no answer.
536. 1215 hrs. - I tried to call DAVE YOCOM, 801-532-7077, no answer.
537. 1220 hrs. - I tried to call Det. THOMPSON, 801-328-7491, no answer.

538. 02/18/76 - 1400 hrs. - I got a call from Sgt. MIKE MUDGETT at UWPB. He was going through some old files and noted that BUNDY came in during May, '70, and offered to be an informant. This was at a time when there were a lot of campus demonstrations and BUNDY was involved in campus groups and didn't agree with the tactics that the groups were employing. He evidently provided valuable information and was into the group far enough to get detailed plans.
539. 02/23/76 - 1100 hrs. - I called CLARK SMITH at the FBI, MA 2-D460, but they had no record of BUNDY ever coming into their office and offering to be an informant during the campus demonstrations.
540. 02/23/76 - BUNDY's trial began in Salt Lake City without a jury.
541. 02/26/76 - The trial ended with the judge deliberating the facts over the weekend.
542. 03/01/76 - 1240 hrs. - We heard a news bulletin on the radio that BUNDY had been convicted of Aggravated Kidnapping. Sentencing was scheduled for 03/22/76. He was remanded to the custody of the Sheriff's Office.
543. 03/10/76 - 1000 hrs. - I received a call from ED LOOMER, who is the Skykomish Marshall, 677-2290. He got a call from Mrs. SULLIVAN, 246-8480, who is JACKIE PLISCHKE's mother. She was concerned for JACKIE's welfare because she was living with a creep in Baring, Wa. and was being held against her will. LOOMER contacted JACKIE and PETER M. SILVERS, WM, DOB 04/25/49, at P.O. Box 398, Rt. 3, Goldbar, Wa. SILVERS is a strung out doper, but JACKIE appeared to be in no danger and was very content. LOOMER had to answer an aid call where SILVERS was spaced out on an acid trip.
