October 21, 1975 (cont.): Denning stopped at C.B.I. with samples of dog hair obtained from Mrs. Robertson who now owns the two poodle-mix dogs which Shelley had. C.B.I. will compare these samples with the samples found at the scene and turned into C.B.I. October 7th.

Denning met with Mr. [REDACTED] and re-interviewed him as to questions that arose since the previous interview. See interview with Mr. [REDACTED].

Mr. [REDACTED] did agree to take a polygraph examination and since he does not own a car this office will have to transport him to Jefferson County.

October 22, 1975: Denning contacted Mr. Roger Burchette at Jefferson County Sheriff's Office by telephone and arranged an appointment for the polygraph examination of Mr. [REDACTED] on October 27, 1975 at 1:00 P.M..

ACTION NEEDED: Notify Mr. [REDACTED] of appointment date and make arrangements to transport him.

CONCLUSION: Due to the lack of connections in reference to the clothing description by Mr. Sullivan and also the fact that all known associates of Shelley Robertson were of a different taste and character Denning feels that Sullivan's identification is in error.

Approximately 2:45 P.M. Denning received a telephone call from Mr. John M. Cook, Wichita, Kansas (316-685-6759). Mr. Cook related that he was at the Holiday Inn on the dates in question when Shelley Robertson disappeared.

CONCLUSION: Mr. Bundy was not using Mr. Cook's identification.

October 28, 1975: Denning received a telephone call from Agent Steve Sedlacek informing him that [REDACTED] had left the State after a warrant had been issued for his arrest in connection with a rape which occurred in Douglas County a few months ago. Mr. [REDACTED] was apprehended in New Mexico where he tried to run a road block and switched identification with his passenger. Mr. [REDACTED] waived extradition and Agent Sedlacek advises he is flying down to pick him up.

Suspect will be lodged in the Arapaho County Jail the evening of October 29, 1975. Bond is set at \$75,000.00.

ACTION NEEDED: An attempt to interview Mr. [REDACTED] regarding the Robertson case should be made.

October 28, 1975: Denning received a letter from Detective Jerry Thompson, Salt Lake County Sheriff's Office, advising Chevron credit cards entered for June, July and August indicate for June 13 and July 9th Mr. Bundy charged gas both times in Salt Lake City. Also Mr. Bundy made several other charges during the last part of July. There is no indication for these charges that Bundy was in the area at the time of Shelley Robertson's disappearance. However, Detective Thompson states there may be charges (credit card) still pending. It seems an unusually long period from June 30th thru July 9th without any use of the card.

Detective Thompson advises he expects a meeting during the first week of November in Salt Lake City in reference to the Bundy cases.

October 38, 1975: Denning telephoned Miss <sup>Ginger Prout</sup> ~~Ginger Prout~~ at 989-4751 attempting to contact <sup>Nancy Prout</sup> ~~Nancy Prout~~ in reference to possible identification of Shelley Robertson as being a friend of ~~Miss Thatcher~~, wife of ~~Robert Thatcher~~. This information had originally come from ~~Tom Sullivan~~ who identified Shelley as being with ~~Bob Thatcher~~ twice as stated in the previous report. <sup>Bob Thatcher</sup>

Ginger Prout advised that ~~Nancy Prout's~~ phone number was 795-3522 in Littleton. Denning contacted Nancy Prout by telephone this date and arranged for an interview October 29, 1975 at 11:30 A.M.. Miss Prout's address is 5579 S. Windemere, Apartment 405, Littleton, Colorado.

Denning received a call from Detective <sup>Sue Drasky</sup> ~~Sue Drasky~~, Ft. Collins Police Department in reference to this case. Detective Drasky specializes in rape cases and also is a distant relative of the Robertson family. Denning arranged to meet with Detective Drasky on November 8, 1975 to review the case with her and to solicit suggestions from her as a specialist.

Denning contacted ~~Mr. [redacted]~~ notifying him of his polygraph examination set for 1:00 P.M., November 4, 1975. Also it will be necessary to pick up Mr. ~~[redacted]~~ as his only transportation is a bicycle.

October 29, 1975: 11:30 A.M. Denning met with Miss ~~Nancy Prout~~ at 5579 South Windemere, Apt. 405, Littleton, Colorado to ascertain whether or not she knew or could identify Shelley Robertson. Miss Prout was shown several pictures of Miss Robertson and she stated that she did not recognize her. Nancy is now studying law enforcement at a college in Arapahoe County.

Denning met with Mr. <sup>Roger Barker</sup> ~~Roger Barker~~, <sup>security agent for Montgomery Ward's</sup> ~~security agent for Montgomery Ward's~~ 555 South Broadway, Denver, to gain information on ~~William C. [redacted] aka Chris Wollerman~~. Mr. ~~[redacted]~~ was a member of Shelley's therapy group and had adopted the name Chris Wollerman for therapeutic purposes of the group. (See previous report reference this subject). Certain data was received from Mr. Barker, reference subject ~~[redacted]~~ who requested this information be kept confidential. See suspect ~~[redacted]~~'s file in regards to this data.

November 3, 1975: Denning received a telephone call from ~~Det. Keppel~~, Homicide Division, King County Police Department, 516 Third Avenue, Seattle, Washington 98104 (telephone: 344-7573) reference suspect Theodore Robert Bundy. Detective Keppel related the following information:

*Bundy has a cousin in Colorado who is a college student*  
~~Bundy has a cousin in Colorado who is a college student, his name is Tom Klespie (Det. Keppel is not sure of the spelling). He was enrolled at Colorado University in September 1974.~~  
*He was enrolled at Colorado University in September 1974*

ACTION NEEDED: Attempt to locate Klespie and interview him. Ascertain dates of travel and Bundy's route.

In the past Bundy has enrolled in college near scene of victims' disappearances.

ACTION NEEDED: Check Colorado University and Denver University for possible enrollment of suspect Bundy.

Both of these schools supply excellent law training. Check the Colorado School of Mines also since it is centrally located to known gas stations that Bundy has patronized in the past and also it is centrally located to the disappearance of ~~Melony~~ *Melony* ~~Cooley~~ and Shelley Robertson. Also check for enrollment of Klespie at these schools, it may be found that this was the reason Bundy was in the area at the time of victims' disappearance. If a record is found, ascertain whether or not the application for Bundy was mailed or delivered.

Bundy was born illegitimate and he has had three different names assumed from his step-fathers. They are: ~~Cowell~~, ~~Nelson~~ and ~~Bundy~~.  
*Cowell Nelson*

When Keppel was advised that the possible connection related to the Arizona garage incident, were sequentially numbered \$5.00 bills used to pay for car repair and the registration of the vehicle was listed to ~~[redacted]~~ and ~~[redacted]~~ Keppel advised that Bundy's girlfriend in San Francisco was named ~~[redacted]~~.

ACTION NEEDED: Write Detective Keppel and ascertain ~~[redacted]~~'s date of birth; then obtain a photo copy of her drivers license.

If this incident proves to be the same Bundy, this evidence may become important at a later date.

When advised that the above incident concerned two colored males, who picked up the vehicle, Det. Keppel advised that Bundy's sister has two colored children.

CONCLUSION: It is possible that one of the colored males was Bundy's brother-in-law.

November 4, 1975: Denning drove to the residence of Mr. [REDACTED] and relayed him to the Jefferson County Sheriff's Department for Mr. [REDACTED] to take a polygraph examination in reference to the Robertson slaying. ~~Deputy Sheriff~~, of the Jefferson County Sheriff's Department, relayed the following information to Denning:

It was his conclusion from the polygraph examination that:

Mr. [REDACTED] had no direct knowledge of who killed Shelley Robertson.

Mr. [REDACTED] did not kill Shelley Robertson.

Mr. [REDACTED] and Mrs. Robertson had a relationship in which much affection was involved, but no sexual relations occurred.

Mr. [REDACTED]'s information concerning Shelley getting into a red pick up was true.

Mr. [REDACTED] did attend school after seeing Shelley get into a red pick up on June 30th and also attended class the day after, July 1st.

CONCLUSION: Mr. [REDACTED] is eliminated as a suspect in this case.

November 4, 1975: Denning drove to ~~Denver University~~ Administrative Office, Law School, and ascertained that ~~Theodore Robert Bundy~~ does not have an application on file with them. This information dates back from the Fall of 1974 to the present time.

November 4, 1975: Denning contacted the Holiday Inn again at I-70 and Colfax. It seems odd that Bundy would come 600 miles, without an alternative purpose other than locating the victim, therefore, Denning checked the schedule of meetings on dates that Bundy purchased gas from the Chevron Station, which is directly across the street.

It appears from the above that the only dates that are consistent with Bundy's appearance would be Stevenson's Chevrolet and the Coors' Company.

Stevenson's Chevrolet meetings consisted of only local persons and they were meeting on Friday's until recently when they changed to Mondays. Therefore, Denning does not believe this showed any significance. However, the Coors' meetings consisted of many non-residents coming from long distances and are held not only at the Holiday Inn but also the Ramada Inn and others.

CONCLUSION: It is possible that Bundy is in some way connected with the Coors' Company and with attendance at the scheduled meetings.

ACTION NEEDED: Contact Detective Jerry Thompson, Salt Lake County Sheriff's Office, and ascertain if there is any background which would indicate that Bundy was connected with the Coors' Company in any way.

November 5, 1975: Denning met with <sup>FBI Agent Jim Horne</sup> ~~FBI Agent Jim Horne~~ in reference to the Arizona incident involving a ~~[redacted]~~. Agent Horne had received a photostatic copy of the suspect's license. The license indicates that this is a ~~[redacted]~~ from the suspect in this case.

ACTION NEEDED: Disregard Arizona incident as it is not related to this case.

*Date Getz* November 8, 1975: Denning received a telephone call from Detective ~~[redacted]~~ at the ~~Boulder County Sheriff's Department~~ (phone: 442-3434) in reference to possible involvement of ~~Bundy~~ in the ~~Maloney~~ ~~Maloney~~ killing.

Denning advised Detective Getz of the following:

1. That ~~Bundy~~ had purchased gas at Salt Lake City and Golden, Colorado on April 14th; and Salt Lake City on April 17th. (This coincides with the date ~~Maloney~~ ~~Maloney~~ was ~~missing~~ ~~April 15th~~; her body was later found in Coal Creek Canyon. Her head had been caved in by a large rock; she was partially clothed; she was having her period).
2. That ~~Bundy~~ had a cousin enrolled in a ~~Colorado~~ ~~University~~ ~~city~~ by the name of ~~Tom~~ ~~Klespe~~ (proper spelling unknown).
3. That ~~Bundy~~ has been known to enroll in colleges where victims have disappeared.
4. That ~~Bundy~~ had also taken the names of ~~Gowd~~ and ~~Nelson~~ by assumption of his step-father's names.

Detective ~~Getz~~ advised that he would check Colorado University for enrollment of Bundy and also check registration records for Tom ~~Klespe~~.

Detective ~~Getz~~ will be at the Aspen meeting and further information exchange will be made at that time.

November 3, 1975: Tex Sullivan was at this office, bonding out his brother, Marvin. He advises that a bartender at the Spaghetti Ranch, known only to him as Ruby, also recognized Shelley Robertson and states that Shelley had been to the Spaghetti Ranch. Tex advised that Ruby usually wears coveralls.

While talking to Detective Roger Burchette in reference to the Harvey Polygraph, Burchette noted that the last victim of Jack the Ripper was named Mary Kelley. It should be noted that on September 28th a Katherine Mary Kelley was reported missing from Telluride, Colorado. It is possible that the murderer of these victims may be identifying with Jack the Ripper.

ACTION NEEDED: Ascertain who the original Jack the Ripper victims were.

ACTION NEEDED: Contact Ruby at the Spaghetti Ranch and attempt to interview her.

November 8, 1975: While reviewing previous reports and autopsy Denning came to the following conclusions:

The assailant of Shelley Robertson was left handed.

1. Most of the injuries to Shelley Robertson were to the front part of her head and body. She was struck in the chest, forehead, cranium and the rear of her head, there was blood found on the right side of her head. This suggests that the assailant was left handed. Possibly the injury to the rear of her head occurred when she fell.

2. Rock samples were taken from the victims right side of her chest. Possibly she was struck in that area with a rock again indicating that the assailant was left handed. The only other explanation would be that her body was weighted, in water, and no large rocks were found in the area. It should also be noted that Melony Cooley suffered head injuries from a large rock.

3. Regarding the question of the right earring missing, if it was removed while she facing her assailant, this again would indicate a left handed suspect.

(Note: Theodore Bundy is left handed) It is possible that the earring was removed after she was prone. She was found lying on her left side.

HOMICIDE: ROBERTSON, SHELLEY K.

11-8-75 continued: Most likely Shelley was not killed in the mine and was dead when she went in.

1. While there was water in the mine there was no water in Shelley's lungs. It is unlikely that she was struck at that location and quit breathing before she hit the ground.

At this date C.B.I. has not yet processed the evidence turned into them by this Department. The question of whether or not the hair found on Shelley's hip belonged to her or the assailant arises. At this time, while Bundy is still in custody, it should be determined whose hair this was.

ACTION NEEDED: Contact C.B.I. and have them process this evidence as soon as possible and all other evidence if possible.

November 12, 1975: The following actions should be taken regarding this case:

1. Set up an interview with Mr. [REDACTED]
2. Attempt to ascertain whether or not any school papers were turned in on the suspected date of the Robertson killing.
3. Contact Bundy's landlord to find out if any rent records were written near the date of the Robertson killing.
4. Attempt to interview Mr. Robert Jones.
5. Attempt to locate Shellie A. Robertson at 2700 South Holly, Apartment 229.
6. Contact Vernal Utah Police Department and ascertain whether a [REDACTED], 1 [REDACTED] North 625th Street East, resides in Vernal. A party giving this name stayed at the Americal Farmer's Lodge on West Colfax June 30th and July 1st. Denning attempted to find a telephone listing for this party and was unsuccessful. It is possible that the name [REDACTED] is an alias.

ACTION NEEDED: Contace Fred Wollerman reference Bundy possibly traveling extensively for the Transactional Analysis group. This could be why Bundy travels throughout the U.S.

Miss Baer knew Shelly very well - they were good friends.

They were both selected in a student group from the Community College, Red Rocks, for a ten week Mexican excursion trip in April and June, 1972. Six months later in January and February, 1973 they returned to Mexico again with Max Abeyta. She related that Shelly and Abeyta were very close but she knew of no romantic involvement.

Miss Baer later received a telephone call from Shelly on June 23, she seemed in good spirits at that time. She also related the following information:

She knows of no friends of Shelly's who owned a red pick-up.

Shelly had never mentioned observing a devil cult to her.

She has never heard of Jeff Williams, Collins or knowledge of Shelly going into the Clear Creek County area.

He could not tell whether it was a local or long distance call as there was a lot of static on the line. However, he indicated that this was normal for telephone service in this area.

Denning interviewed Miss Eckles at Jerry's Conoco, Idaho Springs, Colorado at approximately 10:15 A.M. where she related the following information:

That [REDACTED] had worked at Jerry's Conoco May 7th, 8th and 9, 1975 and showed his address as 97 [REDACTED] Lou Drive, Northglenn, Colorado 80221, phone 451-[REDACTED]. He showed a reference of Brookridge Chevron, Lynn Guetzman, at Littleton, Colorado.

On July 27, 1975 Linda was babysitting for Mr. and Mrs. Jim Crouch, Apartment 310 at the Big Horn Apartments in Idaho Springs. She states [REDACTED] came to the door, advised he was a friend of Jim Crouch and wanted to check on Jamie (the Crouch baby). She told him the baby was fine but he was very insistent and pushed his way into the apartment.

After gaining entry he woke the child and while the baby was playing in the front room he attempted to have the child leave the room several times telling it to go to another room or on the balcony. Miss Eckles at this time kept telling the child to stay with them. At one point he grabbed her and initiated amorous advances which Miss Eckles repelled by screaming. At this point Williams retreated stating "I thought you might be that kind of girl". Miss Eckles then took the child and went downstairs to the club room and Williams followed where they stayed until Jim Crouch came home.

Linda left at approximately 1:30 A.M. and noticed an old, "beat up", Oldsmobile white in color following her. (Possibly 1960 or 1961 year model)

The following day Miss Eckles observed subject [REDACTED] parked near her home, come to the door and rapped at approximately 3:30 P.M., She did not answer the door.

Conversation with [REDACTED] during her time spent with him engulfed:

Previous boyfriends of Linda (he was very curious).

That he had worked at various gas stations since he was 13 years old [REDACTED] was yelling at Jamie frequently.

Linda further advised that [REDACTED] was driving an old, "Elrancho type," pickup when he was working at Jerry's Conoco. The last time she saw him was in the last week in July when he came to Jerry's Conoco for gas. He paid cash.

Miss Eckles was shown a photograph of victim which she could not identify.

Denning: Alright, Mrs. Fisher, going back to August the 20<sup>th</sup> <sup>21 22 23</sup> of this year, last Thursday. Would you relate the events which took place regarding this incident that you reported to us. Go forward from that ~~last~~ time.

Fisher: Well Casey and I were in the area looking at mines and so I said that there was an excellent mine down the road that I had seen water coming out of earlier in the summer and that I thought it would be a good mine if we could get in it. We went down and checked out the mine and found that it was open so we got out our safety lamp ~~and~~ and gear, <sup>and</sup> got it on and went in the mine. When we got back about three hundred or four hundred feet, we started smelling an odor that neither of us could identify ~~and~~ we kept going back in a little farther ~~cause~~ the safety lamp was still on. It wasn't indicating that there was bad air back there, or any other type of gas in the area. We still couldn't identify the odor and it was getting stronger. So we got even with the adit, that the body was later found in the end and we looked around. We saw something white in the adit, but neither of us knew ~~was~~ what it was, and we didn't know what the odor was, so we decided to go back to the office and talk to ~~My Boss~~, Mr. ~~Blonker~~ <sup>Blonker</sup> (?) and see if he knew what the odor might be, and whether or not it was something to be worried about. ~~Neither Not knowing what it was, didn't know whether or not it was poisonous, or not poisonous and we were both worried about ending up dead in the mine.~~ <sup>Not knowing what it was, didn't know whether or not it was poisonous, or not poisonous and we were both worried about ending up dead in the mine.</sup> We were more cautious than anything else. So I talked to my boss and he said <sup>it sounded like something was rotting in the cave,</sup> in the mine. So not to be worried about it...it could be a porcupine or rabbit or something like that or ~~somebody~~ <sup>somebody</sup> could have thrown some garbage in. We both jokingly said, "Maybe it's a body" which we were hoping was not true. Anyway so then Saturday, today, we decided to go back and find out what it was because curiosity was getting immense. We went in, again with the safety lamp, and went back, we went first back into the main shaft that goes straight ahead and then takes off to the right and found that it dead ended, a good place to put the machine. And then went back and when we went through we found that the smell didn't continue into the adit in the back, so therefore it was coming from the side adit. We went in the side adit and then found the body. I was leading and I saw the feet and buttox of a body and I thought that was enough to see. I turned around and came back out and we went down to Berthoud Falls and called the Sheriff. I asked the man at the Standard Station if he knew the number and he did, <sup>so</sup> we called here. <sup>DF</sup>

Denning: OK, You referred to a party by the name of Casey, .....Who was that please?

Fisher: That is Casey Ross, My assistant

Denning: Is that Gordon C. Ross

Fisher: I believe so, I think that is his real name

Denning: You said this you also referred to a, "good mine"...in your statement. What did you mean by a, "good mine"

Fisher: OK, A mine that is suitable for taking heat flow measurements which is basically a dead headed adit which doesn't have natural ventilation that hasn't been ventilated in the recent past...a mine that hasn't been worked. This looked like it hadn't been worked and has never been ventilated, <sup>since it</sup> didn't have any of the paraphernalia around it if it were a ventilated mine.

Denning: Why would that be a good mine?

Fisher: Well, my instruments are sensitive to changes in temperature and changes in temperature regime of the area <sup>yearly</sup> of the interior of the rock. I am trying to put in a place where the ~~season~~ and the daily changes in the ~~winter~~ changes do not effect it. So I want a mine that basically has a constant temperature. If you are ventilating a mine, you will have a constant temperature that is much higher than its normal natural temperature. It will tend to stay constant at because you are venting it with outside air.

Denning: You just referred to a machine. Could you specify what that machine is.

Fisher: It is a Heat Flow Transducer

Denning: Would you spell that please

Fisher: T R A N S D U C E R - That's it, I think. Yeah, that is how you spell it.

Denning: OK, T R A N S D U C E R . What is your occupation, Mrs. Fisher?

Fisher: I'M a geophysicist <sup>or</sup> (sp?) and a student

Denning: Where do you go to school? <sup>or</sup>

Fisher: I go to the School of Mines

Denning: Mrs. Fisher, going ~~when~~ back to when you observed the body the first time on Thursday, could you describe what you saw at that time.

Fisher: We just saw what looked like a white bag or something white. It was kind of low in front and there was a hump in the middle of it and I first thought it was a cement bag, like a cement bag that somebody had gotten wet, and just left it there because the cement had hardened on them and there was no use in carting it out, ~~you know, out of the mine, so they just left it.~~ <sup>or</sup>

Denning: And at that time and date....incidentally would you tell us what that time was approximately.

Fisher: Well it was ~~after~~ noon and it was the last thing we did that day do it must have been about 3:30 or four...some time in there.

Denning: In the afternoon

Fisher: In the afternoon ...would be what I would for sure specify.

Denning: OK, And today approximately what time was it you came upon the body?

Fisher: Well it was approximately ten minutes before I called you. It was about ten fifty when I called you so it would have been about ten forty.

Denning: And when you went to the body, were you at that time looking for a place to put the Transducer?

Fisher: Well, not really, we were more looking for sources of the smell at that time because we had decided to put it in the other adit and we were curious as to what the source of the smell was.

Denning: What did you observe when you came upon the body?

Fisher: Well, I first observed it's feet. Well first you see this white glob because it was covered with something white and over on one side there was more white like whatever it is ... there is a pile of it on the right hand side of the body and then I observed two feet and then I looked up and saw the buttocks of the body. I said, "we have got a body, let's get out of here".

Denning: Did it appear to be discolored? ~~Yes~~,

Fisher: Yes, the feet were maroon in color. The buttocks seemed to be about the same color although it had the ~~whatever the white thing~~ <sup>DT</sup> on it, slightly covering it, but it was still visible. <sup>LT</sup>

Denning: A white thing covering it/... was it cloth or ....

Fisher: I have been trying to figure out what it was and it could be like a toilet paper. ~~That was~~ my first impression .. was that it was wet toilet paper. And I thought somebody had dumped their porta-poty in there ~~xx~~ That makes it real smelly, until I saw the body had feet.

Denning: Did you observe whether it was male or female

Fisher: No,

Denning: Was the body clothed?

Fisher: I would guess no. ~~from the other side~~ It had no shoes on and I could see the folds of the buttocks. I would guess no, but I am not sure.

Denning: Can you think of anything else.....<sup>DT</sup> how close did you ....let me ask this question.....How close did you come to the body?

Fisher: I would say five to seven feet...we didn't actually get that close. We got close enough to recognize the fact that it was a body and we turned around and walked out.

Denning: Were you in the lead or was Mr.....

Fisher: I was in the lead

Denning: OK, Was your dog.....

Fisher: The dog, she was between Casey and I. Casey was holding her collar

so that ...we didn't want her sniffing around whatever we found. Like if it were a dead porcupine or something like that. We were just going to leave it and also we had been told it might be decaying dynamite...somebody had left a box of dynamite and the water had gotten to it and if it was dynamite for sure we didn't want ~~Merke~~ around it because we just wanted to leave out. ~~We~~ If we found a box of old dynamite, we would leave that alone and stay a long ways from it.

Denning: Did you observe anything else?

Fisher: No, other than the odor

Denning: Would you give me the dimensions of the tunnel, the approximate dimensions as you went down toward the body?

Fisher: Well, I would say it is about 5'8" to 6'4ft and it is fairly narrow so it would be about two and a half feet wide...so it is a narrow little adit. Some people might describe it as a dog hole, but it is a little big for that.

Denning: Approximately how far back off of the main tunnel was the body?

Fisher: It was about twenty feet, although I am not horribly good at guessing distances.

(Off record)

Denning: Back on the record,

Fisher: OK, well the mine may have had water running by the body because when we were in there early in July, & late July, we found water coming out of the portal and there was about three feet of water ~~inside~~ in the mine, at the portal. which means that it may have been only one or two feet in the mine where the body was but I am not sure. All the indications around the body were that it had been wet. It was wet. OK

Denning: Officer Bass, do you have a question?

Officer Bass: Was the tunnel used like people go in and out every day or was there beer cans in the tunnel or nobody had ever been in before or what?

Fisher: It didn't look like anyone had been in although there were....this is one of the few tunnels where you can't find beer cans at the very end, but there was a beer can on the way in.

Denning: Approximately, how far?

Fisher: About half way from the one that goes to the body, so about two hundred feet. Also first time in, I didn't observe any footprints but this just reflects since the water has dried out.

Denning: Do you feel that you would have observed footprints if they had have been there?

Fisher: Yes, probably because we watch our feet when we walk in. You know, occasionally up to make sure your heads clear, you could step into mud puddles, holes or there might be a shaft there so you are pretty careful of where you are stepping.

Denning: I see. Anything else Mrs. Fisher

Fisher: I don't believe so

Denning: Mrs Fisher, Do you have any reason for making this statement. Have we promised you anything? Have we made any threats toward you? Is there any reason that you would have made this statement other than voluntary;...or your own free will

Denning: Thankyou Mam. It is now August 23rd, 1975, approximately two-fifteen in the afternoon. Now Mrs. Fisher we will prepare this statement immediately.

(Conversation follows discussing signing of the statement. It was agreed to have Mrs. Fisher and Mr. Ross sign it at Denning's home August 24th between 8 and nine a.m. Mrs Fisher had to get back to Denver)

Denning interviewed Mr. Harvey at his home and was advised of the following information:

Shortly after Shelly Robertson disappeared Mr. Harvey started an investigation of his own. He states that he talked to a bartender at Tony's Bar who told him that a girl came in Monday evening, June 30, 1975, wearing a brown striped dress (as related to be the one Mrs. Rossi observed). Shortly after a man came into the bar and they immediately left. They did not order a drink.

Mr. Harvey related the last time he saw the victim he did walk with her to 34th and Sheridan. At this time she was wearing cut off jeans, a white blouse with a bare midriff (possibly a pull over with colored trim) and Earth shoe sandals. She did not have socks on. It is possible she was wearing a scarf. Mr. Harvey stated that after he crossed the street, leaving Shelly, he heard her call words to the effect of "I got a ride right away". He turned and observed an older model red pickup crossing the traffic lanes and pulling up ahead of Shelly. Harvey described this pickup as being faded red and possibly bearing a yellow license plate. He states that the pickup either didn't have a tail gate or that there was not a brand name on the tail gate. He described the driver as having bushy hair, no glasses and with a full beard. On July 2nd and 3rd, 1975 Mr. Harvey returned to this location between 8:30 A.M. and 9:30 A.M. and believes he saw the same pickup on one of the above dates.

Mr. Harvey had made arrangements with the victim to meet her the next morning, Tuesday. He was supposed to phone her early and get her up. Mr. Harvey did phone but received no answer. He went to the victim's home that morning, knocked and received no answer. Upon looking through the windows he observed a night light which was on and possibly a note on the table near the light. The house didn't look as if there had been a struggle. That afternoon Harvey called the printer shop and was advised that Shelly hadn't arrived for work.

Related to personal information, Harvey advised he had met Shelly at a dance course at Metro College; that they became very good friends (to the extent of putting their arms around each other and holding hands, etc.) but they were never lovers, although the matter was discussed. He states that Shelly used only marijuana and then very rarely. However, she had told Harvey that she had, "done peyote and/or Mescaline - hashish once or twice".

Other items that she had told him:

That she was married to someone in Canada. That this was a convenience marriage and that this man, "Could have been a pro baseball player, but he was out of shape".

She had told Harvey of a girl who was interested in Astrology but had never mentioned devil cults or the occult to him.

She had mentioned "Fred" as being her adopted father in analysis groups.

Mr. Harvey answered the following questions which had arisen since his previous interview. He states that on Monday, June 30th, he left his house at approximately 8:35 A.M. and rode his bike to Shelley's residence arriving at about 8:50 A.M.. Mr. Harvey states it was common for him to do this and spent the early hours with Shelley frequently.

He stated they did have a very close relationship even some romantic involvement, but he did not have sexual contact with Shelley Robertson. When asked if he had any previous record he advised only once when he was charged as a minor in possession of beer in New Hampshire. Mr. Harvey states he was very willing to take a polygraph and requested an afternoon apointment.

On the dates of Shelley's disappearance Mel stated he was taking Child Development (Dr. Susman), Human Development (Dr. Bohan) and Personal Adjustment (Dr. Hoffman).

Denning showed Mr. Harvey the colored photos taken of Kreft's red and white pick-up truck to ascertain if it was possibly that that was the vehicle which had picked up Shelley on June 30. Mr. Harvey stated it definately was not the vehicle.

Denning went on interviewing Mr. Harvey in reference to a possible connection between subject [REDACTED] (" [REDACTED] ") [REDACTED] in light of Tex Sullivan's statements that he had observed Shelley with [REDACTED] in Montrose in October, 1974 and again at the Spaghetti Ranch in Idaho Springs in February, 1975. It should be recalled Shelley was wearing an orange sweater, pink stretch pants, spoon handle ring, cross earrings and spoke with a drawl.

Mel stated he had not met Shelley until January and therefore had no knowledge whether or not she had been in Montrose. He stated he had not seen her in pink stretch pants, orange sweater or cross earrings. He did say he recalled something about a spoon ring.

Mrs. Fox related that Shelly had spent Saturday, June 28th with her, also that she had stayed Saturday night and then on Sunday, June 29th they did attend a church picnic in Coal Creek Canyon. This was through the Church of Christ, Pastor Jim Koob, 72nd and Sims, Arvada, Colorado.

They returned from the picnic about 7:00 P.M., Molly took Shelly home at 8:00 P.M. or 8:30 P.M.. Mrs. Fox sat on the porch swing a couple of minutes, said good-bye and "gave her a hug". (It is noted that this is approximately the time Mrs. Rossi gives as seeing Shelly with a man. Mrs. Fox has short hair and it is possible that this was the incident Mrs. Rossi observed).

Molly related that Shelly had been wearing regular levi shorts with ragged edges and that they were faded. Shelly had on a halter top (no bra) and possibly sandals or tennis shoes.

She stated Shelly had felt sad about Ron Christenson leaving and that she was looking forward to a phone call the first part of the week. Shelly made two phone calls from Molly's residence, one to Fred Wollerman (no answer) and one to the church about the picnic. It is possible she made others which Molly did not know about.

When asked about possible suspects from the theorpy group she replied reluctantly she knew of one member who seemed "Catatonic"; "Someone who does not respond to reality, physically or mentally, if subjects arm is lifted over their head, they will hold it there until someone moves it, subject does not respond in any way". Suspect was known to her as Chris Wollerman, an alias used for theorpy group purposes.

She stated the subjects real name was [REDACTED] last name unknown, and that he had been a dock loader at Wards. She related an instance when the suspect had told her that she was his girl during the Civil War, before he was shot and killed. Apparently this had reference to reincarnation. Molly states subject went to North Carolina for approximately two months and then returned to this area. She went on to say that he had studied for the Mormon Church to be a minister, but then joined the Marines. Subject was known to be a security guard and to own a gun (See Denning's supplementary report dated 09-10-75, reference follow up investigation this party).

This will be a summary of a suspect developed in the killing of the girls in the Salt Lake area, and possibly into surrounding states, being compiled by ~~Detective Jerry Thompson~~ of the Salt Lake County Sheriff's Office, Homicide Division.

The suspect is a ~~THEODORE ROBERT BUNDY, DOB 11-24-46~~, white male, 5'11", 170 pounds, brown hair, blue eyes. Salt Lake County Sheriff's Office arrest number is 78058.

The subject first basically really came to light in my eyes on 8-16-75 when he was arrested by a Highway Patrol trooper in the early morning hours driving around a subdivision, and in his vehicle he had a satchel full of numerous items--handcuffs, pantihose, a ski mask, ~~strips of rope~~, a crowbar, an ice pick, etc. His explanation for these items was very poor.

On 8-21-75 this detective picked the subject up from the Salt Lake County Jail and took him to his apartment at ~~665 First Avenue #2~~, where he signed a consent search of his apartment. A thorough search was made of the apartment by this detective. Basically, we came up with only three items--a Colorado map, a brochure from Colorado on the ski resorts in the state, and a recreational type brochure from a Bountiful recreation center, also one book called the Joys of Sex. Before finding these particular items, the subject was asked by this officer if he had ever been to the state of Colorado, if he had ever been over there skiing. His comment was, "No, that is one state I have never been in." He was asked if he had ever been in the town of Bountiful, just north of Salt Lake, and he stated, "Not to my knowledge; if so, I've just passed through." In finding these items, he was asked by officer how come he had them. He had another explanation for everything, that a friend, he couldn't remember who, left them in his apartment, he didn't know why they were in there. The subject was then asked for his permission



to look through his car and also to take photographs. Photos were taken of his Volkswagen vehicle, which at this time was bearing ~~Utah license~~ ~~115 270~~ ~~68 Volkswagen~~, registered to the subject. The color was either an off-white or a light brown or light beige. Observed in the vehicle at this time is that it did not have a front bumper nor a front license plate, and that in the back window the back seat on the top had a large tear across the top; also, there was a different paint coloration on the right door and towards the fender. The subject never at anytime asked why or what we wanted any pictures for or anything else. He was asked to come into the office the next day and talk to myself and Capt. Hayward, to which he stated he would be more than willing to, again never asking what for. The very next morning we received a call from his attorney, John O'Connell, who stated that his client would not come in, he had advised him not to come in and talk to us, and he wanted to know what we wanted to talk to Bundy about, we surely didn't think that he had killed all these girls. He was informed negative, we just wanted to talk to him.

From this point on, a more thorough investigation went into the individual by myself; Mike Fisher from the District Attorney's Office in Aspen, Colorado; Sgt. Bill Baldrige from the Pitkin County Sheriff's Office in Colorado; Milo Vig from the Mesa County Sheriff's Office in Grand Junction, Colorado; and Lt. Ron Ballantine from the Bountiful City Police Department and the rest of his staff; and Robert Keppel from the King County Sheriff's Office in Seattle, Washington, and his staff. It was then learned from Mike Fisher from Colorado, where he obtained some charge receipt invoices from Chevron Oil, after having been given Bundy's credit card number by this detective, and came up with the first 6 months of 1975's charge cards. The rest had been subpoenaed by this detective and are awaiting arrival, for the years of 1973, all of 1974, and the current 1975. It was observed at

this time, however, of particular notice that on 1-12-75 the subject bought gasoline in Glenwood Springs, Colorado, two times on this date. This is the date in question when ~~CARIN CAMPBELL~~ turned up missing and was killed out of Aspen, Colorado. Glenwood Springs is just a short distance from Aspen. Again of particular notice, on 3-15-75 the subject was observed buying gas in Golden, Colorado; also on the same date in Silver Thorne, Colorado; and the same date in Dillon, Colorado. This is the date when ~~JULIE CUNNINGHAM~~ turned up missing from Vale, Colorado, and has never been seen or heard from since. These towns are all within a very short distance of the ski resort. Again, in April of 1975, on the 4th, it was observed that the subject bought gas in Golden, Colorado; in the 5th in Silver Throne, Colorado; on the 6th in Grand Junction, Colorado. This is the date when ~~RENISE OLIVERSON~~ from Grand Junction, Colorado, turned up missing and has never been heard from or seen since. Her bicycle was recovered along a street. Bundy's whereabouts other than that are not known, other than that he was living in the Salt Lake area during October and November, the time that are girls were missing, and that he was living in Seattle, Washington, in the early part of 1974, when the 7 or 9 girls were missing up there.

In an attempt to learn more about this individual, a subpoena was served on Mountain Bell by this detective, and I obtained telephone receipts of his long distance phone calls. Ones of particular notice were to a Dr. R.N. HIRST in Ogden, Utah, phone 394-9230; and ELIZABETH KLOEPFER, who lives at 5208 18th N.E. in Seattle, Washington, phone 206-525-4494. Several others were noted and are on record, but these two are of significant value. In checking out the call to Dr. Hirst in Ogden, it was learned that this subject is the father of Bundy's girlfriend, Elizabeth Kleopfer, and that he was familiar with the subject. An interview was made with the doctor by this

detective and Lt. Ron Ballantine. From this interview it was determined that it would be of great value to interview his daughter in Seattle, Washington.

On 9-17-75 this detective, ~~Detective Ira Deal from Beaufort Police Department~~, and ~~Detective Dennis Couch from the Salt Lake County Sheriff's Office~~ went to Seattle and talked to Elizabeth Kloepper. It was of particular interest to this officer that his girlfriend had numerous doubts about him, going back to when the girls turned up missing in the Seattle area and had at that time contacted the King County Sheriff's Office with her suspicions. Her suspicions first started approximately June or July of 1974 when Seattle put out a composite which resembled Ted very much, according to her, and also that the subject's name was Ted. From then on she claims that she found numerous items in her apartment which were unexplained, like plaster of Paris, elastic bandages, which the subject so called used up in the Seattle area, which Bundy could not explain to her. She also found a meat cleaver, an ax, and a large knife in her apartment, which he could not explain to her. Her lug wrench from her Volkswagen was taken out of the trunk and it was taped about halfway up and put in the front seat of her vehicle. He told her that that was in case she ever needed it. He was observed on other numerous occasions of going out during the middle of the night most of the time, and one particular time he hid an object in his pocket, which she later found out to be ~~knives and gloves~~. She claimed that he napped a lot during the day and was out during the night; that he followed her and her girlfriends and seemed to like to jump out or come out from behind the bushes and grab them just to scare them. Things from here had just built up, and in Liz's opinion, she is still very fearful of the individual and believes that he is the one involved. His sexual habits, according to her,

have changed tremendously. She has known him for six years, and just this last year his sex habits have changed considerably, which is on another report. Another girlfriend in the Seattle area was confronted about him,

~~Mary Lynn Chino, DOB 2-16-45, who lives at 914 West Emerson in Seattle,~~

home phone ~~882-8289~~. She more or less substantiates the same feelings as Liz does about the subject. Between the two of them it was found that his family background goes as follows: his <sup>father is a cook at Ft. Lewis</sup> ~~father is a cook at Ft. Lewis~~

~~in Washington~~

~~in Washington; his mother is a secretary at Puget Sound University~~

do not have a lot of money; there are five or six brothers and sisters in the family; they are originally from Vermont or Pennsylvania; they apparently came to Seattle in 1969. The subject was told by a cousin that he was an illegitimate child and that his parents have never really told him that; they claim that has had quite a bearing on his life. They claim that the subject is a petty thief and he has stolen televisions and numerous items up there; that he is an individual that has a champagne diet and a beer income, he does not have money. In fact, at the present time he needs money badly for his tuition. He asked his girlfriend for \$700.00 to help pay attorneys' fees. This subject does have a college

~~degree from the University of Washington, a B.S. degree in Psychology,~~

He is presently attending the University of Utah in Law School. He has been quite ~~prominent in the Republican Committee in the Seattle area, and the~~

~~Governor Evans' campaign in 1972.~~ He appears to be definitely a loner,

according to everyone we have contacted. We have been unable to come up with any close friends at this time, other than Elizabeth, his girlfriend.

They claim he has a tremendous personality when he first meets people, but shortly after you can see through him and the fact that he likes to use you. They all described him as very educated, a very handsome individual,



and a tremendous personality.

An around-the-clock surveillance has been put on the subject by our office and Bountiful Police Department in an attempt to locate or come up with friends or associates. We have been unable to come up with this, even during our surveillance. We did come up with the information that he ~~joined the Mormon Church~~ a month or so ago and went to one of their overnight outings at Sweetwater in Bear Lake, Utah. He appeared to stay for the most part alone up there. He does not appear to have any close friends that we have been able to come up with up there either. We have come up with one possible girlfriend, a ~~MARGUERITE CHRISTINE MAUGHAN~~ ~~DOB 3-20-47~~, who lives in the same apartment complex at 565 First Avenue apartment 1 in the basement. She was observed with this individual on two or three occasions. It should also be noted that she does have an arrest record with our office for Possession of Narcotics and a Shoplifting charge.

That basically is all that we know about the subject at this time.

~~On 11-8-74 a CAROL DeRouch was abducted~~ from the area of the Fashion Place Mall this evening in a Volkswagen she describes as an older model, light in color, with a large tear in the back seat across the top. Also, there was a discoloration or some type of marking on the right door and fender. The subject attempted to handcuff her and got both handcuffs on one wrist. He also produced a small calibre weapon, unknown on the calibre, and at one time produced what she describes as an 8 sided lug wrench, or something to that effect. Since that time, this detective showed this victim numerous pictures, approximately 40, with the suspect Bundy. She pulled out Bundy's picture, giving all the rest back, stating she had not seen the individual in there. When questioned about the one in her hand, she stated, "I don't know why I pulled it out, I guess its because he looks like him." She was then shown the photos that I took of the subject's car. She stated that in her opinion it was the same color, the same type of tear in the back window, and the only thing she could tell me was that looked like the vehicle that she was in. Since that time, Bountiful Police Department officers showed her a group of drivers license pictures, along with the subject, and she pulled out the suspect's picture, stating, "I believe that's the man, but I cannot be positive." She was then taken up in an attempt to eyeball the vehicle in person. At this time the subject had put in a new back seat or else had the back seat repaired, there is no tear in the back of it. He has put on the front bumper and the license plate. The hubcaps are changed from what originally photographed by this detective, and it appears that the vehicle has been painted a darker brown color than originally painted. Also, the Bountiful Police Department took both photos of the subject and showed them to their witnesses at the

Bountiful High School, who saw the so-called suspicious person on the night of the ~~DEBBIE KENT~~ disappearance. They pulled a drivers license and mug shot photo from a group of others out and stated, "If you would put a mustache on the man I would say that that was him" ~~put a mustache on the man I would say that that was him~~

It should also be noted that the ~~subject's attorney, John O'Connell,~~ called ~~Bob Keppel,~~ King County Sheriff's Office in Seattle, Washington, and made the comment to him that the police in Salt Lake were harrassing or bothering his client and that he wanted to know basically if they thought he was involved in the killing of the girls in that area, that his client definitely was not and that his client would be more than willing to come in there and talk to them about this if this is what they were looking at him for. They informed him that he could come in and talk with them anytime and they would be more than happy to talk to him about anything. What the Salt Lake authorities were doing here, they did not know and they suggested that he talk to the Salt Lake police. They stated it appeared that he was more or less fishing wanting some information about what we knew about his client.

Also it should be noted that a Detective Bob Denning from Clear Creek County Sheriff's Office in Golden, Colorado, contacted this officer and stated that they had found a nude female down in a mine shaft late in August and it was determined that she turned up missing around July 1 or July 2 of this year. He was inquiring if we had any information that this subject was in that town at this time. I do not have July records from the Chevron Oil Company to see if he was over there in July. They are in the process of obtaining them now. He was in the Golden, Colorado, area however on two occasions, one in March and one in April. A copy of his report is being sent over in regards to his case.



The below will be an interview taken by Detective Jerry Thompson of the Salt Lake County Sheriff's Office on 9-17-75, taken from the King County Sheriff's Office in Seattle, Washington. The interview is with an ~~ELIZABETH~~ <sup>5208 1977</sup> ~~HIRST KLOPPER~~, DOB 4-19-45, ~~823~~ Northeast, Seattle, Washington; employed at the Medical Instruments at the University of Washington.

The above subject was interviewed by this officer, however, she refused to be interviewed or talked to or answer any questions as long as the tape recorder was on. So, therefore, notes were taken and the interview will be put on this tape according to my notes and what I can remember.

The only one present during this interview was myself, and the subject. After explaining the situation to the subject, that I would like to use a tape recorder, that I was a bad writer, and that I needed it to keep notes, she immediately wanted to know who would hear it, who would have access to it. I informed her that it would be strictly confidential between myself and my captain. She stated no way, that she would be more than happy to talk and cooperate, but she did not want it on a tape. She was fearful that her boyfriend may hear it.

She was <sup>ASH</sup> how long she had known ~~TED BUNDY~~. She stated that she has known him for approximately 6 years and has gone with him off and on in that period of time. She stated that she met him in a local bar in the Seattle area. They were very serious at several times and were going to get married a couple of times, but there is definitely not going to be a marriage now. She was asked if she was not the person who came forward last year to contact the Seattle Police in regards to Ted. She stated that she was. She was asked if she would explain that situation and why she went to them and what made her suspicions grow. She stated she was first aware of it when a composite drawing was shown in the newspapers and on the TV in the Seattle area, and that her and a girlfriend commented one day, "You know who that looks like. Somebody that me and you know."

She said, "Yes I know, very much." She said then she started looking back, and that according to the papers' call of when the girls in the Seattle area were missing, she noticed that he was never with her on those particular nights, that he was somewhere else unknown. She stated that then he moved to the Salt Lake area and was going to go to Law School in September of 1974; and that a girl-friend of hers went to the Salt Lake area, and while down here in the Fall, she read the newspaper accounts of one of the missing girls. When she went back to Seattle, she told her, "That's exactly the same as the girls are in Salt Lake and Ted is down there in Salt Lake now." She said that she started to think more and more strongly about him. She stated it was at that time that she had gotten a hold of her father in Salt Lake, who is ~~DR. HIRST~~, and was very concerned, as she had found numerous things also in his apartment, like ~~a pair of crutches, a meat cleaver~~ <sup>a pair of crutches, a meat cleaver</sup>, a ~~large Oriental type knife in a wooden holster type case~~ <sup>large Oriental type knife in a wooden holster type case</sup>, which was in the glovebox of her car, and he borrowed it quite often. She stated that she was upset with the Seattle Sheriff's Office, and the main reason she was is that she didn't think that they got a hold of the Salt Lake office, that she had asked them numerous times to get a hold of us and talk to us about Bundy in Salt Lake because of her suspicions; and she did not think they did because she never heard anything from them, and that's why she asked her father to get a hold of us. She was very optimistic again as to who was going to hear this interview and if I would let him know. She was informed that I would not tell him. I asked her if she would tell him that I was talking to her, because I know she is still communicating heavily with him. She stated, "I really don't think I will. I'm an individual that one minute I don't know what to do. I keep praying about it and I keep praying that you'll find out, and I guess I keep hoping that you'll find out that it's not Ted, that it's someone else. But deep down I'm just not sure." She was asked if she could give me the individual's hang-ups, or what her suspicions



were, or what she really suspected him of. Going back to again to the composite, etc., her finding the meat cleaver and the knife, a pair of crutches, and a roll plaster of Paris in the drawer after snooping around. When she confronted him with it, he stated, "Oh, I stole that from the medical supply place," at the University where he was working. She asked him why, and he stated, "I don't know, I guess just for the hell of it." She confronted him about the crutches, and he stated that he used them for his landlord. She claims that one day she also observed in his apartment in the Fall (she is not sure if this is the Fall of 73 the early part of the year) a paper sack in his apartment, and the only thing she noticed is that it was full and the top item was a woman's bra. She believes that the rest of the items were women's clothing, but stated she did not look any further. She never mentioned it to him because she was fearful and also a little bit embarrassed to ask him what was in there or why he had women's clothing. She was asked if she could tell me anything unusual about this individual, about his reactions in the last year that were different from the year before. She stated, "Very much so." She stated that during the summer of 1974, just before he was moving to the Salt Lake area, his sex drive became very, very nil, or very small, which was very unusual for him. She stated she immediately confronted him about having other girlfriends, to which he stated that wasn't true, that he was just working hard and his frustrations were up too high and that was the thing. She stated that just before he went to Salt Lake she even wanted to throw a kind of a going away party for him, and that even refused to have sex on this deal, which was very unusual for him. She was asked if she could enlighten me on anything about his sexual behavior, if it was any different or unusual in her opinion. She stated no, other than the fact that it was late in 73 or early in 74 when he got a book called the Joys Of Sex. In this book he found and read items about ~~that~~ ~~intercourse~~, and since that time ~~he heavily desired to do this~~. She stated she



did not relish this idea but she went along with him. She stated he also found ~~some items in the book about girls being tied up and bound.~~ She stated that she

~~\_\_\_\_\_~~  
~~\_\_\_\_\_~~ and have intercourse that way, only twice, and she did not like it, it was very distasteful, and she wouldn't do it with him again. She stated he did not make too much comment about this but he appeared that he didn't like the idea. She was asked if he liked her hair the way it was now and if he ever commented on or looked at other girls who had hair like hers. She stated yes, that he liked her hair long the way that it was and if she mentioned that she was going to cut it, he got very upset and told her no, that he liked her hair, he liked long hair very much so. To her knowledge, the only other person he ever went out with was another girl, who she does not know, who had hair similar to hers. She was asked what kind of cars had he had during the time she has known him. She states, "The only ~~two vehicles~~ I know that he's ever had or driven are the ~~light brown or beige Volkswagen~~ that he has now and the ~~old white truck~~ he bought just before he went to Salt Lake." She states that he has driven her Volkswagen, which is light green in color. She was asked if she knew if he had a tear in the seat of his Volkswagen. She stated, "Yes, he had one along the back across the top, like mine," and they assumed that had happened from the sun coming in the back window. She was asked if she knew that he had changed that and got it fixed and changed his car. She stated, "No, I didn't know anything about that." She was asked if she thought that he told her everything, if he told her the truth, and she stated, "No, I've caught him in several lies." He denied being arrested by the Salt Lake County Sheriff's Office, and when she confronted him with him it, he told her it was a traffic violation, to which she told him he was lying, that he had some items in his car that she had heard about. " stated to her, "Yeah, they didn't mean too much. I had a ski mask in there that

I used last year when it was cold for skiing, and a couple of other things they were trying to make a big deal out of." He stated that he had nothing to worry about, that it was an illegal search and there was nothing to it. She was asked if she ever knew him to have gone out and robbed anything or stolen anything. She stated yes, that the past while he had been real hard up for money and he had been stealing things lately. She stated that she knows that he stole a television and a few things in the Seattle area. She stated that at one time, and this is the only time that she can remember, he told her that if she ever told anybody about it or anything else, he told her, "I'll break your fucking neck." She stated that's the only time. She said, "I know he stole a bicycle somewhere too and gave it to someone up here in the Seattle area." She stated she had confronted him about these things and he stated, "No, I didn't steal the bike." He stated that the TV was the only thing he had stolen. She stated that she has communicated with him quite a bit, that he called her again last night and that he was completely different again, he was all lovey-dovey, telling her how much he missed her and he wanted her to marry him and all these kind of things. She stated he also wanted her to get him \$700.00, which he claimed he needed for his attorney in Salt Lake. She stated that he is hurting for money, as far as she knows financially. She was asked about how he got money and what his family was. She stated that his mother works at the University of Puget Sound as a secretary and does not make too much money and that his father is a cook at the Army camp, she believes in Fort Lewis, that they have a total of two girls and three boys in the family and Ted is the oldest. She says the father is probably one of these guys that's really not too sharp, doesn't make very much money, and he and Ted don't get along too well. She states in fact it is not his real father, that Ted was an illegitimate child, but his mother has never told him that and he found out from a cousin of his when he was around 18 or 19 years of age, she believes. But he has never told



his mother that he found out. She says this has bothered him and really upset him an awful lot. She was confronted again by this officer numerous times during the interview, asking her that she really wasn't sure, was she, that she had a doubt in her mind that he may be involved in some of these killings, and she stated to this officer, "Yes, I keep praying all the time and hoping that you will find somebody and that it won't be him. But I can't get him out of my mind, and I guess I'll always have that doubt. The more I hear about him, the more it sounds like to me that he could be involved." She stated, "I heard from the Seattle Police from Kathy that he went to Colorado and that he denied telling you he has ever been to Colorado." She stated, "Was he over there? Can you put him there at the time of some of these girls' deaths." I told her that that I couldn't tell her, I didn't know. She begged me, stating, "I've got to know. Because if he was over there at those times, then I would be sure." She was also shown a picture of a female by the name of <sup>MARGUERITE MAUN</sup> ~~MARGUERITE MAUN~~, a drivers license photo, and was asked if she had ever seen this girl. She stated, "No, whose that?" I would not give her the name, I told her that it was a friend of his. She made the comment, "Well that even puts more icing on the cake." She said, "What do you mean by a friend?" I told her, "Well, he's a, you know what a friend is." She said, "You don't have to say any more." She stated the thing that got her, and she didn't know, is when he called her the other night he said that the police knew that he was coming to Seattle to sell his car. I asked her who had told him, and she said, "I don't have any idea. I don't know how he could know, and I don't know myself, because that information was relayed to us by Kathy from the Seattle Police Department to us, and we have not confronted this man whatsoever from that time on, so I don't see any way that he could come up with this, this is a story." She also stated, going back to the deer hunting trip with her father, she wasn't positive on the dates, but from talking to her



father, it was a Sunday when he deer hunting on the 20th. She stated that he is an outdoorsman, he likes to be outdoors quite a bit. He is no fisherman or hunter or anything like that, but he does stay in the outdoors quite a bit. She was asked if he is a skier. She stated <sup>he has skied a little bit</sup> ~~he has skied a little bit~~, that she's been to Park City skiing with him, that she's been to Snowbird and places like this with him. She stated that her dad calls him a schizophrenic, which she asked for an explanation of that, which I told her. She stated, "The more I think of it now he's right, he is two kinds of people. I couldn't see it before, but he has been using me, and my dad's told me this but I never believed him. But I can see that he is now, he wants \$700.00 for his attorney and he needs \$500.00 for school." She stated that he tried to butter her up the other night wanting some of this money. She was asked out of the clear blue sky if she had ever seen him wear a <sup>mustache or a beard</sup> ~~beard~~. She stated, "Not a mustache alone but a full beard and mustache. He <sup>had a fake one an imitation mustache that he</sup> ~~had a fake one or an imitation mustache that he~~ had in his desk drawer and he <sup>carried it with him usually most of the time</sup> ~~carried it with him usually most of the time~~". I asked her to describe it, and she stated, "It was nothing fancy, just more or less like a bush one." She described it as just a regular one growing down towards the lip, not curling or anything like this. She was asked when he wore it and why he had it, and she stated she didn't know when he wore it, just once in awhile when he was teasing around and asking her how he looked in it, if he looked neat, and this kind of stuff. Other than that, she states he hasn't worn it with her, he has put it on two or three times. She was also informed by this officer that there was a \$10,000.00 out for any information in the Salt Lake area in regards to the killings of our girls, and that everything would be kept confidential. She stated, "I will work with you, I will do anything for you, because I'm just not sure. I like him one minute, but on the other minute I keep telling myself, but I don't want to, that he is involved. Too many things point to him and he has lied an awful lot

to me." She was asked if she would not confront him with the conversation between the two of us. She stated she would try not to, that she is a very compulsive girl, and that at times she just doesn't understand herself.

It should also be noted on this, this interview was conducted in a room in the Seattle Police Department, in the Polygraph Room, with a two-way mirror and also with a device where Ira Beal, from Bountiful Police Department, and Detective Couch, from the Salt Lake County Sheriff's Office, sat and listened to this conversation. Detective Beal took notes as much as he could, and he will be making a report off of that. This officer took what notes he could. A lot of times while I was taking notes it seemed to distract her and upset and she wanted to know why I was writing these things down. It should be noted that the girl was extremely nervous during this interview, that she smoked exactly one full package of cigarettes. The interview lasted approximately two hours. She was also informed that I would get a hold of her the next day and talk to her again, as she had to leave to pick up her 9-year old daughter.

This is an interview of ~~Elizabeth Koteppner~~, 5208 - 18th NE, Seattle, Washington. She works at the University of Washington Medical Institute. Elizabeth goes by the name of Liz.

Elizabeth was asked when she first became concerned about Ted and as to why she became concerned about him and thought that he might possibly be involved with some of the girls that had been slain in the Seattle area. She stated that she first became concerned because he resembled the composite drawing which had been produced in the Seattle area and in following the newspaper reports she discovered the days the girls turned up missing he was not with her on any of these days.

She stated in October a girl friend of hers whose name is unknown at this time had visited Utah. Upon returning from Utah told her about a similar incident in the Salt Lake area which involved a missing girl very closely resembling that of the ones in the Seattle area. At this time Liz contacted the Seattle Police and advised them of Ted Bundy and asked them to contact the Salt Lake Police and talk with them in regards to him.

She stated that later another girl turned up missing in the Salt Lake area, this one as she recalled approximately Christmas time. At that time she contacted her dad who lives in Ogden, requested he call Salt Lake County Sheriff's Office and inform them of her suspicions. He had told her at this time that he did not wish to do this as he had no evidence and did not wish to become involved in the situation. She stated when he informed her he would not do this she herself called Captain Hayward and spoke with him at that time.

Liz was then asked if she knew where Ted received his money for his schooling and other bills. She stated that she did not know for sure. As far as she knew just from jobs he had.

This officer inquired as to whether or not his parents supplied some of the money. She stated she did not think so as they were not wealthy people and his father works as a cook at the Madison Army Hospital and his mother works as a secretary at the hospital at Puget Sound and they live on a moderate income.

Liz was asked if she thought Ted was being truthful with her. She stated no. She was asked as to why she thought this. She stated that she knew he had lied to her in the past. She stated he has stolen items in the past such as a television and a stereo, a bicycle and possibly other items and at that time he had lied to her.

She was asked if she knew when he had purchased the vehicle, the volkswagen, he is presently driving. She stated he had owned the car since approximately 1972. She stated the color was a light beige at that time.

She stated he purchased a white ford pickup which he has presently in the Salt Lake area about one year ago just before he left for Salt Lake City. She was asked if she had ever gone skiing with Ted. She said she had gone skiing one time at Snow Basin, however, could not remember the date. She also drove up to Snow Bird with him last year, however, it was too crowded and they did not go skiing. She was asked when the last time was that she saw him and she stated in August of 1975. She was asked if at that time they had gone to the Park City area. She stated they had not. She did state, however, they had spent some time at Flaming Gorge at her dad's trailer.

She was asked if he liked the outdoors and she stated he did like the outdoors very much. Liz was asked if Ted had asked her anything about any of the girls that had been slain. She stated that he knew he was a suspect in the slaying of some of the girls in the Washington area and that he has known this for approximately 10 days to two weeks as someone has been in contact with him from the Washington area who has been contacted by the Seattle area police. She was then asked if he had said anything to her in regards to being a possible suspect in any of the girls in the Utah area. She stated he had not.

She was then asked if she knew whether Ted traveled much. She stated he was not much of a traveler. As far as she knew he did not travel very much at all. She was then asked if she was very close to him. She stated she was very close indicating that they had in the past had sexual relations. She was then asked if over the past year he had changed and she stated no.

She was then asked if she felt he sometimes had two different personalities or acted like two different people. Her response was I think he is now. She was asked why. She stated that she has of late seen a side of him which is very cold and calculated. Liz was asked about how her father got along with him or what her father thought of him. Liz stated her father gets along well with him, however, he thinks he is just an opportunist that is taking her for a ride. When asked if she felt this way she stated well, he always ate at her house and at that time they talked of plans for the future, which would include plans for marriage.

Liz was asked how long she had worn her hair in the style that she is presently wearing it which is long, dark brown hair parted in the middle approximately shoulder blade length. She stated she has worn this for approximately the last six years as long as she has known Ted.

She was asked if he liked the way she wore her hair. She stated that she had at different times stated she was going to cut it which he became somewhat upset stating he liked it that way and not to cut it. She also stated that he had dated one other girl she knew and she also had long dark hair.

Liz was then asked if there was any unusual sex hangups that she was aware of. Her first response was he has a normal sex life and then went on to elaborate that at the end of 1973 he asked her one night if he could

She stated that he also developed a like for anal intercourse during this same period of time.

She stated that she only allowed him to tie her up a couple of times but the last time he tied her up while they were in the act of their sexual relations that he however, at that time she did not say anything to him in regards to this, however, she refused to be tied up any more after that. She stated he had obtained these ideas from reading a book which he had purchased by the name of "Joys of Sex".

She stated that one thing that bothered her was that during the summer of 1974 that his sex drive dropped to near zero. She stated that one possible explanation was that he was working quite hard and was tired a lot of the time. She stated she had confronted him as to whether he was possibly having affairs with other girls to which he stated no.

Liz also stated that one day as she entered his apartment she found a brown paper sack in the middle of the floor just inside his apartment door and she noticed one of the items in the sack was a woman's bra, however, she did not go through the sack any further. When asked why, she stated that she didn't know, maybe she was possibly embarrassed or scared to do this. She stated this was in the fall of 1973. She stated she did not ever say anything to him about it and he did not ever say anything to her.

Liz was then asked if Ted had any knives. She stated he always had knives. When asked what kind of knives she stated, well kitchen utility knives. When asked if he had any hunting knives she stated he had an oriental type knife which was in a wood sheath which he kept in the glove compartment of her car for several months. At one time she had asked him what it was and he stated it was just a knife that a friend had given him.

She also stated he had a meat cleaver in his apartment that he kept with his other cooking utensils. Liz was then asked if there were any other unusual items she knew of in his apartment that she did not know why he had.

Liz was asked what contact she has had since September of 1974 with Ted. She stated she has talked with him several times by telephone and in December of 1974 at Christmas time she came to Salt Lake. In January of 1975 he visited her in Seattle between quarters and in August of 1975 she again visited him in Salt Lake City. She stated while she was visiting with him in December in Salt Lake she learned Ted was smoking a lot of pot with his roommate or an acquaintance that lived across the hall from him by the name of Scott. She stated this was always a problem between them after she learned it and they argued quite considerably about him using marijuana and the effects it could possibly have on him.

Liz then referred back to the picture which she was shown in the last interview and asked if that girl's name was Gloria Ann or Glory Ann. She was told no it was not. She stated that he had developed a friendship with a girl by the name of Gloria A-n who is a law student at the University of Utah as they worked together on several projects for class.

At the time Liz talked to him she did not know anything about the handcuffs and therefore did not ask him anything about it. Also, she stated that her car had been stolen for a few days in the summer of 1973 and was gone for two or three days and when the car was returned the oriental type knife in the wood sheath was missing at that time. She stated that Ted did drive her car occasionally.

Liz was then asked if Ted had ever been to California. She stated Ted had been to the San Francisco area in the spring of 1973 for a few days on business. She did not know anything more about his visit there.

Liz then stated one thing that struck her funny that she had talked with Ted in June and he was talking about hearing one report on the radio in regards to several rapes which had occurred on 1st Avenue in Salt Lake which is near the area he lives. The description of the guy involved was a guy with a beard and he stated to her I guess that lets me out. He stated that he thought a possible suspect was an individual that lives in a house for mentally retarded people around the corner from him which would be on "F" Street and that right after this description came out this individual shaved his beard and head. She stated she is sure he steals things to get money, that he lies. She stated she knows he has lied to her and he has also lied to Liz. Mary then went on to state that one time when they were taking a river trip, that he likes to get down the river into the rapids area and go further than he should deliberately to try and scare the girls that are with him as he just loves to see girls scared.

The voice of Undersheriff Robert Denning speaking; this is the statement of Mr. Gordon Ross who has just reported finding a body west of Empire, Colorado just off of highway U.S. 40.

Undersheriff Denning: Mr. Ross, do you understand that you are not under arrest or being detained for any criminal offense concerning the events you are about to make known to me, Robert Denning, Undersheriff, Clear Creek County. <sup>3</sup>/<sub>4</sub>

Mr. Ross: Yes, I understand this.

Denning: You are not being accused or questioned about any criminal offenses regarding the fact that you are about to state, do you volunteer the following information of your own free will for whatever purposes it may serve.

Ross: Yes, I do.

Denning: Would you please state your name and address.

Ross: My name is Gordon C. Ross, I live at 1869 West Campus Road, Golden, Colorado.

Denning: And what is your phone number, Mr. Ross? <sup>'CASEY' GR</sup>

Ross: 279-5092

Denning: And how old are you sir?

Ross: I am twenty.

Denning: And what is your date of birth

Ross: 9/12/54

Denning: Who is your employer, sir?

Ross: Well right now, more or less, I am a student; However I am doing a little bit of help for ~~NAME~~ for a graduate student who is working for them.

Denning: OK, Where do you go to school, Mr. Ross?

Ross: I go to Colorado School of Mines.

Denning: In Golden

Ross: That's right

Denning: Mr. Ross, would you just start now, starting back as you have related to me previously the events of last Thursday and go from there

Ross: Thursday Morning, we started out working, I believe we moved our equipment that day to the mines and then we went up to Henderson Mine to check out whether we would need batteries or not. On the way back, we stopped to the mine in question, the mine where the body was found and we went in it, exploring it and my boss Mrs. Fisher, stated that they had been there earlier and water was gushing from the portal. And since it was dry, we decided to check it out, but we were ~~weary~~ <sup>very</sup> about the circumstances in the mine so we got our safety lamp out, which detects any kind of gas, specifically methane or lack of oxygen and went down in the portal, down into the tunnel. We went in about maybe a hundred feet and there was an adit to the left which we checked out. It looked like it was empty; there was nothing in it. We continued on down, we had gone about twenty feet passed the adit when we started to notice a strange odor we couldn't identify. We were really ~~weary~~ <sup>very</sup> about this, we didn't know what it was. The safety lamp didn't detect any of the things that it is designed to detect, but we still didn't know what it was. We couldn't identify it and we were sort of afraid of it. We did continue down the mine to the end of the main tunnel, not quite to the end; we went to the first adit that goes off to the left. We stopped there and the smell was very, very strong odor so we just looked down the portal, down the adit and saw a white undistinguishable thing down there. It was white. Since the odor was so strong, we didn't care to continue down the adit figuring that since we didn't know what it was we didn't want to take any chances and at the time we were sort of wondering if it smelled of decomposing of some kind which, if it was a body, somebody had wandered back there and the bad air had got them they would have keeled over and we didn't want that to happen to us either. So we left and went back to the office and told our boss, the main boss who is experienced with mines. We thought about it and he didn't think it was anything that would harm us. He thought maybe a porcupine, or some animal, had crawled back in there and died and was decomposing. So he told us that, to check it out because that was a good mine for our instrument. So we did today and we went all the way back with our safety lamp and went down the side adit and found the body.

Denning: The date was Thursday, the, August the 14th that you were in the first time.

Ross: No it was just last Thursday, the 21st - it may have been Wednesday, but I think it was Thursday.

Denning: O.K., Mr. Gordon why do you go into these mines?

Ross: Well my boss Mrs. Debbie Fisher, she's working for AMAX. They are doing a heat-flow survey to find geothermal energy in the area and the machine we are using is very sensitive to temperature and we just can't take it out and put it on the mountain side because the sun going over, or the wind blowing across it would affect the temperature measurably. So we assumed that the mine would be pretty much a constant temperature so that is where we put the machine.

Denning: To measure heat?

Ross: Yes, well for the most part, I'm not up on the theory of what she is doing. It more or less measures heat flow from one side to the other

Denning: You know what they call that instrument?

Ross: Heat Flow Transducer

Denning: OK, The first time that you observed the white object, how far



was it back from the main tunnel.

Ross: I would say it was approximately 50 feet. ~~ix~~ However the odor was so strong we didn't really want to go inside.

Denning: And when you did go back, into the tunnel and you did find the body ....would you relate those events, what you did see then.

Ross: We went down there to the end of the tunnel and the odor was very strong. There are two side adits at the end; one went right and one went left. We went down the right one first and then we came back and went down the left one, which was the one we saw the white object in. We went in about thirty five feet, approximately ten feet from the body was as close as we went. Shining our miner's lamps on ~~the~~ it, we could easily distinguish that it was a body. It was white. Debbie was in front so I didn't get a very good glimpse. I was trying to hold the dog, we had a dog with us; I was trying to keep him back, but I did notice that it was a body laying in, sort of on it's side, like it had fallen down. There had been, its feet was toward us. We could easily distinguish the limbs and the feet to determine that it was a body. You could see it from there. It was covered with white. It looked to me like it was just a white body...perhaps with some kind of coating of heavy blanket or maybe some kind of white powder or something, I don't know. It didn't look like a blanket from where I was looking, because you could easily distinguish the features of the legs as you were looking at the white body.

Denning: Looked like it was covered with white powder?

Ross: Well that's what I was thinking, probably seen too many movies, but I think I was thinking at the time that if it was a homicide they put lime or something, whatever they do on it. So I was looking for that and that's what I saw. I saw white.

Denning: Was it clothed

Ross: I don't know, I don't think so, I have no idea. I couldn't distinguish that well.

Denning: Could you tell whether it was male or female.

Ross: No, I thought that the feet were little small so it might have been a female. We really didn't get close enough to distinguish any features.

Denning: You went withing about ten feet and stopped

Ross: Stopped and looked at the body and just determined that it was a body and then we left. We more or less suspect and find out what we were going to do if we did find it was a body. Because of the smell and the odor in there it was impossibility, so we just left. We went directly down to Berthoud Falls, that's the name of that town, and called.

Denning: Did it appear to be discolored?

Ross: The body?

Denning: Yes

Ross: I would say, it was all white, very white. It was as white as the paper there. It was discolored, it was very white. It wasn't body colored, flesh colored.

Bass: Was the white only on the body or was it on the surrounding area.

Ross: It was, for the most part, on the body and not very much on the surrounding area, if any at all.

Denning: Let me interject here. That is the voice of Deputy Bass who is also present in the room. I think I failed to mention that before...for the record. Go ahead.

Denning: Alright, Mr. Ross did you ...was there anything else that you noticed? in the area there.

Ross: About the mine, about the situation?...No

Denning: Approximately how wide was the tunnel?

Ross: That the body was in?

Denning: Right

Ross: Well the opening into the tunnel appeared to be approximately four feet by six and a half, four feet by six and half high...however it appeared to open up a little bit where the body was and I don't know how far back it was. Our attention was all focused on the body...we didn't do any looking around. So I don't know how far back that specific adit went.

Denning: OK, Thinking back over this statement Mr. Ross, Is there any thing that you would like to correct or amend?

Ross: No, I can't think of anything

Denning: OK, Have we promised you anything, threatened you or anything in order to obtain this statement.

Ross: No

Denning: If this statement were to be put on paper, are you willing to sign this statement?

Ross: I would say yes

Denning: And attest that this is true and correct?

Ross: Yes

Denning: OK, Mr. Ross, thank you very much. We are going to put this on paper for your signature. It's approximately ten minutes till two, August 23, 1975.

Mr. [REDACTED] at First, related that he had not been in Clear Creek County since May 29, when he was released on bond. However, he later relates that he was in the area at least three times; twice visiting friends and once when he passed through the County enroute to Grand Lake. His fishing license indicates that on June 25th at 2:10 p.m. he purchased the license at Cook's Sporting Goods in Idaho Springs. [REDACTED] stated that on both trips he was alone and on the first visit he recalls having coffee at Reagan's and visiting with Truman Newberry, Fred Nelson and Bert Hilzer in Empire. Later on the first trip he went to the Empire Dump. He does not recall the date of either trip. On his second trip to Empire he recalls talking to Ivan Smith, Dick Lewis and Bert Hilzer. Again, he went to the Empire Dump.

Before any of the above information was related to this officer, Mr. [REDACTED] requested to telephone his attorney, Mr. Robert Ransom at 279-7841. Mr. Ransom requested to know the circumstances from Denning and he was advised that the Department was attempting to determine the where-abouts of possible suspects at the time of the crime. Ransom advised [REDACTED] to give any information possibly regarding that incident.

[REDACTED] further advised he has not picked up any hitch-hikers, with the exception of one, which returned with him to his home. She stayed with [REDACTED] and his wife for a short period. [REDACTED] advises he asked her to leave after learning she had a venereal disease. He states he picked her up at I-70 and Kipling.

Mr. [REDACTED] relates the following information concerning automobiles now in his possession:

1964 red Plymouth stationwagon, 4-door, registered in the name of Linda Brown with Kansas License plates.

1967 blue Ford Galaxy, which is now at AMOCO Transmission on Federal Ave. It has a temporary permit issued to himself.

NARRATIVE: On August 26, 1975 writer was advised by Deputy Sheriff Danny SCHULZ, that he had been dispatched to the Big Horn Apartments on the evening of August 25, 1975 in regards to the manager finding some clothes similar to those of the Victim.

Writer and Undersheriff DENNING contacted Mr. WILLIAM on August 26, 1975 at approximately 1030 hours. He advised that he had found a pair of women's shorts, blouse, and under garments at the West end of the swimming pool enclosure about the first week of July 1975. He stated that he was not sure but believed that the shorts were blue denim cut-offs and the blouse was of a bright color.

According to Mr. WILLIAM the swimming pool was locked in the evening and unlocked by him the following morning. He said that no one else had a key to the pool.

Mr. WILLIAM went on to note that a plastic mat was taken from the North West door of the apartments at about the same time period. A few days later the mat was returned, but was covered with blood. He washed the mat off as best he could and placed it near the elevator. Mr. WILLIAM gave the mat to the investigating officers. It will be submitted to C.B.I. for blood typing.

WILLIAM stated that two tenants, who worked at the Henderson Mine were living in the apartments at that time but left shortly thereafter.

Number one is a [REDACTED] tall 5-10 to 5-11, long collar length hair, tenant in room [REDACTED] was evicted about the 1st of July.

Number two is [REDACTED] about 5-7 with dark collar length hair. [REDACTED] was noted for going to Denver and bringing back female companions who spent a few days at a time with him. [REDACTED] is a friend of I.S.P.D. Officer Jim CROUCH.

WILLIAM asked to see a photo of the Victim which was provided. He was certain that the photo was familiar. In fact, he

was certain that he had seen the victim in [REDACTED]' apartment the first week of July. He stated that she was cleaning the apartment. Mrs. WILLIAM, wife of the Subject confirmed that the photo was familiar. She stated that she thought that the victim was in the laundry room, just across the hall from [REDACTED] room.

Mike WILLIAM, 12 year old son of the Subject asked to see the photo. He too, stated that the Victim was familiar and thought that he saw her in the 3rd floor laundry room.

Mr. WILLIAM then stated that at about that time, a letter came for a ROBINSON girl. All of the tennants of the Big Horn Apartments have the same post office box number. WILLIAM then sorts the mail and distributes it to the tennants. He stated that he had the letter returned to the sender.

This subject turned up missing on January 12, 1975, at approximately 8:00 p.m. from the Wildwood Inn in Aspen, Colorado, and her completely nude body was found February 17, 1975, at approximately 2.8 miles up the canyon from the lodge where she disappeared from.

This subject had apparently been taken and dumped off the side of the canyon road in the snow. The body had apparently been there for about 37 days covered in the snow. The coyotes apparently had pulled the body out from under the snow and been chewing on it when it was located. Because the neck and the part of the head had been completely chewed away by the animals, it is unknown whether the girl was strangled or not. They also could not state whether she had been sexually assaulted or not. She did appear to have bruises, contusions, and lacerations, etc., and also on the back of the head she had two or three lacerations, which appeared to be the same type as the two girls had in the Utah area. The back of the skull had also been fractured, but due to the decomposition and the animals chewing on the body, the Medical Examiner could not give an exact cause of death. Background on this girl, she came from Detroit, Michigan, the night before she turned up missing, with a doctor who she had been living with for the past year. She was last seen getting off an elevator in the Wildwood Lodge, was going back to her room to pick up a magazine and go back downstairs to the lounge area, and apparently never made it to the room. That was the last she was heard from or seen. She had also just come from a dinner at the Stew Pot at the lodge and had a stew dinner. According to the Medical Examiner, the stew was still in her stomach and had not yet digested.

the door. This door is on the southeast corner of the laundromat. Appears to be a door to a maintenance room. Has the number 139 just above the door. The door was locked. The suspect did touch this door.. Detective Riet later tried to obtain prints with negative results. At this time suspect told victim that they would have to go to the main Murray Police Department and she accompanied him to his vehicle which was parked on the north side of 6100 South facing west, approx. 100 ft. east of the Lockhart Company.
