Practices at the Madrona Dance Studio (the old Madrona Bathhouse) from 2:00PM to 5:00PM weekdays then appears in the opera those nights it plays.

Suspect... [REDACTED] (pronounced [REDACTED]). W M approx. 24-25 yrs. 5'8" tall, bleached out blondish hair, muscular build, dark suntan, small smallpox scars on face, wears sunglasses at all times, corner of one lip turns up when he smiles, facial features are very similiar to "Ted". 






9-12-74 at approximately 1640 hours I received a long distance call in my office from the District Attorney for Washington County, Oregon. He had tried to reach Chief Hanson because of previous contacts in the Ruczicka case. Chief was not available so he was referred to me. He relates the following:

The D.A.'s office received a message today from a professor whom he knows to be reputable. The professor said that he had received a telephone call last night (9-11-74) from a former student with a past drug problem. When the professor inquired, "Drugs again?" the student said, "No, it is much more serious than that." The student then apparently had second thoughts or change of mind and would not elaborate further. This student is known to the professor as Ted [REDACTED] and it is believed the student either was previously or is a student at Bellingham, Wash. The professor indicated he was leaving town for five days on an anniversary trip. Basically the same information was also telephoned to the Detective office in Hillsboro, Oregon, by the prof.

At this time, neither the district attorney nor the detectives have talked to the professor. They are trying to contact him before he leaves town for the five days. They will call the SPD Homicide Unit if they make contact tonight and should learn any additional. Otherwise they will probably await contact from us.



9-12-74 at approximately 1640 hours I received a long distance call in my office from the District Attorney for Washington County, Oregon. He had tried to reach Chief Hanson because of previous contacts in the Ruczicka case. Chief was not available so he was referred to me. He relates the following:

The D.A.'s office received a message today from a professor whom he knows to be reputable. The professor said that he had received a telephone call last night (9-11-74) from a former student with a past drug problem. When the professor inquired, "Drugs again?" the student said, "No, it is much more serious than that." The student then apparently had second thoughts or change of mind and would not elaborate further. This student is known to the professor as Ted [REDACTED] and it is believed the student either was previously or is a student at Bellingham, Wash. The professor indicated he was leaving town for five days on an anniversary trip. Basically the same information was also telephoned to the Detective office in Hillsboro, Oregon, by the prof.

At this time, neither the district attorney nor the detectives have talked to the professor. They are trying to contact him before he leaves town for the five days. They will call the SPD Homicide Unit if they make contact tonight and should learn any additional. Otherwise they will probably await contact from us.



If the arm was truly injured and in a real cast it would be rather difficult to incapacitate a person by hitting with the cast or other means. Then how were these women silenced quickly? My opinion is the arm was not injured, that the cast was easily removable and that these women were silenced via some kind of a powerful drug, a quick tranquilizer such as used on animals. It would take a person familiar with medicine or veterinary procedure to make a cut cast look convincing also to obtain drugs for his deadly purpose. I hope my reasoning will be of some help.

Blond hair - straw color. no bangs as if [REDACTED]'s hair has been let to grow and dyed or bleached almost white. I feel as if the man on the porch is watching a woman with the child [REDACTED]. Perhaps a kidnap for replacement of their own dead blond child. I am looking at this scene as if I am facing East. Which means this would be on the West coast of America. I didn't feel it was on foreign soil. Like the Alps area. What place on the West Coast would have palm trees at the beach level? It wasn't green enough to be Hawaii. - - - - -

I have tried to get more on this but find that too much at once is always confusing. I presume you have checked the death notices for girl children of four years. But I got the impression that the dead child [REDACTED] is replacing was not reported dead. That the man who had custody of this child was panic stricken when the girl died suddenly. The woman had not seen the child for a long time. He devised the plan to replace the child for a while. Therefore the beach to make it look as if their child was sun tanned. [REDACTED] is dark skinned. Somehow the woman is not leaving so soon and the man is bound to play this game for how long????? How long can [REDACTED] go along with the scheme? Does the child remember and will she make a slip? If so what will happen? Another panic?

I pray that you will be directed to this man, woman and [REDACTED] before it really is too late.
