First of all I would like to thank you for your time last week. The nine hours which we spent together really flew by, and I have a bunch of other questions which I have realized that I wish to ask you.

/ I want you to know that I really do sincerely appreciate your interview. The students were told some things, but as I promised I said nothing about the Washington case and a few other things which you said that you did not want repeated. Your ideas about the concrete motivations of a serial killer left me with a lot to think about. The reasons a serial killer stops, methods of disposing of the bodies, conscious motivations and so on. What do you think is the main reason serial killers murder. I know in my typology I allude to types, mission type, visionary type, etc., and there are motives in each of these types. I know that you disagree with some of these models and my thoughts. I can appreciate that, but I also would like to know some of your thoughts about motivations. Is compulsion a factor. Your mention of rational factors in serial murder is something that academicians, such as myself, truly experts in the field, do not think too much about. It is truly an ivory tower. I have included with this letter a few copied pages from a new book called Mass Murder by Fox and somebody. There are some theoretical statements regarding "mass" murder. They did not differ from mass and serial murder. They identify you as a mass murder along with other people such as Speck, Stano, Lucas, Gein, and others.

✓ As you know, I am still interested in coming back and videotaping an interview with you." "The Green River situation is a classic case," Brooks said. "The last body they found they tracked to a murder that was committed a year ago, in December 1983. So where is the murderer of these women now? Is he dead? Is he in jail? If he's free and somewhere else, what is he doing?"

Brooks believes that once VI-CAP is operational, it will be able to detect the movements of serial killers across the country, to spot patterns in apparently unrelated, random and motiveless murders. In addition to this tracing of the physical movements of serial killers with VI-CAP, the FBI's National Center for the Analysis of Violent Crime is also taking a different tack. The National Center's research and development unit is conducting a series of interviews with convicted serial killers to try to learn more about what motivates their behavior — what makes them tick.

A certain amount is already known about the psychology of serial killers. Ann Rule, a member of the VI-CAP Advisory Task Force who was closely involved with the investigation leading to the arrest of serial killer Ted Bundy, says such killers are usually violent towards women, which may stem from abuse or neglect suffered in childhood at the hands of their mothers. "When they grow up and become men, they act out their rage towards women" by systematically killing victims, who often have similar physical characteristics, she said.

Most serial killers are very intelligent, Rule said. "The dumb ones are caught early on, they can't run up a string of 35 murders." And many of them, she said, "have tremendous egos. When they're caught they like to brag about what they've done." It is this quality that the FBI has found yery useful in conducting its research.

Under the direction of Dr. Ann Burgess, a psychiatric nurse associated with the University of Pennsylvania, members of the National Center research team interviewed 36 of the most notorious sex-oriented serial murderers to try to develop some insight into the psychology of serial killers. While the report on this research is not yet available, FBI Special Agent Roger Depue, head of the National Center and of the FBI's Behavioral Sciences Unit, said the research will be very valuable to law enforcement.

"For the first time, law enforcement is conducting its own empirical research," he said. "It's unique because it's being done from the law enforcement perspective, and so we're asking questions that have not been asked before."

"For example, take the question 'Does the killer return to the scene of the crime?' Now that question has been around for 200 years, and investigators have said in specific instances, yes, but they have never been able to explain it, and they have never gathered any empirical proof. We are attempting to answer that question, and others. How does the killer select the victim, how does he maintain control of the victim, how does he choose his weapon, and so on. We're interested in learning more about the techniques the criminal uses to beat the system."

Because of the egotistical quality mentioned by Rule, the serial murderers interviewed by the FBI team were generally cooperative, Depue said.

"We interviewed what you could call the 'very best' criminals, the most prolific criminals," he said. "And surprisingly, they were extremely cooperative. I say surprisingly because we have always been perceived by

should be physically housed, there was a period
of intense head-scratching.

Initially it was thought that the computer system should be housed in a city somewhere in the U.S. — "but I knew that would never work," Pierce Brooks said. "VI-CAP is a national program, and when we looked at what the FBI was doing with its criminal profiling and research, it became clear that Quantico was the logical place for it to be."

When VI-CAP settled in at the FBI Academy in Quantico, Va., it became the final piece in what Roger Depue, chief of the FBI's Behavioral Sciences Unit, called "a puzzle that finally fit together." The name of that puzzle, which is composed of several innovative systems designed to make the tasks of American criminal investigators easier, is the National Center for the Analysis of Violent Crime.

The National Center (it has no convenient acronym) is overseen by Special Agent Depue and was funded by a \$1.7-million transfer of funds from the National Institute of Justice and the Office of Justice Assistance, Research and Statistics. It has its roots in the pioneering work of the FBI's Behavioral Sciences Unit, which 12 years ago began to construct psychological pro-

files of unknown offenders who had committed unsolved violent crimes. The program grew under Depue's guidance, and has become firmly established as a valuable national criminal justice resource.

The next piece of the puzzle came in the person of Dr. David Icove, formerly of the Knoxville, Tenn., Police Department. Icove, who is now a member of the National Center's staff, had developed a computer program called the Arson Information Management System, or AIMS.

AIMS uses advanced computer technology to analyze data about fires in order to predict where the next arson is most likely to occur, and to construct a profile of the arsonist. It is the AIMS program upon which the VI-CAP software is based.

"When we heard about Pierce Brooks' idea of a Violent Criminal Apprehension Program, we were naturally very interested," said Depue. "We're always looking for new ways to tackle old problems, and we were quite excited about the idea of bringing all these good ideas together under one roof.

"We all felt that it was kind of like the old story of the blind men feeling the elephant, and all reporting something different about what they're feeling. It was only when they put together what they had that they could construct what the beast looked like. That's what we're doing here at the National Center — we're putting it all together.".

"It's one of the ways we keep them honest," Depue said. "We know more about the topic than they do, so we can tell if they're veering from tha truth."

The FBI is also planning to do similar research on serial rapists and multiple-victim child molesters. "This type of research will give us insights into the criminal personality that will lead to superior investigative techniques," Depue said.

Meanwhile, the debate continues on the question of how many serial killers are actually roaming around the country at any one time. The official Government estimate is roughly 35, but most experts put the figure far higher. There are about 5,000 unsolved homicides every year in the United States, and Pierce Brooks, for one, believes that many of these are the handiwork of serial killers.

"Most of the unsolved murders remain unsolved because there is a stranger-to-stranger relationship between the victim and the suspect," he said. "If there is a relationship between the suspect and the victim, the police probably clear 98 percent of those cases. The Agatha Christie-type murders are really pretty easy for us. They make interesting reading, but if you read the mystery stories, you'll find that there

"Most serial killers are caught by accident," said Ann Rule. "They're stopped on traffic violations or something like that."

Brooks agreed. "Without VI-CAP we count on arresting these people kind of by luck. It's luck laced with good police work. 

Dear Ted:

As I said yesterday in my letter sent to you, I received your letter dated November 18, on the 21st of November.Not bad for the mail service. Let me react to some of the comments you made.

First of all, I can certainly understand and appreciate your concern about destroying confidentiality. I also am a strong believer in this. I will not under any circumstance repeat what someone has told me is to stay between the two of us. I also expect other people to do the same not only with me but with the other persons they relate with. So, it should go without saying that what you and Jerry Stano or you and Ottis Toole have taked about and appears to be confidential should stay that way.

Your comments about the dump sites for bodies of the victims of serial murder appears to be very interesting. Yes, I would like very much to have your outline. Part of my book will deal with dump sites. The article which I sent you yesterday deals in some part with the investigation of such sites in organized nonsocial type of lust killings. I thought I would use something like the following as an outline for the discussion:

*Location - kills in one area, moves body to another
may display or hide body depending on motive
scene is close to home or business
early in his killing career is the closeness
appropriate

*Weapon - brings it with him

significant in choice (hands-on weapons

*Souvenir - may give to significant others

psychologically relives the crime with it

*Victim - often mutilated

clothing removed or taken shows evidence of torture little or no physical evidence

So, what do you think as an outline?

What do you think I should add? delete? Your mention of an outline stated that the dump site leaves clues to the killer has important ramifications for law enforcement.

Ted, any thoughts on so-called spree murderers? Are they different from serial or mass killers? New area of interest for me.

You mentioned that you are getting to the point where you don't like to write letters. Do you have a cassete recorded? We could exchange tapes. A thought. This would erase the feeling of having to write down letters. I don't know what your limitations are at the prison, obviously.

I am enclosing with this letter a copy of a transcript of the Phil Donahue Show which talked of serial murder. They mention you and your case, talking with Carol DaRonch Swenson. They also mention the issue or rehabilitation, the role of pornography and VICAP. I thought you might be interested in the copy. I would send you more but if I write more I can send you a thing or two each time.

I think that your clemency hearing comes up around December 13. Is there anything I can do?

Well, I'll close now. I would like to come down and see you soon.

Dear Ted,

Please excuse my tardiness in writing. I have been up to my ears with work around here. I am the chairman of the Personnel Committee at the University and one of my faculty has been denied tenure and this has proved to be a great source of difficulty for both him and me. He is really a worthwhile person and has contributed a great deal to out School through research and teaching. The trouble is that there are some people who are judging him who have not written a publishable word in years, if ever, and they are sitting in judgement of him.

I am enclosing with this letter some stuff including a chapter of the book on serial murder which I am writing. React to it when you can. I am becoming concerned about why and how, and the disposal of the victims is important from a profiling point of view.

Ted, I would really like to get down to the nitty gritty of serial murder. I know that you deny all of the crimes which you have been formally and informally accused of, but I think you can share some things with me that would be of great benefit. The strength of the "force" within some of the serial killers is something which I believe needs to be examined. Liz, in her book, The Phantom Prince, states that you tried to kill her, and the killings in your case started way before 1969, she quotes you by saying that, "The police are way off." I want to see you again and talk about the serial murder in general and more about you if we can.

I am going go be in Tallahassee the last part of February at the Southern Conference on Corrections at Florida State University. I figure I can rent a car, drive over and spend the day with you. How does that sound? I will call Mr. Dugger this week and arrange a day of the week and see if he will talk with you or if we can communicate in some way.

There is a fellow who is a state probation officer who probably spends most of his waking hours reading about you. I may have mentioned his name to you in the past, Jim Massie. He has talked with Jerry Thompson and Mike Fisher last week, and one of them said that someone is doing a TV special about you, a mini-series, which is to be aired the latter part of May, 1986. Do you know anything about it? Thompson said they were in Salt Lake filming some footage and were on the way to Florida after that. I have not talked to anyone about you except my students. This is what I thought we had agreed upon. I understand that they are using Don Larsen's book, The Deliberate Stranger as the basis of the book. Maybe we can talk about this too.

The roles of fetishes, partialism, fantasy and ritualism may be something else we can talk about when I come down. I am really looking forward to talking with you. There is a lot of information I have secured from a variety of different places that I could share with you when I come down. Of course, I would have to tell Mr. Dugger.

Please respond as soon as you can. I hope to see you in the last part of the month.

IT IS NOT SEX, BUT VIOLENCE, THAT IS AN OBSCENITY IN OUR SOCIETY.

ESSAY

n July 1986, the United States Attorney General's Commission on Pornography issued its final report on a subject that is as complex as the human condition. While many people have commented upon the report, few have actually read it and fewer still understand its implications. As social scientists and two of the researchers whose work was cited throughout the two-volume work, we feel it necessary to point out that the report fell short of our expectations in several important respects. First, there are factual problems with the report, representing serious errors of commission. Several of the contentions made in its pages cannot be supported by empirical evidence. Some commission members-apparently did not understand or chose not to heed some of the fundamental assumptions in the social science research on pornography. Second, and perhaps more importantly, the commission members have committed a serious error of omission. The single most important problem in the media today, as clearly indicated by social

science research, is not pornography but violence.

The report begins with some history about previous attempts to examine the question of pornography. One of the most important of these was the President's Commission on Obscenity and Pornography, which issued its final report in 1970. "More than in 1957, when the law of obscenity became inextricably a part of constitutional law, more than in 1970, when the President's Commission on Obscenity and Pornography issued its report . . . we live in a society unquestionably pervaded by sexual explicitness," the current report states. It goes on to point out, quite rightly, that the most dangerous form of pornography is that which includes specifically violent themes. But then the report adds: "Increasingly, the most prevalent forms of pornography . . . fit this description It is with respect to material of this variety that the scientific findings and ultimate conclusions of the 1970 Commission are least reliable for today, precisely because material of this variety was largely absent from that Commission's inquiries."

It is popularly assumed—and the members of the commission appear to share this assumption—that images of violence have become more prevalent in pornography in recent years. Interestingly, there has never been a systematic content analysis of X-rated books, films and magazines that would be needed to support such a conclusion. But there are a handful of studies, concentrating on specific media, that at least call this notion into question.

One of the most recent of these was undertaken by sociologist Joseph E. Scott of Ohio State University. He

examined the content of cartoons in *Playboy* magazine from 1954 to 1983 and found that there was indeed a period—around 1977—when the violent content peaked. But just as there had been an increase in violence in the years before 1977, there has been a like decrease since. Further, he notes that sexually violent material seems to occur on an average of about 1 page in every 3,000 and in fewer than 4 pictures out of 1,000—a level that would have to be considered barely noticeable.

In addition, there is evidence indicating a different sort of trend in sexually oriented videocassettes. Psychologist Ted Palys of Simon Fraser University analyzed the content of 150 randomly selected home videos, most of which were produced between 1979 and 1983. He divided these films into "Triple X," in which sexual activity is explicit and graphic, and "Adult," in which no explicit sex is shown but nudity and "implied" sexual behavior is allowed.

Palys found that the Adult films actually portrayed a higher percentage of aggressive scenes and more severe and graphic forms of aggression than did the Triple X videos. More important, there was no increase in aggressive images between 1979 and 1983 for either type of video. In fact, as Palys notes, the difference between these two types of videos may be widening over time, primarily because of decreases in sexual violence in the Triple X category.

At least for now we cannot legitimately conclude that pornography has become more violent since the time of the 1970 Pornography Commission. The results of the few studies that have been done are inconclusive and inconsistent, but at least a few of them point in the opposite direction. Perhaps it is because all forms of pornography are more prevalent now than they once were that we are more aware of the sexually violent forms of pornography.

What is so particularly evil about violent pornography? Here, the commission does not mince words: "In both clinical and experimental settings, exposure to sexually violent materials has indicated an increase in the likelihood of aggression." The commission goes on to state that "finding a link between aggressive behavior

toward women and sexual violence ... requires assumptions not found exclusively in the experimental evidence. We see no reason, however, not to make these assumptions." The assumptions include the idea (in the commission's words) that "increased aggressive behavior towards women is causally related, for an aggregate population, to increased sexual violence."

One persuasive reason to be careful about an intuitive leap like this, however, is a closer examination of the empirical evidence—what it says and what it does not say. We have no argument with the commission on its first point. Experiments by psychologist Neil Malamuth at the University of California, Los Angeles, suggest that, especially when the experimenter appears to condone aggression against women, men act more aggressively toward women in a laboratory after having been exposed to sexually violent stories. But a question that the prudent reader might raise is: "How long do these effects last?" In the vast majority of studies, aggressive behavior is measured almost immediately after exposure to the violent pornographic films. But is the effect cumulative or does it disappear over time?

In one study by Malamuth and psychologist Joseph Ceniti, college-aged men were exposed to violent and nonviolent sexual material over a four-week period. They watched two feature-length films each week and read similar materials. About seven days later, they were (according to the researchers' plan) angered by a woman working with the researchers and then given an opportunity to act aggressively against her. Contrary to expectations, the men who had been exposed to pornography were no more aggressive against her than were those not exposed to pornography. For the moment, then, we do not know if repeated exposure has a cumulative effect or if such effects are only temporary. But the evidence, such as it is, points toward the latter conclusion. This fact seems not to have been given sufficient consideration by the commission.

In addition, there is evidence that particular themes in pornography might be especially harmful. Recent research indicates that it is specifically the message that women find force or aggression pleasurable that seems

For example, in a study Donnerstein conducted with psychologist Leonard Berkowitz, men were shown one of two films, both aggressively violent and sexually explicit. In both, a young woman arrives at the home of two young men to study. She is shoved around, tied up, stripped, slapped and ultimately raped by both men. In one version of the film ("positive ending"), the woman is shown smiling at the end and in no way resisting. A narrative added to the film indicates that she eventually becomes a willing participant. In the version with a "negative ending," the reaction of the you would not be caught?" woman is not clear, but the voice-over indicates that she found the experience humiliating and disgusting. Men who saw the positive-ending film interpreted the film itself as less aggressive and said that the woman suffered less, enjoyed herself more and was more responsible for what happened than did the men who saw the negative ending. This seems fairly clear evidence that the different messages in the two films affected the men's attitudes in different ways. But this literature can be tricky to interpret. In one study by Malamuth, researcher Scott Haber and psychologist Seymour Feshbach, for example, men read several stories, some of which were about a woman being raped. When the men were asked how likely they blamed for them. would be to behave as the rapist did if they knew they would not be caught, more than half indicated some likelihood of behaving that way. Many assume that this surprisingly high percentage was due to the effects of men

being exposed to violent pornography. As the commission report concludes, "substantial exposure to sexually

violent materials ... bears a causal relationship to antisocial acts of sexual violence and, for some subgroups, possibly to unlawful acts of sexual violence."

Yet nothing could be further from the truth. In none of the studies by Malamuth has a measure of motivation such as "likelihood to rape" ever changed as a result of exposure to pornography. If the men reported feeling this way, it might be because they were generally callous about rape to begin with. As Malamuth has noted, men who indicate some likelihood that they might com-

mit rape (if not caught) are more sexually aroused by and more attracted to violent materials, but there is no reason to think that exposure to violent pornography is

the cause of these predispositions.

Malamuth and psychologist James Check again asked men to read two stories. Some first read a story with a "positive ending," in which the woman becomes sexually aroused; others read a story with a negative ending; then all of the men read a realistic depiction of a rape. But first, the researchers classified the men as "more likely to rape" or "less likely to rape" based upon their answer to the question, "Would you rape if you knew

While both groups were more likely to view the woman in the second story as enjoying rape if they had read the positive-ending story first, the "more likely to rape" men seemed much more affected by exposure to this sort of pornography. They agreed much more frequently with statements suggesting that women enjoy rape and enjoy being forced into having sex than did those who were "less likely to rape" to begin with. This indicates to us that exposure to violent pornography is not necessarily causing callous attitudes about rape but rather may reinforce and strengthen already existing beliefs and values. If aggressive pornography is not the cause of the negative attitudes, then it ought not be

What we have is a picture of violent pornography that is somewhat different from that drawn by the commission. We do not, as yet, know if the detrimental effects. of watching pornography are long-lived or only fleeting. We do know that it is specifically the pornographic materials that depict women "enjoying" rape that are espe-cially damaging, but it remains unclear whether all men are affected equally even by these bizarre scripts. Finally, it remains to be seen whether changes in attitudes about women and rape revealed in relatively small-scale tests have any applicability to rape and aggression in the real world.

There is some evidence from the work of Malamuth that these attitudes do have some relationship to realworld aggression, but again, these are attitudes that

people already have. The commission members were obviously aware of these issues. In fact, these conclusions, well-grounded in scientific research, are briefly summarized deep within their report, which makes it even more perplexing that they ignore the data in making their 92 recommendations.

Our major criticism of the report and its authors, however, has to do with a subject that has been glossed over in the commission's 1,960-page report. The commission has ignored the inescapable conclusion that it is violence, whether or not accompanied by sex, that has the most damaging effect upon those who view it, hear it or read about it. This is an extremely important distinction, with direct relevance to the work of the commission, because it has implications far beyond violent pornography and pornography in general.

Sexual violence and depictions of women "desiring" rape are not limited to X-rated films, books and magazines. In the popular film The Getaway, for example, one of the robbers kidnaps a woman (portrayed by Sally Struthers) and her husband. He rapes the woman, but she is portrayed as a willing participant. Struthers's character becomes the kidnapper's girlfriend and the two of them taunt her husband until he finally commits suicide. The woman then willingly continues with the assailant. Far from being consigned to dingy X-rated theaters, this film, originally produced in 1972 and shown in cinemas all over the country, is still shown occasionally on commercial television.

Malamuth and Check tried to determine whether the mildly explicit sexual violence in *The Getaway* and in *Swept Away*, another film with similar content, influenced viewers' attitudes toward women and rape. When the researchers questioned college students who saw both films and students who saw nonviolent films or no films at all, they found that the men who saw violent movies more readily accepted interpersonal violence and more frequently believed that women enjoy rape.

In another study we did with Berkowitz, men saw different versions of a film. The first version contained a scene of sexual aggression in which a woman is tied up, threatened with a gun and raped. The second version

contained only the violent parts of the scene, with the sexually explicit rape omitted. The third version contained only the sexually explicit rape scene with the violence deleted.

The most callous attitudes about rape and the largest percentage of subjects indicating some likelihood of raping or using force were found among those men who had seen only the violent coercion. Subjects who saw the X-rated version without violence scored the lowest on both measures, and those who saw both the explicit sex and the violence scored somewhere in between.

Taken together, these studies strongly suggest that violence against women need not occur in a pornographic or sexually explicit context to have a negative effect upon viewer attitudes and behavior. But even more importantly, it must be concluded that violent images, rather than sexual ones, are most responsible for people's attitudes about women and rape.

As should be obvious to anyone with a television set, the mass media contain an abundance of such nonsexually explicit images and messages. These ideas about rape are so pervasive in our culture that it is myopic to call them the exclusive domain of violent pornography. In fact, one would not have to search much farther than the local 'I-Eleven to find numerous bloody murder mysteries in detective magazines that reinforce this point.

And this is where we have our strongest disagreement with the Commission on Pornography. Granted that the charter of the group was to examine the pernicious effects of pornography on society. Granted also that the time, money and other resources of the commission were limited. But it seems appropriate to note that if the commissioners were looking for the most nefarious media threat to public welfare, they missed the boat. The most clear and present danger, well documented by the social science literature, is all violent material in our society, whether sexually explicit or not, that promotes violence against women. Let us hope that the next commission will provide a better example by disentangling sexuality from violence, therefore yielding more useful conclusions.

I have included with this letter a couple of these books, you are welcome to keep them. I do not have an extra copy of my book (honest), but when I get one, I'll send it on down to you. I have included a copy of the chapters on kiddie porn and adult pornography.

As you suggested, I have called Mr. Dugger and sent him a letter describing to him what I wished to do. I told him basically that I had asked you for an interview and also if I could videotape the session. I related your concerns about publicity, etc., and he said that he too would have some concerns about the establishing a precedence. Anyhow, I sent him a copy of my vita, some supporting documents, and asked Don Patchen if he could drop him a note to let him know I was who I said I was (I make myself sound important, don't I?). Neither of the magazines are refereed, so the academics look down their noses on non-refereed journals. However, I believe that my writings should go out where the most people will read them. A journal in sociology I recently read stated that on an average, Il people read an article which appears in a refereed journal. Well, to get on with what I am trying to say. Would you look over the article and give me any thoughts. I have tried to look at serial killers, breaking them down into immediately two categories, stable and transient, and then into four types. What do you think?

I am sitting here at my desk writing this letter and listening to Ann Murray. I really like country music, not the real twang, but people like Ann Murray, Oak Ridge Boys, Johnny Cash, Marty Robbins, etc. What do you like. If you have a casette player, my sons have a thing (a technical term don't you think?) and I can make you some copies of such good music.

As I mentioned, I have permission to talk with Henry Lee Lucas when a date can be arranged with the Texas Rangers. I thought perhaps I could swing by Florida and see you. Just for a talk if you would like, no videotape. I also will be in Florida the first of May. My middle son, Steve, plays baseball for the University of Louisville, and the Metro tourney will be held at that time. I could also come by that time.

Dear Ted,

It has been quite a while since I have heard from you, and frankly I am becoming concerned about our relationship. I have written to you on three separate occasions since the first of May, and I have not received any reply. My first thought would be that perhaps the mail has been somewhat delayed or misplaced. I hope that this is the case. The other alternative is that you have decided that we should not continue our relationship. I would hate to see that happen because I think I could learn a lot from you about serial murder. Secondly, I enjoyed our meeting, and I would like to talk with you some more. Also, once I meet someone I like and feel comfortable with, it's hard to see this relationship dissolve without a good reason.

I have kept my word with you about talking with the media. Some people have called me, and I do verify the interview we shared, but the details of the conversation remain our own business.

✓ I have recently signed a contract to do a book on serial murder. Would you like to write a chapter? Think of the possibilities. I would split the proceeds with your daughter (I'm not like Michaud and Aynesworth). If not, that's OK too. But I think it would be a shame for someone like yourself not to share their knowledge and information with others. I think you could make a great contribution.

I was in Sarasota in July and heard that your clemency hearing had been rescheduled until September and now until December. Is there anything I can do? I would be happy to write someone or do anything I can on your behalf. I agree with you, there is no reason to execute, society can be much better served by learning about human behavior.

I have begun to collect police detective magazines regarding the murder cases that we once talked about. I'll let you know more about it later. I was involved in a homicide seminar in Phoenix a couple of weeks ago. My topic was serial murder, of course. I talked about serial murder in general, and used a couple of your ideas, e.g., formula for serial murder, compulsion, etc., and of could did mention that you and I have talked. I also said that I wanted to talk with you again, but did not know the current status of our relationship. Al Carlisle was there talking about psychological profiling. He, Bob Keppel, Rod Englert, Jerry Potter (a guy doing a book on Lucas), and a guy from the FBI (Bill Cheek), are going to do a seminar in California together. I don't know what the FBI can add. I know you hold them in high regard, but I have some serious doubts about their expertise. Maybe this is just professional jealousy.

Any information you can share with me about Stano and Toole? You may recall, we talked a little about them when I was down there in April.

Ted, there are many questions I want to ask you about serial murder. I hope you choose to respond to this letter so we can really move into trying to get some answers regarding this very serious propblem. I believe that you are the person to talk with. You certainly have the ability to respond intelligently and intelligibly. This is a big advantage over other persons. Lucas will tell people whatever they want to hear. As you said Stano and Toole have problems communicating. I have written Edmund Kemper, and I have not mailed it as yet because of some of my own thoughts about our relationship.

I guess what I am saying is that I would like for our relationship to continue. I don't know how you feel since I have not heard from you since April. I believe that you have a lot on your mind, this is an understatement I realize, and us talking and writing is probably a low priority. On the other hand, I really don't want to bug or hazzle you with letters. So, if I don't hear from you I will assume that you wish not to go any further. I hope that this is not the case.

Dear Ted,

Please excuse me for taking so long to write. I have been so busy with trying to get my thoughts down on paper for the book I am trying to do. I am better at rambling with my thoughts on a tape recorder, and it takes so long to put stuff down and still have it make some sense.

I have been assigned to teach a new course at the University of Louisville, juvenile delinquency. I have not taught this course for 7-8 years, and in some instances I am sure it will be the blind leading the blind.

Of course I got your letter and your very nice Christmas card. Both were appreciated. I hope you got my card and everything finds you well and in good spirits. I saw in the paper where Governor Graham has postponed some actions on your case; hopefully things will work out OK for you. Don Patchen sent me a news clipping and I have enclosed this in the negot this letter. Don, Al Carlisle, Bob Keppel, Ann Rule, Jim Boutwell, the sheriff at Georgetown, Texas where Lucas was housed when he was in his confession mode, and myself are going to be in a seminar in California outside L.A. February 13-14. I hope that I can talk with you in person before that time. Also I hope we can get a videotape interview. (I'm sure you have heard that before.) I'm also going to be involved in a serial murder seminar in Columbus, Ohio in March, give a talk at the Academy of Criminal Justice Sciences the last of March in Orlando, and be involved in a series of lectures at the Southern Police Institute at the University of Louisville starting in June. I believe that it is very important that I talk again with you before this all happens. I know that you can tell me a lot regarding the problem of serial murder. How about it?

I really don't know about the writing from Al. He called me last week and said that you had written to him after several years. I did not say anything about what you had written to me, neither did I say anything about the letter from him which you shared with me. Al is starting to become very interested in satanic cults and murder. I know very little about this sort of thing. He was in Kentucky last year in Lexington, Ky., and visited a murder site located on the campus of Transylvania College. A young woman was strangled with her own bra (no, I don't think you are a suspect in this case). Her body was found next to the grace site of a person who supposively placed a curse on the College. The College and the grave site are located in the

edge of a pentagram. Interesting, but again I know very little. There was a case in Louisville a couple of months ago where the police located a man who was a pedophile and also had a collection of pictures of himself and little boys nude, tied up, and all of the poses were inside the pentagram. He had a collection of satanic things, and I was called in by the local exploited child unit to offer some ideas. I believed, after talking with the man, that he was too stupid to be a real satanist, and he was playing around with things that he knew very little about. I believe that a person who is really into the satan worship genre must be intellectually sharp and know a little more than when to come in out of the rain. No child was hurt, and he is presently in jail awaiting an indictment by the grand jury.

I know that you have probably heard that Henry Lucas has recanted all of his killings except the murder of his mother back in 1961 or so. Any thoughts about his case?

Ted, reacting to your thoughts about your role in my research, I believe that you are right. I think I can get a lot of good information from you if I can get your confidence and listen to what you have to say. "Deep throat" is probably the better way to handle the serial murder iformation problem. There is no way I can get the information myself. I need you. I better go on and admit it.

Can you tell my anything about "the force?" I know you have mentioned it in some instances as "a deep feeling inside me," "the entity," and so on. When they interviewed you down in Pensacole you said something to the effect that there was something deep down within you that you could not control. * Is this an accurate quote?

Are you corresponding with any of the other people I might be interested in? I have the addresses of people such as Edmund Kemper, Wayne Williams, Kenneth Bianchi, Wayne Gacy and a few others. I have written to Kemper (no reply), Kenneth Bianchi (no reply), Wayne Williams (he wanted to talk but his lawyers advised him against it). Perhaps you might have better luck. Maybe you could tell them about me and the fact that I can be trusted. Think about it. If all of you can get together and exchange ideas and toughts, what a terrific pool of knowledge.

Tomorrow I have no classes. I plan on going over you letter more carefully and react to your points. Another letter will follow in a couple of days.

Thank you for your quick reply to my letter. I shall try to answer some of your concerns about my motives and my activities in the area of criminal justice and specifically serial murder.

First of all, I can certainly appreciate your concern about the so-called "experts" in the field. I personally know of only one expert in the field of life and that is my sixteen year old son, Terry. I can only say that I am very interested in the subject of serial murder, and my interest is that of an academic nature. I am not interested in making money at another person's expense. That does sound unbelievable, doesn't it?

My focus on the subject of serial murder is to try to obtain as much information and knowledge as possible. My interest then is to try to do some workshops, seminars and college class sessions to college students as well as law enforcement personnel at the School of Justice Administration, National Crime Prevention Institute, and the Southern Police Institute. I am at a point in time when I feel the need to talk with a variety of persons who apparently have some experience in this subject. This has lead me to converse with such people as Ann Rule, Don Patchen, Mike Fisher, Carol DaRonch Swenson, and even Ken Katsaris. I can understand that you may have some negative feelings about some of these people, but I hope that you can also understand my point of view. There is not much to base a judgement upon until you meet someone personally and then make your own judgement. I don't think I would want to buy a used car from Katsaris.

I can only relate to you in my sincere tone. I have included with this letter a copy of resume which will show you my background. As you can see, most of my work is in the area of child abuse, juvenile prostitution, juvenile pornography, and homosexuality (no, I am not gay). I have little experience with serial murder, but as you so aptly state in your letter, who does? I am trying though. I have done a lot of reading in the area both the pop stuff and the academic stuff. I believe though that I could learn a lot more by talking with someone like yourself who could give me his side of the story. My motive, as I said above, is to pass on this information, information from the professional literature as well as your input. I believe that your input would add a valuable dimension.

I have included with this letter in addition to my vita, several of my publications, the literature from the seminar last November, and other incidental stuff. We have not designed the final advertisement for the May meeting as yet. When we do, I will send you a copy. I hope that you will find that I am truly on the up-and-up and am only trying to gain some insight into this problem. Please accept my sincere thanks for your consideration into this problem. I am sure you understand my concern over writing to you in the first place. I certainly can understand your concern about answering a letter from someone who is a total stranger and someone with whom you are not familiar.

I'm sorry it has taken so long to get back with you... But I must say I believe I must write you this last time.

I am truly sorry you have taken offense at the material I have given you. The reason I gave you the chart, for example, was that this was material that I had gleaned from several sources, e.g., Deliberate Stranger, Stranger Beside Me, and so on. I wanted you to take a look at it and tell me what was wrong so I could react to it and make notes and changes. It was not a finished piece of work. Maybe you misunderstood the chart.

Of course, your remarks about the quality of my notes I cannot respond to. You really have no way of knowing about my note taking ability especially since you did not see my notes. They may be good or they may be bad.

Of course, my writings on serial murder has to be taken from my case studies and interviews with some serial killers. I have secured a rather large sum grant to do such a study nationwide and anticipate doing this in the next few months. I think this study will last about two years. Hoffully by that time I will have some more information, information which is mine and not what I have been forced to learn from other writings. I hope to get the information from the people themselves.

I have enclosed a chapter from my book which should be coming out in September. I have tried to take some direction from the conversation we had together last year. Incidentally, I talked with a former FBI agent in Jacksonville the other week, and he said that he had talked with you several times. I know that he is going to talk about you in a seminar they are doing in Racksonville in August and November. I hope he told you that. I was honest in my dealings with you, and I expect other people to be the same. But we all know that this does not always happen.

It was certainly nice talking with you and writing letters back and forth. But I guess you and I really have reached an impasse. Too bad.

I thought I would drop you a line after the seminar was over.

Overall, I think it went very well. I was very impressed with Al Carlisle. His thoughts on serial murder were interesting. He talked about a feeling of compulsion which he believes sweeps over people who feel the "need" to kill. There seems to be a "shadow" which overcomes their being and they need to kill to keep the shadow from coming and taking over. There is something down within themselves, it becomes so strong that they cannot handle the stirrings.

Don Patchen was good at explaining about the political infighting and turf protection which goes on. Jerry Potter, an author, made a short presentation about Henry Lucas. He is doing a book on him, and his thoughts were that Henry indeed has killed many more people then the 3 Texas has found him guilty of. Thompson and Fisher were there. Ann Rule is concerned about how you feel about her, I believe she still has some very positive feelings for you. I know she would like to hear from you at some time.

My presentation was a little different than the others. I tried to take off on some of the things you talked about. The rational feelings of the serial murderer, the dumping of the victims, the crime scene, etc. I had several people asking about the differences in the presentations of myself and Carlisle. He was very theoretical and almost psychodynamic while mine was practical and pragmatic. Quite an interesting comparison.

Dear Ted,

It has been some time since I have heard from you so I thought I would drop you a line. I hope everything is going OK with you. I am somewhat concerned since I have not heard from you since your letter of April 24th.

I am still very interested in the topic of serial murder. An agent with the FBI was at the Southern Police Institute the other day, Bill Cheek., and he said that serial murder is becoming an old topic. I cannot agree with his statement, but then I seldom agree with the FBI. Rod Englert was also at our school last week. He and Cheek tried to get me to talk with them about you, but I felt it was better to let you talk about your feelings to the FBI if you wanted to. I remembered that you said that a fellow from the Jacksonville office had talked with you. I also have had several news persons call me and want me to talk with them about our conversation. I have refused to do this as per our agreement.

I still have not received my book on the Hillside Strangler. It should be in any day. I have a bunch of stuff I could send you, books, etc., but I should save these until you want to "spend" one of your tickets. Let me know.

I have talked with the people at a company in Louisville called the Louisville News. They have the local distribution rights on magazines and place them on the newstands. They promised to give me all the left over detective magazines each month. This can be the start of the gathering of names of serial killers. I am not aware of any newsclipping service on serial murder, but I do belong to a computer service which will do a monthly gathering of sources where mass, serial, multiple, etc. murder is mentioned. I will initiate this immediately.

I have included with this letter a copy of the news clipping on the Beoria Simmons case, the one I did the profile on. I am looking for the profile itself. I have included a profile on another case where a street drunk was found with his own crutch inserted 17 inches into his anus. The homicide detective has since been transferred back to a beat and no one is working on this case.

Thank you for your latest. I was very interested in your many points and I agree that there was nothing really very remarkable about your early relationship to animals. I think all bright youngsters are bound to inflict cruelty without evil intent just because they have to explore and learn. That is quite different from someone of any age getting their kicks out of putting puppies and kittens in cardboard boxes and setting the boxes on fire or shooting arrows or a .22 through the box. Unfortunately, there are people who do those things for years, starting in childhood.

As for violence in general, Ted, I have no explanation. It is a human capability - i.e. war - and so much else we hear about. We laugh at small time drug users and pushers but they are certainly doing violence, particularly to kids. Answer? I don't have any.

I am well aware of the irony of our two positions. A gliche here or there I suppose and our positions could be just the opposite from where they are now. I can't conceive of my doing the things of which you stand accused but who knows their true capacity for good or evil? It would take a very wise man or an absolute fool to say it is impossible for me to do or have done this or that thing without all of the stresses and history that goes with those things on line to play their part.

You write very well, you are terribly articulate and apparently thoughtful. Have you done any serious writing? It seems to me you have insight that could be important if you really do understand the forces to which you have been subjected and your reactions to those influences. Insight is a sad thing to lose. Put your energies to good use, Ted, write it down if you have not already done so. Having written rather a lot of books myself {54, I think} I know it takes sitting and sweating and thinking and facing oneself.

I do thank you for taking the trouble to write. I don't know if introspection is difficult for you or whether it is something you like to do. Either way, thank you for the insight,



The purpose of this letter is to confirm a recent conversation between you and Mr. Terry Green, Major Case Specialist, National Center for the Analysis of Violent Crime (NCAVC), in which you were extended an invitation to participate in a Ted Bundy Multi-Agency Investigation Team Conference to be held February 20-24, 1989, at the FBI Academy, Quantico, Virginia.

It is expected that this meeting will provide a forum for investigators involved in recent interviews of serial killer Theodore Robert Bundy at the Florida State Prison just prior to his January 24, 1989, execution. Also in attendance will be representatives of agencies intimately familiar with Bundy homicides who were unable to debrief him and detectives from other states where Bundy was known to be active.

As you are aware, it has been a very difficult process of selecting invitees as there is a tremendous amount of interest displayed by law enforcement worldwide in these cases. The participants will number approximately 20 and will be representative of seven states.

It is expected that from this conference and especially the timely exchange of information between attendees, an accurate assessment of Bundy's activities will evolve and provide valuable insights for law enforcement in ongoing or future investigations.

You have been invited because of your obvious expertise in investigating Bundy matters and/or your familiarity with him.

Also in attendance will be Supervisory Special Agent Bill Hagmaier of the FBI's Behavioral Science Investigative Support Unit who, as you know, had developed and maintained a close and confidential relationship with Bundy over the years.

In an attempt to provide for the most constructive utilization of time and offer a model for exchange of case data, investigators are being provided with a suggested format as well as a Multi-Agency Case Presentation Booklet for your use prior to arrival at the conference. It is realized that it may not be all-inclusive and certain descriptors or investigative elements may be non-existent.

It is also requested that participants bring visual (especially 35mm slides) and audio aides for use during presentation and discussion.

It is recognized that your absence from your respective duties may result in some hardship; however, your participation and the cooperation of your superiors are greatly appreciated.

You will be contacted in the near future by your local FBI office who will assist you in travel arrangements. All costs associated with travel and lodging will be covered by the FBI. Please note the enclosed information as a guide for your arrival in Washington, D.C., and your stay at the FBI Academy.

TRANSPORTATION

Arrival

Since there is limited public transportation from Washington, D.C., to the FBI Academy, the FBI will furnish transportation from National Airport to the Academy. Travelers should book flights to Washington National Airport with arrival time at 6 p.m., if possible.

Buses will depart for the Academy directly from the main bus lane at Washington National Airport at 7 p.m. on Monday, February 20, 1989. The main bus lane is located in the center of the airport circle. Gold Line buses will display a sign reading "Academy/Quantico." The Travelers Aid Station inside the airport will have current information should any problems arise.

For your convenience, it is strongly recommended that flights be arranged in and out of Washington National Airport. Attendees arriving at Dulles are to take the Washington Flyer shuttle leaving every hour on the hour from Dulles to National Airport to meet the Academy buses. The fare for this shuttle is approximately \$9.

In the event circumstances beyond the control of the traveler make it impossible to meet the Academy buses, Washington Flyer operates a shuttle that departs National Airport every two hours, beginning at 9:30 a.m., and every hour between 5:30 p.m. and 9:30 p.m., with service to the Academy. The Washington Flyer office is located on the north side of the Main Terminal past United Airlines. The shuttle fare is approximately \$15.

To minimize transportation costs to the Academy, the use of the Washington Flyer or taxi service must be specifically justified on the traveler's voucher claim.

The FBI Academy is located approximately 40 miles south of Washington, D.C., near Interstate 95. Attendees driving take exit 49 (Marine Corps Base Quantico) and travel approximately 5 miles west of the interstate.

Departure

The conference will conclude Friday, February 24, 1989, and bus transportation to Washington National Airport will be provided at 12:00 noon.

ACCOMMODATIONS

The FBI Academy, a training facility for both FBI employees and police officers from around the country, is laid out similar to a small college. There are dormitory-style rooms, cafeteria-style dining facilities, a snack bar/pub (called The Boardroom), movie theater, and numerous recreational facilities such as a gymnasium, tennis courts, weight room, and indoor swimming pool.

Used towels and linens may be exchanged at the laundry room for fresh ones daily. The laundry room, located on the first floor of the dining hall building, operates from 7 a.m. - 9 a.m., and from 12 noon - 2 p.m.

The FBI Academy dining hall operates on the following schedule:

Monday - Friday

Breakfast: 6:30 a.m. - 7:45 a.m. Lunch: 11:30 a.m. - 1:30 p.m. Dinner: 5:00 p.m. - 7:00 p.m.

The Boardroom, located near the cafeteria, offers a variety of snack items, including coffee, sweet rolls, and sandwiches. These items must be purchased by the attendee; the meals in the main cafeteria are free of charge to those wearing appropriate badges.

The Boardroom operates as a cash bar after 4:30 p.m., with snack items available for purchase.

DRESS CODE

Guests and students, while at the FBI Academy, are required to dress in a manner in keeping with the professional status of the Academy. During attendance at the conference, men must wear slacks and shirts with collars. Women are required to dress in a comparable professional manner, such as blouse and skirt, business suit, or dress. Jeans, t-shirts, tube or tank tops, halters, shorts, sandals, and sneakers are not considered acceptable for students in residency at the Academy. All males are required to wear coat and tie for Wednesday evening meal, with females wearing comparable attire.

RECREATION

A variety of recreational activities are available to guests at the FBI Academy. Color television sets are provided in the lounge areas. Outdoor facilities include lighted tennis courts, racquetball courts, obstacle course, horseshoes, and soccer. Equipment is available for such outdoor activities.

The gymnasium is open for use Monday - Friday from 7:30 a.m. to 8:30 p.m. The gymnasium may be used during these hours except when scheduled for classes. Activities include basketball, volleyball, jogging, and calisthenics.

The pool is open for use Monday - Friday from 12 noon to 1 p.m., 5 p.m. to 6 p.m. and 7 p.m. to 8 p.m.

Towels, soap, and locker space are provided in both the men's and women's locker rooms. The women's locker room also has blow dryers available for your use.

TELEPHONES

Each dormitory room is equipped with a telephone that may be used for calls within the Academy only. Pay phones are located throughout the complex for making all outgoing calls.

Incoming calls are handled by the operator and can be transferred to individual dormitory rooms. Incoming collect calls cannot be accepted. The FBI Academy phone number is 640-6131, area code 703.

Pay telephones are located in the Administration, Classroom, Dining Hall, and Dormitory buildings. All other phones available to attendees cannot be used for outside calls and operators will not place such calls.

HEALTH SERVICES

If you should become ill or injured while at the FBI Academy, you should contact the Front Desk in the Administration Building by dialing "O" from your room telephone. In the case of traumatic injury, serious illness, or a death, you should use the telephone hotline number, 3333. The operator can alert the Security Force, who are trained in emergency first aid and CPR.

A registered nurse is on duty during normal working hours Monday - Friday. Her office is located in the gymnasium building near the men's locker room.

AUTOMOBILES AND PARKING

All attendees driving to the FBI Academy will register their vehicles at the time of registration. Parking is provided in the large lot across from the Administration Building. Please observe the areas marked "Reserved." A parking permit will be issued at registration and must be displayed in your car when parking at the Academy.

MAIL SERVICE AND MESSAGES

A Sovran bank branch is located in the Dining Hall building adjacent to the cafeteria. Attendees may cash checks using proper identification and indicating the course they are participating in. Banking hours are 9 a.m. - 1:30 p.m.

A small Marine Corps Exchange is located in the Dining Hall building adjacent to the cafeteria. Personal care items, snacks items, and miscellaneous merchandise are available. The store is open from 10 a.m. - 6 p.m., Monday - Friday.
