This dept. received four American Express checks at \$20.00 each signed by [REDACTED]. The checks were returned to the victims as forged checks. According to American Express office in San Francisco [REDACTED] purchased \$1000.00 in travelers cheques from Seattle First National Bank in Des Moines on 11-23-73. On 11-29-73 he reported that he lost \$920.00 in the checks while shopping in South Sound Shopping Center Lacey Wn. while shopping there. He thought they were taken from his pocket by an unknown person.

Lacey Merchants took these checks on 11-27-73. According to witness Larson who took one check at the Village Coast to Coast store at 4516 Lacey Blvd. the incident went as follows; In the mid-afternoon on 11-27-73 a WMA in his twenties, Approx 5'10" to 6'0", approx. 175 lbs. with light brown wavy hair entered the store and purchased \$2.00 to \$3.00 worth of hardware. The items were believed to be a small screw driver and possibly a pair of pliers. The Wit. was not certain of this but did recall that where these objects were was where the susp. had been standing.

Larson stated that the susp. had a homemade type cast on his right arm. The cast was made from two splints and a thick covering of ace bandages. The susp. related to her that he had a broken hand or arm. (there is some question as to which as the bandage was apparently much larger than that needed for a broken hand). Larson stated that as a first aid instructor she should have known better, that the bandage was not the type that a doctor would use on broken bones.

The susp. produced a traveler cheque to pay for the merchandise and when confronted with the fact that the signatures did not match there was some light hearted conversation about the fact that they wouldn't match due to the fact that he was writing with a broken hand. Susp. produced a driver's lic. which was believed to be a Montana or possibly a Wyoming lic. Larson stated that the signature on the lic. and the original one on the check did match.

██████████ gave the address of 9915 South Tacoma Way as his home and 10 ██████████ Bridgeport Way SW Tacoma as his employment address.to the bank when he purchacedthe checks. According to the bank the home address of the subject was not a true address. It is unknown at this time if the place of business was also phony.


According to Washington D.M.V. they have no record of an ██████████. The telephone Co. relates that they have no listing for such a subject either in the Tacoma area or in the Seattle area.

Information received by this dept. shows that susp. cashed checks in the King Co. area and possibly in Pierce Co. This investigation is continuing.

American Express indicates that Seattle First in Des Moines gave the susp. a full refund without taking I.D. information.

The checks written in the Lacey area were taken the same week as Cathy Devine was murdered.

More investigation on ██████████ is in progress by this dept. for fraud. Any of this information will be forwarded to those dept.s interested.

The business address of 10 [redacted] checks out to be the former address of [redacted]'s employer; The Americana Corp. The corporation shows a new address in Anchorage, Alaska. [redacted] is reported as being a salesman for the firm and travels a great deal of the time.

It was reported to this officer by the present occupants of the upstairs office at 10 [redacted] that [redacted] had quite a charming personality. He is said to have been and is a ladies man, having what seemed to be irate boyfriends looking for him. [redacted] was reported in this instance as having dark, almost black hair and a thin mustache. It was also noted that before the mustache he had a small beard. Indications were that he might have frequently changed his personal appearance. [redacted] has also made several trips to Idaho, Montana, Wyoming and Alaska.

Susp. has no solicitor lic. in the city of Tacoma.

She stated that a combination of the composites of "Ted" could match the description of the second subject. She also stated that the color of hair on susp. [redacted] could have been a sloppy dye job.

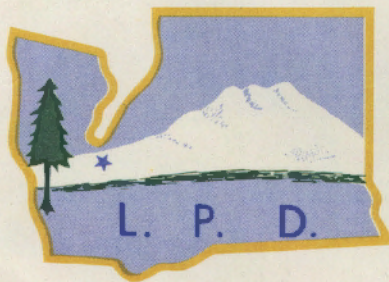

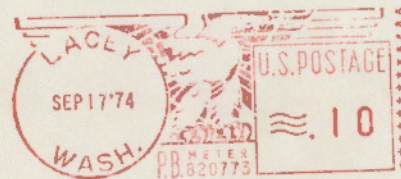

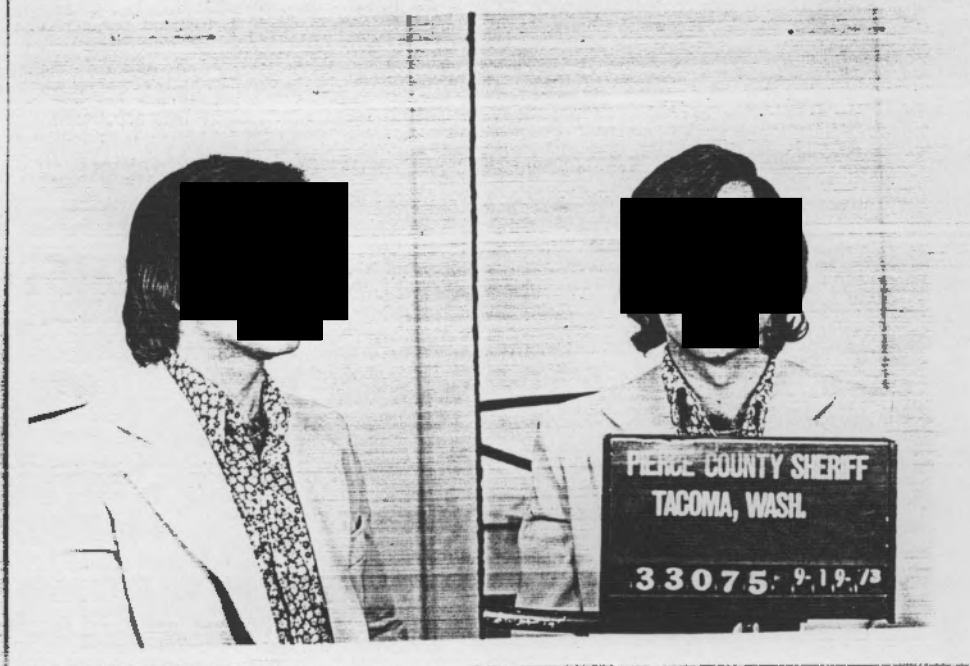

SUBJECT: CANADIAN "TED" SUSPECT

I received a call from S/Sgt. Fred Bodaruk, R.C.M.P. today with information about a subject they have under surveillance who could be connected with one of their homicides. His name and address are: [REDACTED] of Apt. # [REDACTED] St. Andrew Street, New Westminster, B.C. He is 6'1", born September [REDACTED], 1936, occupation - steelworker, has medium brown slightly wavy hair, scar on nose, neat dresser, drives sporty cars and could very easily have an accent. He drives a '73 medium green Mazda Stationwagon, NDF-[REDACTED]. He was running with a Tony Cuch for awhile. [REDACTED] has done time for 2 counts of rape in 1963. He apparently is in the vicinity of Saskatoon and Moosejaw. The R.C.M.P. has a special task force watching his movements; they feel that he could possibly be sleeping in cars.

[REDACTED] is a "mother's boy" and runs home whenever he gets into trouble. He is divorced and was living with a woman named Ester. On one occasion [REDACTED] had intercourse with Ester while his mother watched. During this act he failed to climax so he got up and walked around the room masturbating. Mother packed up and left.

On several occasions he has gone to Seattle putting 800 to 1,000 miles on his car. When he returned from one trip his mother noticed blood all over his clothes. She asked him what it was and he replied that it was blood. He said that while he was in Seattle he was sleeping in a park when some guy tried to rob him. [REDACTED] said he beat hell out of the robber and that's where all the blood came from. He didn't have any injuries to himself at this time. There was no time on this incident.

[REDACTED] has bragged to his sisters who reside in Price George that he has raped and killed since 1963 and will never be caught as there are no witnesses whenever he commits an act. S/Sgt. Bodaruk is going to re-interview the sisters personally.

I requested S/Sgt. Bodaruk to send us a photo and reports regarding [REDACTED] to me.

For what it's worth it's something to consider not only for the Ott-Naslund case but SPD and our morals unit as well. Further information will be forwarded to this Department as the R.C.M.P. gathers it.

# Forsyth women's body found

FORSYTH (AP) — A spokesman for the Rosebud County sheriff's office said Friday two Vietnam War veterans grilled repeatedly in the disappearance of Peggy Harstad probably will face more questions, now that Miss Harstad's body has been found.

Fishermen walking through a tree-lined, flood-water drainage slough of the Yellowstone River found Miss Harstad's badly decomposed body Thursday night.

The body was found just upstream from Forsyth, hometown of the 22-year-old woman who was the subject of a search since July 5 when her abandoned automobile was found on a frontage road only two miles from her parents' home.

She was last seen July 4 in Melstone, about 80 miles from home, after attending a rodeo the same day in Harlowton.

Rosebud County Coroner W.E. Beals said Miss Harstad was identified from clothing and jewelry still on the body. He said Dr. John R. Pfaff, a Great Falls pathologist, was conducting an autopsy.

Beals said the body's decomposition would make it impossible to determine if the woman had been sexually assaulted. He said an initial investigation showed conclusively that the body had been immersed in water but it could not be determine how long.

Authorities said the Yellowstone River flowed regularly through the slough — about 75

yards from the main river bed — until mid-July. Beals said the river rose last week as the result of heavy rains and flooded in the slough again.

"There was no water there when the body was found, but the ground was damp," he said.

In mid-July, Sheriff James V. Schiffer and an undersheriff traveled to Sheridan, Wyo., to question two men in connection with the woman's disappearance.

Undersheriff Graham Makin said Friday the men had been questioned both by local authorities and the FBI. He said they were not charged and had since

## Dying police chief's wife kills hi

ST. ANNE, Ill. (UPI) — Jewel Dandurand, wife of St. Anne's police chief, watched as her husband was shot to death Friday. Then she picked up his revolver and killed two of his assailants as they scrambled to disarm her.

Rudolph Dandurand, 38, who had been police chief of this small eastern Illinois town for 14 years, died at a hospital in nearby Kankakee shortly after he was shot once in the left side with a hollow bullet.

Kankakee County Sheriff Tom

Maass said Mrs. Dandurand, 35, gave this account of the incident:

The Dandurands were driving in a squad car when they saw three men arguing outside a tavern. Dandurand recognized one of the men, Earl Stalneck, 25, who owned an auto body shop in St. Anne, and he went over to talk to the group.

"He decided to take Stalneck back to the body shop to sort of cool things down," Maass said, but shortly after the squad car arrived at the body

shop, the other two men drove up in a pickup truck.

Maass identified the pair as Larry Selvey, 25, and Carl Tiberia, 30, both employees or former employees of Stalneck.

Maass said Selvey had a .22 revolver, which he turned over to Dandurand upon request, and which Dandurand gave to his wife. But a heated argument continued, with all the men standing near the squad car, and suddenly all three turned on the police chief.

"In an instant it changed

from an argument between three men to a fight between the chief," Maass said. He said one of the three died, but he did not say who.

At that point, though wounded, he picked up his squad car, and he radioed for help.

He handed his .38 Smith & Wesson Magnum as Selvey entered the squad car, and Selvey began to kill him and all the other officers of the police force.

He also said there may be further developments in the case now that a body has been found. He did not elaborate. "There is a chance they (the veterans) may be talked to again," he said.

Schiffer said the men, described as mental patients, are known to have been motorcycling in the same area through which Miss Harstad would have traveled on her way home.

Beals said results of the pathologist's report should be available within three days.

Since I've resided at this hotel off and on and do historical *C.W.S.C.*  
researching at both the Ellensburg Public Library and the college,  
I do move about this town since 1970..and usually walk out the  
back entrance of this hotel onto their parking lot when cutting  
over behind Postoffice to the public library on Ruby Street.

I was here then, when Susan Rancour turned up missing at the Central  
Washing State College, a year ago early April.

I brought this information to the attention of Lee Cummings and  
her co- manager, Lindy Johnson, "that a girl was missing and to  
be on the watch for her." *(Then manager of Webster Hotel)*

Now one day I saw downstairs a blond girl, wearing light grey  
cordoroy slacks ~~and~~ printed fabric blouse..of Rayon material..in  
a light tan blending of colors in combination with pastel reds//etc.

This girl had been there at the hotel on two differnt times ..during  
a possible two day interval. And with a very tall dark, young  
man, whom I took to be an ex-college student, and conversing with  
a young blond man by the name of, Randy Essex..who was then local

I saw that Rancour girls picture in the local paper here and decided she looked familiar and that she was dressed exactly like the girl I had seen down in this hotel lobby with several young men.

A I should have called the police right then..But I didn't..Because this case was not taken seriously enough and at that time many young girls were "dropping out" or running away..etc.

B But then I heard a young man visiting with my then neighbor on second floor, a very elderly gentleman, Reed Evans..at about midnight. <sup>or later</sup> They were talking very loudly and I complained to them and to the desk. They finally had to call Mr. Evans. <sup>to</sup> hold it down..etc. And he does drink heavily and habituates the local bar's and is generous with his money, food and company..and, on time..

That very same period I saw out in back a beige colored Volkswagon. An unusual color then, for me...I took a good look at it and of course..did not look at the license plate..I was looking at the peculiar painting of that coat of paint..Either it had just been done by an amateur..and had a sort of "glazed..or frosted <sup>color</sup>" look in the "over tones"..or that was a new car and with a brand new paint concept."

Then I heard about ..or rather..read, locally that a young man had been bothering one of the librarians..and was thought to be the person called.."Ted." So I called the Security police up at the college about this Volkswagon..and "no" I had not taken down that license plate number.. <sup>unfortunate</sup>

However, It then came to me, this was the second time I had seen that same Volkswagon at this hotels parking lot..and the way it was parked both times? It was parked right in front of Mr Evans' apartment ! which is <sup>yes</sup> B30 right off the downstairs laundry unit. And straight off the parking lot adjoining Pearl street.

Now you see this picture the way I have altered it :

During this same period of the mysterious Beige colored Volkswagon's appearance at the Webster hotel ? The first time it was here ..Mr

Reed Evans was sharing an apartment with another man..and was living downstairs in B30 apt.

But the second time that Volkswagon was here in the parking lot it was parked in the same location right in front of Mr Reed Evans apartment. <sup>B30</sup> however he had moved to the second floor and was now in Apt #12..right around the corner from me..so that his apt window opened right out on the same parpet and was so close to me..by being around the corner.. of that squaring..I could hear Mr Evans talking or heavy breathing when he was sleeping.. *even.*

<sup>here</sup> Nowhere is the decription of this man I Saw coming from around the same corner leading to Reed Evans apartment...either going there or coming from..this picture was also in the Post Intelligencer.. <sup>#12</sup>

A. About 5' 7 1/2" or 8" tall

b. Dressed in faded blue jeans..Levi's , medium blue, pull over sweat shirt <sup>type sweater</sup> with long sleeves and an undershirt or turtle necked white woolen, or cotton, pullover, over sweater underneath..so that the V neck..was all white.

c. Tennis shoes..white I do believe.

D..a medium -acqua blue, stocking cap ..wool or simliar weave and simulated material..He wore the same on those two occasion's I saw him all in the one day..and the last time and first time I ever saw him here or anywhere. *Sis Wilkins*

Now here's the sticker...I saw the maid <sup>later</sup> or, between these two trips of this stranger and I remarked to the maid.. *quote* " That young man that was just here looks like that "Ted" that is in all the newspapers.." *quote*

The maind said..quote.." Oh you must be talking about Reed Evans son.." Unquote..and that was the conversation.. *Then.*

Later, she came around my door and said.." You know Mr. Reed Evans son, does look like that "Ted"..unquote..and that was the end of at discussion.

Now this young man..assumedly Reed Evans son ? Had pale skin.. light blue eyes...freckled faced..and sort of reddish skin. a little blotched even..as though he could have been a sailor.. or at least spent time on the water. *a indoors But might have been drinking beer*

He looked a bit fatigued..and was very thin..possibly weighing between 125 pounds to 135 pounds..he just was a small young man whose face would put him at 25 to 27 years of age..

I hope you have absorbed all of this to here? Because I am going to tell you: a Young blond man called David..stayed here this past winter.. Light blue eyes..brawny..weighing around 180 lbs..medium blond hair..down to below his outer coat collar. About 5'10"

With a damaged nose bridge, as though he had been injured in a fist fight..or car wreck? that nose was definitely broken sometime or had been..<sup>at the September</sup> he had a jolly manner..likable but a heavy drinker.. and like his "Stepfather" Reed Evans ? spent considerable time in the local bars or drinking in the rooms here with other men.

So this man then was Mr. Reed Evans "stepson" David..and he had lost his drivers licence and could not drive. He spent all of his spare time with Ernie Neuman..an ex-convict..who had an apartment

at the end of my hallway here in apt #24. Ernie Neuman, is now back in jail as a sneak thief and had robbed this hotel floor's, both lower and on the third floor where I now live. and in violation of his parole -

So then..David Evans ? did he take Reed Evans name. I don't know.. But I have this feeling..David Evans..was not the young man of the enclosed picture herein..Not by a darn sight..He was much too heavy and brawny..

So then ? Who was the "Ted" type young man who was seen coming from or going to those rooms..from #4..through 12 on the second floor and in the general direction of Reed Evans apt #12..Was it "Ted" Bundy ? And had he struck up an acquaintance with the old man, Reed Evans..or was this "Ted" type person..a relative of Reed Evans..or, had he merely taken rooms here on two different times..and by co-incident just parked near Reed Evans downstairs.. and later, taken a room near Reed Evans on the second floor..?

However, I believe I have tied this all in together so that the overnight room registrations taken in April ? by Lee Cummings and her boy friend Lindley Johnson shall show..who was the owner or driver of that "Beige colored Volkswagon .

When Susab Rancour disappeared here in April ? Lee Cummings and or Lindey Johson definitely were on the desk.

When I heard voices in Mr. Reed Evans apartment # 12 on second floor ? A Mrs and Mrs Richard Rapier were then the managers .  
( Hotel owned by Rex Rice and still owned by him etc.)

And this was the time I saw the person who looks like enclosed picture..and the brown -beige colored Volkswagen..in parking lot..

It was then a few days later I called Sherril Martin and told her about the beige colored Volkswagen in the Webster Hotel parking lot..so this would place all of that activity during May-June..? of 1974 ? Miss Martin's records at Security Police will show up at Central Washington State College..

It was at this time I remember..the maid said.." Mr Reed Evans son was here..and "yes he does look like that "Ted" whose picture was in the newspaper..so then ? This picture was in the Ellensburg Daily Record..because Lois Wilkens .maid..does not take the Post Intelligencer.. (I do & have - long time)

Now in closing ...: When Mr. Reed Evans " Stepson" David ? was staying here last winter and this spring ? He was a sheep herder. So was Reed Evans,,and, a very knowledgeable one..and also as a person..he is still very mentally alert and I say.." Learned"..  
But now a diabetic..and has been hospitalized..but is out now..  
So his stepson then. did own a off white Ford Sedan..about a 1964-1965 4 door sedan . See ? It does not check out with "Ted" driving a beige colored Volkswagen..does it ?

Who was the facible of this picture as I have re-shaded..and of a golden haired young man..too. But I believe " my "ted type" as drawn here..had even darker..hair..tough to tell when one does not like to stare at a stranger..in a hotel hallway..or at any time..

So you can very easily check out all I've put together here .. And who knows ? Maybe Mr. Reed Evan's son tell you A. If it indeed was his son here those two times driving a beige colored volkswagon..or a stranger who picked him up in a bar.. or even in passing Mr. Evans apartment. A lonely old man..who is very hospitable..and a heavy drinker even bar-fly !

And who always keeps his apartment door open so that anyone in passing could speak to him and be heartily invited "to go in and visit" with this poor lonely old gentleman.

And Mr. Reed Evans is the type of man who would share his room..bed..food and hospitality..to a stranger..and if he did this..then there would not be any registration of my "Ted type" who was here..and Lois Wilkens maid, called him "Mr. Reed Evans son.."

Now you have to be careful with Lois Wilkens..she is a police hater..and a dam liar..you cannot trust one darn word she says..as we who have lived here at any length of time..know so well to our own chagrin..I personally have suffered from her avid gossiping..and pathological lying..Because she cannot tell the truth..she just is to be pitied..that is all. period.

I did report that she had in her possession shortly after the Richard Rapiers had quit here...Managers in May- June..etc..1974  
"A Yellow light weight linen coat..womens.. And, why you are getting this letter? Our police here went right out to Lois Wilkens home and asked her about that Coat..which put me right on the hot griddle..because outside of the Owner Rex Rice..and Lois Wilkens? I was the only other person who knew that yellow bouffant dress style canary yellow casual coat was here and that "some over night" had left it behind..so Lois Wilkens then has not trusted me since that period..and I honestly? Cannot blame her: Susan Rancour? Had such a coat..remember?

Therefore in closing..please protect me? In every way?

And maybe just possibly? Either his hotel or Mr. Reed Evans may hold a clue to whom the owner of that odd looking beige colored Volkswagon belonged to..? (He could be related to Reed Evans)  
And all good luck to you. If I can think of anything else..I'll pass it along at once..

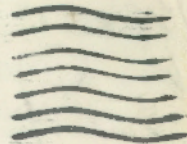
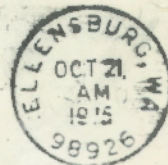

Dear Sir:

What is the saying<sup>9</sup>..no matter where you are or what you are doing ?  
Someone , somewhere has been watching you ?",,Remember ?

I've been very interested in the Bundy case. Because one of our  
College students Miss Rancour turned up missing in Ellensburg in  
1974 ..April...and a man resembling Ted Bundy was seen here trying  
to entice two different girls into his Brown Bug Volkswagon..etc.  
And she was one of the six girls whose bones were found near  
Lake Sammish etc..near our state highway traveling over Snoqualmie  
pass in a place easily accessible from our Snoqualmie pass highway.  
Okay ?

Now..let me fill you in on Ted Bundy and Governor Daniel J . Evans  
in Yakima Washington on a cold day in about Feb.march of 1973..

this is the scene: A young man suddenly wheeled up a grey-blue

Thunderbird 4 door sedan..about a 1963 model in the alley in the rear of the Old Commercial Hotel in Yakima Washington..about 8:30 P. M. This incident happened in hunting season that year in Yakima. The young man quickly stepped from the car and almost bent in a half crouch was eyeing me..eye to eye..in almost a defiant manner.. watching me closely as I neared them and came aside their car now parked right up against the rear door of a bar..restaurant...complex still functioning with in the old now closed..Commercial Hotel.. Where, inside a most excellent cocktail lounge and restaurant was most active and popular.. But a more or less "in" place and expensive and usually patronized by those who did not wish to be seen entering a bar..serving liquors etc.

When I was within less than 8 feet of this young man ? The car driver ? another young man stepped out of the passenger seat of the front seat and was watching me too..because ? Right at my side almost within less than six feet now..was none other than Daniel J. Evans..being propped up by a young woman on his right..and he had his right arm tightly clenched over her left shoulder..and on that young ladies right was still another young man..helping the two of them walk from ...? The alley and car port of the Chinook Motor Hotel..whose drive through..made it possible for anyone to walk right through their archway..across the Bank of America Parking lot..also adjoining the old Commercial Hotel..

And inside the aforementioned dining and drinking complex of the Commercial hotel..without being seen on either Yakima Avenue.. or Fourth Avenue..or third avenue..because this alley comes off of Fourth and third..avenues..in between them and the Capitol Theatre. And, The Bank of Yakima..is first across Fourth avenue..still on the alley..then the parking lot..a coin operated one..and the Commercial hotel..dining and drinking complex...

So ? Imagine Gover Daniel J. Evans embarrassment to get caught..red faced..flat footed..hatless his thinning hair on top not covering his skull..and he now has rather long sideburns..but well trimmed.. He is obviously so drunk..he cannot walk alone..in fact, he looked totally helpless..and three terribly concerned young men are trying to cover for him..and get him out of that bright alley into the semi-darkness of the Commercial hotel interior..A very embarrassing moment..for the Governor..repeat because his face is being seen daily almost, on television for he is running for re-election for his second term.!

Now Ted Bundy ? You couldn't mistake that face..not any more.. For I now have him placed in time and place..and he was fit to be tied because I obviously was doing double takes when I saw the Governor..and when I saw Ted Bundy acting like he was saalming..for ~~Some~~ High Eastern Potentate..no less..You could tell Ted Bundy was terribly impressed about his chaufferring and "herding" of Governor Daniel J, Evans of Washington State ! And who was ? Drunker than a skunk...!!!

So I was as curious as I could be trying to fill in the missing links here of how come our state Governor is so drunk that early on A Sunday Afternoon..and, what is he doing in Yakima ? There was no mention of him in the local newspapers as coming to Yakima.. so I slowed my walking enroute to the Chinook Hotel archway..and watched Ted Bundy yet..quickly wheel that Thunderbird..backwards into the Bank of America Parking lot..and then walk hurridly back to join the Governor and his party now safely inside the back door of the Cocktail lounge and restaurant of the Commercial Hotel..

Within a 3/4 of an hour..or maybe a full hour, I came back from a Sooper -Dooper Grocery store over on sixth avenue and came back the same way..across the Chinook Parking ..

through their archway and across fourth Avenue..onto the Bank of America parking lot..where I saw the Thunderbird sedan..now parked. Drive concern etc.. in *Yakima WA* <sup>above</sup>

So in our brief encounter that lasted for ~~three~~ <sup>about</sup> minutes.. Because I was watching that scene..from the entrance of my Yakima Hotel.. straight across from the Capitol Theater..and directly down that Alley as I recognised Governor Daniel J. Evans at once...and tried to cool it so that I could walk right past him..and get even a closer look at our Washington State Governor..! Because ? had lived in Packwood Washington the winter and spring of 1967 and had been in contact with Governor Evans and his office concerning a Packwood Brochure I was then working up..etc...And his officenically sent me this picture..his biography and his endorsement of Mt Adams recreational area..but forgot to include..Mt. Rainier which is only 15 miles from Packwood Washington..etc.

Now ?..Let me take you people back to a car wreck that happened near Olympia..in about the same time slot..that is..somewhere between..1973..or earlier..I believe it was an encounter with a pickup..and another car..on a cool wet morning..when said car came barreling out of a side road near the state capital "conglomerate"..complex...onto the main highway..and ran smack into the pickup..broadside..Someone was hurt..in the pickup.. and I believe "the hit and run car"..sped off..but was tracked down a "Belonging to A State Official".."Who was very high up.."Right at the very top!" so it was told to me..and ~~there~~ <sup>Q</sup> injured and ~~owners~~ of the damaged car..a pickup I do believe..were going to sue the hell out of that same

when they learned his name..But their attorney.." Already seemed to know who it was that struck them..left them hurt and sped off.. And who was driving..not his own but a borrowed car!" Unquote.. Now I know who this lady is who told me the story..but since I was traveling a great deal about this state that time in pursuit of historical researching..I cannot get a handle on the young lady. But as I write this I can sort of see her..and it was in Yakima at the rear of the Parkside Apartment in the apartment of Mrs Edna Woods Henderson..a recently bereaved widow..of Lloyd "Swede" Henderson..a deceased..cowboy..and now Edna his wife..was no longer manager of the Parkside Apartments ~~on~~ East E. Street, Yakima.. And this young lady..I'm talking about who was hurt? in that recent car wreck near Olympia..was either living at that very time..in The Parkside Apartments <sup>*she was living there!*</sup> waiting on a settlement of her hit and run..car accident that saw one or both of her limbs severely damaged..and a knee cap still in very bad condition.. The time of that wreck? Had to be also in 1973 <sup>*or early 1973*</sup>..and possibly around..the Thanksgiving Holidays..!

I got the impression this young rather heavy set..about a twenty <sup>*blue eyes - dark hair -*</sup> three year old young lady..had a good idea..she either had..? A..Governor Daniel J, Evans on the run..(Hit and run..leaving the scene of an accident and injured person..) B. Lt. Governor <sup>*John*</sup> Cherberg.. or....The <sup>*retired attorney*</sup> ~~Attorney~~ General? John O'Connell <sup>*just retired*</sup> (Lt. Governor's attorney General..John O'Connell.) She was very carefully coached by her attorney fighting her case for her..so you could take it right from the top..that it was...Governor Daniel J. Evans or...recently elected..Secretary of Agriculture..Stewart Bledsoe.. who also drinks very heavily..etc.

Now how does all of this involve Ted Bundy ????

Number one..he was seen in Yakima driving a blue grey car that obviously belonged in the Governor Daniel J. Evans party...and Ted Bundy..had obvious control of that same car..and to where it would be parked..

He also was running interference for Daniel J. Evans..and his party who had just walked across the street from the Chinook Hotel and who was seen entering the back door of the old Commercial Hotel for one or two purpose or both..to eat..or to drink some more..too.

And Ted Bundy was strenuously alert I might recognise..Governor Daniel J, Evans..at a time when the man was so drunk he could not navigate under his own power and it took a woman to his right and a man to her right to prop the Governor along for a span of some two hundred feet..from the Chinook to the rear of the Commercial hotel back door and get him through a rather narrow..screen door. right off the alley..between a whole flock of garbage cans on either side of that narrowed doorway..

The timing of both incidents..Governor Evans arrival in Yakima.. with some one else doing his driving for him ? and that earlier hit and run case over near Olympia..in Thurston County..all might very well tell you people a most interesting story. ...about Ted Bundy..and why he is suddenly chauffeuring for the Governor.. and why now ? John O' Connell ex-attorney General for the Same Governor..is fighting the Ted Bundy case..

And I know with all your expertise..you can run all the contents of this letter down..

and learn, just how closely did Ted Bundy relate to..Governor Daniel J. Evans ????



From where I sit ? I just think you have the right man..who is a woman killer of the worst kind ! Because that deeply intense young man I saw driving Governor Daniel J. Evans car in Yakima in 1973.. had the same appearance, intentness and demeanor..of a Jeb Stuart MacGruder..who would do anything for the disposed..Richard M. Nixon.. and so who being so fired up with his own self importance..might just be the kind of a guy..who would kill..to keep from ever being recognized..because he had some exalted idea of becoming Governor of Washington State..one day !



I always went out the rear of the Webster hotel..because among other thing' it was a direct short-cut to the Model cleaner's and the public Library ." ? Well let me refresh your memory to a letter of last summer and about a girl wearing a yellow , Canary yellow, bouffant ~~type~~ coat. A spring, light weight wind break ~~er~~ type coat ? The kind that was then selling at Penny's store here ? ( Last spring)

I said and I quote.." I was coming home from the library and I saw on the opposite side of 3 rd <sup>st</sup> a fellow and a girl..she was "high" on something..could not stand or walk alone..and this guy in overalls..bib..and no outer jacket was kidding her..and they were almost to the telephone exchange...parking lot on the west side of third street..I said 'it must have been before 9. 

## Grief Attends Service For Lynda Healy

BY LETTIE GUDMESTAD

The natural sorrow was stretched thin from the year of waiting, and heightened by the frustration of not knowing how or why it happened.

It was sorrow that brought them together yesterday, the family and friends of Lynda Ann Healy, as they gathered for a memorial service for the University of Washington student, 21, who vanished from her University District rooming house Jan. 31, 1974.

The final chapter to Lynda's disappearance was written last Thursday when remains found in a search area near North Bend were identified as those of this first-of-eight young women missing from the area last year.

The remains of three others have been found at the site in the Taylor Mountain area and identified by King County police as Roberta Kathleen Parks, 20, of Lafayette, Calif.; Brenda Carol Ball, 22, of Normandy Park, and Susan Elaine Rancourt, of Anchorage, Alaska.

The remains of Denise Naslund and Janice Ott, suspected to have been killed by the same man, were found at another site earlier this year.

After an inch-by-inch search of the Taylor Mountain site, Saturday police officials announced the formation of an eight-man combined task force of county and city police who will tackle the baffling case.

But the crowded congregation of Eastgate Congregational Church yesterday concentrated on the good, the bright and beautiful Lynda Ann Healy.

Cathy Keller, a friend of Lynda's since grade school, remembered the slumber parties, the football games, the sock dances and the shopping

that the friends had enjoyed together.

"We sang for hours," she said, "shared confidences, held discussions far into the night. She was my friend when I needed support, she had the ability to inspire confidence, she was the eternal optimist."

Another friend, Kathy Brown Lee, sang "Let There Be Peace." "Let there be peace on earth, and let it begin with me."

In his memorial message, the Rev. James P. Fairbrook referred to the "terrible and unbelievable mystery hanging like a dark and gruesome shadow over our area and the lives of us all" and the "enormous tragedy of her death."

And he remembered warmly Lynda's interest in music, her appearance as Fiona in the Newport High production of "Brigadoon."

"She was one of our soloists in the Winds of God folk mass in 1969," he said, "and she came back and sang for us after she entered the University of Washington."

She continued her music at UW, took courses in childhood education and worked with retarded chil-

dren at Camelot House, he said.

"But most memorable was her cheerful personality and her widespread interests. She loved doing things, she loved life, and she gave herself to it. She lived fully and joyfully her too-brief score of years," the Rev. Mr. Fairbrook said.

After the service, friends stopped for a few words with Lynda's parents, Mr. and Mrs. James Russell Healy, of Bellevue; her brother, Robert, and her younger sister,

Laura. Her grandmothers are Mrs. G. E. Healy, of Portland, and Mrs. R. L. Strickland, of Oregon City, Ore.

The Healys told friends about a memorial that has been set up in Lynda's name with the Chief Seattle Council of Boy Scouts, 3120 Rainier Ave. S.

"The fund will be used to buy equipment for the Scouts' Search and Rescue units," Mrs. Healy said. "They helped with the search up near North Bend, and they also searched Cowen and Ravenna Parks, near her house, after she disappeared."

"It has been a bad, bad year. But, I guess, it's somewhat of a relief now that we know

Last year around the first ten days <sup>not later than</sup> in June , while living in an apartment right off the stairwell on second floor of the Webster hotel , in Ellensburg , I heard a strange commotion out on the stairway.

I looked at my radio clock and it was about midnight. Up until then the hotel had been very quiet. As a retired nurse I was a bit disturbed because the sounds were like those of someone who had fallen..or was having difficulty manoeuvring those stairs from the second landing up to the second floor. ( 2 floor here )..At that time a young couple , she expectant and about 7 months pregnant were managing her by the name of Mr and Mrs Richard Rapier . They were not very helpful to registerants.. nor to anyone, for that matter, being too wrapped up in the expected babies arrival..etc..and never came upstairs to show a new rentor their room's..etc.

So....I began to hear giggling then again another series of bump, bump, bump. I put on slippers and went out to check and looking

down the stairwell I saw two young ladies.. One a lovely honey gold blonde..with shoulder length <sup>dark</sup> tresses..wearing one of those over the head white macarame shawles that come down complete with long fringe to about the hips. She was a buxom big blonde..wearing white sandals..and i believe <sup>lavender</sup> ~~now~~ <sup>bright</sup> ~~light~~ colored slacks..I'm <sup>(Pink?)</sup> still inclined to see them that color..She was about 5' 7" or maybe a trifle under that..weighing about 138- to 140 lbs or so..when she stood up.. that is.. but at this <sup>moment</sup> ~~moment~~ she was ~~just~~ sitting ~~indiscreetly~~ and giggling.. with her companion..

Girl # 2..I was looking right into her lovely brown eyes..she had bangs and black hair..her hair was not as thick and flowing as her friend... the blonde..thinner..She had a very well defined face..very petite.. smaller and rather perfect features.. nice white even teeth and she seemed more embarrassed than the blonde who was inclined to bluff until I said.." Look kids, I'm a nurse..can I help you get up these steep stairs..

The brunett when she stood up..was slighter of build,..about 5' 4 ".... She was a "study in all lavender", and purples..slacks...sweater over a possibly modified version of a turtle necked under the light coat <sup>(hip length)</sup> sweater..now all of her clothing ~~was~~ shades of purple and lavender and she may have had on a silvered typed of sandal..either silver or gold .. metallic finish, that is..

To make this more brief now..The blonde was "the aggressor"..very definitely taking hold of the brunetts arm and she was going to get them both upstairs without any aid from me..a little old grey haired lady...But obviously neither one could stand without hanging onto the handrail .. So the Brunette said.." We will appreciate any help.." So I went down and got the Blonde on one arm..and she held on to the smaller brunette and upstairs we went...all the way to the third floor where they turned to their right..and I never saw them - <sup>again</sup> -

That is , I didn't think I had until I saw the pictures of Gloria Hawkings..and this same Lynda Ann Healy...and I swear to this very moment these girls were together last early June and right here in this very hotel

Now in walking up this long series of stairways...to third floor..

The Brunette apologised..well, they both did and one said..

" We are just celebrating Graduation time..you know ? Out of school... college overwith.." ? Still giggling...

But I smelled Marijuana on them that reeked to high heavens...and Vodka..They said they had been drinking Vodka..but nothing was said about smoking 'Pot'..and I naturally was keeping my mouth shut.

Just laughing with them and being compassionate ..like anyone who found two beautiful and lovely and obviously well bred..well dressed and truly good girls..in a slight embarrassing moment..They had simply become intoxicated..and lost their equilibrium. (oops). but I do mean power of locomotion..

One thing that stayed with me to this moment..the little <sup>Brunette</sup> ~~blonde~~ kept repeating.." But we won't drive..." Then lapse into more giggling but again saying waggishly." We won't drive. " Unquote..

That gave me a thought..perhaps these girls had come here from Seattle, or Yakima?...and had been entertained some place where they had been slipping the Marijuana ciggeretts..I just looked at them..their skin coloring..both had beautifully fresh and clear and good skins..both girls approaching their 20's..etc. The Blonde had a true "peach and cream" complexion..she had high color in her rather high cheek bones. as though from Slavic parentage..or heritage..The brunette had very good delicate skin..their eyes showed the ravages of time that would have been present had they been addicted to drugs over a period of time. Not these girls!...they were well cared for in every respect...But just out on the town for a evening of fun..and I don't think any males were included.. later.

To digress a bit..Before young Rapier and his wife managed here? A pair of advanced alcoholic's man and wife...were in charge..They would rent to anyone..almost..Young kids..couples...and just shut their eyes and ears.. This is a college town.

So the moment I saw the item in paper and heard it over the news..that the Rancour girl from this college was missing..I called the lady Manager and she brushed it off.." Oh yes.." she snapped.." We all know about her." So I just kept looking anyhow..A small town like this and a young college girl missing? It put a pall over this town..We elder people may have been even more concerned...having to face up to the fact..that poor young people of both sexes are no longer safe any where in this Nation. Also, Patricia Hearst was in the news..so I saw a pair of girls too at that time..One was a blonde with a brand new baby..the other wearing very dark Glasses..looked exactly like Patricia Hearst! But then, the way so many young girls wear their hair long and straight without even a pin curl..just dreadfully and monotonously straight and no vestige of make..up and those infernal dark glasses...you can say.." They all look alike.." pale faced..blue eyes..straight hair..then..and wearing those ugly hiking loafers etc...or "clod hoppers"..It is very tough for me... or anyone used to looking right into people's faces...to tell these young women apart..and the same with the men with their ratty beards.. long matted hair..and dirty clothing...and dark colored glasses.. So, even if this girl who looked like Patricia Hearst..was indeed she..I personally did not have the guts to walk up and ask her if "she was..Patricia Hearst..and guest here never bother new guests.. or...never speak until spoken to by them..Especially if you are older..etc.

All of this is what made it so tough for me to say to anyone.." I believe I saw Miss Rancour here in this very hotel <sup>in April 1974</sup> I also believe I saw Miss Healye and Miss Hawkings here... <sup>together in June 1974</sup> who would believe me ?

But I'm going to throw it all in here:

During this very same period...<sup>2</sup>twice I saw a glazed medium brown Volkswagon parked in this hotels parking lot.

So in september last ? I spent a week at the Windsor hotel on some business, in Seattle..and there I learned, there indeed was a Volkswagon rental..place in Seattle out near the University district..

Therefore..this so called " Ted " Could he have not rented that same Volkswagon ? from a rental place ? This one was new...and that glazed icing painting..like a light colored chocolate cake...?

I'd never seen that painting before until last year. And right here in the rear of the Webster hotel in *their parking lot for guests*. So much for this information..

I reported this about the car to Sherril Martin security Police up at the C. W. S. College..So she has had an interview with me..and some information that all turned out to be duds...and dead end...etc.

There is just one other item in conclusion here: Trucker's frequent this hotel..hay hauler's..and Mayflower driver's..that is, they used to until a girl was raped here in the rear of this hotel...<sup>in January 1975</sup>and the young couple here now...<sup>managers</sup>A "professed minister"...and his bride..(Bahai Faithful) and friends of Sherrill Martin security police..never called the police.. nor, did they go to that poor girls rescue..and you could hear her screaming all over..later I saw a red Sports car pull around..and go up the street which sounded like it had a ~~truck~~ <sup>truck</sup> motor in it.. *diesel* But every time that girl screamed for help ? The man assaulting her. .. or ~~else~~ a truck driver.. kept revving up his motor..trying to drown out her yelling...finally the man yelled.." Oh Ball's!" And this could be heard all over the block and all this noise cleared up to this apartment on this third floor overlooking third street..

And that was it. A poor girl had been raped..right in the back yard of this small town hotel

So...I'm just going to suggest...that you consider truck adriver's too.. especially Van type hay hauling trucks..because there is living herQ a truck swamper for hay hauler's.. by name of Wayne Nurnberger...great big brawny guy..well over six feet about 6' 4 " 190 ..200 lbs..who is an odd ball...Devout 7th day Adventist...but he almost let something slip one day to this effect he said and I quote..while talking about religion.." You can never tell about the Devil...he might just be standing talking to you..Or be right around..you. Once I got mixed up with him .. and I'm not out of the woods yet"..unquote..He said this to me..about last June..He rides a Yamaha Motorcycle and is gone for days at per time..Often just takes off at midnight and runs down to Yakima and back..And he carries different colored helmuts..and goggles..blue,, somtimes red..and then again gold...all matching..He is a guy that could scare me to death if I met him in a lonely place..almost in the daytime..

You see , once I had a physical encounter with a stranger..a rapist.. and only for the love of God and his protection am I able to sit down and write you this lengthy letter. Some of which I pray shall save other young girls lives one day..

In conclusion..should anyone from over there wish to contact me in person ? Would you please protect me with all of your efficiency.. and have whom ever it is..come see me as a close friend...after they talk to me and identify..use this name.."
