This is an interview with a Mrs. Betty Bell of 15411-
SE 42nd Bellevue concerning information that may be pertinent
to the investigation surrounding the disappearance of a number
of women from the greater Seattle area. This recording is
made for documentation and in the hope that the information
obtained may be of assistance in the investigation of the
missing women.

This recording was made in agreement with Mrs. Bell
following telephone conversations on March 5, 8, and 9, 1975.
with myself, and after telling me of her concern and belief
that she knows who the Suspect may be.

Mrs. Bell was aware this interview was being recorded
and did not object to ~~this interview being recorded~~. Present
during this interview was Mr. Paul Hiltz of Bellevue, Wash.

The date is March 9, 1975, the time is 1441 hours,
the location is in the Dining Room of ^{the Bell Residence at} 15411-SE 42nd, Bellevue.

(You) Mrs. Bell, Deanna Schekin Morgan called me by phone
and told me some things that you had seen and heard
that concerned you and she felt that I could probably
assist you in some way manner. Could you relate to
me some of those things that you had spoken to
Deanna about and later related to me by phone.

(Bell) OK. Ch. I guess I should start at the beginning
which was when I was first told a number of times during
the week of Aug 18th to about the 24th to do something

with a map. And ^{oh}... This included using a compass and drawing circles on a map from 3 or 4 areas of which I can not remember the exact areas. I believe one was Seattle and oh, Lake Sammamish, ... they were areas that the girls had disappeared or had ... he had tried to ... oh ... take girls. One I think had escaped or something. And that if I did this, it would overlap and there would be an area where there was something that had to do with the missing girls, that we would find something. And I was told this approximately four times during that week and finally went ahead and did it. They did intersect and there was an area which fell within all four circles or three or four circles whichever it was and then I was told "yes, but it's out just a little further, ... just a little further" and mentioned this to my husband at which point he said, "Well, of course, you put your point in the wrong place. Seattle isn't there; it's over here" and upon moving this, the arc did go ~~out~~ out further. My husband then got out another map of the area. Oh it looks like a Ranger District map ... and ^{oh} immediately upon looking at it I pointed to a road and said, "For some reason I'm being told there's something out there". And he said, "That well that's a logging road or something. That's just a dirt

About that time he took an exit and drove off to . . . off the road and we went on and went camping.

Olson: Which direction did he exit?

Bell: Ah - he exit . . well of course all the exits go off to the right. Then I believe he went over. . .

Olson: Do you know where he went?

Bell: . . .because we tried to watch. I don't know where he went. I thought he passed on over the highway though because it seems to me we had looked back and had seen him. Anyway, then I was in the meantime being told other. . after this. . .we were back home again and I started getting messages of things like "he's . . .there's something in the license plate that has to do with his name. Oh that was one of them. I was also being told that this man lived in Bellevue. Now, I'm probably kind of a nut, but when these messages kept coming 'he lives in Bellevue, he lives in Bellevue.' I picked up the Bellevue phone book and started looking for TEDDYS and THEODORES, I mean such and such THEODORE and such and such TEDDY. Then it started saying the license plate had something to do with his name and I said: 'I-D-P, I-D-? well, I.D. that kind of . . it's like identification, maybe the "P" had something to do with his name. So I started looking through the Ps in the Bellevue phone book for the like TED PRESTON or whoever knows what. Found nothing. I'm kind of giving these things out. I was also being told that there was something with a mechanic that either he was a mechanic or . .

Olson: Before we were interrupted at the end of the tape, you were mentioning you were getting messages that this person was a mechanic and he also was a . . .

Bell: Well, that he was a mechanic or was getting it seems that might have something to do with Vets, a veterinarian, I can't . . . And then on August 30th, and I remember that date because we had picked up my daughter's clarinet and had it fixed on that date and was in the process of buying a reed. We had driven over to Crossroads to buy reeds for the clarinet and was just parking - this was about 5:30 or 6:00 o'clock and I remember at that time it was starting to get dark. We had just pulled in and a car was turning into Crossroads and something said again. "That is the man" Well of course I looked again because you know, and it was the same car and the same man. And this really shocked me because. . .

Olson: You're pretty sure it was the same person the second time?

Bell: I'm pretty sure, by the looks that . . . you know. . . I would think so. I couldn't swear on a stack of bibles because. . . you know. . . you see a person once and. . . you know. . . but I would say it was. Both times he was alone. . . both times he was, I would say about the same age of person. . . same color of hair. Because, I mean I couldn't tell immediately at that point. I saw the car. I then looked at it. It had the same license plate, same car, a young fellow in it and I said: 'Oh, my gosh!' And got out of the car and I said 'Hurry up, hurry up.' Dragging my kids around. And ah. . . got over. . . he parked near Mayfair and I was trying to encourage my husband and kids to go on. . . I was going to follow him. And ah, so, I watched him get out of the car and go into Mayfair and I could see through the windows which were completely glass. He did not go in to buy anything. He went in and went to the counter to apparently cash a check or something at which you could see the checker saying no. And then he walked out of Mayfair then and over to his car and stood there for a moment so I got a pretty good look at him at this time. And he appeared to be looking around, I don't know, as though he was wondering what he should do next, where he should perhaps go to get done whatever he wanted to do. And so, during this whole time I was standing there looking at him. My family was all there too but I was trying to get a good look and asking my husband "How tall do you think he is approximately, compared to you? What weight would you say and this type of thing and I do remember he was dressed in a kind of a pinkish-lavendar colored shirt that was split entirely down the front, ah, I guess they're made that way. And I think he had a chain around his neck. And ah, had on, ah, I think it was either a plaid or striped type of pants. A very good looking fellow. Then we came home from there and I had had some articles or something regarding the girls downstairs in old papers and we then did try to check to see that this man seemed to fit the height and the weight of what they were saying. And we felt it did. We felt he really came pretty close to what they had said. We of course, you know, didn't do anything. I. . . I don't know. . . we were told - I don't know exactly where to go from here. I became more and more curious. . . I. . . I began to worry having been told twice that this was the man and feeling that it was the same man. I then was curious about other things and the fact that I'd been told it was Bellevue and I had gotten out a Bellevue map one night and I told my husband that I felt that this man lived along a certain road and I had shown him a road that leads from like out Lake Sammamish Way and up along Northrup Way and I said: 'Now if you see, this runs right into Northrup Way and comes into here. And I feel he lives along here somewhere.' And ah, then the next day, through the help of someone, we obtained from knowing his license number, his name and his address. I then checked the address against the map and discovered that he was within about a half a block of Northrup Way and this kind of floored me because I thought 'Oh, my gosh!' You know, he could have been anywhere

The only thing my husband said he knew from the license number was that it was King County because it started with an "I". Other than that everything else as far as feeling or being told he lived in Bellevue came from I don't know where . . . just that's what I was told and then finding out that he did actually live within probably a half block off the road I said, when I guess he could have lived anywhere in King County, kind of shook me up too. Then I had checked the man's name against the city directory at the library and found out that he was a mechanic and this shook me up even more because I thought 'Oh, my gos, just too much is what was either said and I had no way of knowing if all of this is correct.' Then perhaps the other 'that is the man' is correct. And, ah . . . so for a number of months all this has bothered me. And I have not called back the police to tell them because after taking in the bones and talking to them about that, they have . . . they haven't given us any information as to whether they were human and I was waiting to find out. I do not profess to be a Psychic. I don't sit down with things and do that type of thing. I didn't know whether to believe it even myself or not. The thing is still kind of shocking to me--to be told to do something and to find bones and I was hoping to find out whether or not they were human. And then if they were human, I guess I felt that then perhaps if I told them what else I had been told or maybe they would even ask me: "Have you received any other messages?" And that then they would believe it. Because to me it's all . . . it's ah . . . I still can't. . . it's hard for me to understand it. And so, I've kind of gone along and I know it has upset me for many months. And then in January (1975) I was again told. . . I was on my way to do some clearing for a woman, an elderly person, ah, and ah, going out, I guess towards Redman? I think she lived in Redman, and ah, I was driving out. . . ah . . . is that 156th? that goes out by Crossroads and continues on out until you get to the Public (?) Health Department or something?

Olson: That's right.

Bell: And I was going out there when all of a sudden I was told: 'Keep your eyes open, you may see the car.' Now it didn't say I may see him. It just said: 'You may see the car.' So I thought 'Oh yeah, I just might. I'm out this way after all, he lives over near Crossroad, who knows, I may see the car.' I was ? and I had not at that point ever really checked out exactly where his house was. By the address I felt 'oh, he probably lives in some of these apartments.' So that's where my mind was. He may be parked along some of these apartments when all of a sudden a car pulled on the right side of me. Pulled around the right side of me and pulled right in front of me, and it was him. And this was even more shocking. I thought: 'Oh, my gosh!' I mean, you . . . the message was 'You may see the car' but to have him pull right around and get right in front of me was more than I expected. And I thought: 'OK, here's your opportunity, boy, you're going to follow him.' And ah, so, he went on... ah, I can't even tell you . . . he went on . . . he went on the road past Northrup Way and turned right . . . that's right . . . and ah, I, I'm bad on left and right--and I thought: 'Great, this is the same way I have to go to get to Redmond.' This will show you how bad my directions are, because I got lost. So I got past way up that road and he turned off by a school and I thought: 'Oh, oh, he's turning off. Well, let's. . . I'll just keep going.' And I started following him through the cul-de-sac until I thought perhaps he was suspicious. We made about four turns or more through the cul-de-sac and all around the school. When I realized he.. he'd gotten ahead of me that he'd slowed down or it appeared, I could be wrong, he may have slowed down for something else, but he appeared to have slowed down and almost stop. And when I got up there I thought: 'Oh, oh' I. . . I began to worry a little and I thought 'It's time to turn around, don't mess around.' So I turned around in the cul-de-sac that was near and

went on back out and found my way to Redmond to clean the woman's oven. And ah, it's. . . just that. . . I don't know. Too much seems to have been told and. . . and the fact of finding these bones out there and still not knowing. . .

Olson: King County Police never advised you what the disposition was of the bones, whether they were human or animal?

Bell: No. Oh, when they found JANICE OTT . . ah . . and the bodies, out that way, ah, I became even more nervous because by that time I did have. . I had already been told 'that is the man' and at that point I at least had the license number. I did not know his name, but I did have his license. So I became very nervous and I thought 'Oh, my gosh! Are the ones human that I found also? Let me know.' I mean, this was just really on my mind. And I did call up and maybe it was really a bad time to call because they were terrifically busy I guess with all they had found . . of . . about JANICE OTT and trying to dig up those bones and ah . . they . . for awhile we had trouble at even getting any . . they . . they couldn't seem to find a report or anything on the bones turned in. Ah . . then finally one detective did say he would check it out and find out what had happened and apparently he did. And ah . . then the one time I think it was SGT. RANDALL who called me back and said that the original bones had been thrown out, but that they had retrieved them or whatever, and that they would be examined or that they would let us know. And ah . . so I guess at point I said 'OK' 'Fine' or something. I was told that an officer would go back out with me that day. They were extremely busy because I was so upset. I said "OK, fine, if you won't go out, may I go out and dig for further evidence?" I wanted to find more bones that were definitely going to tell me that his is a human. I wanted more evidence. I wanted to get it off my mind. And at first they said: "Sure you can go out and dig anywhere you want to as long as you don't dig where we're in digging around the bones for JANICE OTT. You cannot go within a-- and then he listed off a certain area that I couldn't go in. And then I said: 'Fine, because I want to out and find out.' I said: 'It just. . . and he said: "Well, if you're that concerned you really seem like you're that concerned bout it, maybe we'd better send someone out, because if they are human you really shouldn't be digging out there. They should all be left. . . you know.' Which was what my husband was telling me - don't disturb anything. Oh, he said: "So I have three officers coming in around like 12:00 today, I'll have one of them give you a call and go out with you." No one ever called. No one ever came out. More days passed and I became more and more upset by it all because every time. . in fact I. . one or two people did know and this is what first upset me. They'd call and say: "Listen, I have a feeling the bones are the ones you. . you know, are in the same area and everytime somebody would do this I would become more and more nervous. Ah, so I had a friend go out with me who had done insurance investigative work and had seen skeletons before. . has had to investigate them and he went out with me with a shovel and ah, we picked up another full bag of bones. The bones seemed to reappear. I mean, there were bones there and I thought that the first officer that went out with me. . we picked up pretty much the bones that were there to be visually seen, easily seen. Ah then, we went back out. We picked up another bag full. And ah, I'd say that they'd been chewed on, in fact, I know of one time during the period of time we went out and a bone was bigger and the next time I went back out one of the ones that we had left, ah . . was cheded down more. He took the bag of bones down to the police station. He said: "After all I deal in these offices and maybe they could help." And ah he has gotten no where. They told him that they will let us know. And each time - nothing.

Olson: When was that? When was the second time you found the bones, approximately?

Bell: Ah - I know school had started about that time but it wasn't . . it hadn't been in progress very long. It would have had to be the first part of September.

Olson: Was it before or after JANICE OTT's body . . .

Bell: It was after JANICE OTT.

Olson: Can you describe what position the bones were in when you found them? Were they scattered about or were they piled up?

Bell: They were scattered. The third time I went out with DEANNA MORGAN. We went out to the site again because I was continually upset. If only I could find something and. . . and finally she said: "OK. Why don't we go out and we'll look around, I don't mind." So the two of us went out. We did find a few more bones, not as many. I'd say maybe 4 or 5, and again scattered.

Olson: What did these bones look like? Could they have been arms or legs or ribs?

Bell: I would say what I thought was ribs and parts of. . .like spine, because you could see like . . .discs. I don't know that much about the human body either, but it looks like disc parts and parts of rib areas or something coming off from them.

Olson: The vertebrae?

Bell: Well . . .

Olson: Possibly, where the ribs connect into the spinal?

Bell: Yeah, well, that's because, you know things coming out from the bones, ah I know of one time it appeared to be part of a grizzly party that looked like something that would open - you know, like attached, you know? I don't know what part it would be. But actually with quite a few pieces between the two bags.

Olson: Maybe I could reflect back on some substance here that came to my mind. . where is that may now that you initially had the compass and wrote the circles on?

Bell: My husband has taken it with him to Kennewick last week where he has been transferred and he did not drive his car back, he rode back with a friend, so it's still there.

Olson: Then in August 19 to 24, you were told four times in one week to mark the map, is that correct?

Bell: Yes.

Olson: How did you determine that the driver of this Chevie Nova that you observed was a mechanic.

Bell: How did I find out definitely?

Olson: Yes, how did you determine it in your mind?

Bell: Before I ever knew that - I had gotten kind of messages that the man who had done this was a mechanic.

Olson: And then you subsequently discovered in the directory in the Bellevue Library, that he is a mechanic?

Bell: That was after I found out his name. And I do not remember exactly whether it was around December or November before I found out his name.

Olson: When was the last time you received one of these messages? What is the most recent message you have received?

Bell: Ah - I would say the one where I was going to see him , probably about January 20th - or see the car -

Olson: About January 20th?

Bell: Yeah.

Olson: When you saw this car with this subject in it, what times of day were they?

Bell: The first time when we were going camping I would say it was about 10:30 or 11:00 o'clock. The second time it was 5:30 or 6:00 in the evening. I was at Crossroads. The first time was about 10:30 in the morning.

Olson: If you were to see this same person again, would you be able to recognize him?

Bell: I don't know - like if you put up 5 or 6 people that all looked very much the same, perhaps not. On the other hand, I had a real strange feeling inside, I can't describe it, I can't explain it - I don't know but what I could probably pick him out. I almost think there is something that is attracting, you know - somehow I feel 'how could I have even known a few things about him, without having any way of knowing?' You know, not knowing the man at all, the first time I ever had any connection with being told that that is the man who did it.

Olson: Where did you go to school? Did you go to school in this area?

Bell: No, I'm from Michigan.

Olson: How long ago has it been since you moved out here?

Bell: Let's see, I moved from Michigan, gosh, I was married in 1963, I must have moved from Michigan in about 1962 to California, and was married in California around '63. We moved up to Washington about 5½ years ago. We lived in Olympia, and after a year or so in Olympia, we moved up around the Bellevue area.

Olson: So that would be about 4 to 4½ years ago that you moved into this area.

Bell: I don't know - I could figure it out - we were in Olympia about a year and a half, but those are rough figures.

Olson: So there is no possibility that you and this person may have gone to school together?

Bell: Not in this area, because I've never gone to school in this area. All of my schooling was in Michigan.

Olson: And has your husband ever had his car worked on in this general area where you may have seen him?

Bell: No, my husband does all his own work - it's cheaper.

Olson: Is there any idea of how you might have been this person before? Outside his car?

Bell: You mean, have I hever met him before? No. I do not, we don't go out that much, we don't associate with parties that much. I'm pretty occupied with three children.

Olson: Just for the record, may I ask how old you are?

Bell: 34.

Olson: Then you graduated from high school in Michigan?

Bell: Right.

Olson: Do you have any questions? (a male voice answer in the negative.) Have you told anyone else besides myself about the license number of this Chevie Nova, or the driver of that car?

Bell: I had told another party that I had been told about the man. I did not tell them his name. I did not tell them the license number. Ah . . . this was the party who had gone out with me and picked up the bones. Then, I also, on several occasions, in talking to DIANA MORGAN, had mentioned the man, and in talking of why I was so upset, I know that I mentioned the fact of comparing the fact that IDP in the license number did coincide with the name of [REDACTED]. I do not remember how much of the name or anything that I told her and I don't know that I told her the full license plate. But at some time, I guess I might have. And my husband knows.

Olson: OK. Have you ever received these messages before? Is this something new to you?

I have received messages in the past - I receive messages, I feel, quite often. But normally, they're not of this scope. But everyday type mesages that I feel - some I just disregard and then am very sorry afterward because I'd know 'you were told that just 5 minutes ago, and if you had gone and one it, this wouldn't have happened.' I had been told one recently, just prior to this, and in fact had mentioned to the officer, is another reason why I figured he thought I was a nut. Even I questioned it - I had repeatedly gotten messages during the week prior to being told this other - regarding something I was to do or have my husband do regarding a fishing lure - like I said it was very simple, very normal. Even I laughed and chuckled and said: 'Well, now really!' It was so funny. I said: 'That's really funny.' I was supposed to maybe put these nylons on the end of a fishing pole and 'you're going to catch a fish.' And it said - 'No,' and explained what I was supposed to do and how I was supposed to make this thing - a fishing lure out of a pair of pantyhose. And I mentioned that to my husband and he said: OK, fine. Then we got very busy, I think that was the week I had company most of the week and Friday came and my company left and I was doing dishes and I was told several times 'You have not done it.' 'You have not made it.' And I said 'Well, now really.' 'Why should I?' Because it said that if I did, my husband would bring in very big salmon in that fishing derby if we used this lure. I thought everyone would laugh at him but anyway this is what it said. And again while doing dishes on Friday

night before the derby, it said: "You have not done it." "You have not made it." And I said: "What makes you think this is going to mean anything anyway?" And it said: "Didn't Jesus tell Simon Peter to throw the net back out into the sea, after he could not catch the fish? And upon doing so as he was told to do, did he not bring in the fish?" And I had to admit 'Yes, I guess you're right.' And it said: "Go make the fishing lure." So I knew I couldn't make the fishing lure entirely by myself - my knowledge is limited, only to the extent it had shown something resembling a worm and how I was supposed to do this, but I didn't know how to put a hook onto it or anything, and so I figured I needed my husband's help and I mentioned it several times that I'd have to cut off the nylongs and that was as far as I got. My husband got tired and we never got the fishing lure. He said he was very sorry because he ~~hooked~~ a real big one the next day and it broke his line, and took it off and he didn't catch anything. And this is what I had told the officer so I think he figured: "Boy, I've really got a lulu here."

I had in the past, received other messages, regarding people - like I said more or less everyday situations, not anything this extreme. I find that frightens people - if you can tell somebody exactly what's on their mind - then you think they're frightened by the fact that you know. If you can tell somebody that you've never met before, like how many children they have, what their children's eye colors are, what's going to happen to them in the next period of time. And even if it's in a fun-type situation like it was one night and someone produced an Oija board and then when it really began to move around - we'd had a couple of drinks - and it began really printing and everybody got excited and started in on questions. The only sad part was that everything I said came true and the people became very frightened. Things I had no way of knowing - things where I said that they would separate, that they would leave each other and the couple said: "Well, we just never would" "There is just absolutely no reason." And within a week and a half her husband ran off with another woman. I hadn't even known these people. And what they would earn next year. And they said: "Well, that just proves it's absolutely false, my husband makes almost that, and I'm employed on a second job." When her husband did return home, she was told you're quitting your job, you're not working anymore. She said she realized that was right - we're not going to earn that much, we're going to earn just about what she said. Too many things came true. In college I had people ask me, get frightened, and almost run away from me. And I just don't like that type of a feeling. It seemed something abnormal, and tried to put it out of my mind. And even, like I said, every big occurrence even in my own family life, it was something that was a problem between my husband and I because there are things that I have no way of knowing, that I have known and I'll say 'It's such and such.' And he'll say: "It can't be." And it does turn out to be that, and yet I have no way of knowing. When you can know these things, and have no way, and after quite a few years you realize that this something we have to live with. I try not to overdo it, and he no longer lets him bother him. He realizes that some of the trivial things I have told him have come true. We both kind of accept it. I think a rather recent one was that I was told that we should reduce our that I should prepare, that we should start packing. I feel there's more than one reason - I'd rather not say exactly why, there are other things involved. I did tell my husband about it and I felt it was either for that reason because I was told to do other things, certain things - pay off bills. I did start, because it kept re-emphasizing "You have to do this." "You just have to. . . do this now." And I was thinking that maybe the next thing we'd have to move then come to find out that all of a sudden my husband had been transferred. So I continued with my packing and we have to move.

OLSON: How many years have you been receiving these messagez?

Bell: Approximately 16 years, I guess.

Olson: This terminates the interview with MRS. LAWRENCE BELL, the time is 1543 hrs.

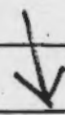

Their big area of business is however young couples. We noted a few sales addresses for reference, and a complete list could be obtained if needed. Sales: 12-6-74 329 NE 76th Seattle, 7-14-75 32nd & 17th NE and another on E. Summitt, 6-1-75 403 Stillwell. I believe we will get cooperation on anything further if needed. [REDACTED] called and will be in at 1300 4-1-75 to talk to me. If anything further is gained a further report will be initiated. A copy of this report has been forwarded to Det. in front of me, he appeared quite nervous and was
mumbling to himself although he was alone in
the booth, as young girls went by he would
mumble to himself, not to the girls but to himself I
watched him for a period of about 40 minutes this
time, as I and my family were having our dinner.
this man was approx 5'9" medium blond I would say

BENJAMIN

about 155 or 160 lbs and I doubt if he's over 24 or 25 years old if that old, age wise he would be kind of hard to tell although not over 25, he was clean shaven and not the long hair style usually seen in the district and he was dressed rather nice, in fact in appearance he looked rather well. Every once in awhile he'd get kind of a liped stare then turn his head and mumble, not so loud so as to be able to understand him.

The next time I observed him was approx a week later and I and my family were sitting in a side booth and I saw this young man walking up the sidewalk on 12th Ave NE next to Sherfy's and really what struck me as being odd at this time was he stared inside, just stopped and stared inside for about 3 or 4 minutes then he walked to the front of the building and came inside got something to eat and sat down in the same booth as before the corner booth, I noticed at this time he didn't have his arm bandaged as he did have one on his arm the first time I saw him but his actions were

He didn't appear quite so nervous and again his clothing appearance was neat and casual, but He's more interested in watching young girls than eating, I understand at this age of the young man this could seem quite normal but you'd really have to see him to understand what I mean.

The third time I seen him was about a week and a half ago, this time we were sitting in our car outside the front of Heefy's, my son had just gone inside to get milk shakes to take home with us and while we were waiting this same young man walked up 12th Ave NE looked in as before for a few minutes then come to the front of the restaurant closest to the West entrance stood to the side of the door as if trying not to be observed by those inside but peeking inside he stood there about 5 minutes then walked past our car and into the main front door he went and to the counter for his food and my son came out and I asked him not to start the car that I

was watching the actions of this young man and I'd never mentioned my suspicions before to my family about the guy, but this time I did discuss his actions. My Oldest Son said "Ah Mom he's just a weirdo and he thought the guy acted like he was on the make!" This did it then I told my family about my suspicion and perhaps this guy could be involved with the disappearances of the young girls in the 21 district plus those of Lake Semmamish.

We came home and looked for our P.L. newspaper which had the drawing of "Ted" or whatever his name is, and there is a slight resemblance somehow but not quite this exactly alike, "but something there." I realize this is just a sketch drawing but there is something about this young man and the sketch, maybe it's just a coincidence.

On a hunch and strictly a hunch last Sunday I asked my son to drive us all to Herfy's this time my Brothers who 42 went

with Us and We ordered Our food this time to take home I really didn't go because of food but wanted to see if this guy would show up, I wanted a better look, We waited for my son to come out and still the guy didn't show up, I didn't want to leave because I had a feeling he would come so I suggested We just sit there and eat in the car and We did, And He did show up ^{until} just as We were about finished with Our meal, I tapped my son and without saying any thing to anyone else in Our car, We watched this guy until my 13 old son said hey theres that guy who looks like the guy in the paper, my Brother said well he does in a way but then you can't really be sure but why is he peeking inside, about this time a Seattle Police car pulled up and an Officer went inside but this time the Young guy didn't go in he left. And We came home.

Now since I've gotten all the papers together I've gone over the story you've printed word by word and I've given this plenty of thought

as you can damn well tell, If I'm wrong I'm
sorry but if I'm right then just maybe some-
one else will be spared.

I've contacted an Officer of the Police
Dept and told him exactly what I've told you
and this Officer advised me to write to you,
because The Police Dept are sure going to invest-
igate this guy out, He also asked me to call
them if I ever saw this guy again, not for me
to try to apprehend him but to get to the nearest
phone and call them, which I will do.
