Transcription of Taped Interview Bell TAPED INTERVIEW WITH MRS. BETTY BELL, address 15411 SE 42nd, Bellevue

Taken by OFFICER CLINT OLSON on March 9, 1975.

This is an interview with a MRS. BETTY BELL of 15411 SE 42nd, Bellevue concerning information that may be pertinent to the investigation surrounding the disappearance of a number of women from the Greater Seattle area. This recording is made for documentation and in the hope that the information obtained may be of assistance in the investigation of the missing women.

This recording was made in agreement with MRS. BELL following telephone conversations on March 5, 8, and 9, 1975 with myself, and after telling me of her concern and belief that she knows who the suspect may be.

MRS. BELL was aware this interview was being recorded and did not object. Present during this interview was MR. PAUL HINTZ of Bellevue, Washington.

The date is March 9, 1975, the time is 1441 hours, the location is in the dining room of the Bell Residence at 15411 SE 42nd, Bellevue.

Olson: MRS. BELL, DEANNA SCHELIN MORGAN called me by phone and told me some things that you had seen and heard that concerned you and she felt that I could probably assist you in some manner. Could you relate to me some of those things that you had spoken to DEANNA about and later related to me by phone.

OK. Oh, I guess I should start at the beginning which was when I was Be11: first told a number of times during the week of August 18 to about the 24th to do something with a map. And, this included using acompass and drawing circles on a map from 3 or 4 areas of which I cannot remember the exact areas. I believe one was Seattle, and ah, Lake Sammamish. They were areas that the girls had disappeared or had escaped or something. And that is I did this, it would overlap and there would be an area where there was something that had to do with the missing girls, that we would find something. And I was told this approximately four times during that week and finally went ahead and did it. They did intersect and there was an area which fell within all four circles or three or four circles whichever it was and ah, then I was told "Yes, but it's out just a little further...just a little further" and mentioned this to my husband at which point, he said: "Well, of course, you put your point in the wrong place. Seattle isn't there; it's over here," and upon moving this, the arc did go out further. My husband then got out another map of the area, it looks like a Ranger District map, and . . ah, immediately upon looking at it I pointed to a road and said: "For some reason I'm being told there's something out there." And he said: "That . . well, that's a logging road or something. That's just a dirt road." And I said: "Well, would you like to go take a ride and we can just take a Sunday afternoon ride or whatever?" And he said: "Sure, come on." And so we got our children and went out, expecting to really take a ride probably out the logging road and a little hike and we actually intended to have lunch and come back. And ah, instead we drove out to the spot which my husband, by looking at the map, could locate. We'd never been out there.. and I don't think my husband had ever seen the area either except the highways. We went out to that area which was off I-90 off of 18 . . . I don't know what 18 is called.

Olson: Highway 18?

Bell: Highway or I-18 or whatever it is, I don't know. And found the logging road which I think was about the first road or so on your left and drove as far as we could which was not very far because the gate was across the road and we were not able to go any further, and of course,

he stopped for the gate and we sat there for a minute, saying: "Well,

this looks like this is it." Upon glancing out my car window, I then noticed a pair of girl's underpants and this pile of dirt that had been plowed up. And of course this prompted me to get out of the car because automatically, thinking about the girls and seeing that I got out. And so then we all got ou and we walked along. . . there's a swampy area on the side road and then I said: "I feel we should go in here." There's an area on the left of the logging road where you can drive a car into the wooded area and ah, I said: "Would you mind if I went into here?" "I feel that I should go into here." And my husband said: "No, that's fine." He stayed where he was with the children because we were actually dressed in shorts and were not really prepared to go tramping through the woods because I had . . we had to push the stuff away. So I walked. . I went in the wooded area on my left and walked around in back of the area. I became quite frightened. I don't know why. It just really began to bother me and I continued walking on around and when I got about to the right side of the parking area there were bones lying on the ground. And then I became very frightened. I thought 'Oh, my gosh, this is something I never expected to see.' To tell you the truth when I kept getting the messages of "you will find something out there regarding these girls, I figured - 'Oh, maybe we'll find that bicycle that they're looking for.' Upon seeing the bones I really got upset. I was very nervous. We drove immediately back and called the police. I shouldn't say that I called the police first. I really thought they're going to think "they're nuts." What do I do? So I called the number that was in the paper of the girl that was associated with JANICE OTT and they said she was a liaison between the police and if you didn't want to call the police direct, to call there. I called there but since it was on a Sunday and I believe it's a Juvenile Court number or something, the girl wasn't working. Ah, I asked the man and told him I was a little concerned and he gave me the number to call of the police of who was handling the case. And then we called that number.

Olson: Who was that, do you know?

Bell: What number did I call?

Olson: Do you know who you talked to?

Bell: No, I think she answered the phone saying something like "Juvenile Court" or something. I've got the number yet because it's in that paper.

Olson: OK.

Be11: Then we ah . . . they said they would send out an officer, which they did, and ah he came out to the house. We showed him on a map where it was and he asked if someone could go out there with him and we said "Yes." And I drove out and showed him the location, and the pants, and everything. We went in and he picked up a bag full of bones that were . . put these bones in a bag of what we found, and put them in the back of the car. - The first time when we were going camping I would say it was about 10:30 or 11:00 o'clock. The second time it was 5:30 or 6:00 in the evening. I was at Crossroads. The first time was about 10:30 in the morning.
- lson: If you were to see this same person again, would you be able to recognize him?
- Hell: I don't know like if you put up 5 or 6 people that all looked very much the same, perhaps not. On the other hand, I had a real strange feeling inside, I can't describe it, I can't explain it I don't know but what I could probably pick him out. I almost think there is something that is attracting, you know somehow I feel 'how could I have even known a few things about him, without having any way of knowing?' You know, not knowing the man at all, the first time I ever had any connection with being told that that is the man who did it.
- lson: Where did you go to school? Did you go to school in this area?
- ell: No, I'm from Michigan.
- Ison: How long ago has it been since you moved out here?
- ell: Let's see, I moved from Michigan, gosh, I was married in 1963, I must have moved from Michigan in about 1962 to California, and was married in California around '63. We moved up to Washington about 5½ years ago. We lived in Olympia, and after a year or so in Olympia, we moved up around the Bellevue area.
- 1son: So that would be about 4 to 41/2 years ago that you moved into this area.
- ell: I don't know l could figure it out we were in Olympia about a year and a half, but those are rough figures.
- 1son: So there is no possibility that you and this person may have gone to school together?
- ell: Not in this area, because I've never gone to school in this area.
 All of my schooling was in Michigan.

- Olson: And has your husband ever had his car worked on in this general area where you may have seen him?
- Bell: No, my husband does all his own work it's cheaper.
- Olson: Is there any idea of how you might have been this person before? Outside his car?
- Bell: You mean, have I hever met him before? No. I do not, we don't go out that much, we don't associate with parties that much. I'm pretty occupied with three children.
- Olson: Just for the record, may I ask how old you are?
- Bell: 34.
- Olson: Then you graduated from high school in Michigan?
- Bell: Right.
- Olson: Do you have any questions? (a male voice answer in the negative.)
 Have you told anyone else besides myself about the license number of
 this Chevie Nova, or the driver of that car?
- Bell: I had toId another party that I had been told about the man. I did not tell them his name. I did not tell them the license number. Ah . .this was the party who had gone out with me and picked up the bones. Then, I also, on several occasions, in talking to DIANA MORGAN, had mentioned the man, and in talking of why I was so upset, I know that I mentioned the fact of comparing the fact that IDP in the license number did coincide with the name of the license number how much of the name or anything that I told her and I don't know that I told her the full license plate. But at some time, I guess I might have. And my husband knows.
- Olson: OK. Have you ever received these messages before? Is this something new to you?

I have received messages in the past - I receive messages, I feel, quite often. But normally, they're not of this scope. But everyday type mesages that I feel - some I just disregard and then am very sorry afterward because I'd know 'you were told that just 5 minutes ago, and if you had gone and one it, this wouldn't have happened.' I had been told one recently, just prior to this, and in fact had mentioned to the officer, is another reason why I figured he thought I was a nut. Even I questioned it - I had repeatedly gotten messages during the week prior to being told this other - regarding something I was to do or have my husband do regarding a fishing Iure - like I said it was very simple, very normal. Even I laughed and chuckled and said: 'Well, now really!'
It was so funny. I said: 'That's really funny.' I was supposed to maybe put these nylons on the end of a fishing pole and'you're going to catch a fish.' And it said - 'No,' and explained what I was supposed to do and how I was supposed to make this thing - a fishing lure out of a pair of pantyhose. And I mentioned that to my husband and he said: OK, fine. Then we got very busy, I think that was the week I had company most of the week and Friday came and my company left and I was doing dishes and I was told several times 'You have not done it.' 'You have not made it.' And I said 'Well, now really.' 'Why should I?' Because it said that if I did, my husband would bring in very big salmon in that

fishing derby if we used this lure. I thought everyone would laugh at him but anyway this is what it said. And again while doing dishes on Friday

night before the derby, it said: "You have not done it." "You have not made it." And I said: 'What makes you think this is going to mean anything anyway?' And it said: "Didn't Jesus tell Simon Peter to throw the net back out into the sea, after he could not catch the fish? And upon doing so as he was told to do, did he not bring in the fish?" And I had to admit 'Yes, I guess you're right.' And it said: "Go make the fishing lure." So I knew I couldn't make the fishing lure entirely by myself - my knowledge is limited, only to the extent it had shown something resembling a worm and how I was supposed to do this, but I didn't know how to put a hook onto it or anything, and so I figured I needed my husband's help and I mentioned it several times that I'd have to cut off the nylongs and that was as far as I got. My husband got tired and we never got the fishing lure. He said he was very sorry because he hook of off and he didn't catch anything. And this is what I had told the officer so I think he figured: 'Boy, I've really got a lulu here."

I had in the past, received other messages, regarding people - like I said more or less everyday situations, not anything this extreme. I find that frightens people - if you can tell somebody exactly what's on their mind - then you think they're frightened by the fact that you know. If you can tell somebody that you've never met before, like how many children they have, what their children's eye colors are, what's going to happen to them in the next period of time. And even if it's in a fun-type situation like it was one night and someone produced an Oija board and then when it really began to move around - we'd had a couple of drinks - and it began really printing and everybody got excited and started in on questions. The only sad part was that everything I said came true and the people became very frightened. Things I had no way of knowing - things where I said that they would separate, that they would leave each other and the couple said: "Well, we just never would" "There is just absolutely no reason." And within a week and a half her husband ran off with another woman. I hadn't even known these people. And what they would earn next year. And they said: "Well, that just proves it's absolutely false, my husband makes almost that, and I'm employed on a second job." When her husband did return home, she was told you're quitting your job, you're not working anymore. She said she realized that was right - we're not going to earn that much, we're going to earn just about what she said. Too many things came true. In college I had people ask me, get frightened, and almost run away from me. And I just don't like that type of a feeling. It seemed something abnormal, and tried to put it out of my mind. And even, like I said, every big occurrence even in my own family life, it was something that was a problem between my husband and I because there are things that I have no way of knowing, that I have known and I'll say 'It's such and such.' And he'll say: "It can't be." And it does turn out to be that, and yet I have no way of knowing. When you can know these things, and have no way, and after quite a few years you realize that this something we have to live with. I try not to overdo it, and he no longer lets him bother him. He realizes that some. of the trivial things I have told him have come true. We both kind of accept it. I think a rather recent one was that I was told that we should that I should prepare, that we should start packing. reduce our I feel there's more than one reason - I'd rather not say exactly why, there are other things involved. I did tell my husband about it and I felt it was either for that reason because I was told to do other things, certain things - pay off bills. 1 did start, because it kept re-emphasizing "You have to do this." "You just have to. . do this now." And I was thinking that maybe the next thing we'd have to move then come to find out that all of a sudden my husband had been transferred. So Iconintued with my packing and we have to move.

OLSON: How many years have you been receiving these messagez?

Bell: Approximately 16 years, I guess.


