Dear officer:

This maybe just another "Ted" dead end, but I feel you should be aware of this person.

On the evening of September 20th I was on my way to Life from our Browns Point home. At approximately 6:50 a car pulled out from the former location of Parker Trucking on the west end of Hylebos Waterway in front of the car ahead of me, so close he had to apply his brakes. He went to the left turn lane on 11th Street to turn on to Taylor Way, I pulled up behind him, he had a very white cloth, which I took to be a mans handkerchief, it looked out of place as his clothes and car weren't all that neat, and placed it on the dash, then he untangled a light weight rope or cord that was on the floor by his feet and placed it on the seat beside him. When the light changed he turned and went the normal speed while he kept watching me in his mirror. When we were fast

the active manufacturing plants he tried not to let me pass and tried to make me stop by waving his arm out the window and slowing down. He is somewhere between 20 and 35, blondish and seemed to have the same shape face and hairline as the sketch of "Ted". When I passed him he had his face all screwed up either yelling or yawning. I had to stop at the light just before entering Life, but he stayed back and that was the last I saw of him.

I didn't realize how shook I was til I tried to talk to the clerk at the Life Valley mart. I went across the highway and gave the policeman the license number. He asked me to have the office girl run a check on it. The OHX [redacted] Chen was listed to a [redacted] of 3 [redacted] 22nd S.W., Seattle. He wasn't wanted in Tacoma or Seattle, so I assume that was the end of it. Just checked the City Directory, says [redacted] is retired, which would be too old for this person.

By this persons' action and equipment I do hope you'll do some checking and please don't give him my name. I hope I've seen the last of him.

The physical description of the above listed subject, Detective Kidd, is 6'2" to 6'4", thin frame, 160 pounds, dark brown balding collar length hair, with brown eyes, glasses and contact lenses intermittently. He also has a mustache and beard.

The last known address is [REDACTED] Waterfront, Seattle, Washington; which is apparently an address attached to a warehouse. He also has a phone number in the Seattle, Washington area listed in the Seattle directory under the name [REDACTED].

The following is a narrative by Officer Heide of his discovery through a contact here in Eugene, Oregon, which relates [REDACTED] to considerable suspicious circumstances both in the Eugene area and the Seattle, Washington area, which I feel you have a right to be aware of as does Officer Heide.

OFFICER HEIDE:

On September 6, 1975, the Eugene Police Department received a call from a Miss [REDACTED], who wanted to report a possible kidnap. I then responded to Miss [REDACTED]'s mother's residence at 2 [REDACTED] East 15th Avenue in Eugene. At this address I contacted Miss [REDACTED] and her mother, Mrs. [REDACTED]. Miss [REDACTED] advised me that she was now presently residing at 20 [REDACTED] Southeast River Road, Apartment # [REDACTED] in Milwaukie, Oregon (phone number: 659- [REDACTED]). She was now in Eugene staying with her mother for a short period of time and could possibly be reached at her mother's unlisted phone number of 345- [REDACTED].

At this point, Miss [REDACTED] felt it was important to report to the police agencies the information surrounding the above listed [REDACTED], who had taken her out of the State of Washington and into the State of Idaho against her will. Her entire story follows as such.

EUGENE, OR

Officer Heide (continued):

Miss [REDACTED] was in the Eugene area in June of 1975, attending the Renaissance Fair when she first met [REDACTED]. She stated she talked with him for a short period of time and then he asked her for her phone number. She related she did not know why she gave him her phone number, but she did. Approximately three weeks after this point she received a call from [REDACTED] at her residence in Milwaukie. At this point she was aware that he was from the Seattle area and she agreed to go out with him. She went out with [REDACTED] on a number of occasions before she started getting the idea that he was a little bit on the wierd side and was apparently obsessed with sex. On approximately August 23rd or 24th, Miss [REDACTED] was again contacted by [REDACTED] who requested that she accompany him to the San Juan Islands in the State of Washington. She agreed to make this trip with him. They left on the 24th or 25th with the understanding that they would be returning on about the 27th.

Prior to this trip she had received a certain amount of information about [REDACTED] that at one time he was the anchor man for one of the big radio stations in the Seattle area but quit the job because of bitter feelings on his part. He had attended U.C.L.A. college in the Los Angeles area and he had also gone to the University of Oregon in Eugene, where he had been kicked out due to conduct and grades. When she first met [REDACTED], he was going by the name [REDACTED] and she later found out that his true name was [REDACTED]. [REDACTED] started telling her about all the Ted killings in the Seattle area and related to her that he had changed his name due to these crimes involving a subject by the name of Ted. He had also advised her that he was 27 or 28 years old and not the 31 years old that he actually is.

Miss [REDACTED] continued to describe him as very spacey and a strong obsession with sex. She stated she did have sexual relations with him on a number of times prior to her trip with him to the San Juan Islands. He was very demanding sexually, with a strong demand for oral type sex and if she would not comply he would generally force her to. On a couple of occasions he actually drug her upstairs and took her clothes off, forcing her to have sex with him. A number of [REDACTED]'s friends thought that he was possibly homosexual, but as far as she could tell she saw no evidence of it.

[REDACTED] had interests in the sorcery area and was an atheist, against Christianity. His religion was Budism and his Bible was the book written by Mao-Tse-Tsung. He also was very knowledgeable in the area of astrology and able to give her details and analysis. At one point, he requested that she read a portion of one of his books, which was the Tibetan Book of the Dead, which is a Budist religious text. He used to tell her how he imagined he was a black cat and other types of animals of this nature and claimed that he had a certain relation to all animals.

[REDACTED] is on unemployment and yet he rents two (2) places of residence, the first one in Seattle and the second one he rents a Geodesic Dome on Egglake Road in the San Juan Islands. He rents the Geodesic Dome from a couple by the name of Elaine and Ron, who live on Egglake Road in the San Juans. He also had a Volkswagon bus, 69 in year, light blue with Washington

plates. The exact number is unknown. Even with all these possessions and rentals of his and being on unemployment he still continues to have an almost unlimited supply of money. I asked her if he was possibly dealing in narcotics and she felt that he was not because his use of narcotics centered around marijuana only to her knowledge. He had apparently told her about dropping acid on a number of occasions, but she had seen only marijuana in his possession.

It seemed that [REDACTED] was upset with women generally and this was due to his impatience with them. [REDACTED] stated that he would generally travel from Seattle to Portland or to other locations and upon his arrival would contact a female friend of his and if he was not immediately accommodated with room and board he would become very upset and felt that he had been shafted. This was his continual complaint about the way he was treated by women and apparently had a persecution complex due to the fact that he once worked on a tug boat and felt that he was being pushed around by the other workers because he smoked pot. He also used this paranoia or persecution attitude as to why he got out of the broadcasting business.

[REDACTED] apparently envisioned himself as quite a musician, playing the guitar and the harmonica, but [REDACTED] related that his talents were extremely limited.

[REDACTED] stated that she did not meet many of [REDACTED]'s friends but she was aware of one of his girlfriends by the name of Nancy from Walla Walla, Washington, and at one time saw a picture of her. She described her as a young attractive lady with long dark hair parted in the middle. As I recall, most of the girls that are missing or have been killed in the Northwest area in the last few years have been described mostly as long, dark hair parted in the middle. Prior to her leaving with [REDACTED] to the San Juan Islands, she was able to observe his driver's license and determine that his true name was [REDACTED] and not [REDACTED], as he had claimed. Even with her extreme uneasy feeling about [REDACTED] and his conducts and lies that he told her, she agreed to accompany him to the San Juans. They travelled directly from Portland to the San Juans where they stayed at his Geodesic Dome on Egglake Road. [REDACTED] had previously agreed to have her returned to her Portland address on about the 27th of August. When the 27th arrived and [REDACTED] requested to be returned to home, [REDACTED] told her that she would go home when he was ready to take her home and not until. At this point she was becoming very scared of him, due to his forceful sexual actions on a daily basis, but she felt she should keep her cool because he might do something physically harmful to her. It was on one of these occasions when he had requested sex with her and she refused, that he physically dragged her upstairs and took her clothes off to have sexual relations. She then tried to use a little psychology on [REDACTED] and by Sunday she was able to convince

him to take her home. This was on about the 31st of August. At this point, [REDACTED] requested of [REDACTED] to accompany him to the State of Montana to stay with some friends. She declined and reaffirmed her request to be returned to her home in Milwaukie, Oregon. He then agreed and they left for Milwaukie, Oregon. While in route, [REDACTED] started noticing that they were travelling on what she thought was Highway 99E and asked [REDACTED] if they were going to Portland and he stated, "yes, they were". An hour or so later she then determined that they were indeed east bound towards Idaho and Montana area. At this point when she asked him which direction they were going he refused to answer and she advised him that she did not want to go to Montana, but wanted to go home. He continued to ignore her until they arrived in the State of Idaho.

During this entire week that she had spent with [REDACTED] she had continually been making plans as to how she could get away from [REDACTED] without him knowing it or making him angry.

Upon arriving in Idaho, they spent the first night in a rest area where they went to sleep in the back of the van. Not wanting to sleep with [REDACTED] or to have sex with him anymore, she made the excuse that she was not tired so she would not have to go to bed with him. He told her that he was going to zip the two sleeping bags together and that he was sleeping with her on this particular night. She then told him that she was going to sleep in one of the sleeping bags by herself and that she would not sleep with him or have sex with him anymore. He then stated that she would, took the sleeping bag away from her and zipped them together. She continued that she stayed up as late as she could, but due to the cold temperature she was eventually forced to get into the sleeping bag with [REDACTED]. At this point he forcefully removed her clothes and had sexual relations with her. Apparently on this particular evening he had consumed a certain amount of beer and smoked a number of marijuana cigarettes, which eventually caused him to go into a deep sleep. At this point she was able to remove \$40 from his wallet, gather up her possessions and she left on foot. Apparently she was able to return home by way of a bus.

She has not seen or heard of him since.


We feel that this man could be potentially dangerous to females, due to his obsession with sex and his rough treatment of his lady friends. It is possible that he has forced other females sexually and a possibility of taking them against their will, as he had demonstrated with [REDACTED]. [REDACTED] was aware of some of the details in regards to the Ted killings but we are unable to determine exactly the amount of details and information that he does have. He did change his name to [REDACTED] and he had a friend by the name of Dave who had a sailboat on the Seattle waterfront near an oyster or chowder bar type restaurant near the area of 38th and Waterfront. Apparently [REDACTED] did spend some time with this friend of his by the name of Dave who lived in his sailboat.
