On December 1, 2022 at approximately 1343 hours, the warrant was served via email to [REDACTED]@google.com.

This was done in an attempt to locate a suspect possibly searching for the victims prior to the murder, potentially gaining information on the persons, their residence, or lifestyles, which could be located on social media. The searches after, were done in an attempt to locate a suspect possibly searching for information on the murders prior to the discovery of the victims.

I was contacted by Google regarding the warrants and informed the process of the searches were extremely complicated and the large date range was problematic to their search queries. They stated they had to restart the process several times due to the complexity of the searches.

On December 19, 2022, Bryan Kohberger was identified as a possible suspect.

On February 15, 2022. After talking with other investigators and conferring with the Latah Prosecutor's Office, it was decided to return the warrant without data, as the original broad scope of these warrants was to determine a potential suspect, when none was known. New warrants, specific to Kohberger's Gmail accounts, which can include search history, have been requested.
