On January 23, 2023, the FBII tip line received an email from A [REDACTED] H [REDACTED] which stated Kohberger attended PHD courses at Oklahoma State University. H [REDACTED] added she met Kohberger during this time and Kohberger had befriended a professor named J [REDACTED] D [REDACTED] who gave Kohberger a Ka Bar knife. I spoke to H [REDACTED] on the phone on March 2, 2023. I did not record the phone conversation. H [REDACTED] related that she met Kohberger when D [REDACTED] brought him to her house for a visit. H [REDACTED] stated Kohberger made her very uncomfortable and she warned D [REDACTED] about him. I asked H [REDACTED] to email me anything she had to support her claim. H [REDACTED] emailed me the following information on March 2, 2023:

"2016-2017 University of Oklahoma began offering criminal justice bachelor degrees. Kohlberger found it cheaper to take the courses here that he needed for degree.

The dean who approved kohlberger was M [REDACTED] B [REDACTED]. Since retired. Ask for dean above P [REDACTED].

Kohlberger used a credit card to pay for courses and travel expenses. Subpoena
his financial records.
I'll have another report for you this afternoon with addresses numbers and any
other evidence of visit.

J [REDACTED] D [REDACTED] lies to investigators period. He lied to M [REDACTED] E [REDACTED] Virginia state
police in a cold case murder investigation. He is a krav maga instructor and a
predator. He encouraged kohlberger and initiated him into brutality.

I am here to help moscow idaho in any way possible and I have faith in your
competence as a chief of police.

Upon further investigation, it was learned H [REDACTED] had reported thirty-six tips
to the FBI over the past several years. In addition, there is no current
information to support Kohberger ever attended Oklahoma State University.
I will investigate further if information arises that Kohberger attended OSU at
any point in time.
