U of I documents from General Counsel; Capt. Berrett

On 11/19/22, I emailed K [REDACTED] N [REDACTED] at the U of I Office of General Counsel requesting a list of vehicles with parking permits on campus or had been ticketed between 08/01/22 and 11/13/22. The request was made to assist investigators locate persons who owned vehicles of interest in the on-going homicide investigation. On 12/08/22, I received an email from N [REDACTED] that contained a spread sheet showing U of I records for parking passes and parking tickets for any white Elantras, dating back to 2017. The email containing the spread sheet was forwarded to the investigation team.

On 11/30/22, I emailed K [REDACTED] N [REDACTED] and requested the rosters for all the fraternity and sororities on campus to assist investigators in this case. On 12/08/22, I received an email from N [REDACTED] with spread sheets containing the rosters for all Greek living groups for the fall, 2022 semester. On 12/06/22, N [REDACTED] sent me an email with spread sheets containing the individual chapter rosters for Greek organizations on the U of I campus from fall 2019 to fall 2022. I forwarded the information to the investigation team.

On 12/02/22, I received an email from K [REDACTED] N [REDACTED], responding to a request from the FBI, that contained spread sheets detailing the following regarding the six occupants of the house on 11/23/22;

List 1: All classes back to initial enrollment under dual credit enrollment in high school

1. Name, class, location, instructors

List 2: Specific information for each class in list 1

1. Additional information not included in list : Class location

List 3: Class rosters for each class in list 1

1. Term, class descriptions, student names and id numbers, student email (at the time) final grades

The email containing the spread sheets was forwarded to the investigation team.

On 12/01/22, I received an email from K [REDACTED] N [REDACTED], responding to a request from the FBI, that contained spread sheets with data relating to card-swipe lock on the U of I campus. I forwarded the information to the investigation team.

On 12/02/22, I received an email from K [REDACTED] N [REDACTED], responding to a request from the FBI, that contained data relating to card-swipe doors on the U of I campus. The information was forwarded to the investigation team.

On 12/06/22, I received an email from M [REDACTED] T [REDACTED] with the FBI, who was requesting the U of I pay schedule. I contacted K [REDACTED] N [REDACTED] and he emailed an explanation of the pay scale, and I forwarded to T [REDACTED].

On 01/17/23, I received an email from K [REDACTED] N [REDACTED], indicating the U of I had completed downloading data from their security camera system, onto a server MPD provided. I relayed this information to our forensics detectives and they were put in contact with U of I staff to take possession of the server.
