3. Narrative

On Wednesday, September 13, 2023 FBI Tech Specialist T█████ forwarded me tip serial #9237 via email. The tip was called in on August 22, 2023 to the FBI tip line. The caller, R█████ T█████, advised the call taker he saw a person whom he thought was Kohberger at 1122 King Road on two occasions in July on 2022. T█████ advised he came to 1122 King Road as he was a real estate agent looking for property for clients. T█████ stated on both occasions he saw Kohberger and Kohberger's father.

On Wednesday, September 13, 2023 I called T█████ on the telephone after verifying his identity via TLO. T█████ was a licensed real estate agent living in Florida. I asked him to relate to me what he reported to the FBI. T█████ told me he drove his nephew, "T█████", to the western US from Florida as his nephew was dying from cancer. T█████ advised he came through Moscow and saw a sign for property for sale, so he followed the sign to 1122 King Road to look at the property for clients. While he was parked out front, T█████ said a brown "Jeep type pickup" pulled into the parking lot driven by an older man with a red beard. T█████ said he then saw a male who he was sure was Kohberger get up from the back seat. T█████ and the driver exchanged small talk, and T█████ said he walked to the back door to speak to the tenants but no one answered. T█████ said he left the area with his nephew shortly after that.

T█████ said he returned to 1122 King Road on his way back to Florida. T█████ said he was parked in front of the house when a white car, which he described as "the same one they've shown on television", drive by the house. T█████ said he was sure the driver was Kohberger's father and Kohberger was in the passenger seat. T█████

said the vehicle sped away and he did not see where it went.

I asked T [REDACTED] if he remembered when this took place. T [REDACTED] asked me what month the homicides occurred. I told him it was November to which he replied it must have been around then. T [REDACTED] previously told the FBI he was in Moscow in July. T [REDACTED] then told me his nephew passed away a short time after he returned from his trip. I asked T [REDACTED] when his nephew passed away. T [REDACTED] told me his nephew passed away eight years ago. I thanked T [REDACTED] for his time and told him I would call him with further questions if needed.

At this time, there is nothing to corroborate T [REDACTED] statements based off inconsistencies in his timeline. Further investigation will be completed if necessary.

This is a summary of my conversation with T [REDACTED]. Our conversation was not recorder.
