Interview with M [REDACTED] C [REDACTED]:

On December 1, 2022, Cpl. Payne asked if I would assist with interviewing [REDACTED] members of Ethan Chapin at the Latah County Annex building. I arrived and spoke with M [REDACTED] C [REDACTED], Ethan's [REDACTED]. I introduced myself to M [REDACTED] and told her I would be recording our conversation so I would not miss anything she said. M [REDACTED] had filled out an adult victim background questionnaire which I reviewed before speaking with M [REDACTED].

M [REDACTED] listed Ethan as being easy going, positive, friendly, funny, and stated he did not have any negative issues or negative feelings with anyone. M [REDACTED] listed the following people as being the people whom Ethan spent the most time with: Xana, K [REDACTED] F [REDACTED], F [REDACTED] E [REDACTED], H [REDACTED] C [REDACTED] ([REDACTED]), F [REDACTED] J [REDACTED], and E [REDACTED] A [REDACTED]. M [REDACTED] told me the following about the people who Ethan was closest to:

Xana:

Ethan and Xana have been dating for about one year and met through school. M [REDACTED] has known Xana for one year and met her through Ethan. M [REDACTED] talked with Xana once, during rush, but never hung out with her until Xana started dating Ethan. She partied with Xana but never hung out with her outside of that. Xana was a junior, had a lot of friends, and knew most of campus. M [REDACTED] met Xana's dad briefly during parents weekend, never met Xana's sister, and never heard anything factual about Xana's mom but knew Xana did not have contact with her. Ethan would often spend time with Xana while she was at work at Mad Greek. Ethan and Xana never mentioned having weird feelings about anyone (customers or employee) at Mad Greek. Ethan never said anything negative about his relationship with Xana to her.

F [REDACTED] E [REDACTED]:

F [REDACTED] is a [REDACTED] and in the [REDACTED] fraternity. M [REDACTED] does not know much about F [REDACTED]. M [REDACTED] thought F [REDACTED] was a farmer and from California but she was not sure. Ethan would spend a lot of time with F [REDACTED] and they met through the fraternity. Ethan and F [REDACTED] were very similar and would often watch football together on Sundays. F [REDACTED] lives at [REDACTED]. Ethan would hang out with F [REDACTED] 3, 4, or 5 days out of the week. When Ethan would be with F [REDACTED] they would spend time at Xana's residence, F [REDACTED] residence, and several apartments at the "Whites" ([REDACTED]). F [REDACTED] A [REDACTED] and J [REDACTED] I [REDACTED] apartment [REDACTED] on the second floor, left side. The [REDACTED] apartment at the



"Whites" - C [REDACTED] A [REDACTED], T [REDACTED] R [REDACTED] (Ethan's [REDACTED]), and H [REDACTED] (unknown last name) the top floor, on the right.

K [REDACTED] F [REDACTED]:

K [REDACTED] was one of Ethan's closest friends. K [REDACTED] lives in [REDACTED] at [REDACTED]. M [REDACTED] stated K [REDACTED] and F [REDACTED] were Ethan's closest friends. M [REDACTED] did not see any drug use amongst any of Ethan and his friends but said they drank a lot, which was normal for the fraternity life.

H [REDACTED] J [REDACTED]:

H [REDACTED] J [REDACTED] is dating E [REDACTED] A [REDACTED] and was the person who B [REDACTED] and D [REDACTED] called to come to their house the morning of the homicide. Ethan golfed a lot with J [REDACTED] and J [REDACTED] and E [REDACTED] came to their house over the past summer several times and hung out. Ethan never had any issues with J [REDACTED].

M [REDACTED] never heard of or observed Ethan get into fights with anyone. Ethan never confided in her about having problems or frustrations with anyone. Ethan never mentioned having any issues with any of the girls who lived with Xana. M [REDACTED] spent time at Xana's house and never observed any issues between any of the roommates. M [REDACTED] said she did not know Madie or Kaylee well and said she knew B [REDACTED] and D [REDACTED] better. M [REDACTED] thought, if Ethan did have anything he needed to talk to someone about, he would most likely speak with their [REDACTED] H [REDACTED] or Xana because he saw them daily. M [REDACTED] said Ethan was an "open book" and was not a private person.

I asked M [REDACTED] if she knew what Ethan did on Friday and Saturday, November 11th or 12th. M [REDACTED] said she was not sure what Ethan did on Friday. M [REDACTED] said on Saturday, Ethan did not go to the football game or tailgate and thought he spent that time at the "whites", possibly at J [REDACTED] and E [REDACTED] apartment. M [REDACTED] said in the evening Ethan went with her to her formal event, which was at Hunga Dunga from 1900 to 2000 hours. M [REDACTED] said they drove to Hunga Dunga in their vehicle with Ethan, H [REDACTED] C [REDACTED] with his date R [REDACTED] S [REDACTED], L [REDACTED] (D [REDACTED] M [REDACTED]) and his date H [REDACTED] B [REDACTED], and J [REDACTED] K [REDACTED] and his date R [REDACTED] B [REDACTED]. M [REDACTED] said D [REDACTED] and J [REDACTED] are both [REDACTED] members. M [REDACTED] said Hunga Dunga was rented by her sorority and this was a private event. M [REDACTED] told me she knew the majority of everyone who was at Hunga Dunga and nothing out of the ordinary occurred while they were at the event.

M [REDACTED] said they all left Hunga Dunga, in the same car, and drove to her sorority where the girls (including her) got out, went inside, and changed clothes. M [REDACTED] said R [REDACTED], H [REDACTED], and R [REDACTED] all got back into the car and left with Ethan, H [REDACTED], D [REDACTED], and J [REDACTED] to go to a party at [REDACTED]. M [REDACTED] said she texted Ethan at approximately 2014 hours telling him she did not want to go with them to [REDACTED] and was going to stay at her sorority. M [REDACTED] said Ethan texted her several times, trying to convince her to come to [REDACTED], but she did not go and eventually fell asleep around 2200 hours. M [REDACTED] said the [REDACTED] party was just a normal Saturday evening party.

I asked M [REDACTED] if she saw any weird comments on Ethan's social media. M [REDACTED] said she recently logged into Ethan's Instagram account and made it private because it was public and a lot of random people were making bad comments on it. M [REDACTED] said people were speculating this was a drug related thing or something to do with the girls. M [REDACTED] told me she did not notice the names of the people who were commenting but said they were weird accounts with just one follower. M [REDACTED] said people were making bad comments on all of the other victims accounts as well.

I asked M[REDACTED] if the girls had any bad feelings with any of their neighbors. M[REDACTED] said she did not think so. M[REDACTED] told me she was at Xana's house a lot of the weekends and said they would often get noise complaints. M[REDACTED] said she was present for two of the noise complaints. M[REDACTED] thought the person making the complaint lived in a house behind 1122 King Rd. but was not certain. M[REDACTED] told me she never witnessed any retaliation from any of the neighbors. I asked M[REDACTED] if Xana and her roommates knew everyone who lived around them and she said she did not know. I thanked M[REDACTED] for speaking with me and told her if she thought of anything else to let us know. My conversation with M[REDACTED] was recorded and is copied onto DVD which I have booked into MPD evidence.
