Narrative:

Phone interview R. R. [REDACTED], J. Q. [REDACTED], C. W. [REDACTED] on 11-15-2022:

On November 15, 2022, I had a phone message from the front desk to contact R. R. [REDACTED], as she may have information regarding Kaylee Goncalves having a stalker.

R. R. [REDACTED]:

On November 15, 2022, at approximately 1115 hours, I called and spoke with R. R. [REDACTED]. I introduced myself to R. R. [REDACTED] and told her I was given her message to call about possible information regarding Kaylee having a stalker. R. R. [REDACTED] told me she and some friends had lunch with Kaylee around September 11, 2022, and she thought Kaylee said something about having a stalker. R. R. [REDACTED] thought Kaylee mentioned receiving something in the mail but some of the other friends at the lunch thought Kaylee mentioned getting a strange message through facebook messenger. R. R. [REDACTED] told me she had been speaking with all of the friends who were at the lunch and they were trying to remember what was said. R. R. [REDACTED] provided me with the names of the other friends who were at lunch with Kaylee on or around September 11, 2022:

C. W. [REDACTED], graduated last year U of I.

M. E. [REDACTED] - left U of I last semester

S. R. [REDACTED] - student at WSU

B. D. [REDACTED]: unknown phone #, current U of I student

R. R. [REDACTED] provided me with the name, J. Q. [REDACTED], and told me J. Q. [REDACTED] and Kaylee were very close friends and had plans to live together in June. R. R. [REDACTED] said J. Q. [REDACTED] was not at the lunch but she thought Kaylee would have spoken with her the most. R. R. [REDACTED] said Kaylee spoke with J. Q. [REDACTED], C. W. [REDACTED], and B. D. [REDACTED] the most.

I asked R. R. [REDACTED] if she could think of anyone who Kaylee had any issues with and she said, no. R. R. [REDACTED] told me Kaylee was very kind hearted to everyone.

I asked R. R. [REDACTED] how the conversation came up regarding the stalker at the lunch with Kaylee. R. R. [REDACTED] said Kaylee would always talk about things in a light hearted manner and said one time she was speaking about childhood trauma in a joking manner and they did not think much of it. R. R. [REDACTED] thought the stalker topic just got brought up at some point during the lunch conversation but she could not remember how specifically. I thanked R. R. [REDACTED] for the information and told her to contact us if she remembered anything else.

J [REDACTED] Q [REDACTED]:

On November 15, 2022, at approximately 1430 hours, I called and spoke with J [REDACTED] Q [REDACTED]. J [REDACTED] told me she and Kaylee had plans to move in together in June and said she spoke with Kaylee often. I asked J [REDACTED] about the topic of Kaylee saying she had a stalker. J [REDACTED] told me she remembered Kaylee mentioning something about a stalker but could not remember any of the details. J [REDACTED] said she last saw Kaylee the weekend of October 3, 2022, when she came for a visit to attend the U of I football game. J [REDACTED] said she also visited Kaylee around the weekend of June 14, 2022 and did not think Kaylee mentioned having a stalker on either of these weekends. J [REDACTED] thought the topic was brought up sometime during the previous school year, in May.

I asked J [REDACTED] if Kaylee shared any information with her of having problems with anyone and she said, no. J [REDACTED] told me she did not know of anyone who did not like Kaylee or would have it out for her. I asked J [REDACTED] if Kaylee mentioned having any potential love interests or said she was seeing anybody. J [REDACTED] told me when she last saw Kaylee on the weekend of October 3, 2022, Kaylee said she was not seeing anyone or sleeping with anyone.

I asked J [REDACTED] what she knew about J [REDACTED] D [REDACTED], Kaylee's ex-boyfriend. J [REDACTED] told me Kaylee and J [REDACTED] both loved each other and did not have any hard feelings against one another. J [REDACTED] said J [REDACTED] and Kaylee started dating when they were younger and Kaylee broke up with J [REDACTED] so she could grow up a bit and experience other things. J [REDACTED] said at first, the break up was hard for J [REDACTED] but they remained friends. J [REDACTED] said she did not know the other roommates that well who lived with Kaylee. J [REDACTED] said when she visited during the weekend of October 3, 2022, there were a bunch of people at Kaylee's house but no one who stood out. J [REDACTED] told me she was with C [REDACTED] W [REDACTED] and handed the phone to C [REDACTED] so I could speak with her.

C [REDACTED] W [REDACTED]:

I told C [REDACTED] I had spoken with R [REDACTED] about the lunch they had with Kaylee and the topic of the stalker. C [REDACTED] said she and her friends have all discussed the stalker topic and could not remember exactly what was said. I asked C [REDACTED] if there was anyone Kaylee spoke to her about and she said, no. C [REDACTED] told me she graduated from the University last year, was not in Moscow, and did not spend that much time with Kaylee. C [REDACTED] said she did not know anyone who did not like Kaylee or had it out for her and she did not know Kaylee's roommates. I thanked C [REDACTED] for speaking with me. C [REDACTED] gave the phone back to J [REDACTED] who told me I should speak with Kaylee's friend, N [REDACTED] G [REDACTED], and said N [REDACTED] and Kaylee spent a lot of time together. C [REDACTED] and J [REDACTED] both provided me with their current addresses:
