3. Narrative

On November 13, 2022 at around 1347 hours, I interviewed E [REDACTED] F [REDACTED] at the Moscow Police Department, in regards to the death of 4 of her roommates. E [REDACTED] is a resident of 1122 King Road. F [REDACTED] was home sleeping in her room located on the basement floor of the residence. E [REDACTED] has an I-Phone 11 Pro cellphone with passcode [REDACTED].

E [REDACTED] went to the [REDACTED] party at around 2030 hours with Ethan Chapin and Xana Kernodle. They hung out in an apartment for a while together and then E [REDACTED] went up to the main part of the fraternity to hang out at the party. Maddie and Kaylee went to the corner club together, not sure when they left. E [REDACTED] did not see Ethan and Xana at the party and left to go to K [REDACTED] residence at [REDACTED] Taylor Avenue. E [REDACTED] walked home at around 1ish and when she got back to 1122 King Road D [REDACTED] and I [REDACTED] M [REDACTED] were at the residence and they all watched a movie together. Maddie and Kaylee got to the house at around 0145 or 0200 hours. I [REDACTED] left the house and D [REDACTED] went to bed. E [REDACTED] hung out with Maddie and Kaylee for a while in Kaylee's room. E [REDACTED] and Maddie took Murphy (Kaylee's dog) out to go to the bathroom between 0230 and 0300 hours. E [REDACTED] did not stay outside for very long as it was cold. Maddy then went to bed and watched a TV show to help her sleep (Baby Daddy). At around 0400 or 0420 hours, E [REDACTED] heard what she thought was a firework and saw a spark on the ground from under her door. E [REDACTED] then heard Murphy barking. D [REDACTED] called E [REDACTED] and stated she had seen someone in the house and E [REDACTED] told her she could come down to her room and sleep with her. D [REDACTED] went to E [REDACTED] room and went to bed. They woke up at around 1100 hours and talked to other friends who came over and they checked on Xana and Ethan and found them deceased. E [REDACTED] originally called 911 and stated her friend was passed out and would not wake up.

E [REDACTED] talked about an incident with Kaylee who stated about a month ago she

saw an unknown male up above their house to the south who was starring at her when she took Murphy out to go potty.

B [REDACTED] stated Kaylee broke up with her long-time boyfriend about 3 months ago because she was planning on moving to Texas.

B [REDACTED] could not provide me with anything else at that time.
