5-1-75: Houston Texas P.D. has reported that Gary A. Taylor is currently a suspect in the rape and assault of a 17yr. old female, and a warrant is forth coming. Taylor is currently driving his Chry. he will be entered into N.C.I.C. this week, indications are that he is traveling from the west coast back to Michigan where he is from, and now to the southwest.

MR. & MRS. TAYLOR were neighbors of the STUTHS, 14216 24th S., one week prior to MS. STUTH's disappearance. After that they moved to 40224 228th S.E., where MR. TAYLOR was arrested on 12/5/74 for investigation. During the evening of 11/27/74, TAYLOR's van was seen at 14216 24th S., in the driveway at approximately 2200 hrs. While MS. STUTH was talking on the phone, a neighbor came to her door asking if she wanted a boxer dog, as he was moving. TAYLOR owns a boxer dog. When TAYLOR was arrested neither he, nor his wife, would give statements. Due to lack of evidence, he was released.

TAYLOR was incarcerated in a mental hospital for the criminally insane in Michigan for 11 years. He was released in 1970. His M.O. was assaults on women and shooting them with a .22, cutting them with a machete, and morals offenses on lover's lanes.
