Reporting officer was contacted by Officer Don FAZER of the Utah Highway Patrol, who stated that a George BEHUNIN, [REDACTED] or work number is [REDACTED] had contacted him at the Echo Utah Line Weigh Station.

Mr. BEHUNIN advised Officer FAZER at 6:30 AM on December 10, 1974, he was at the Metro Station, 2488 South Highway 91, obtaining gasoline and he observed an individual in a light-green Plymouth also getting gasoline. He had a female in the car with him who looked like Debra Kent. Mr. BEHUNIN stated this individual paid for his gasoline with a credit card.

Reporting officer obtained the credit cards information which were given to the Metro Station that morning and the only Plymouth was listed to a Mike ALLRED, who works at Triangle Oil - Main office in Bountiful.

This information was mentioned to Officer Gordon Garrett who knows Mr. Allred and he advises that Mr. Allred dates a girl who would appear to look like Debra Kent.

Mike ALLRED is the brother of Doug ALLRED, the owner of Triangle Oil.

Reporting officer was contacted by Mr. BOWEN, Vice-Principal of Viewmont High School, and his daughter, Karen, who lives at [REDACTED]. She works at Murray First Thrift in Orem, Utah.

Karen stated that a SHANA McDONALD, who lives at [REDACTED] had advised her that she is going with an individual by the name of MIKE LUND, age 29. Description is 5'10", exceptionally good looking, pretty eyes, a good build and wearing a mustache. Mike is supposed to have a sister who lives in Bountiful.

Shana stated that Mike, as she put it, "is weird". He often-times talks about the narrow-mindedness of the people in the state of Utah, in that they will not allow humans to have sex with animals.

Karen Bowen stated that Shana had advised her that one day Mike took off his shirt and he had scratches all down his back. It is not known how he obtained the scratches.

Shana is approximately 40 years old - has a daughter by the name of [REDACTED]. Shana stated Mike is always watching [REDACTED] and is very interested in her. [REDACTED] description is not known.

Mike ALLRED goes to school at BYU and is majoring in Motion Picture producing.

According to Karen Bowen, Mike spends alot of time at the University Mall. He also

drives a dull-orange Volkswagen, with a California license.

Karen is very desirous that her name be kept confidential by this department. She further stated that Shana McDONALD may not be too much help as she is, as Karen states, "wishy-washy". One time she will feel something should be done about Mike and the next time she will protect him.

Reporting officer contacted John SHAFER, [REDACTED] Mr. SHAFER stated he was at Viewmont High School, on November 8, 1974, to pick up his two daughters who were attending the play. He stated he thought the play let out at 10:00 PM and he arrived there approximately 10:20 PM, was parked at the Masonic Temple, waiting for his daughters to come out of the school. He noticed that at about 10:20 PM, a grey or white Volkswagen, very "ratty" looking, with rust spots on the driver's side and he thought also on the side, but he was not certain.

This vehicle came out of the west parking lot, went east toward Main Street. The license number was not obtained by Mr. SHAFER as he did not have any reason at that time to obtain it. He stated, the reason for the delay in reporting this, he had been thinking about it since the two girls have been found - one in American Fork and the other in Summit County, and realized the description of the Volkswagen seen in the Murray situation and he decided there could be a tie-in so he called this department.

Mr. SHAFER did not observed anyone in the vehicle but he did observe that the front seats did not have the high backs like the late model Volkswagens do.

Reporting officer was contacted by Sgt. Bill STETTLER from the Ogden Police Department, concerning a suspect by the name of Fred TOLMAN, 10-12-49. His ex-girl friend is Kathy KILLIAN, [REDACTED]

Sgt. STETTLER stated that Mrs. Killiam would be happy to talk to this officer concerning Mr. Tolman, he is desirous that her name be kept confidential.

On 12-11-74, at 0945 hours, reporting officer and Detective Beal, interviewed Kathy Killian at her residence. She stated that it had been two years in August since she had gone with Fred TOLMAN. She stated that she had met him in 1972. She stated that while she was going with him he worked at Coca Cola Bottling Company, in Ogden. He had either quit or had been fired from the job, she is not certain which. When she asked him about it, he became very violent with her, grabbed her and shook her very strongly. Kathy stated shortly after that time, she broke up with him and he

did not like it. He loaded a gun, told his mother he was either going to kill Kathy or himself, however, he was restrained from doing so.

Approximately one month later he was placed in the Veteran's Hospital in Salt Lake in the Mental Ward. Kathy further stated that Fred Tolman had belonged to the National Guard, Browning Armory in South Ogden. He was discharged from the Military approximately 1971. A check will be made to see if any information can be located from the Military on Mr. Tolman.

Kathy stated she did not see him again for about three months and he was engaged to be married and stated he couldn't go through with it because his girl reminded him too much of Kathy. He told Kathy at that time that he had registered at Weber College - to major in Child Development, because he knew that this pleased Kathy and he wanted to make her happy. Kathy stated Mr. Tolman worked at Felt Auto Parts. When I asked her if he talked about sex life or if she could relate any information concerning any violence in his sex life, she stated that she could not, but stated he had made the statement to her that he would go anywhere and do anything to get his sex, regardless of what he had to do.

I specifically asked Kathy if she felt that at that time he meant that he would commit rape. She stated she didn't feel that he would go to that point.

Kathy stated he had never been violent, other than the one time when she confronted him about his job at the Coca-Cola Company. However, she did state that Mr. Tolman had admitted to her that he had been on drugs in the military, namely LSD and Marijuana.

Kathy stated she knew that he still uses drugs at the present time.

Reporting officer and Detective Beal then went to Hill Field, OSI, where they attempted to obtain information from the Veteran's Hospital, however that hospital would not release information without a Court Order or consent from Mr. Tolman.

A description of Mr. Tolman - is 24 years of age, 6'5" 140# to 145#, light brown hair. Information was received that he hung out at the hospital pharmacy between 24th and 25th Streets on Harrison Blvd. We talked to the druggist there and asked him if this subject was extremely handsome or good looking and he stated that he was not. He had a very thin nose, which would be readily observed by anyone observing him, therefore, this suspect, at the present time, has been eliminated as a suspect in this case.
