<p>Reporting Officer was contacted by Mr. Clarence DeMain, Phone No. [REDACTED] Mr. DeMain advised reporting Officer that he drives for Lakeshore Lines and he picked up an individual which appeared to look like our composite. He rode the bus to the Roy, Utah area.</p> <p>He stated the individual was quite rowdy all during the ride and as they got into Roy Mr. DeMain observed that the individual had cut the seats on the bus. He stated as the individual started to leave the bus he showed him what appeared to be a Florida Drivers License with the name Kismore on it stating he was with the Highway Patrol and was looking for a man.</p> <p>Mr. DeMain stated there was an empty wine bottle sitting on the seat. He took this and gave it to Mr. Hargis who is the Manager of the Lake Shore Lines in the Ogden office. Reporting Officer will retrieve this bottle in an attempt to obtain fingerprints from it.</p> <p>Reporting Officer then contacted Leola Mullins [REDACTED] Mrs. Mullins stated that on Wednesday, October 16, 1974 her 13 year old daughter [REDACTED] had been raped somewhere in the Kearns area. Near as they could determine towards the end of 7200 South. She stated that information had been received by her through individuals at the Junior High and High School in the Kearns area that possible suspect on this would be a Brent Carson, approximate age 19. This individual supposedly hangs out at Hubs in Murray.</p> <p>Mrs. Mullins stated that Jerry Thompson and Ken Miles of Salt Lake County Sheriff's Office were investigating this case. Reporting Officer will contact these Officers for further information.</p> <p>Reporting Officer then contacted Billy Tingey at Meadowbrook School. He stated he had been hiking in the Centerville Canyon area and an individual with brownish-blond fluffy hair and mustache came down the road in a small bluish-green car with rough paint approximately one block west of the mountains on the east end of Parrish Lane. He stated the individual went by them and they started to run. He slowed down and banged on the window and hollered "hey". Billy stated he and his friend ran and hid from the individual.</p> <p>When this Officer inquired as to whether or not he had conversation with the individual and he stated no the individual had not talked with them. Reporting Officer did inspect the area at the east end of Parrish Lane, however, was unable to locate anything.</p> <p>Reporting Officer was then contacted by Sandy Cullimore who informed this Officer she had observed an individual in a pickup truck, black top with goldish brown bottom in the area by the "B". Greeves, [REDACTED] and lives at [REDACTED]</p> <p>Trooper Rasmussen stated he was driving a 1967 Ford Mustang, Blue in color with a light colored hood. He stated they had located in the vehicle a pillow cover with numerous articles of clothing in it. Among this clothing was a two-toned brown pair of leather shoes with lace ties. Trooper Rasmussen however indicated that they appeared to be a small size man's shoe. He also indicated that it appeared these clothes were man's clothes probably belonging to the victim. He stated he was a flashy dresser. The victim stated he was in the process of moving to Ephriam where his mother lives to stay with her.</p> <p>At this time it appears that these items do not pertain to this case, therefore, it is felt by this Officer that no trip to Mt.
