This Officer interviewed



She stated that she had talked with Debra Kent during the intermission in the girls restroom and from everything she could tell in talking with Debra all was well with her. She stated Debra was acting her usual self. Tami stated that approximately 10 minutes after the intermission she got up from her seat in the auditorium and went to the rear of the auditorium and stood back there talking with another girl friend. She stated at this time she observed a man walking back and forth in the rear. She described this individual as being between 27 and 28 years of age, good looking, standing between 6' and 6'1", approximately 180 pounds. She stated he had dark brown hair, almost black and had a mustache that came down on both sides nearly to his lower lip. He was not wearing glasses. He was wearing a blue jacket, white shirt and possibly a tie.

She stated he hung around the area by the doors which lead out to the south with his arms folded and appeared to be an individual in authority acting somewhat as an usher. She stated the jacket he was wearing was navy blue in color, solid and she believed he was wearing print pants.

She stated on 11/6/74, Wednesday at approximately 1300 Hours as she was walking east on D00 North at approximately 400 West a man who was driving a green car pulled up alongside of her, slowed down and yelled at her wanting to know if she wanted a ride. She stated she was just going to the High School. He told her he had been a student there approximately four years ago. She stated, well I don't know and then stated to him no I guess I just as soon walk. The individual then left. She stated she had not seen this individual before and has not seen him since. The description on this individual was.

He was between 26 and 27 years of age, medium brown hair, collar length, believed the hair was combed to the left. He had a mustache down to the lower lip. He was wearing green sunglasses (square on the lens), had a suit or sports jacket hanging in the window behind the driver's seat and also a white shirt. She stated that the vehicle appeared to be that of a Super Sport Car about average length. It was solid dark green in color and jacked up in the rear, two door, believed to have mag wheels, was not noisy and appeared to be in good shape as she did not observe any dents or damage on the vehicle.

Sherry was shown an automobile identification manual and after looking through the vehicles stated that the vehicle she had observed looked like a 1968 Oldsmobile, 442.

While mentioning this information to Chief Anderson it was noted that his daughter had also seen this vehicle in the Bountiful area during the last two weeks and indicated that it has been seen quite regularly by other students in the Bountiful area. The driver of this vehicle does have a mustache.

The vehicle is believed to have black racing stripes on it, solid green and definitely a two-door with the rear end jacked up.

Tami Tingey and Sherry Leonard got together after hearing about the disappearance of Debra and at this time discovered they had both probably encountered the same individual and after discussing it between them feel they are talking about the same person.

This Officer then interviewed Myron Beniost, [REDACTED] [REDACTED] He stated he had also seen an individual matching the description given by the other two standing by the back doors at the rear of the auditorium. His description was the same as that given by the other two individuals and he stated after the intermission he watched the play for approximately another 10 minutes, then got up, walked out to get a drink and observed another individual standing between the double doors leading out to the south of the school whom he described as being approximately 215 pounds, approximately 6'1", between 40-45 years of age. Dark hair, receding, believed to have a mustache wearing plaid shirt, dark in color, and did not appear to be dressed for the occasion.

When asked by this Officer if he thought the two individuals, the one standing inside and the one in the breezeway could have been together he stated he doubted it. He stated he merely gave the individual in the breezeway a glance and then went over by the office and got a drink, walked back into the auditorium and watched the rest of the play. He was asked whether or not there was anyone else in the hallway when he went to get a drink and he stated he did not notice anyone in the area.

It was noted that Mr. Cameron was in charge of the ushers and they were all girls from the Drama 1 Class and he was back and forth in the area where the one suspect was noticed and would have very possibly noticed him by the doors.

It is noted by this Officer and Deputy Hunt of Davis County Sheriff's Office assisted Major Adams from Centerville of the Utah National Guard and took off in a chopper at 1200 Hours this date and made a complete and extensive search of the Davis County area west to the Great Salt Lake checking all roads and ditches and drainage canals in the area. The surrounding area of Viewmont, canyon areas and foothill areas to the east were checked to the top of Skyline Drive, to the top of Mueller Park, Ward Canyon and other canyons in the area.
