Sandy was interviewed in regards to possible information she had in connection with the Kent case. She states that she is acquainted with and has dated one Richard Fallows, approximate date of birth would be [REDACTED]. She stated that on Friday evening, Nov. 8th at approximately 7:00 P.M. Richard Fallows came to her residence in Bountiful and asked her to go out with him, at which time she turned him down. At that time the subject, Fallows was wearing dress levis and a white sweater or knit shirt, he was driving a brown Mustang II. Fallows is described as: brown hair, dark in color, brown eyes, medium complexion, 185 lbs, 6' in height. When questioned about a mustache, Sandy stated that there was no mustache and she had never known him to have a mustache. Approximate address on subject is [REDACTED] with the phone listing of [REDACTED] she is not certain about that phone number.

Sandy states that this subject is different in his behavior with women, as she states that when it comes to a sex relations the subject is very violent and gets upset very easily if his wishes are not complied with. She states that he has access to numerous cars in addition to the brown mustang mentioned, he also has a orange colored Barricuda, yellow Pentera and other vehicles available to him. She states that she has never known him to work and to her knowledge he is now unemployeed and on welfare, however she states that he always has money and never seems to be hurting for money.

Sandy requests that she remain anonymous at this time in regards to this subject.

It should be noted that Miss McEwan works at Utah Sand and Gravel's main office on the north Beck Street area, Salt Lake county and if she receives any more information in regards to this individual she will advise Bountiful Police Department or this Officer.

Reporting Deputy was also requested to attempt to locate any Brent Olson's who may be involved with the subject seen at the Viewmont High School area on Friday, November 8, 1974 in regards to this case. This Officer has been able to develop an approximately a twelve Brent Olson's in the Salt Lake, Davis County area, this list does not include children of person's listed in telephone directories, however it is all Brent Olson's listed with U.B.I. who have any type of criminal record.
