COMPLAINANT: DEAN KENT

On Saturday, November 16, 1974 the Bountiful Jeep Posse organized a search utilizing approximately 200 volunteers in addition to the Bountiful Jeep Posse members.

The area searched included everything north of U. S. 40 and Ensign Peak on the south to the north end of Farmington Canyon and included the Farmington Ponds on the north west from the lake short to the snow line on the east in the mountains.

Their search consisted of a foot search 100 yards on either side of any road that was drivable within this area.

Commander Mick Smith was the organizer and coordinated with the Police Department. The search was for any evidence of the missing or any clues that may lead to her location. The entire search proved negative except for some miscellaneous clothing items which do not belong to Debra Kent.

Dave Cluff one of the Jeep Posse members called this Officer to the Mueller Park area to investigate further on a pickup truck that was parked at the top of Mueller Park. This vehicle was a blue Ford 250 pickup with a utility box, Dealer No. 1391, registered to Dave Singer Mobile Homes,

Dave Cluff reported that the pickup truck drove up while he was there. The pickup was occupied by two males. #1 - Look-alike for the drawing circulated by our Department. He was 6' to 6'1", brown hair over ears, collar length, drooping mustache. #2 - Mid 40's, light grayish hair, 6'2" to 6'3", 200+ pounds, wearing glasses.

When they arrived at the scene Dave went up and introduced himself to the two. Dave was wearing his Jeep Posse clothing with insignia and badge and name tag. The two subjects refused to give him a name or to be cordial as he was. Subject #1 refused to look at Dave or stand face to face with him. When they walked east on the trail on the south side of the creek they took with them a roll of rope, a roll of heavy wire, a cable come-along and subject #1 was wearing a small army pack. The only thing they did state to Dave was that they were just going for a walk.

On Sunday, November 17, 1974 Jay Parker contacted this Officer and informed him that he was returning from California on Saturday the 9th of November and as he crossed the salt flats east of Saltair he observed a vehicle believed to be a car rather than a truck north of the highway in an area where there were no roads. This vehicle was driving as though it was lost or having a difficult time driving in the non-traveled areas of the salt flats. It did have its lights on.

Jay Parker stated he did not connect this with the Debra Kent case until he got thinking about it.

I contacted Mick Smith of the Jeep Posse. He checked the area described by Jay Parker and made an extensive search but could find nothing of benefit to this case.

On Monday the 18th I received information that there was an active CB operator that lives in the east bench or Holladay area of Salt Lake City that refers to himself or uses the call letters on CB Channel of Sundance Kid. Person giving this information stated that he had only seen this person once and this was at a dance in Ogden on the 2nd of November. This was a dance sponsored by and for CB Operators.

On Tuesday the 19th I was contacted by Norman Workman who is another CB operator who stated he is also a special deputy for Salt Lake County and works in the Holladay area. I contacted him and inquired of him if he knew Sundance Kid. He stated he knew of him, had met him a couple of times. He stated the Sundance Kid is a look alike. He described him as being 25 to 30 years of age, 6'1", 185#. He stated his face was a little fuller than our drawing. Sundance Kid drives a 1967 or 1968 Blue Ford pickup with a "big engine". He is believed to live in the Holladay area.

I contacted Sgt. Leake of the Holladay Division and he stated he would check and see if he could find out who this individual is and where he lives and would relay this information to this Officer.
