I interviewed

Joan stated that she had already talked to an officer however she wished to look at some pictures of automobiles in an attempt to identify one which attempted to pick her up in front of Bountiful Bowl. She described the individual as having dark brown hair approximately 30 years of age. She described him as being better than average looking, driving a yellow vehicle.

She picked out three cars in the mug book, a 1967 Cougar, 1968 Pontiac Firebird and a 1970 Chevelle. She stated that of the three, that the Chevelle most closely resembled the one she saw. She stated that the vehicle was definitely a two door model, being a yellow or golden yellow in color.

She stated that the vehicle had wider tires on the rear that it did on the front. The exhaust was louder than normal. She stated that the subject stated, "I've been watching you for two days and I'll get you before I'm through." She stated that he had a deep voice and that he was alone in the vehicle at the time.

She stated that when the incident occurred she was walking south along the front of Bountiful Bowl when the subject pulled up alongside her. She stated that she stopped while he made the comment and then she immediately began walking faster, crossing the road towards Lee's Cafe. She stated that he did sound very serious and the incident frightened her considerably. She stated that she felt that this might be the individual responsible in the KENT case and that was why she was reporting it to this department.

Mr. Allen, the assistant principal of Woods Cross High School contacted this officer and stated that he might have students at that school who might have information concerning this case, which might be of interest to this department.

Mr. ALLEN was contacted by this officer assisted by Officer J.R. Hunt of the Davis County Sheriff's Office. Mr. ALLEN stated that he had spoken with Doug CHADWICK and George FREESTONE. Doug was brought to the office and questioned by us.

Doug stated that last Friday night he had heard that a man answering the description of the man in the composite (#1) had been seen over in the area of 400 North in a park. Doug stated that he had not seen the individual in person, merely heard that a man of this description had been over there.

George FREESTONE was then called into the office and interviewed. He was heard to remark that he knows the "dude" on the composite drawing, which was being shown around Woods Cross High by Tricia KENT, Debra's sister. When one of the teachers, Mrs. GORDON, asked him what the individual's name was, she was told that it was none of ther business.

When George was interviewed he confessed to these officers that he was merely acting and in fact did not know the name of the individual. He told us that he had seen an individual who resembled the picture, out behind the high school attempting to sell dope to the students. However he did not have any other reason to believe that this individual might be a suspect. He was reprimanded by this officer for insinuating that he might personally know the individual on the poster and for wasting our time.

George did offer the information then that the individual was dressed in a brown suit. 5'8" or 5'9" wearing a goatee, brown hair. George lives at

I then talked to a Gary METTLER, who attends Woods Cross High, lives at an an address unknown to me. Gary stated that the composite looked almost identical to the subject that George was talking about. He stated that definitely the man did not have a goatee. Gary stated that his hair was parted a little more to the middle and looked freshly styled. He stated that the individual was very neat in appearance but could not remember a description of the clothing. Gary stated that he had also heard that this individual was seen in the area of the 400 North park and was at that time reportedly driving a smaller white car described as both a Nova and a VW. Gary stated that he spoke personally with the individual at the same time that George FREESTONE did and stated most emphatically that he did nothage a goatee. He did not know why George would
