I also admitted we were still interested in another subject and hoped DNA may eventually settle the situation.



Tuesday, January 2, 1973.

We went back to school today. I still wish Christmas vacation would last longer. Although we did have 17 days off this year. It went so fast thow. I still haven't gotten over losing 101B I don't think I ever will. He's a great loss.

I babysat after school today and no 15 minutes after I got home, I had to leave for my regular babysitting job (every night, G-12). Well that's all for today.

Wednesday, January 3, 1973.

This is the happyest day in my whole life.

1018 said that he wanted to get back together with me. But he already asked 1018 to go to Truth or Cons.

So we're going to tell her after it. I'm so happy I could cry. He said that 1018 doesnpt show how much she likes him and I do! He also said that every time he'd kiss her she'd french him! (Gross!)

I just got back from babysitting. I'm making 60 dollars a month.

Thursday, January 4, 1974.

101B sure was fucked up tonight. He had 3 pipe loads of hash! He's going to kill himself one of these days. He was trying to get my body shirt unbottened, but I stopped him cos' I knew once he got me going I'd never stop and I had to get back to my babysitting job. (Damn it!)

Today was a boring I stayed in the house all day except for when I was babysitting. Well School tomorrow and I really don't feel like going!

Well, I've been writing in my diary for 1 week and I've only missed one day Thats pretty good. Huh? Not much happened today. (As usual!) 101B told me he loved me tonight. He's said it to me before but for some reason it mean all lot more to me tonight than it ever has before. I love him so much I've told him before but I don't think he really knows how much. I went rollor skating with 101B It only cost 25¢ to get in. Me, 101B and 101B went downtown this morning. We were gone from 11:00 till 4:00.

#### Tuesday, January 16, 1973

Me and 101B went to Truth or Cons. It was really dumb but we had fun. I can't write much cos' me and 101B have school tomarrow. Well, 101B doesn't but I do. She's spending the night and she's going to 101B with me.

Wednesday, January 24, 1973

Moms going to let me go back to school for the rest of the week. Shes only letting me go for 1/2 day thow cos' I'm still pretty weak and my back is still hurting a little. It sure is windy out tonight. I was walking back from babysitting and it nearly blew me of my feet!

The stupid cat is sticking her paw in the whole in the window. Almost scared the shit out of me. I really miss my dad. I wish so hard he'd come back. I love him so much.

Thursday, January 25, 1973

We had instalation practice tonight (boring) I was voted Tresurer so tomorrow night I'm getting installed.

Saturday, February 3 1973

Me, 101B and 101B went downtown today and we met this black guy and he stated talking to us. He said he was 40 something and that he was going to die because of an operation. He kept saying he was so glad he met us and that he would never ever forget us. He took us to his apt. and on the way he stopped off at the store and bought us some beer then he stopped at some house and got a lid. We talked an hour or two then he got us a taxi back to town. I really love the man. He made us his blood sisters and blood brother.

February 4, 5, 6,7,8,9,10,11, 12, 13, 14.

Thursday, February 15, 1973

I just know 101B doesn't love me anymore. He never tells me he loves me anymore, he hardly kisses me, he don't sit by me or put his arm around. I can tell he likes 101B again because of the way he acts around her and I know she can tell to cos' she's fighting hard to get him away from me again and I'm so scared she'll get him and he'll brake up with me. I love him so much. Why does 101B insist on taking every one's boy friends. She's done it lots of other times. I hate her! I pray 101B still loves me.

Well its over between me and 101B tonight. I told him I just wanted to be his friend. I know its the best thing for both of us. Thats what I told him and he agreed. I'm glad I did it now. I still love him alot and I think I probly always will.'

Friday May 25, 1973

101B took me skating tonight. I had a lot of fun. 101B came over after skating and he stayed till 4:10 a.m.: 101B came over too and he fucked 101B and she was so scared that shes going to get herself pregnet.

Saturday May 26, 1973

Me, 101B & 101B went Northgate today and we were passing a jewlry storestore window and just kiddingly I showed 101B a ring and I said "thats the one I want you to get me" and that night he called me up and said he had something for me, so he came over and gave me a small box and it had a 14 k. gold ring with 5 small diamonds on it! Its a wide gold and silver band. Its so pretty and their real diamonds. too! cont.

Sunday June 17, 1973

Then we hitched back home and then over to 101B then to 101B then back home. I got on restriction for two weeks cos 101B was in the house at 4:00.


