IRWIN: The date is 5-29 of 85. Time is 1:18 in the afternoon. We are in a private office of the dectective's division of the Spokane County Police. With us today is Detective Daugherty, myself, Officer Roger Irwin, of WSU, and Mr. Donald White. Don, would you state your full name for the record.

WHITE: Donald Edward White.

IRWIN: And your date of birth?

WHITE: 4-13-56.

IRWIN: Okay, Don, well, we have already chatted a little about Larry, why don't you just take off, for we, (unable to read tape)

WHITE: Okay, as I understand, this is in reference to some people being killed, okay

IRWIN: Right, perhaps I should expand on that a little bit Don. In 1971, there was a young coed murdered on the WSU Campus. Okay, and I believe it was in '81, am I correct Rick?

DAUGHERTY: Um

IRWIN: When Kristine, in 1981, a young lady by the name of Kristine David was

WHITE: That's the one on the hill, in

IRWIN: On the Lewiston grade, right

WHITE: Um

IRWIN: And as I stated before, we had received information through Detective Bailey that you may or may not have information that would be helpful to us.

WHITE: Okay, frankly, I don't think I do, but I will tell you, you know, that's for you to decide. Uh, okay, at the time, Larry and I were in the Palouse, in '81, okay, we were all over the place in '81. And at the time, you

you, he had an interest in the case, we talked about it a number of times, uh,

IRWIN:

About the case, Kristin David?

WHITE:

Right, um, at that time, I believe that there was a brown van that was a suspect, in the, in the abduction, or whatever, um, and then after Larry and I had been arrested by uh, Whitman County Sheriff's on some unrelated matters, when we both were released, he was making a big deal out of, uh, he claimed that his wife, Shirley Knauf, while we were in custody in Whitman County Sheriff's, had been questioned by the Whitman County Sheriff's Department, uh, as to whether or not Larry ever had a brown van, or whether or not he was involved in, in that slaying. Uh, since that time, my wife has talked to Shirley Knauf, and she denies that she was ever talked to at all about that, uh

IRWIN:

Does Larry own a brown van?

WHITE:

No, not as far as I know, he didn't. Uh,

DAUGHERTY:

When did uh, he get the brown van that Fred bought?

WHITE:

Oh, that's this year, or you know, as soon as started dealing with the chemicals, we got that. Um, okay, at the time, I didn't think anything of it, alright, you know, when I think back on it, it's seems like he had an undue interest in, you know, I mean, yeah, great, it was kind of an mobid case and all that, but uh, there was a lot of things in the newspaper, we had a lot of other things going, it just, strikes me as odd now. Okay, then this last fall, uh, Larry and I had had a falling out down in California, as to what was going on with our pot garden, and we didn't deal with each other for about six weeks. During that six week period, my kids starting talking, uh, they started evidencing a lot of signs of trauma, where they had been sexually attacked, okay. And my

WHITE: wife developed a relationship, it took about two or three weeks to get them to talk about it, and at first, they didn't mention Larry at all.

They mentioned this other family in, in uh, uh, Oroville, California, where we had lived at the time,

DAUGHERTY: What was the

WHITE: By the name of Ron, well, I don't know, that is kind of a big mystery to me, the guy told us that, they told my wife, I never really knew the family that well, but my wife and my children did uh, but they claim that their name was Ron and Kathy Mathieson, okay, uh, later on, once the kids told us, you know, everything that was going on, we uh, contacted the County Sheriff's down there, and they determined that their name was actually Mathis, there was no Mathieson

IRWIN: Excuse me Don, could you go into a little detail what was happening with your children.

WHITE: Okay, I will, and then uh, I, since then I have called, and they, the Police tell me their name is Mathis, okay, the directory listed them under, under Ronny and Kathy Mathieson, okay, to be specific as to what my kids told me. Uh, countless acts, uh, mainly just sadistic type stuff at first, you know, they burnt my son's feet, uh, there is hospital records in California that document that, uh, my wife had to take him to the hospital. She thought that his feet had been burned on the pavement, cause it was a hot day that day. Well, my kids tell me that what actually happened is,

or whatever, a fourteen year old kid in that household, had held his feet up to a light or a piece of hot metal or something, on a light casing or whatever, and had his mouth covered, inside and out, and then ran him out on the street, still with his mouth covered, sitting down and split, and that's where my wife found him, was out on the pavement. Uh,

until she took him to the hospital. Well, she was at the hospital, she she just had the impression that the medical personnel did not believe that that's what had happened, and they were almost accusing her, without really saying anything, of, of having harmed our son. Well, she didn't think too much of that, at the time, okay, well, later on my kids talk of uh, of the same teenage boy coming uh, we had a, we had a train that went by, right behind our house, and it would go by three, four times at night, and just rattle the whole house, just really shake it up. my youngest son, or my youngest child, is two, then he was about eighteen months, started developing fears of all kinds of stuff. Dogs, uh, trains, airplanes, just, I mean, he was afraid of everything. You know, I would come near him, he would cry, he didn't want me around him, he didn't want, uh, the only relationship he really had in the house was with my wife, and come to find out, from what my older daughters tell me, is that when I was out scouting chemicals, or whatever, if I wasn't in the house, that a lot of times that the fourteen year old boy would put his, my children, it wasn't really a second story, but from the outside, it would require a ladder to be leaned up against the window, and that this fourteen year old out when the train kid had been coming through the window, and taking was going by, to, to cover whatever noise he might make. Taking back out the window, and to a car. And Larry Knauf, was in a blue car,

back out the window, and to a car. And Larry Knauf, was in a blue car, incidently, his brother Don Knauf, did have a blue sedan at that time. Taking them into the car and taking them to what my four year old daughter says is a Motel 6 in Oroville, California. She would know Motel 6, because she has stayed in a lot of motels with my wife and I, so you know, I feel pretty confident that she is accurate in that. Uh, at the motel, Larry and other people that we have haven't been able to identify, other than the

WHITE:

engage, my two youngest to engage in sexual acts, between them, mainly oral copulation, uh, and the fourteen year old kid was filming it with a video camera. Uh, they claim that Larry molested uh, both, I mean, there was no penetrations or anything like that, but there was definitely molestations. They, okay, I want to be, I want to clarify something for you, Larry's involvement, I mean the kids, Larry and I got back together after this, uh, estrangement, if you will, okay, and at that point, they still hadn't talked about Larry. Okay, then he was in the house like everyday you know, you know

IRWIN:

And you were not aware of what was happening?

WHITE:

I was aware of the other family, you know, but I didn't know, had no idea that Larry was involved in it, they, at that point, the main things they had talked about, well, I will tell you next, what they talked about. Is they, uh, my oldest daughter claimed that they had been taken into some kind of room some place, okay, and uh, in the neighborhood, she felt it was, you know, the way she decribed it, it was a basement, or an abandoned basement or something of that sort, that was concrete walls and floors that were broken down and dilapidated. She says that they had a women that she judged to be about my wife's age, which would be about 25 years old, tied up down in this room, and that they uh, they used to go down for like a two day period, this women was tied up down there, and that ultimately

DAUGHERTY: Was Larry and

WHITE: No, Larry, the kids don't talk about Larry being in that room

DAUGHERTY: Okay

WHITE: You know, not at the, I mean, if they do, it hasn't

IRWIN:

And what city was this in, Don?

WHITE:

Oroville, California, I would like to say something else, too, I brought every bit of this to the attention of the Butte County Sheriff's Department, and it's their opinion now, that nothing happened to my kids.

Okay, I mean, it's my opinion, that they didn't investigate none of the leads we give them, they never went to the hospital, never got the hospital records I mentioned, they didn't do a god damn thing except that decide that I'm a chemical thief and that I use drugs, and somehow or other, that influenced what my children are saying, okay.

IRWIN:

Do you know what hospital your child was taken too?

WHITE:

My wife will know, she, uh, in Oroville, it was the, I don't know, the Oroville Community Hospital or General or

IRWIN:

Small community?

WHITE:

Yeah, it was the major hospital in Oroville, um, but what got me thinking about Larry was the method that this women was killed. Because I
remember details of dismemberment from the '81 case on the grade. That's
what got me wondering about that, is later on, when they mentioned Larry
had been involved in the motel things and you know, that uh, that they
had seen him repeatedly at the Mathis home, accepting money from, there
was two teenage boys in the house, and apparently, there was some type
of money transactions

IRWIN:

Now, who saw this, Don?

WHITE:

My children.

IRWIN:

0kay

WHITE:

Okay, and uh, so I got to thinking, well

IRWIN:

Did you children ever see Larry in that basement room? With that women?

WHITE:

As near as I can tell, no. You know, but I want to stress something else

WHITE:

too, this, my children won't talk to nobody. We are talking about, my wife and I camped out, they wouldn't sleep, once we started talking about it, we had intense acting out in the house, I mean, you know, fighting each other, trying to harm each other, they wouldn't sleep alone, we had like a six week therapy session, in the living room. I mean, we couldn't leave them alone, they were just psycologically, they were just shattered. Okay, and they stayed that way for a good six to eight weeks. And during that time period, I mean, you know, we stressed that they hadn't done, I mean, they were told stuff like okay, uh, your Mom and Dad know you are here, they want to here, you are supposed to be doing this, uh, we will kill your friends, we will kill you, we will kill your parents if you don't, you know, if you tell, or if you don't cooperate, and so, they had a lot of, they were intimidated, very you know, effectively intimidated. It took us a real long time to get it out

IRWIN:

Is this what the children were telling you?

WHITE:

Yeah, I mean, I could go on for hours with the stuff they were telling me.

DAUGHERTY:

Okay, back to the room, with the woman tied up.

WHITE:

Okay, in the room, it didn't make any sense to me at first, because first off, she said the woman wasn't bound, I mean, you know, her mouth wasn't gagged, she was tied up, but she said her hands were free. And that she said that they left her for, alone for periods of time. And I couldn't understand, well why didn't this woman scream, why didn't, if her hands were loose, why didn't she attempt to untie the rest and get away. So I asked my daughter, you know, I said, okay, you know, why why wouldn't, why wouldn't the woman you know, call out for help. And she said, well, they had told the woman in the presence of all the children, you know, that

if she made any noise what so ever, they were going to start killing kids. Okay, that kind of made a little sense to me. But I said, okay,

why didn't she untie herself, free herself, and just get away. And she said, well, she couldn't. And I said, well, how come, her hands are free, they way she described it to me, the woman was in the corner, with some kind of anchor bolts or something, and had her legs out against the wall like this, and her legs were bound to the uh, you know, from, to the wall, on each side like this, and she had ropes around her torso, back against, with knotting behind her of some kind. She said yellow, what she described to me was like a ski rope, a big heavy ski rope, tying her back. And I started to get an idea, yeah, maybe the woman couldn't get, you know, untied, maybe she couldn't reach the knots, maybe you know, that made sense, uh, of sorts. She, they described that, now, my daughter, my oldest daughter, uh, doesn't really describe, you know, she claims to uh, to have been down there, and then just before the killing, and then she left, and then she come back in, apparently, when it was just about done, or whatever, and they ran her off, okay. My two youngest children were still down there. Now, we are talking about a four year old girl and a two year old boy. Now, I know that they don't make real credible witnesses, but if you could have seen the trauma they had, I mean, something, they seen something, okay. Um, my oldest, youngest daughter, my four year old, says that

the fourteen year old boy, stabbed the woman to death, while Ron, his dad, or step-dad, filmed it, okay. She says that there was cuts made from here back, on the mouth, I mean, the woman was totally disfigured, she was dismembered, she was put in plastic bags, and they talk about the bags being placed in holes in the wall. Okay, later on, they come back and my daughter talks about them spraying bug spray around, okay, with a pump, like

a garden sprayer, okay. To me, that make sense again, you know, I, I'm not thinking bug spray, I'm thinking disinfectant, or some kind of chemical to, you know, mess up blood tests on the floor, or whatever, on the floor, I don't know, okay. Uh, that all by itself is, you know, it is kind of hairy, but then I start remembering, during the same time period, before, that they are talking about, when this act occurred, okay, I start remembering how my children were acting in the house, my daughter, my four year old daughter, got into this trick with knives, she went up in, one day, she went and got the whole butcher block down, okay, she took all the knives up and had them hid all over her bedroom, okay. Uh, came running down, I wasn't home, but she told the wife that was trying to stab that's my two year old boy. My wife went up there, and you know,

sure enough, she was playing around with the knife over Okay, that really blew our minds, because we had never had, you know, we had never had any kind of problems like that. In addition to that, was just learning how to talk, alright, and he would sit, he would be sitting on my lap, sometimes, and you know how kîds would point at your nose or your mouth or whatever, you know, well, he had a, just an intense interest in my mouth, you know, he kept pulling my cheeks apart, wanting to look way into my mouth, he really wanted to check it out. Well, when the kids started talking about the woman's mouth being cut like this, I started remembering the look on his face. The kid was scared, you know, at the time, you know, I just, I wasn't doing my job, I wasn't paying a whole lot of attention, I didn't really understand what was happening, and I, you know, I didn't have any conception of what was going on. But, he is scared to death, you know, he would be pointing at my nose, the kids talk about the woman's nose either being cut off or smashed, or something,

it's a little yellow capsule, okay, I had four of them in the bottle, that's

what's that, you know, uh, and, cause he doesn't use drugs, or any, or he

doesn't drink or anything. So,he claims. And I said, well Larry, these

little yellow ones here make a hell of a mikkie, you put one of those in

somebody's drink, and they are history. You know, it isn't going to kill

And when I get home, there is three of them left in the bottle. Okay, my wife just, you know, in the course of conversation with his wife, she says well, you know, where is your husband? She says, well, he is in the County Jail uh, because he isn't paying welfare or something like that.

IRWIN: What was the wife's name, do you remember?

DAUGHERTY: Kathy

WHITE:

Kathy Mathieson, yeah, um, and she uh, you know, my wife accepted that, you know, why not, sure, that's no biggy. Well we, so, when we first go to the Butte County Sheriff and tell them, you know, what is going on, or

what we believe is going on, we mentioned the fact, hey, you can get a handle on this guy, cause he was in the County Jail, at such and such a time period. He was never in the County Jail. So she lied about that, where the guy was, I don't know. But he was not in the County Jail, at least the investigators that I was dealing with down there say he wasn't. But people lie all the time, there is a lot of lies that just don't make any sense, there was no need for them to begin with, and they, you know, this was in Oroville, yeah. Um, Larry, Larry swears up and down he doesn't know these people, okay, um, they say they don't know him. My kids say he was over there all the time, okay. I have got a phone bill right here, that's their telephone number right there, alright, it was placed from a Chico calling card, at the same time I was in Winnemucka, Nevada. was only two calling cards on that phone, me and Larry's, you know, and that again, that fits with his sloppy work, you know, I mean, he would do something like that. His home records, I believe, are going to turn up that same number a lot, it don't mean nothing, I mean, I can't see any case that can be there. It's the bottom on there, 533-7809. That's an Oroville number. Um, let me tell you a little bit about some of the stuff that was going on in this room, to give you kind of an idea, okay. What kind of people these people are, alright. Ron Mathis is the father, okay, now, well, I should say something else first, okay, once Larry come back and we got back together again, alright, I confided in him, he was my partner, you know, I told him, you know, these assholes, you know, I'm going after them. At the time, I had a .38, and I was going to get, you know, I was going to get me some ass, okay

IRWIN:

And Larry never acknowledged that he knew them?

WHITE:

No, okay, in fact, Larry was always telling, he was always, you know,

pumping me for details, he wanted to know everything the kids were saying, uh, he was telling me, well, I am going to help get these assholes, you know, they were real sick, yeah, we got to get them, all this, okay. Well, my kids tell me know, during that same, uh, time period, from roughly the first of December until I found out about his involvement, everyday he was in the house, whenever my wife and I weren't, you know, paying attention to him, he was getting one of them off to the side, saying, you bet shut up, you know, he was coursing them some more. He was telling them stuff like this is a real nice dog you got here, I will kill your dog if you keep, you know, talking about it. And I remember him, you know, at the time, I thought, what the hell does he care about this dog for, you know, cause he was constantly making open remarks in front of my wife and I, about what a nice puppy he was always playing with the puppy, and Larry don't give a shit about dogs, you know, I mean, he has had a lot of them, but, you know, for him to all of a sudden to fall in love with a little mongrel mutt, you know, at the time, I didn't think anything of it, now, it makes sense, because the kids, the threats he was trying to keep them quiet. Alright, my daughter, my oldest daugther, we got together with the Oroville City Police Department, and they said, okay, can your kids take us to where this, where this occurred. And initially, my daughter said, hey, no problem, I know exactly where it is at, okay. Well, when the time period actually come for them to hop in the Police Car and go over there and look it out, they pointed out a house tells me know that that didn't even have a basement in it. Okay, Larry told her to point that house out. Okay, you know, you know, that didn't, that hurt my credibility a lot down there, I don't blame her, you know, or nothing like that, but as far as the investigators down there go,

WHITE: every time they turned around, something else was just getting bent out

of shape on them and it just wasn't working out.

DAUGHERTY: Well, why don't you, why don't we do this, you are going to see your

wife today, visiting?

WHITE: Uh, yeah, I think so.

DAUGHERTY: Okay, why don't we kind of put this on hold a bit and we will sit down

with her, since they told it straight to her

WHITE: Okay

DAUGHERTY: Maybe we should go

WHITE: You would be

DAUGHERTY: with that, and that will give us a chance to do some background on these

people.

WHITE: Um, she has talked to um, Wade Ralston, in Lewiston, so

DAUGHERTY: Okay, so I will give Wade a call.

WHITE: Yeah, I want to tell you right now, the kids are, you know, they're, they

are real relucant to talk about it, with anybody. You know, they went

through

DAUGHERTY: Well, as long as, you know, they will talk to your wife, that way

IRWIN: Fine, no problem.

WHITE: Yeah, and I really don't want any pressure on them.

IRWIN: You don't want to bring it up again

DAUGHERTY: No

WHITE: Okay, yeah, yeah, I just wanted to let you know how I felt about that.

IRWIN: This Ron, do you know what he did for a living, what his profession was?

WHITE: Uh, he didn't do nothing, he stayed at home all the time, uh, he has got

money all the time, his wife has got a, from what my wife tells me, she

WHITE:

Latah County.
