Joyce LaPage was a WSU student. She went missing around July 22 or 23, 1971. She frequented a closed house on WSU campus, Stevens Hall. A large piece of carpet was discovered to be cut from the lounge area of the house. This was reported to have occurred between the night of July 22 and early morning of July 23rd. Some of her personal belongings were located in the house.

Her vehicle was located on WSU campus 8/2/71. It wasn't checked until 8/3/71. They found a billfold with ID, checks, school papers, and shoes were in there. It was not "processed" until 8/12/71. There were two individuals, I believe from the Washington State Crime Lab, who searched the vehicle, and found "nothing significant." The vehicle and "personal effects" were immediately turned over to Joyce's father. The lab # is 0705. I have a carbonless copy of the report, but it has faded too much to be of much value.

A check of her apartment revealed no personal items were missing. I seem to remember some family members claimed some items such as a coat rack were missing. It was her roommate who initially went through the apartment with law enforcement.

4/16/72 Joyce's remains were found on the Wawawai Grade out in Whitman County. Since it was 1750 hrs and a dangerous area, they decided to wait until the next day to recover the remains. The bones that were found were sent to the FBI lab for identification. They confirmed this was Joyce. The remains were sent back here, and turned over to the funeral home. Per conversations I have had with Joyce's brother recently, she was cremated. They do still have some of her hair. Both of her parents and at least her brother are still living.

Numerous people of interest were interviewed and some took the polygraph. There is no solid suspect. We are hoping with the technological advances since the time of original submission, will assist in identifying a suspect.

To my knowledge, we have all the evidence except the bones and maybe teeth. Most of it is packaged in paper bags in my evidence room. I do not want to break seals to verify what's there and possibly contaminate it.

It's weird Jodie but one of the pictures at the recivery site, had what looked like twine (not fishing line) tied around the pelvis, it made no sense to me. I mean it looks like it was tied on. I couldn't fathom how, unless it had been on her thigh before decomposing, Weird.

I am working some 12 hour days to cover things and will be on duty until Tuesday, Then off for a few.

On Bruce Bierbaum, I got a couple more e mails from his soon to be ex-wife, Dee. You know at first she said she saw the missing horn hat/coat rack, now she says she not sure, and is sending me pictures of old cow horns that Bruce has. Yuk.

She is definately out there in some other world I think.

I've been waiting for the P.I. to send me copy of the Dead Girl poem that Bruce wrote, but nothing so far. And the understanding was, is that he would send stuff and I wouldn't ask first.

Wow, there is a lot of stuff in our case that I have to get organized. I filled up two of those fat binders with the original microfiche case.

After you get familiar with everything, then perhaps you'd want to come over and I'll walk you through the thirty two year old crime scene. It's kinda interesting.

Back to Johnson; I was wrong about how far away he was working from where she was at. He was less than a hundred yards away and said he worked until 2:30 AM (That's during the period she was missing). I came across some obscure notes and some minor mention of a WSU work supervisor who had scuttlebut about one or some of his people seeing a gal who was staying in Stevens Hall when it was closed down. It mentions that a worker(s) was seeing this missing girl. But, who knows, it may have been a gossip story that made the rounds.

We can solve this Jodie. I really do believe that. I'll keep an open mind on the whole thing, maybe you will see something or someone totally different.

Last seen in the early evening on July 22, 1971, by Bruce Robert Bierbaum (052751). They had eaten dinner together and then he left the Oak Street apartment that they shared. The apartment is a ten minute walk to Stevens Hall.

Stevens Hall at that time was closed for summer session and some remodelling. Joyce several weeks prior to her disappearance had discovered a window that was unlocked in the bottom level of the building, and began an irregular practice of entering through the same window, and spending the night there in a small room at basement level and also in the hall directors office. She would study, write letters (to her fiance'), play the piano and ???? Several people knew this but there was never any information that she took anyone else inside. Some of the letters she wrote were recovered from her fiance'. A couple that were friends with her warned her once to stop staying up there because of the possiblity of danger or arrest. She promised them that she would stop going there.

At 0800 hours on July 23, 1991, WSU PD received a burglary report that a piece of carpet had been cut out and removed from the lobby of Stevens Hall. Found in the Stevens Hall room was property, books, notebooks, belonging to Ms. LePage. Police were not able to locate her at her Oak Street apartment, to question her about the missing rug. Ms. LePage's VW bug, was found several blocks from her apartment, near the FIGI house. It did not appear to be a usual place where she parked her car (WSU PD Lt. Brennan later said). WSP Spokane Crime Lab came down and inventoried and processed the car. Nothing significant was found, other than it appeared to be parked there for a while.

On August 3, 1971 she listed as missing person, after her father called from Pasco, washington, saying that she failed to show up at their home on July 24th (a tentatively planned visit was scheduled, with her being driven there by an Oaksdale, Washington teacher (Michael Ralph Finch 011144). There had been tentative plans made for Ms. LePage to chaperone an Oaksdale dance with Finch on July 23, and then he would drive her to Pasco on July 24, where she could see family and then attend the boat races with Finch on July 25th. Finch was contacted by police and he said that she never called him on the 23rd as planned nor was she home on the 24th when he drove by, leaving to Pasco. About a month and a half later Finch was involved in a serious one car rollover in

Garfield County in which his VW was totaled and taken to Lewiston where it was salvaged and destroyed.

During the time that Ms. LePage was last seen, interior renovation was being done to Arts Hall, which was located approximately 200 yards from Stevens Hall. The work included tile laying. A vehicle belonging to one of the tile layers (Robert Loren Johnson 011336/ SSN: 533-30-8903), was seen parked next to Stevens Hall the night before she came up missing. The vehicle was an old Ford ambulance,(that was later being used up to the 1990's by Connell, Washington. Johnson was interviewed and admits to being on campus, and working until 0230 hours on July 23, 1971. He was later interviewed in 1973 by a WCSO detective and passed a polygraph.

Returning to Ms. LePage being missing: local juristictions attempted to track down leads to the whereabouts of Ms. LePage without success.

On April 16, 1972, subjects were rockhunting off of Wawaii road, about 10 miles from Pullman, when remains of Ms. LePage were found, at the bottom of a steep break, near a stream. Her body had stopped about three feet short of the creek, but her remains were almost exclusively skeletal remains. The remains were partially rolled up in, two blankets and the carpet piece that was missing from Steven Hall. Later it was determined that some of the orignal cut out carpet piece was missing, and was never located at the dump site. Also, her clothing was mostly missing. In a later examination by FBI lab, it was concluded that her underwear was sliced at both hip edges by a sharp instrument. FBI also reported that no blood was found on the blankets or carpet piece. They further determined that there were knife marking on her right rib areas, In 1991, I took the measurements made by the FBI to the WSU anthropology department and had them place the marks on a skeleton approximately the size of Ms. LePage. It was noted that for one of the entry points, below her right armpit, her right arm would have had to rotated upward as to expose the armpit. One supposition could be that she was trying to break the grip of someone that was holding her around her neck from behind, while stabbing her in the right side. As the report explains that the knife was very long and during one insertion knicked the interior side of her spine.

Police interviewed roommate Bruce Bierbaum and also conducted a polygraph examination, concluding that he was not involved.

Police interviewed Mike Finch, who denied any involvement in her murder. The interview was to be followed up by a polygraph examination at a later date, but was postphoned after police received a call from his attorney (Carl Maxey), who said that he would not allow his client to be polygraphed or interviewed without his involvement.

The case remains unsolved.

On January 16, 2003, Dianna Bierbaum who is Bruce Bierbaum's current (third) wife, called WSU PD requesting information on the unsolved homicide. At the direction of WSU PD Lt. Scott West, I contacted Ms. Bierbaum by phone, to her residence in Kalispell, Montana, to ascertain why she was making the inquiry. I surmissed that she might related to Bruce Bierbaum

Ms. Bierbaum explained that she is going through a divorce with Bruce as result of his odd behavior and his abuse to her. She said that while handling a domestic, local police discovered that he had a previous criminal record. She said that she confronted him for the reason he had an FBI number and Bruce responded that it was over an old incident in which his girlfriend in college was murdered and he was questioned about it. He told her that it turned out to be Ted Bundy and that did it, and did not discuss it any further.

Ms. Bierbaum stated that she has a private detective who was investigating the civil issues concerning Bruce, and that he might have some information to pass on to police.

I contacted the local law enforcement, Chief Frank Gardner and he provided me with some limited background on the Bierbaums. He added his opinion that the local P.I. that she had hired was creditable in his information in the past when working with police.

I contacted the local P.I., Ike Eisentraut. He recounted some of the information that Ms. Bierbaum had provided.

He said that he would like to share any relevant information that might be connected with the LePage case, that may come up. I advised him that previous investigators had cleared Mr. Bierbaum, and at this time no information has been established to link him with the LePage homicide. He stated that he understood that and would provide

any relevant information that might come up during his civil investigation

Since that time, Ms. Bierbaum has contacted me several times and provided the following unsolicited information. That she found a disturbing poem written by Bruce, concerning a woman laying on the ground and looking up dying. She further stated that she had moved a box that contained some items from Bruce's college days, to the PI's office. She said that she would share any suspicious information that was uncovered. I stated her her, and then to the PI, on three seperate occasions, that I was not asking them to remove, review, secure or hold, any property or items, for the purpose of any police investigation. I, in fact probably said that at least a half dozen times. Both stated that understood that and were acting on the own behalf and in their own interest, with no direction from police.

There were two items reported missing from LePage's apartment by her friend Jan Ellis (Ms. Ellis had the items stored at the apartment at the time of the murder). One was a blue vase and the other a hand made hat/coat rack made of animal horns.

I sent a picture of each of these items to Ms. Bierbaum. She stated that she recognized the hat/coat rack item as something that she had seen in the basement before. She did not know if it was still around. It should be noted that the items may or may not have any relevance to the case, but was something reported at the time as missing.

The P.I. has uncovered information concerning Mr. Bierbaum that indicates that he is heavilly into pornigraphy and has been videotaping sexual encounters between he and other women. He speculates that the current Ms. Bierbaum may have been secretly taped by him. I was also provided with a web address of where Mr. Bierbaum is currently advertising for a women. His preference is that she live within 50 miles of Vero Beach, Florida (this is near where his first wife Patricia Bierbaum (051153) lives). She is on active probation on a grand theft/fraud conviction.

It appears he intends to relocate to Florida, but unknown when. Bruce has a current veterinary practice in Kalispell, Montana, he is DVM.

I spoke today to both Dianna Bierbaum and P.I. Ike Eisentraut, and confirmed with them agin that no new information has be discovered that Bruce was involved in this old homicide. P.I. Eisentraut said that he was disturbed by the poem that Bruce had written and was going to send it to me.

I spoke with Ann Shannon earlier today, to apprise her of the limited information concerning this case, as "heads up" if something develops. It is her opinion that I have correctly stated law enforcements stance that neither subjects are being asked or directed to provide any information or take any action. She said that if some solid information is received it could be used to petition for a search warrant, before the Montana courts.

After you have had time to review some of you material, we should get together and update one another and fill-in any information that each of us lacks. Regardless of where Nierbaum is involved or not, this may present an opprotunity to collectively try to get a resolution to this old case.

- Lt. Brennan was the WSU PD investigator on this and I asked him his opnion of things and he listed the suspects in the following order:
- 1. Mike Finch
- 2. Jan Cole
- 3. Bruce Bierbaum

*Jan Cole is mentioned in the report, but I cannot recall his significance other that he was someone that was interested in her, he was someone that the LePage family felt creepy about. he attended her funeral and her borther remarked that Jan just kept hanging around like he wanted to say something to them but couldn't. He runs a local computer store in Pullman still.

I asked Lt. Brennan why he didn't list Robert Johnson as a suspect and he said that he really didn't know all the work that the county investigators did on him.

Okay....so you are now briefly informed.
