# Girl's Body Found In Black Hills Park

A man and his wife from Turnwater Thursday morning discovered the partially nude body of a teenaged girl lying in a Department of Natural Resources park area about five miles from Littlerock. Time of the discovery was pegged at 10 a.m. today.

Thurston County deputy sheriffs were investigating the death scene, the Margaret McKinney Camp and Picnic Area operated by the Department of Natural Resources.

Lieutenant Don Snook, Thurston County sheriff's officer, said it was too early to speculate on the cause of death, but the crime appeared to be one of a

The body of the girl was discovered by Mr. and Mrs. Dale S. Saling, 1765 Linwood Avenue, Tumwater

The Salings, deputies said, were in the area as caretakers for the park when they stumbled on their

gruesome find in the middle of the wooded area used for trailer parking

Investigating at the scene was Inspector Charles
Graef, Deputies Clyde McFarland, Dwight Caron,
Dave Humphrey, and Sergeant Mike Cleland

The place where the body was found is a secluded wooded area along a deserted stretch of Waddle Creek Road

County Coroner Hollis Fultz had not arrived at the scene at press time, but said early this morning that he was told by deputies at the scene that the body of the girl appeared to be that of a 17-year old or younger.

There had been some speculation that the body might have been that of Debbie Potter missing since February of this year but the condition of the body eliminated this possibility, deputies said.

# Unidentified woman found slain in park

LITTLEROCK — The partially disrobed body of a young Caucasian woman was discovered Thursday morning in McKenney Park, about five miles north of Littlerock.

Mrs. Dale S. (Barbara) Saling, Tumwater, stumbled onto the body, which was found face down at the edge of a clearing in the park. Mrs. Saling and her husband are employed by the Department of Natural Resources as caretakers of the park. The discovery was made at approximately 10 a.m.

Death apparently had occurred several days ago and was the direct result of an extensive knife wound to the throat. Inspector Charles Graef, Thurston County Sheriff's Office, reported Friday. He said a postmortem examination was expected sometime Friday morning to determine whether the crime was of a sexual

Identification has not yet been established, as her wallet and purse could not be found in the search of the immediately surrounding area, the inspector said. However, she was described as being 20 to 25 years old, revealed the body was not that of about 5-7, 120 pounds; with brown hair - Debbie Potter, an Olympia teen-aged

and grayish eyes. She was clad in a brown mock-suede jacket with fur trim, a white peasant blouse and blue jeans. In addition to all identification, a new, brown waffle stomper-type boot is also missing-

Graef said that since the victim has an unusual composition in the arrangement of her upper teeth, identification may be established through dental charts. He said all dentists in the area have been notified.

Crime investigation of the deserted vacation spot was made difficult by heavy rains and mud. The search of the area for clues or leads continued for about five hours. Thursday and will be widened today. Sheriff Don Redmond heading the overall investigation, has asked personnel from supportive organizations to assist in the search

Of primary concern, Graef said, is the location of the missing purse, wallet and boot.

The age of the stabbing victim was at first believed to be 17 or younger, according to County Coroner Hollis Fultz, but later indicated the woman was in her early 20s. The investigation also

Since the vacation area has been closed for the season, the sheriff's office has set up a search control point at the state park entrance. Volunteer search headquarters are presently located at the Littlerock fire hall.

Inspector Graef stated, "no com-ment," when asked if there were any suspects. He did say, however, that the department is following all leads, such as a report of a prowler in the area. He asked persons to report any unusual or suspicious incidents to the sheriff's office.

Graef said the state wire service is assisting in the department's request for names and descriptions of older missing females. Her unusual teeth composition have eliminated several names from current missing persons lists at the sheriff's office and Olympia Police Department

The inspector did not comment on whether there is a connection in this latest Thurston County stabbing crime and that of Patty Garrison, which occurred about three years ago. However, he did say that "the county-sheriff's office and the Olympia Police Department have kept the Garrison case active. All leads are checked."

# Still No Identity For Slain Girl

Chances are diminishing by the day, Thurston County sheriff's deputies said Monday, that the slain young woman found last week near Littlerock is from the Olympia area.

The partially nude body of the girl was found Thursday in a brushy area adjacent to a parking lot at Margaret McKenny Park in the Black Hills, west of Olympia.

Since then deputies have been sifting through clues trying to find the identity of the girl. No purse or wallet was found near the scene.

In addition to their own questioning, officers estimate they have received more than 60 calls from area residents who have attempted to identify the woman.

Coroner Holks Fultz said Monday he hopes to have the results of an autopsy later this week. King County Medical Examiner Dr. Besant Matthess conducted the post mortem last Friday afternoon.

While officers fingerprinted the girl, they are now afraid the downward adjustment of her age, between 15 and 20-years-old, may preclude her prints being on file.

Twenty searchers Saturday failed to uncover any new leads in the case. The searchers concentrated on roads near the park. Besides the usual assortment of beer cans, searchers found a scarf which has been added to the evidence. No signs of blood were found on the scarf.

Still missing, deputies said, besides the purse and wallet; is a left waffle-stomper boot. The victim was found lying face down withher left boot missing.

The victim is described as being five-feet eight-inches tall, weighing 120 pounds and with light brown, shoulder-length hair parted in the middle.

Deputies said the young woman had pierced ears and was wearing small gold cross earrings.

Clothing included a brown, mock-suede coat with the collar, cuffs and waist band trimmed in sheep wool. She wore a peasant-type blouse and blue denim trousers.

On her left hand the victim wore a friendship ring. On her right hand little finger, she wore a ring with a blue-green Zircon imitation.

Deputies still hope to have some success with the circulation of her dental charts. The girl reportedly had several recent fillings and has two teeth that came in behind the rest of her teeth.

Dentalhygiene was exceptionally good, deputies said. Officers are trying to circulate the charts to as many dentists as possible

Sheriff Don Redmond said his office still is interested in information on all suspicious or unusual incidents, missing or overdue persons or recently found waffle stomper boots, wallets and purses.

In addition, persons who visited: Capital Forest between December 1 and December 6 are asked to communicate with deputies:

Persons may remain anonymous, Redmond said. The sheriff said people can call Crime Check (dial 357-6668) or him personally at 753-8100.

# Dead girl's identity still sought

OLYMPIA — Authorities continued to trace leads Monday in an attempt to identify a young woman whose body was found Thursday in McKinney Park near Littlerock.

The woman, between 15 and 20 years old, was found with her throat cut and had been dead about five days, said Inspector Charles Graef of the Thurston County Sheriff's Department.

He described the park as a "lover's lane" and asked visitors with knowledge of suspicious activity between Dec. 1 and 6 to contact the department at 357-6668. Names of callers will remain confidential he said

Graef said the body carried no identification, and the only clue to the victim's identity was an unusual tooth formation in which two of her front teeth had grown in behind the existing row. Area dentists are being checked, he said.

The victim was described as 5 feet 7, 120 pounds, with long brown hair and gray eyes. She wore blue jeans with a dragon patch on a rear pocket, white peasant-blouse, mock-suede, waist-length coat a fd one waffle stomper" shoe.

Graef said the other shoe and the woman's purse were missing when her body was found.

# Deputies Still Lack Clues To Victim's Identity

Despite a flood of calls, Thurston-County sheriff's deputies Tuesday morning reported no few firm leads on the identity of the slain woman found last week in Margaret McKenny Park.

"We have been busy, but there are no new developments. There have been lots of calls and lots of visitors," explained Inspector Charles Graef.

Last Thursday Mrs. Dale Saling found the woman's partially nude body near a parking area at the park. Mrs. Saling's husband has contracted with the Department of Natural Resources to keep the Capitol Forest park clean.

Since the body was found, deputies have been unable to find a clue to the woman's identity. No purse, wallet or identification for the woman have been found.

The woman has been described as 15 to 20-years-old, wearing shoulder length, straight brown hair, and weighing 120 pounds. She had pierced ears with gold cross earrings.

Deputies said she was wearing a brown mock suede coat, a peasant blouse and blue jeans with an embroidered dragon patch on the left rear pocket.

Chief Criminal Deputy Dwight Caron said his office is receiving information from all over the Northwest. None of the leads, however, has gone very far, he said.

Caron said he was amazed there are so many spouses and children missing from this area who were not reported gone until the body was found.

Deputies still are requesting that persons report suspicious or unusual activity they may have witnessed. Anonymous calls will be accepted. Dial Crime Check at 357-6668 or 753-8100

## Slain girl identified

OLYMPIA — The identity of a girl whose body was found last Thursday in a park near Littlerock was established as Katherine Merry Devine, age 14, Tuesday morning, according to the Thurston County Sheriff's Department.

The girl daughter of Mr.and Mrs. William Devine, Seattle, was identified by her uncle, Delmar Bennett. The girl's body was found partially disrobedat the edge of a clearing in McKenney Park. She had a knife wound in the neck and her wallet and purse were missing.

The uncle and parents of the girl had been working with detectives from the Thurston County Sheriff's Department and detectives and juvenile authorities from the Seattle Police Department. Bennett traveled to Olympia Tuesday.

The girl was a runaway and was last seen in the Seattle area by a girl friend Nov. 25, according to Dwight Caron, chief criminal deputy for the Thurston County Sheriff's Department.

Caron said the girl was seen to leave the area by hitchhiking. He said his office is working with Seattle authorities to obtain information on a suspect.

#### Attempt Now To Trace Girl's Path

Thurston County sheriff's deputies were in Seattle Wednesday trying to pick up the trail of a 14-year-old Seattle girl who was found dead last week in woods near Littlerock.

After four, days of investigation, the body Tuesday was identified as Katherine Merry Devine, 743 North 92nd Street, Seattle.

Sheriff Don Redmond said Miss Devine was last seen November 26 at 92nd and Aurora at her home. The sheriff added the young woman had had a fight with her boyfriend, and told girlfriends she was hitchhiking south to Oregon.

Redmond said Wednesday morning from Seattle that deputies are investigating reports of a vehicle picking the Devine girl up.

According to the sheriff, November 26 was not the first time the girl had hitchhiked south. She is known to have gone to Oregon once before, and there are also reports she spent some time in Olympia Redmond said.

Last Thursday the body of Miss Devine was discovered lying face down and partially nude near the parking area of Margaret McKenny Park.

Redmond said his men are trying to pick up the Devine girl's trail and work back to December I, the day deputies estimate she was killed.

Four Thurston County deputies are working in Seattle with that city's police department.

Thurston County Coroner Hollis Fultz said Wednesday morning he has not received an autopsy report, but hoped to get it in the morning mail.

In Olympia, deputies were completing identification of the girl and checking out local leads. Although Inspector Charles Graef said the body has been identified, he added that deputies plan to use dental charts and footprint records to complete and further confirm the identification.

An uncle, grandfather and Seattle friend were in Olympia Wednesday to identify the body.

In a false lead Tuesday, deputies went to a Lacey drive-in restaurant where a boot was reported in one of the garbage containers. Miss Devine's left boot, purse and wallet have never been found.

Officers emptied the garbage can, sifted through the refuse and found a boot — but it was a man's and had no connection with the case.

#### Delay In Devine Autopsy-Report Irks TC Sheriff

There is still no autopsy report on Katherine Merry Devine, 14, Seattle, and Thurston County Sheriff Don Redmond is unhappy about it.

The body of Miss Devine was found two weeks ago in a brushy area off the parking lot of Margaret McKenny Park near Littlerock

An autopsy was performed last Friday by King County Medical Examiner Dr. Besant Matthess. But no report has found its way to the sheriff.

"This is ridiculous," Redmond said Friday morning "We are being put at a terrible dis-

advantage. With the pathologist not giving us a report, it is making our chore impossible."

Otherwise, there are no new leads in the killing, which deputies believe happened around December I. Miss Devine was last seen. November 26 hitchhiking south from Aurore and Ninety-second Street in Seattle.

The funeral service for Miss Devine has been set for 4 p.m. today in Seattle.

Cosden worked for his father at the Restover Truck Stop off of Interstate 5 in Tumwater at the time. The truck stop was a magnet for hitchhikers in the 1970s.

According to police reports, witnesses saw Cosden come in with blood stains on his clothing

Three miles from the truck stop, Cosden's truck caught fire and was destroyed. During initial interviews with police, Costial interviews with police, Cost den denied ever seeing Devine.

In 1986, based on additional information, a search warrant was obtained for Cosden's blood, hair and saliva. The materials were collected and stored by the Sheriff's Office. Last year they were sent to the State Patrol to analyze. Katherine's mother, Sally

Devine, said she is confident the

Devine, said she is confident the state's evidence will bring closure.

"I would like to see him punished; he can't get the death penalty, but that's all right," said Sally Devine, who envisions Cosden living in a "postage-sized" cell.

"He'll probably get a lot worse

than the death penalty."
Sherrie Devine, 16 when her sister died, often lets her three children thumb through the scrap-book that chronicles Katherine's life and the search for her killer.

"If they're out late at night ...
this lets them know why I'm a little sensitive," said Sherrie Devine,
whose eyes well up as she remembers her sister.

## Suspect charged in 1973 slaying

Cosden says he's not guilty in killing of 14-year-old girl

OLYMPIA — William E. Cosden Jr. is scheduled to stand trial for murder in May after police announced last week that they had unraveled a 28-year-old slaying.

The trial could provide a final chapter to the scrapbook that chronicles the short life of Katherine M. Devine and the drawn-out investigation into her November 1973 death.


Thurston County Sheriff's Office officials arrested Cosden on Friday. He is accused of killing the 14-year-old Devine.

On Monday, Cosden pleaded not guilty to a charge of first-degree murder in Thurston County Superior Court

A pretrial hearing is set for April 4, and a jury trial will begin the week of May 6.

Monday's court appearance marked the family's first encounter with Cosden, who has been in prison since 1976. He is serving a 48-year sentence for first-degree rape.

"Just seeing him kind of gave me butterflies, but it's important that I came here because it brings me clo-

Cosden, who law enforcement officials long have considered a suspect in the case, was arrested Friday at the Washington Corrections Center in Shelton on a warrant for first-degree murder.

If convicted, Cosden would serve a minimum of 20 years to a maximum of life in prison, based on 1973 sentencing standards, said county Deputy Prosecuting Attorney Phil Harju.

The first-degree murder charge does not carry the death penalty.

Under his current rape conviction, Cosden would be released from prison

"If he's convicted, we would be requesting a consecutive sentence," Har-

The state's case against Cosden is based on the DNA evidence as well as other evidence that Harju would not

#### Did you see this girl?

The Thurston County Sheriff's Department is seeking clues to the events leading up to the murder of Katherine Merry Devine

The 14-year-old Seattle girl was found dead, a stab wound in her neck, Dec. 6 in Camp McKermy State Park, about five miles north of Littlerock.

The girl was five feet, eight inches tall, weighed 120 pounds and had light brown shoulder length hair with blue or grey eyes.

She was clad, at the time, in a brown mock suede coat with fur trim, navy type blue denims with a dragon patch on the left rear pocket, white peasant

type blouse and brown waffle stomper type boots.

In addition, she wore golden cross earrings, a Florentine friendship ring and an imitation blue green zircon ring.

The girl, a runaway from home, was last seen hitchhiking out of Seattle on Nov. 25. At the time the girl's body was found it was evident she had been dead several days.

The body of 14-year-old Katherine Merry Devine was found December 6 in Margaret McKenny Park in Capitol Forest. She had been murdered.


Thurston County sheriff's deputies said the slain Devine girl last was seen hitchhiking south on Aurora Avenue in Seattle.

The Devines said Monday afternoon they are confident of obtaining the 117,804 signatures necessary to put the initiative on the general election ballot.

"We have a silent partner who has done a great deal of petition work in the past," Mrs. Devine said. She added they are hoping for contributions, and estimated the campaign will cost at least \$5,000.

THE shocking death of a 14-year-old Seattle girl, whose brutalized body was found in a wooded area near Olympia, is only the latest in an ever-lengthening list of crimes in which the victims were hitch-hikers.

Since the spring of last year, In fact, when hitch-hiking became legal in this state, the State Patrol has compiled a record of some 400 crimes related to hitchhiking. Seattle police have compiled equally disturbing statis-

Two were murders that also involved sexual assault, as in the recent tragedy of the 14-year-old Seattle girl. Others ranged from armed robbery and assault to theft and abduction. Approximately one fourth of them were morals offenses.

BECAUSE such records were not kept separately prior to the effective date of the 1972 law, it is not possible to establish a cause-and-effect relationship sta-

tistically between hitch-hiking and violent crime.

But the pattern of the past 18 months is plain enough to reinforce the strongly held view that hitch-hiking subjects its participants to extremely serious risks.

Probably the vast majority of hitch-hikers and ride-givers are law-abiding citizens.

Experience with the state's hitch-hiking law has shown. however, that it has aggravated the crime problem, caused traffic hazards as a result of motorists stopping to pick up riders in designated areas and generally has made it more difficult for lawenforcement men to carry out their public-safety responsibilities.

IN short, the benefits of the law are being far outweighed by its drawbacks and it should be an early candidate for repeal when the Legislature meets in Olymvia next month.







# Girl Murdered About December

Thurston County deputy sheriffs late Saturday afternoon were scouring the countryside, tracing investigative leads and attempting to piece together the circumstances surrounding the death of as yet the unidentified young girl whose body was found Thursday morning at Margaret McKinney Park, in the Capitol State Forest.

"We need the help of the public in identifying this young girl," said Sheriff Don Redmond in a plea from his office Saturday afternoon. "Our first priority is finding a next of kin, acquaintance or close friend, that can make a positive identification.

Thurston County Coroner Hollis Fultz said after a preliminary autopsy Eriday that the young girl died "around the first of December. We tentatively have her age pegged at between 18 and 20 and the time of death as Saturday, December 1, but final conclusions will not be known until results of the autopsy are finalized in two or three days."

King County Medical Examiner Dr. DeSant Mathews performed the autopsy Friday beginning at 3 p.m.

The young girl's partially nude body was found lying face down in the thick underbrush five miles north of Littlerock by a Department of Natural Resources worker who was cleaning the park Thursday morning. The victim was wearing blue jeans with a dragon patch on the left rear pocket, a white peasant blouse and a distinctive brown, mock suede waist-length coat. On her right foot she wore a white crew sock and brown waffle stomper-type boot. The left boot is still missing.

Deputies described the woman as 18 to 20 years old, weighing 120 pounds and having long brown hair and greyish green eyes.

In addition, the teenage girl had a wart in the middle of her right palm.

"Perhaps her most distinctive feature," said Chief Criminal Detective Dwight Caron, "is her dental work. The two upper front teeth were in their normal position. The two on either side, however, grew in almost behind the front ones. Her eye-teeth grew almost next to the front pair giving her a most unusual dental structure." Olympia dentists said much of the dental work is recent.

Copies of her dental charts and physical descriptions have been circulated throughout much of the country and by late Saturday forencen the Sheriff's office was swarmed with inquiries.

"Each piece of information is being treated as the key to this girl's identity," Caron said. "We have deputies in several surrounding counties checking out all leads."

"We are pleading that anyone who has visited the park-since last Saturday to please contact the sheriff's office," said Redmond. "Whether or not they have seen something suspicious is important. But just as important, is other information that they may be able to provide."

In addition deputies ask that any unclaimed wallets or purses or abandoned cars be reported to their office.







Caron dreads that the unnamed girl may have been a hitchhiker and won't be identified. "There are all kinds of missing bodies in morgues around the country that have never been claimed," he said.

He reported Saturday, "We can't say for sure yet whether or not


He reported Saturday, "We can't say for sure yet whether or not she was killed at the park site." Friday Caron said it did not appear that she was killed in the park because of the lack of blood. He clarified that statement Saturday saying, "We had extreme rains in that area previous to the finding of the body and until the ground samples are analyzed we won't be certain if she was killed on the spot."

Deputies spent much of Friday investigating the report of Natural Resources personnel who reported seeing a pickup parked in the middle of the road near the park on November 20. The keys were reportedly in the ignition and "a definite, obvious trail of blood lead from the truck to the bushes," deputies said.

Sheriff's Inspector Charles Graef said, Saturday "The report was thoroughly investigated and it turned up that someone had killed a deer. Instead of a possible suspect, we have a case of poaching," he said.
