Attached teletype from the Dallas Office advises of a Bank Robbery matter in Abilene, Texas, 3/18/80 in which the lone female employee was murdered by a shot in the back of the head as she lay face down on the floor. The Savings and Loan is located in a small temporary metal building in an isolated area.

ASAC Dallas is aware of similar bank robbery in Houston, Texas, on 3/17/80, wherein a teller was also fatally shot in the head. The ASAC advised that the Savings and Loan has no surveillance cameras and at this time there are no known witnesses.

Enclosed for the Identification Division, Latent Fingerprint Section are ~~the~~ invoices and one fingerprint card for Lynn Gray (deceased).

For information Identification Division on 3/18/80 Unsub(s) robbed captioned institution and lone employee, Lynn Gray, was murdered by single bullet wound to the back of the head as she lay prone on the floor. A delivery boy allegedly found the body and called police, and is considered as a possible suspect.

Enclosed invoices were found at the scene on victim's desk, and they were delivered by the person who found the body. There is speculation that victim may have handled the invoices prior to her death, which would contradict the delivery boy's statement regarding finding the body.

REQUEST OF THE LATENT FINGERPRINT SECTION

It is requested that enclosed documents be processed for latent fingerprints and any latents found be compared with those of the victim, Lynn Gray.

Expeditious handling is requested inasmuch as this case may be related to several other unsolved murders in this area where similar MO used.

Elimination fingerprints of Lynn Hall Gray

Thirty-four latent fingerprints, six latent palm prints and two latent impressions of value were developed on the three invoices. The impressions may be either fingerprints or partial palm prints.

Three latent fingerprints, which are from the extreme tip and side areas of fingers, and the two latent impressions were compared, insofar as possible, with the submitted fingerprints of Gray, but no identification was effected. Major case prints are needed for conclusive comparisons of these prints, as well as the latent palm prints. The remaining latent fingerprints are not the fingerprints of Gray. No palm prints are here for this person.

The specimens are enclosed, together with an identifying envelope and your mail envelope.

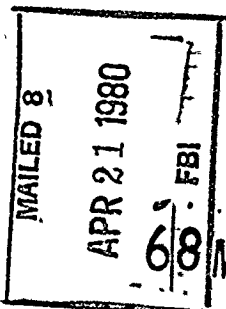

Result of examination:

Specimens Q1 and Q2 were not fired in the same weapon. It is noted that both specimens bear limited microscopic marks of value for comparison purposes should suspect weapons be found.

Specimen Q1 is a .22 Long or Long Rifle caliber cartridge case of CCI manufacture.

Specimen Q3 appears to be a .22 caliber bullet, the remaining observable characteristics of which are consistent with bullets of CCI manufacture.

Specimen Q3 was fired from the barrel of a weapon rifled with five lands and grooves. Weapons with rifling similar in dimension to that which produced the impressions in the Q3 bullet include rifles of Remington manufacture. It is noted that the Q3 bullet bears no microscopic marks of value for comparison purposes.

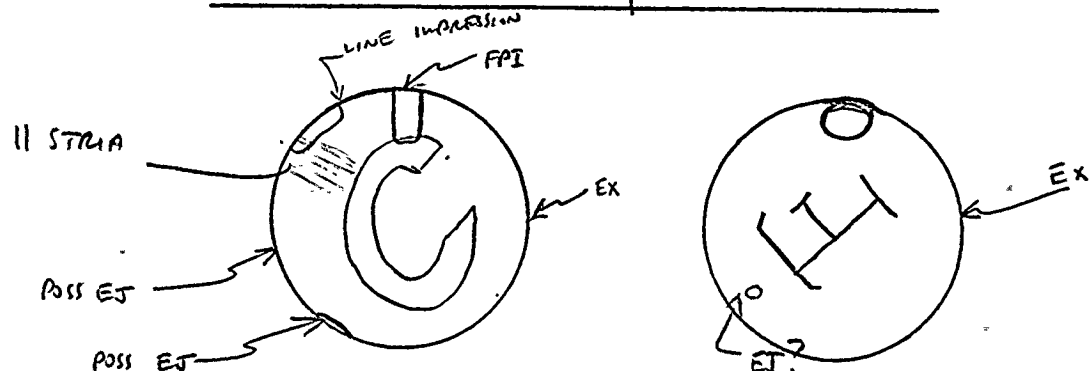

On 3/15/79 a similar murder occurred at Oplin, Texas with similar MO.

It is requested that enclosed items be examined in attempt to determine the type of weapon which fired the bullet and logical examinations feasible re the enclosed bullet fragment.

It is also requested that casing from captioned robbery be compared with casing from Oplin, Texas murder to determine if any similarities exist.

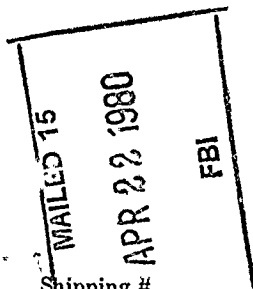

On March 18, 1980, the First Federal Savings and Loan Association, 3801 South Clack, Abilene, Texas, was robbed by an unknown person (s), who apparently entered the office between 10:50 a.m. and 11:20 a.m. and murdered Lynn Gray, Loan Processor, who was alone in the office at that time. Another employee, [redacted] had departed the office for lunch at approximately 10:50 a.m., leaving Gray alone. Gray's body was found by a delivery boy at approximately 11:20 a.m., lying face down behind the counter with a single bullet wound in the back of the head. The cash drawers were apparently ransacked and [redacted] was missing.

The temporary office opened in January, 1980 and had no alarm system or cameras at the time of the robbery. Bank officials indicated they were in the process of negotiating for an alarm system at the time of the robbery.

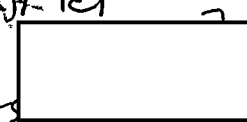

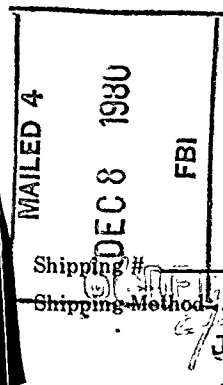

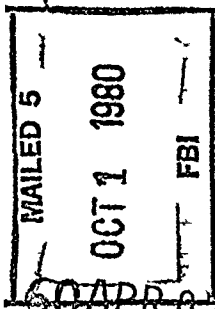

On March 18, 1980, Henry Lee Lucas entered the temporary location of First Federal Savings and Loan Association, 3801 South Clack, Abilene, Texas, which was then attended by victim teller, Lynn Gray, who was alone in captioned financial institution at the time of robbery. Cash drawers were apparently ransacked and Gray was murdered, execution style, with a bullet wound in the back of the head. Total loss to the financial institution was [redacted] including [redacted] bait bills.

The savings and loan building was a temporary structure located in a then remote location near a new shopping center on a one way access road. The temporary office opened in January, 1980, and had no alarm system or cameras at the time of the robbery.

On October 4, 1983, the Abilene, Texas Police Department (APD) advised Special Agents of the FBI at Abilene, Texas, that Henry Lee Lucas, a self-confessed mass murderer presently incarcerated at Montague, Texas, had confessed to the captioned robbery-murder. Detectives from APD advised that on July 28, 1983, captioned subject had provided a sworn written statement admitting sole responsibility for captioned matter. The sworn statement of captioned subject to police contained numerous specific details, knowledge of which could only have been possessed by a person who committed captioned robbery. In referring to victim teller's death Lucas stated, "I was standing close and holding the gun about 12 inches from her head. I heard a noise that scared me and just reflexes, I fired. The gun had a hair trigger and just went off...I don't think she ever knew what hit her."

On October 31, 1983, the facts of instant matter were presented to Assistant U. S. Attorney (AUSA) [REDACTED], Northern District of Texas (NDT), Fort Worth, Texas, for prosecutive opinion. AUSA [REDACTED] deferred prosecution to state authorities citing the greater latitude of penalties available as a result of the murder prosecution by state authorities.
