Bundy's Utah kidnaping conviction is upheld by U. S. Supreme Court

WASHINGTON - (AP) - The United States Supreme Court left intact today the Utah kidnaping conviction of Theodore Robert Bundy.

The justices refused to hear an appeal by lawyers in Salt Lake City that Bundy's 1976 kidnaping conviction should be overturned.

The conviction stemmed from a November 8, 1974, incident at a Murray, Utah, shopping center.

Prosecutors said Bundy, 32, from Tacoma, abducted an 18-year-old shopper, Carol DaRonch, after representing himself as a police officer investigating a break-in of her parked car. Bundy also stands accused by Florida authorities of beating two college sorority sisters to death.

Bundy's appeal, which was rejected by Utah's Supreme Court December 28, raised constitutional. questions about the evidence used at his trial.

Bundy is also charged with the January 15, 1978, murders of two Florida State University co-eds, Lisa Levy and Margaret Bowman, both of St. Petersburg, Fla.

Prusecutors say Bundy severely beat two other members of Chi Omega sorority on the Tallahassee campus. A fifth victim was badly beaten at a nearby apart-

The United States Supreme Court last Monday refused to hear an appeal from Bundy in the Florida murder case.

Bundy was convicted of kidnaping in Utah and extradited to Colorado to face a murder charge. He escaped from a jail at Glenwood Springs, Colo., before being arrested in Florida.

18 August 1978 MEMO TO: CTB FM: PYK Ted Bundy and Related Cases RE: Bundy remains as a subject of intense public and media interest. However, an inquiry into crimes in which he is a suspect immediately becomes intertwined with numerous other cases. All of these incidents contributed to the climate of fear and hysteria in the community, and a general demand that something be done by law enforcement agencies. There is also an interesting pattern that just when things would be going "stale" with Bundy something dramatic would happen. 5/2/73 a student at Roosevelt, is reported missing. Her body is found in Snohomish Co. on 6/3/73. Immediate and only suspect is , who has had a murder/rape conviction and death sentence reversed by the U.S. Supreme Court. Considerable media attention to this case. 1/4/74 assaulted in University District apartment. Left near dead. Recovered but could not aid police. 1/31/74 Lynda Healy missing from University District-Ravenna area apartment. Blood found and other signs of violence. 2/15/74 Nancy Klinghammer missing in West Seattle. 2/21/74 Penny Haddenham missing in West Seattle. 2/21/74 missing on north Capitol Hill, setting off massive search and massive amount of publicity. Klinghammer and Haddenham are found dead in West Seattle, Haddenham hanging from a tree. On 3/27 , escaped from Western State, is charged with their murders. Ravenna Park is completely searched by SPD and scouts looking for Healy's body under the valid assumption that had killed her. The original rape for which he was at Western State was in the park, he had been seen in the area shortly before her death, and had stated to a cellmate that he had killed three young women. This assumption generally continued until 3/75 when Healey's body was found.

Memo 18 August 1978 Page Two 3/12/74 Donna Manson vanishes while walking across Evergreen State campus. 4/17/74 Susan Rancourt vanishes walking across Central Wash. State campus. 5/6/74 Roberta Parks vanishes walking across Oregon State University campus. 5/26/74 Brenda Baker, missing hitchhiking in Puyallup, found on 6/17/74. This is now considered a possible for Bundy. 6/1/74 Brenda Ball missing after leaving a south King County tavern. 6/11/74 Georgann Hawkins vanishes behind the Theta house at University of Washington. Janice Ott and Denise Naslund vanish within four hours 7/14/74 of each other at Lake Sammamish. 40,000 people in the park. The press goes wild. "Ted" appears as a suspect along with a VW, broken arm, English accent, sailboat, etc. By the end of the month Killien is assigned by Boerner to work with the police agencies, primarily KCP and SPD, on missing women. Bundy has been living in the University District during this period. At this time a professor at the University gave the county police Bundy's name based on the general name and description. There was nothing unusual or incriminating about this report. extremely important to realize that the "clues" produced an incredible inpouring of names, rumors, etc., which swamped the police who were attempting to deal with them and sort them out. In August of 1974 Bundy left for Salt Lake for law school, but probably came and went a couple of times during the fall. 9/7/74 The skulls of Ott, Naslund and other bones are found by the old railroad bridge in Issaquah. Massive publicity. 9/25/74 is arrested in Minneapolis and charged with numerous rapes, assaults, and murders. This received considerable attention in the Seattle press as it related to the situation in general and Miller was never a serious suspect in particular. from the police point of view on the other cases because he was out of the area. Was considered regarding Healey because of the close proximity of her apartment and his gas station.

THE SOURCE OF THIS INFORMATION AND THE PHOTO-GRAPHS HAS NEVER BEEN DISCLOSED. 10/2/74 missing after leaving residence, Salt Lake, never found. 10/12/74 Bodies of Carol Valenzuela, last seen hitchhiking in Vancouver, WA 8/2/74, and that of an unknown female, are found in rural Clark County. These are now considered as possibles for Bundy. missing, Salt Lake, found 10/27. 10/18/74 10/31/74 missing while hitchhiking, Utah Co. south of Salt Lake, found 11/27 11/8/74 Carol DaRonch kidnapped in Salt Lake, escapes. 11/8/74 vanishes from parking lot at high school, greater Salt Lake, never found. Bundy has been in Salt Lake for school. King County Police have forwarded their information regarding his suspect status here. 11/27/74 Vonnie Stuth vanishes from her house in Burien while preparing Thanksgiving dinner. is immediate suspect. Caryn Cambell vanishes within ski lodge at Aspen. 1/12/75 Bundy is eventually charged with this murder. Two gas receipts put him in immediate area. is found within a block of her residence. 2/1/75 is suspect, never charged. The skulls, and nothing else, of Healey, Rancourt, Ball 3/5/75 and Parks are found at Taylor Mt. "Massive" is a considerable understatement concerning the media attention. It should be noted that this is the first time these cases, which are widely separated geographically, actually can be considered on the basis of solid evidence as being the work of one person or persons. After Issaquah, it had been suspected that another "dump" was a possibility, but nothing this dramatic was seriously anticipated or considered.

Memo 18 August 1978 Page Four At this time the joint KCO/SPD task force was formed which lasted about one month. 3/15/75 Julie Cunningham vanishes from her apartment at Vail, Colo. (gas receipt puts Bundy in Vail on that date). 4/6/75 Denise Oliverson missing, Grand Junction, Colo., never found (gas receipt puts Bundy in Grand Junction on that date). 4/6/75 Tina Jacobsen and Gaelisa Burton mirlered at Moclips, Grays Harbor Co., while camping. charged and convicted. May '75 Stuty, whose body is located. charged, extended extradition procedures. Eliminated from other cases on basis of gas receipts which put him out of the area. July '75 KCP task force re-formed. Aug '75 Bundy is arrested in Salt Lake with the handcuffs, etc., and charged with kidnapping Da Ronch. All our efforts turn towards him. Robin Groth shows a single picture of Bundy, obtained after arrest in Utah, to a witness from Lake Sammamish, with negative results. Major Mackie is alleged to have said that this ruined the entire case. Groth is admonished by Killien regarding her identification procedures. This picture is subsequently shown, in proper fashion, to the other Lake Sammamish witnesses, who by this time have seen literally hundreds of photographs. Two picks of Bundy - THIS HAS NEVER BEEN DISCLOSED. Bundy is out on bail and returns to Seattle during Thanksgiving and Christmas vacations. He is followed by SPD and KCP. - THIS TAILING HAS NEVER BEEN DISCLOSED, but there is no particular reason now that it can't be. 10/4/75 Det. Robert Keppel to Utah. 11/13/75 Keppel and Mackie to Aspen for general conference. 2/10/76 Keppel, Mackie and Killien to Salt Lake for general conference. 3/1/76 Dave Yocum convicts Bundy of kidnapping DaRonch in a trial to the court. Sentenced to 1-15 years.

Memo 18 August 1978 Page Five Killien and Maida to Houston re 4/76 Because of severe questions over confession procedure, is plea bargained to murder 2° over severe protest from "Relatives and Friends of Missing Women", and considerable media hysterics by Stuths mother. 10/22/76 Bundy charged in Aspen with killing Cambell. Bundy escapes from Aspen courthouse. Big search, 6/7/77 captured in a few days and charged with escape, burglary and car theft. 12/30/77 Bundy escapes from Garfield Co. jail in Glenwood Springs Colo. "Chi Omega" killings and assaults in Tallahassee. On 1/15/78 1/16/78 Keppel calls and informs them about Bundy. kidnapped in Florida. 2/9/78 Bundy arrested in Florida and charged with just about 2/78 everything. 

In response to your request for homicides in Washington State linked to Theodore Bundy, you will find enclosed the following information:

Enclosure one contains fact sheets on six murdered women and one assaulted woman. In addition there is also a summary of the disappearances of Janice Ott and Denise Naslund, missing from Lake Sammamish State Park on July 14, 1974. The Lake Sammamish incident contains the best description and M.D. of the suspect. Also included in enclosure one are summaries of the two sites where victims' bodies were found.

Enclosure two contains fact sheets of Ted Bundy's personal history and whereabouts from 1965 through 1973. Bundy's activity from January 1974 to September 1974, when he left for Utah, is too voluminous to place in this report. There are included fact sheets of how Bundy is connected circumstantially to the deaths of each of our women from January 1974 through July 1974—we have a day by day resume of Bundy's activity during this time.

These two enclosures should supply you with a capsule idea of the homicides in this area. The investigations of each girl as a missing person were completed by numerous agencies in our area.

Detective Robert Keppel is at your disposal anytime of the day or night should you need more specific facts of our homicides. His home phone number is 206-641-0430, the homicide office number is 206-344-7557, and police radio communications is 206-344-4080. He will also be standing by should you need a personal representative from our department in your area.

We are anxiously awaiting information regarding your interview of Ted Bundy. If we can be of further assistance please let us know immediately.





On January 4, 1978 I contacted by phone at her residence per her request (work phone 543-5626, home phone 524-100). She is known to me and is employed at the University of Washington in the School of Social Work. She stated that while attending the U. of W. in the winter of 1972 she was accosted by a male subject in the stairwell of Padelford Hall who grabbed her and attempted to remove a pair of tights she was wearing. She stated that she struggled with him for a period of time and then he left. She stated that she followed him for a short distance and that the male turned and faced her and laughed. She didn't know what to do so she left. She did not report the incident at the time and does not wish to make a formal complaint at this time, but wanted to supply this and some additional information.

She stated that when Bundy was arrested in Salt Lake she felt that he was the person who had accosted her, but because of a variation in hair style she could not be certain. She stated that when the most recent set of photographs came out she was positive that Ted Bundy was the subject.

She additionally stated that a friend of hers, Ann Romine (English) had met Ted Bundy through an acquaintance of hers. She stated that Ms. Romine was currently residing at 446 Oak Street, Webster Groves, Missouri, 63119 (314) 962-0196. On January 12, 1978 @ 1545 hrs. I contacted Ms. Romine at the above phone number. She stated that she was acquainted with a woman by the name of Elizabeth (Liz) Kloepher (unknown exact spelling of last name - Kloeffer or Kloether) through a friendship of their daughters. She stated that both girls attended University Heights school during the 1974-75 school year; both girls were 8 yrs of age and in the 3rd grade.

Ms. Romine stated that her daughter Peyton related a story that Molly (Liz Kloeffer's daughter) had told her in confidence. Peyton told her mother that when Molly's mother was not at home and the boyfriend of Ms. Kloeffer was caring for her he liked to play hide and seek and on at least one occasion (one known) stated he was going to take off all of his clothes so that he could be more invisible and apparently did. Ms. Romine stated that she was introduced to the boyfriend on at least two occasions when he and Ms. Kloeffer were out and the boyfriend's name was Ted Bundy. Ms. Kloeffer indicated to Ms. Romine that they planned to be married. Ms. Romine also stated that she saw a citation in Ms. Kloeffer's house with Ted Bundy's name from a police department for having stopped a purse snatch. Ms. Romine stated that because of a move, the friendship between the girls ended immediately after the information regarding the incident was brought to her attention. She stated she believed Ms. Kloeffer to be employed by the U of W Hospital and does not know where she is currently residing.

1145 hrs- 1800 hrs. Review of Abduction and Homicide scenes with Detective Jerry Thompson, Salt Lake County Shefiff's office.

Current evidence in the Abduction case involves the victima picking Bundy out of a photographic lineup them selecting him in an in person lineup by looks, voice and walk. She has also identified photographs of Bundy's volkswagen Bug and the Seat Tear on the rear seat of him VW.

Bundy's arrest for evading apprehension and possessioh of Burglary tools revealed a set of Gerocal handcuffs and a crow bar. The Victim of the abduction had a set of Gerocal handcuffs placed on k her right wrist during a struggle with the suspect. The suspect also tried to strike wictim with a crow bar and victim graphed the bar and fought with suspect. The same type of crow bar was identified by the victim.

Det. Thompson has interviewed Bundy on a couple of occasions. Bundy Claimed to have never stopped in & Bountiful, Utah but has passed through. Bundy had in his possession a Brouchure from a Bountiful recreation center. Ivestigation revealed that this brouchese could only have been obtained in person. Bundy had also a credit and receipt from a gasoline purchase in Bountiful. On 11-8274 of Bountiful turned up missing from a school play at her high school. A handcuff key that fits the gerocal handcuffs was found in the parking lot of the school.

The abduction rex which Bundy was arrested for occured from the Fashion Place Mall in Nurray, Utah. The Mall is about one mile from a pizza parlor where Melissa Smith is missing on 10-18-74. ki was found about 20 miles in a wooded area from where she was last see was strangled, beaten on the head and anally raped. The blows to the head resemble marks that would be made by a crow bar. Smith was struck below the left ear lobe. Her body was found nude. She had her dark blue stocking tied around her neck. The back of the skull was cracked.

In Utah county was missing on 10-31-74 and was found on 11-27-74. Her body was nude, anally raped, with severe head wounds. She had a stocking around her neck and was also struck below the left ear lobe. She Her skull was also fractured in the rear.

Through the use of standard oil credit card receipts, Det. Thompson has placed Bundy in Aspen Colorado when Karen Campbell was missing on 1-12-75, in Vail Colorado on 3-15-75 when Julie cunningham was missing BR, in grand Junction, Colorado on 4-5-75 when Denise B Gliverson was missing. The only one found is Karen Campbell on 2-17-75 ten miles from the wildwood Inn where she was staying.

10-4-75 Continued.

Campbell was nude, blows to the head and raped anally. She also had a wound below the left ear lobe.

Det. Thompson had interviewed Bundy prior to knowlegde of the Colorado Homicides. Bundy claimed he had never been in Colorado. Thompson found a ski book in Bundy's possession which had an X marked by the Wildwood Inn. Also Bundy had a book EXE Called the Joys of Sex. He also had a map of Colorado. Since the interview, investigation has revealed Bundy to be lying.

Det. Thompson transported R/o to The Fashion place Mall and 35 MM slides were taken of the area.

The handcuffs and key waxe and crow bar were set back to the FBI for analysis and tool marks impressions.

Thompson pointed out discrepancies in Bundy's application to the Univ of Utah Law School. Bundy checked the part of having previous psychiatric care then erased it. He is did not indicate that he had attended Univ of Puget Sound law school previous to U of Utah.

Thompson related that at a preliminary hearing, Bundy's attorney, John O'connell requested that police not talk with his client and the judge granted his request.

Thompson is going to forward copies of autopsy photos of homicide victims. Thompson is going to process Bundy's VW and mail photos of the VW.

10-6-75 1330 hrs. Det. Keppel received T/C from Ann Rule. She related that Ted Bundy called her on Wednesday (10-1-75) from Salt Lake City. He stated that "what had happened, it's confidential; I'm going to be in a line-up." "If things don't go right, You'll read about it."

He said, "I guess the next thing is the polygraph." He daid he would be willing to take it.

Bundy asked Rule what a line up consisted of and she told him.

Bundy stated that he would be coming up here this winter and would talk to Keppel and McChesney. Bundy's lawyer told him that the Seattl authorities seem to be nice people.

Bundy gave her a new address. He said he moved because he wanted to be close to the school.

Bundy knew that Ann Rule was writing a book. He said, "That's great, I hope you make a million dollars."

Rule received a message from the associated press that Bundy wanted to tell her that "He's OK and all right."

Rule wrote Bundy a letter and told him that she would come down to see him if he wanted her to. She told him that she would have to be Faithful to herself, to him and to the police in this case.

1630 hrs. Contacted at the Glenn Muller residence, 10632 Des Mones way South. John Muller is former friend of Ted Bundy. They lived together at 4125-12 NE. The Muller's were not at home. Talked with basement tenant Nr. Miller. The Mullers had gone fishing and would return on Thursday. John has taken a government job and is currently in Austrailia working for US Government. Left card with Mr. Miller to have the Muller's call when they returned.

Rule was informed that Det. Keppel could not recommend any direction for her to pursue, that anything she did was of her own volution. She stated that she would keep ** the police informed as to her activity.

10-6-75 1900 hrs. Contacted Mr. and Mrs. Bundy at their house in Tacoma with Capt. Mackie. Bundy's were informed that the conversation would be held in strict confidentiality and nothing would be passed on to anyone else.

Bundy's could not recall anything in Ted's childhood that would give them a clue to a change in Ted's behavior. They related that Ted had not lived with them for seven or eight years. Oceasionalyx, he would either drop in or call. Ted din't write letters to them.

Mrs. Bundy could not recall Ted Mentioning going to Portland, Corvalli or any place in Oregon. He has lots of friends and its possible.

Mrs. Bundy was asked if Ted was 4-F from the military. She believes that he had a school deferment until he graduated from the Univ of Washington, then he was I-A. He passed his induction physical. Then he slipped on some ice and had a compound fracture of his leg. He wome a cast and had crutches. Then the lottery system was used and Ted was way down the list; he was never called.

Mrs. Bundy was not aware of any fires or animals killed by Ted. If anything he was just the opposite because he used to bring home stray animals to keep.

Mrs. Bundy could not recall any friends or relatives that TED may have ing the Issaquah area.. To her knowlegge Ted never wore an arm cast or sling.

The dates of the missing girls were given to Mrs. Bundy in the event she could come up with a verification of Ted's whereabouts on or near any of the dates. A possiblity of a Polygraph was mentioned and Mrs. Bundy understood that it may be necessary since it would be difficult to confirm one way or another where Ted was on the crutial dates.

The Bundys were asked if Ted had stored any property at their house that may reveal where he would have been. The only property that they had were books in storage from when he went to the Univ of Washington. She in did not have any of his property from 1974. She did not have any papers, letters or in other property of TED.

The bicycle that was shipped from Utah to Tacoma was a boys model ten-speed that was observed by Capt. Mackie. Ted's 13 year old brother had spent two weeks with Ted in Salt Lake in the last part of July and returned home on August 3, 1975. The bike was shipped on the airplane with the brother.

Mrs. Bundy related that Ted was aware that Mr. Bundy was not his real father. Ted was 4 years old when the Bundys were married.

Bundy's cousin John is John Cowell who lives in tacoma.

Ted has never had psychiatric treatment.

10-6-75 1900 hrs. Continued.

Mr. Bundy related that the cabin they owned wax is located on Crescent Lake near Gig Harbor. Ted had been to the cabin for family type occasions as well aw taking k Liz to the cabin periodically.

10-7-75 1100 hrs. Received Telephone call from Det. Thompson, Salt Lake city.

Thompson related that he was just called by Clearwater Creek County, Colorado authorities. They had just found the nude body of Shelly K. Robertson who had been missing since 7-1-75. She was located on 8-21-75. The victim was last seen at a service station in Golden, Colorado. Credit card receipts place Bundy in Golden on 7-1-75. The service station attendant picked Bundy's photo as the person who stopped and last saw victim talking to. She was located in a mine shaft.

Thompson also was in contact with Jefferson County Colorado. They have found a body of a nude female, beaten severly about the head, undientified at this time.

He will forward information on both of these cases when he receives it.

1300 hrs. Contacted by Det. Hanson, Tacoma, PD.

He was investigaing a rape that occurred a 800 Burroughes xee road in Tacoma on 11-26-73. His victim had seen a photo of Bundy in the newspaper and identified him xx as the person who raped her.

Gave Hanson copies of University of Puget Sound records placing Bundy in Tacoma in November, 1973. Hanson will call Det. Thompson for Bundy's gas receipts for that period of time. It is unknown at this time in charges will be filed.



CAMERON of SPD: He 1700 hrs. requested that I call Captain JOHN POTTINGER of Leon County-Sheriff's Office, PO Box 727, Tallahassee, Florida, 32301, 904-386-2857. His office phone is 222-4740. Captain POTTINGER requested number one, the background information that we had on TED, number two, his phychological profile, and number three, the facts-concerning the murders in this area. Captain POTTINGER mentioned several little things about conversations Pensocola authorities had with BUNDY. He stated that he was talking around the murders in ten different ways. He really did not admit to them, but he stated that he was going to. He stated that he had some sort of dislike for Captain MACKIE. One of the victims in Lake City, Florida is a 12 year old girl, and they supposedly have the vehicle that he used. Evidently BUNDY refers to his "problem" started sometime in 1969 observing a girl walking down the street while he's on his bicycle. BUNDY says that he is trying to get used to talking because it is not usually like him to talk. Supposedly the interview is going to go with three interviewers that have talked with him the most, that no other people will talk with him, and they are Florida authorities only. Some information regarding the Tallahassee murders was that BUNDY lived within a block of the murders. He had credit cards apparently from the girls. BUNDY has admitted that his fetishes were down to hourly fetishes from monthly fetishes. He mentions alot of missing girls and three stolen cars. The bodies there in Tallahassee were strangled and beaten badly. BUNDY is being evasive when he talks around the murders. 2-21-78 Sent letter to Captain POTTINGER with enclosures. -- 1450 hrs. -- Contacted at the King County Courthouse by-LIZ KLOEPFER and MANUS M. MULLIGAN. He is the new fiance of LIZ KLOEPFER. She had indicated that on 2-16-78, she received a telephone call from TED BUNDY at about 5:00 PM on a Thursday.
