

Dear Ms. Lewis:

This letter is in response to your public disclosure request sent to the Green River Task Force website on April 5, 2007. Your requests were forwarded to the Legal Unit for response.

You have requested the names of the investigators of the crime. There are many people involved in an investigation of size. We have attached several documents with names of personnel that we are able to identify. Since there are less than ten pages and we are sending the documents via e-mail, we will waive the fee of \$.15 per page.

Secondly, you requested a list of suspects, their background and their alibis. We have no single document responsive to this request. Suspect (subject) files are voluminous and contain non-conviction information. Non-conviction information under RCW 10.97.050 which prevents copying of criminal history record information relating to an incident that has not lead to a conviction or other disposition adverse to the subject and for which proceedings are no longer pending. Non-conviction information is available for inspection only. If you would like to inspect the non-conviction information please contact the Legal Unit at 206-296-5292 to schedule a time after clarification to your request. We are unable to release this information because it is a specific investigative record and is exempt according to RCW 42.56.240 (1) it is essential to effective law enforcement and according to RCW 42.56.050 as it is to protect a person's right to privacy.

Next you requested a psychological profile of Mr. Ridgeway and other suspects. We have located no document(s) responsive to your request.

Your request for forensic evidence is very vague. We are unable to respond to this request without further clarification.


